Michael Paducah has signed the letter that is address to the Board of Selectmen and is attached to the Classification Memo from Gail; a brief summary of the Open Space, Residential and Small Commercial Exemptions. There is the Department of Revenue approved Assessment/Classification Report and the Tax Rate Recapitulation. Copies of the packet were made to bring to the selectmen's meeting for anyone attending.

Ellen Blanchard mentioned attending an MAAO event and to keep an eye out for a ruling in regards to Verizon Wireless. The SJC said the residential is separate from business – Carver has FY2010 and FY2011, hopefully things will be decided soon and we can settle these cases and everything will be done.
