I. Public Hearings

II. Discussion:

A. Covid-19 Update

1. Kevin Forgue noted an increase of Covid cases; on average one (1) new case a day which is "concerning".
2. Kevin Forgue stated the current Town of Carver active Covid case total is ten (10). In addition, as of November 25th, two (2) cases will drop off leaving with eight (8) cases, then two (2) more active cases to drop out November 28th, leaving the cases total down to six (6).
3. Currently the Town of Carver is Yellow.
4. Kevin Forgue remarked there was a sample of seven (7) cases listed positive in which they were previously tested and tested negative due to a glitch in Massachusetts Virtual Epidemiologic Network (MAVEN).
5. Chairman Mueller inquired about communication streamline within the town?
 - i. Kevin Forgue noted there is daily communication with the Town of Carver School Nurse and the Atlantic Hill nurses. Kevin Forgue noted that sometimes The School Nurse finds information prior to the MAVEN system due to phone calls from parents keeping children out of school potentially Covid related. The School Nurse has been trained and authorize to operate in MAVEN.
6. Kevin Forgue remarked if the trend continues to increase, the town will start receiving recommendation from the State.

1. Kevin Forgue remarked there is now an understanding from Administration and The Board. The Board of Health needs to be involved in the future regarding new health protocols to alleviate unnecessary conflict.

D. MAVEN ((Massachusetts Virtual Epidemiologic Network)

1. No further information besides what was mentioned above in Section A.4

- E. Plymouth Street Water Main Extension
 - 1. Kevin Forgue stated this was approved through Conversation Commission and in which he received a draft copy. Between last meeting and present there was another round of sampling for public waters supply for individual homes.
 - i. Currently there are four (4) detects which is one (1) less than last testing.
 - 2. Member Callis inquired if the water supply to residents is uninterrupted?
 - i. Kevin Forgue replied "yes, their water is delivered to their home".
- F. Topics not reasonably anticipated by the Chairman 48 hours in advance of the meeting
 - 1. Letter of rejection sent by Kevin Forgue to Mr Glenn Priolo dated November 10, 2020 regarding his plan to service the condo units by private wells instead of public water supply available at this site.
 - 2. Member Borden noted only one item has been removed from the donation box at the Frosty Dog. Member Borden recommended the Board of Health sends a written letter of compliance. Kevin Forgue noted he spoke with the Owner of the business two (2) months ago regarding this and will re-visit this issue.
