

**Minutes of the Selectmen's Meeting of September 24, 2013**  
**Town Hall – Meeting Room #1 7:00 pm**

Present: Chairman Michael O'Donnell Selectmen Sarah Hewins, Helen Marrone, Richard Ward, Vice-Chairman Jack Franey, Michele Doll

**O'Donnell led the audience in the Pledge of Allegiance and read the announcements.**

Marrone read notice from Board of Health regarding EEE. She also offered her condolences to the family and friends of the (2 ) Carver residents who recently perished in an auto accident.

Ward acknowledged Connie Shaw and Clark Griffith who both received the Presidential Volunteer Service Award, through the Mayflower RSVP.

Hewins offered appreciation to all the residents who supported and attended the Young Peoples' Alliance of Carver (YPAC) Open House on Saturday, September 7th. She also made reference to the generous donation made on behalf of the Dorine Merritt Memorial Scholarship Fund.
