Minutes of 1/26/22

The meeting was called to order at 7:00 p.m. by Chairman Ieronimo

**Minutes of previous meeting and possible vote**

Mr. Garnett motioned to approve to accept the minutes of November 17, 2021 with a correction to DDT and Edgewood Bogs LLC as partially completed per Chairman Ieronimo, Mr. Harrison seconded with the corrections. Mr. Nauen Abstained.

Vote 3 to 1 Abstention.

**Alex Johnson and Sons location Map 83 Lot 1 - Permit status and discussion of project completion**

Chairman Ieronimo inquired to Ms. Maki and Mr. Nunes representing G. Lopes about the time frame needed to complete the project. Mr. Nunes stated that it was one half completed and stated another four to five years to finish as the material is difficult to move. Mr. Garnett inquired about the estimated remaining yardage and Mr. Nunes response was 200,000 cubic yards. Mr. Garnett stated that completing would be favorable to the neighbors. Chairman Ieronimo stated that he is favoring completion in two years. Mr. Nunes stated that he would produce something completed; Chairman Ieronimo suggested completing the outside by the one year review and completion by the second year review. Mr. Garnett encouraged the use of sea grass. Chairman Ieronimo stated the road condition as swept. Mr. Nunes encouraged him to call if any complaints are received. Mr. Nauen moved to amend the Order of Conditions Map 83 Lot 1 to be finished in two years, January of 2024, and reviewed in November; Mr. Garnett seconded the motion. Unanimous.

**Review of Site Visits December 4, 2021; Johnson and Sons and Johnson Cranberries LTD.**

Chairman Ieronimo stated progress to the Johnson and Sons where the road is maintained. He stated no activity on the quiet side of the Johnson

Cranberries LTD site. Mr. Harrison inquired about remaining time to complete the water hole; Chairman Ieronimo stated he would inquire.

**Permit Closures; Federal Furnace, Paul & Kailin Foley, and Route 44 Development**

Chairman Ieronimo spoke with Federal Furnace which is completed and may request one more visit. He stated Route 44 as completed and the first Foley project as completed and commented that it was nicely done. The Committee members signed the closure forms. Mr. Harrison inquired about what would happen if they did not get a signature from the permit holder; Chairman Ieronimo stated he would address if presented. Mr. Nauen suggested a statement attached if unsigned.

**Review of Earth Removal account**

Chairman Ieronimo stated the DPW received about \$335,000 for repairs and at no cost to the tax payers. Mr. Harrison suggested keeping the permit active on the list unit the closure forms have been executed.

**Review of Discriminatory Harassment Policy**

The Committee signed the form.

**Announcement of Darlene Whittemore's resignation**

Chairman Ieronimo stated the sad news for Ms. Whittemore's departure. The Committee displayed appreciation for her years of service. Ms. Whittemore thanked them and that she enjoyed her time working with the Committee for many years.

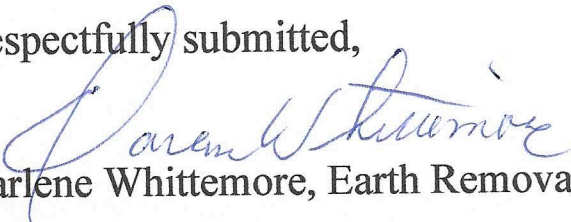
**Set next meeting and adjourn**
