#### Discussion of recent site visits and schedule next site visits

The board discussed site visits they went on 5/20/23 starting at 8am

Mason said the entrance was improved and he was surprised with level of cleanup. The roads were moist and they were not working since it was a weekend. This project is finally shaping up.

#### **Discussion of new business for Earth Removal Committee**

Ward would like to have on the next agenda a discussion on having a sub committee and how to go about that including revisiting the bylaws of E.R.C. Have all members think of ideas on how to approach and go about this. Vice Chair Garnett announces that Robert Ieronimo has chose to resign after several years on the E.R.C. He is just too busy with his work and all that is needed to volunteer on the Earth Removal as the Chair. Mason said how much he appreciates the Chair and all he has done for the committee and Town. Vice Chair thanks Ieronimo on his 10-15 years of service on the Earth Removal Committee. The Vice Chair said he visited Town Hall to speak to Town Administrator on truck hauler status but didn't get an answer so will go back soon to ask again. The board agrees to wait until truck hauler is on board to reorganize the committee with Chair and Vice Chair.

### **Review of Earth Removal Account**

Members really want to meet with Shelby to go over account balances and how they are set up. Garnett did explain it's the software they use that makes it so confusing and it's a work in progress as they are tying to switch over to new software. Recording secretary jotted down some ideas and will go over with Shelby for future meetings when printing reports. There was appeared to be a double charge on two different dates for the new printer Earth Removal had to purchase. The board tabled that for next meeting to discuss further.
