- SLT has taken about 10K gals só far Mostly for hydro seeding.

The plant is running great.

I am working on a quote for the pump. There is a conflict with part number and our motor. The vendor is verifying with the manufacturer. When I get the quotes, I will send it directly to Kevin. Mr. Tracey – We have until July 11 to get all

invoices in for the fiscal year. The invoice has to be dated on or before June 30.

Mr. Siedentopf - The church on Green St has excavator and is ready to begin. Mike Ohl still needs to mark water lines. Dave will have them contact Mike directly. Mr. Tracey - This will give us 5 more hookups. The town will be extending it

beyond that.
