# Reorganization of the Board:

### GAP 2 Grant / Generator Replacement:

Mr. Siedentopf – I called FM Generator on Friday and spoke with the Supervisor. They are just waiting for the electrical piece. Their Electrician was out, but is now back. We will be doing a rerouted line (to the back of the building – more

cost effective). Mr. Romano – It will require another pad. Mr. Sinclair – We will be saving money and it will be more reliable. Mr. Romano – Is the generator there yet? Mr. Siedentopf – I will check on that.

### Rte. 44 Development, Urban Renewal Plan:

Mr. Sinclair – Environmental Impact Report is done. I have questions for Stephen but he has not been available. There are only two properties left. Mr. Sinclair – We had a great joint meeting a few months ago but communication is very slow now.

Mr. Tracey – Regarding the Webby Property – I am in the earliest phases of investigation. It appears the the NCWD put a lien on the two Webby parcels. It was our intent to better them. Somewhere along the line, the betterment was never done. They are now requesting the lien be released. Typically, this would go out with the tax bill but appears to not have done that. I spoke to Steve Webby today. He indicated that he was aware at some point the property was going to be taken in tax title but he then squared up. Mr. Sinclair – Who was the attorney? Mr. Tracey – Jean McNight, who is now retired. I have a meeting on Wednesday with the Administrator. Mr. Romano – We need an attorney. If we signed a commitment and it's included in the commitment and the town didn't send the bill, we could still collect. If it's not on the commitment, there could be legal issues. Mr. Sinclair – We should consider setting you up with a scanner to get all of your documents on the computer. Mr. Romano – We could provide that out of the budget.

- Middleboro flushed our system on Friday and it only took 2 hours!
- Meter list Hoping it's outdated. It lists 40+ meters. Mr. Tracey Yes It's outdated. Jill can help you.
- The old VFW contacted me for a meter hookup. I told them they had to fix the water leak first. They will need a new meter. Mr. Tracey This will be handled as a new connection.
- 0 Plymouth Street 33 house development They are looking to start in a couple weeks. They are stilling looking for a written cost. Mr. Tracey I gave that to Michael; I will follow up. Mr. Woollum They also want a temporary meter. Mr. Tracey We allow for that. Mr. Romano He went crazy with the trees.
- We are having issues with the locks on the yellow gates. Someone is taking/destroying the locks. The firelock is completely missing. Dave is aware.

• Nothing from Indian Head yet. Mr. Tracey will reach out to them.
