Meeting called to order at 5:31 PM, by Mr. Tracey

Frosty Dog – Water Main Extension:

Mr. Sinclair – I have no update tonight. Mr. Tracey – They are going to connect to the building that they have and go from there.

FY21 Budget, discussion and possible vote:

Mr. Tracey – It's at a surplus of \$980.79; most of the money came from "Other Professional Service". I moved some money into the phones and electric, which has a 2% annual escalator. I will continue to follow up to make sure we get the credits that we deserve. Billing has been reduced. The surplus may get used with "Indirect Costs". That number may not be known until just before town meeting. I don't have the final number for the Retained Earnings piece. Mr. Romano – The end of year report should be all inclusive. Mr. Sinclair – This is a very tight budget. Mr. Tracey – If we get a serious hit such as a watermain break or bacteria issue, we will address it at that time. We had a 20% reduction in our subsidy at the last town meeting. Mr. Sinclair – There was a 5% increase included on usage.

Mr. Tracey - Mr. Siedentopf is not here this evening. The generator is here and onsite.

Mr. Sinclair – Nothing to report.

Water Operators Report:

Mr. Romano – The church was shut off. Mr. Tracey – It has not yet been paid and remains off.

Mr. Woollum via phone -

- Everything is going well.
- I did shut off 2 people for non-payment; one paid and is back on. The church is still off (about 2 weeks). He paved over is boxes; which I had to address with a bar. You have in your regulations that we can charge for this; he will be billed.
- Fire test/sprinkler system done at 0 Plymouth Street. Mr. Tracey He's getting ready to sell a unit? Mr. Woollum Yes.
- Generator Waiting on FM Generator to do about a little bit of work. Gas is hooked up, with regulator. Mr. Romano
 Did they dig up the old pipe? Mr. Woollum No, the other is still hooked up.
- A new propane tank has been set.

Mr. Sinclair – 11/29 bill – Extra service due to compressor B being down. Mr. Woollum clarified that it was a contactor. If replaced, it's about 90.00. You can just get the coil but it would be about \$50. Do we want a spare? Mr. Romano - \$124.06? Is that both pieces? Mr. Woollum – Yes. Mr. Sinclair – What is causing it to fail? Mr. Woollum – It's been a while since this has happened. Mr. Sinclair – Do you know what the draw is on the compressor? The contact may be too small; it shouldn't be burning. Mr. Woollum – That's possible; I don't have the ability to check it. Mr. Sinclair – We can meet up and test the draw on it.
