- Mr. Tripp is the gentleman who is interested in the Silva Street development; he may be moving forward with an additional project on route 58, by USA Fitness.
- Santana Way I spoke to Glen and sent a copy of the Rules and Regs, highlighting fire service and water lines.
 I think he only has one more service and then he plans on moving forward with wells.
- We jetted screen in Well #1. We are refilling the well. Something is plugged up again. I have someone coming out on Thursday. The wet end was replaced last year. If we jet the line going to the building, we are hoping to increase flow to 100 gals/min. If not, we will need a new wet end before next year; this is at least a \$5K cost item. Mr. Romano Does that put extra stress on #2? Mr. Woollam No, it self-adjusts.
- We lost power last week and the generator ran over night; while I was there in the morning, the generator had to be manually restarted twice. FM Generator can't find anything wrong. There were no fault codes or anything. There was a storm the night before. Mr. Tracey We will just keep an eye on it. Mr. Siedentopf It does exercise once per week. We will keep an eye on it.

Mr. Siedentopf – It went out to bid for engineering plans. Mr. Tracey – The request was for information that we don't possess. Mr. Romano – Who do we pass it on to? Mr. Tracey – It would need to go to the Health Agent or Dave. Mr. Siedentopf – I believe they are working on it.
