- A. Rte. 44 Development, Urban Renewal Plan
  - a. Kevin T. Tracy noted no new updates
- B. Service connections on Santana Way
  - a. Mike Woollam noted no new updates.
- C. Discussion: Well maintenance
  - a. Mike Woollam noted this project has been completed
    - i. New motor wasn't needed which is now on spare.
    - ii. Mike Woollam sent Jill Martins the bill on March 8, 2021
- D. Water Operator Report
  - a. Mike Woollam noted power issue at plant Saturday March 6, 2021
    - i. Lost power and computers were down
    - ii. No call from customers without water.
    - iii. All systems and power have been restored
  - b. Kevin T. Tracy noted bids opened March 8, 2021 for the water main extension project.
    - i. Kevin T. Tracy discussed with Kevin Forgue; Health Agent the bid numbers that came and appear reasonable.
    - ii. Project to potential start Spring 2021
  - c. Jill Martins contacted Mike Woollam about a new phone charges with his name attached
    - i. The charge consists of \$98.08 which started on January 28, 2021
    - ii. Mike Woollam noted Verizon is billing the North Carver Water District an extra line
    - iii. Mike Woollam noted there has been no changes since modem replacement one (1) year ago.
    - iv. Due to lack of access on the billing account, Mike Woollam will have Dave Siedentopf; Director of Operations and Maintenance speak with Verizon about charge
  - d. Kevin T. Tracy is seeking a motion to be made for second spare parts for well pumps to be paid in the amount of \$1,028.00.
    - i. This payment will come from the North Carver Water District Commission: Repair and Maintenance account with a balance of \$3,500.00
    - ii. Stephen Romano made a Motion to approve the payment of \$1,028.00 for well spare parts. Seconded by William Sinclair. Voted and passed unanimously, 3-0

  - i. Kevin T. Tracy would like the Town of Carver Residents to disregard this rumor as they do regular testing.
