MONTHLY PROGRESS REPORT - OCTOBER 2020

GENERAL COMMENTARY OF MONTHLY PROGRESS

During the month of October, sitework continued with Dig-It prepping and laying out the site to prepare for binder. They brought in fill to grade and paved the binder course of asphalt. They also helped with the fire suppression line to the outbuilding and the underground conduit for the future gate. After paying, they began the layout of the pre-cast curbing. American Electrical continued the exterior disconnects for HVAC equipment. They continued overhead wiring at the main building and outbuilding for power, fire alarm devices, and lighting. They also installed electrical panels at the electrical room. LaPan installed the outbuilding vent and piping, the water meter, and 1" water line at the outbuilding. They continued copper water connections inside of the mechanical room and installed the water heater and associating piping. G&H continued ductwork in the attic area, installed refrigerant line sets at the main building, and installed condensate connections. They continued mechanical rough-in at the outbuilding including installing the unit heater in the fire pump room. Viking Industries continued ductwork insulation. Commercial Masonry continued CMU walls in the mechanical room and cells to the deck. T&C Woodworking was on site for measuring and layout of the upcoming casework. Barber Drywall continued hanging drywall and taping and sanding walls to prepare for priming. Dandis began priming around door frames and finished walls. They also continued painting exterior trim and the Sally Port walls and piping. Empire continued siding at the cupola edges and PVC at the main entry. They also framed the attic access door and crickets at the roof hatch and security ceilings. Belcour finished the outbuilding roof. Tower continued the outbuilding soffit trim and siding, installed door frames at the outbuilding, and installed wood blocking around the overhead doors at the Sally Port. Debrino caulked the exterior PVC gaps and corners, around windows, and the cell area and door frames. They also began caulking the outbuilding PVC trim. Central Ceilings began installing acoustical grid. Bobe Materials met on site for layout of the upcoming wire mesh partitions. JAILS began their security ceilings in the cell areas. Next Generation Doors installed the overhead doors at the Sally Port. Cape Cod Central Vac continued the remaining piping in the corridors for the central vacuum system. American Flag Pole installed the flag pole foundations. New Era continued installing access control wiring. Briggs was on site for compaction testing, asphalt testing, and a wood construction inspection. SWE's structural engineer was on site to inspect the outbuilding trusses. Heads Up Irrigation visited the site to review scope of work and provide the irrigation layout plan. E911, ComTech, Comcast, and Verizon were all on site for a walk-through to review upcoming work. Eversource installed a new utility pole adjacent to the site. DPH performed a preliminary walk-through of the cell area and will return once JHA requests the final inspection. All activities are outlined below.

SCHEDULE COMMENTARY

Tower Construction provided a master schedule with an occupancy date of March 8, 2021.

SAFETY COMPLIANCE

Ongoing safety walks are performed. No outstanding issues. Extra precautions are being taken due to COVID-19; a handwashing sink has been installed on site and all meetings are virtual. Tower Construction had a discussion with subcontractors on site on following safety protocol. They are each filling out a daily COVID-19 safety sheet. CHA is filling out daily health certifications as well.


