# Carver Select Board Meeting Minutes Town Hall- 108 Main Street April 18, 2023 - 6:00pm

Chair led the Pledge of Allegiance and Cotter read the community prayer.

# <u>Authorization for Planning Director to enter into Electricity Aggregation agreement on behalf</u> of the Town:

Town Planner Tom Bott present to discuss the Municipal Aggregation. Carver and 25 other Towns buy electricity together. Information on the Town's aggregation is on the Town's website. The rates change every 6 months if you go through Eversource, the aggregation does not guarantee the lowest rates, however, it does reduce the risk of the volatility in the market. Under the current agreement it is around \$0.10 per kwh, the cost of the aggregation charge is considerably less than the Eversource cost which is \$0.25 per kwh. On April 25, there is a meeting to look at costs and on May 2, towns will be making a decision on whether or not to opt in. There is a 3-hour bid to lock in the cost of electricity.

Cotter asked what they are bidding on in May. Bott stated the discussion at the meeting will be how long they will be buying a rate for (possibly up to 3 years or less, depending on the feeling of the market conditions).

Cotter asked if there is a benefit for the Town not to be in the aggregation. Bott stated every resident has the option to opt out. Everyone is automatically opted in. There is no charge to the resident for opting in and out.

Hewins stated this is the third time the Town has participated in the Community Electricity Aggregation program. When the Town first started, there was a little savings (\$0.10 per kwh through aggregation and \$0.11 per kwh through Eversource), but not as much as it is now. Hewins noted every resident gets a notice in the mail to opt out.

Townsend stated there is very little down-side to this.

Motion to approve Town Planner Tom Bott to enter into the Community Electricity Aggregation Agreement on behalf of the Town of Carver by Hewins, second by Hoffman.
