Board of Health meeting minutes for October 16, 2018, Carver Town Hall, Meeting Room 3

Meeting called to order, by Mr. Borden, at 5:03 PM

Discussion:

Private Hauler Regulation:

Mr. Forgue – I feel that the list I gave you last meeting was pretty inclusive. Mr. Mueller – Would this be per truck or per company? Mr. Forgue – Could be either way but would be easier per company. We have to work out the fee. Mr. Mueller – Can we mirror it off of the haulers licenses? \$100 per truck? Mr. Forgue – I can check in with Rochester and Mattapoisett to see what they charge. We need to give some thought onto whether we have an exclusive on a company or stay where we are. Mr. Mueller – I think we should keep it open. Mr. Forgue – If we did one company, the contract would be awarded each year. Mr. Mueller – On the application, should have a second page with vehicle information on it; year, make and model; registration, current inspection sticker, etc....

Donation Bin Regulation:

Mr. Forgue – I've emailed Attorney Korbo? For feedback. He doesn't feel we can ban them but will look into it. He's also looking into illegal dumping and fines associated with that. I would hope that a fine schedule will help deter some of it. I asked him to research the maximum amount of fees that can be applied. I don't think we want to start at \$1000 but we need something that impacts. Mr. Mueller – I think the property owners need to pull a permit with fee as well, with the understanding that it needs to be maintained. Mr. Forgue – Do we want a formal meeting with these folks? Mr. Mueller – No I don't think that is needed but they need to know that it is coming with details of fines, three strikes, etc. Mr. Forgue – We would have to

add language that addresses maintenance, monitoring, etc. I would like to know what the landowner is getting out of it. The one at Quickeez says that the container company comes out within 24 hours of a call so they should be able to address issues quickly. Mr. Mueller – What happens if they become abandoned? If the landowner pulls the permit, maybe they should be held responsible for the removal of an abandoned bin. I don't know if the DPW would be interested in the removal of the bin(s). Should we limit the number of permits? Currently have 5 or 6 bins in town. Maybe limit it to 6. The building must be an occupied parcel, as well. We should also limit to commercial property, with one per property. Mr. Forgue – I will compile everything for review at our next meeting. Mr. Mueller – We can submit the draft to Attorney Korbo too.

Storm water Regulations:

Mr. Forgue – There was a question as to the Board of Health overseeing the storm water calculations. The Board of Health really isn't doing that; we are relying on the peer review. Our regulations mirror the DEP Standards. I think we should just retain the regulations that we have. Mr. Mueller – A lot of towns require annual cleanings of catch basins, car runoff, leaves, etc.... Do we have that out there now? Mr. Forgue – For something like Shaws, I would look at the Conditions of Approval. Even with an O&M plan, who is following up. Mr. Forgue – We don't have anyone to police that here. I could talk with John Woods and Stephen Cole to see if something like this is going on. I could look at the files and see what's in there. Mr. Mueller – Maybe look at some of the newer businesses, Norfolk Power Equipment, etc.
