Public Hearings:

On the application of Tracey Tsina requesting the following variances associated with a septic system upgrade at 25 Walker Road on a 14,549 sq. ft. lot, Map 14, Lot E, pursuant to 310 CMR 15.405 Local Upgrade Approval.

- a. 310 CMR 15.405 (e) to allow the reduction from 50' (required) to 25.2' (proposed) between the SAS and surface water.
- b. 310 CMR 15.405 (g) to allow a reduction from 100' (required to 89.4' (proposed) between the SAS and the Locus Well.
- c. 310 CMR 15.405 (g) to allow a reduction from 100' (required) to 93' (proposed between the SAS and the well at 27 Walker Road

James Garfield, on behalf of applicant – Presented property plan. The site is pretty tight. Currently serviced by a failing system. The only two options are the front and rear yard. We are proposing the rear yard. We would love to have it as far away from the pond as possible, in the front yard, but would put us under 50' to the neighbors well. This should be a great improvement compared to the two leaching pits that are there. Mr. Forge – The original system was a cesspool and then an overflow cesspool. Mr. Mueller – Any input from Conservation? Mr. Forgue – No, they look at it similar to us. This is an improvement. Mr. Garfield – We have a NOI and are scheduled to appear before them.
