Board of Health meeting minutes for October 24, 2017, Carver Town Hall, Meeting Room 3

Meeting called to order, by Mr. Borden, at 5:03 PM

Public Hearings:

On the application of Dorothy Freeman, requesting two variances under 15.405 (1) (g) and 15.405 (1) (i) located at 15 Pine City Road, in Carver, MA – to allow an upgraded septic system on a 13,362 sq. ft. lot.

Requested Reduction:

- a) Installation of a soil absorption system 90' from a well, instead of 100'.
- b) To allow a sieve analysis in lieu of a percolation test.

Mr. Mueller - Why are they requesting the Sieve Analysis? Mr. Forgue – In this case, it's just too deep/change in soil noted. The change is 6 ½ feet. Mr. Mueller – Will they will make sure it is consistent? Mr. Forgue – Yes.

Motion to approve installation of soil absorption system 90' from well, instead of 100'and the use of a sieve analysis in lieu of a percolation test: Mr. Lawrence

Discussion:

- Mr. Forgue 31 Russell Trufant Road I received Mr. Borden's info regarding this property. I went out there; it is bank owned and they are dumping on the grounds. I have emailed the bank requesting they get in touch with me.
- Fees for submittal of title 5 inspections We are charging the \$25 fee.
- A property owner came in to complain about neighbor's pigs near property line. Our regulation is vague. I was thinking that we might want the same restrictions for pigs as horses. For example, a corral can't be any closer than a specified number of feet to a well or property line. Mr. Mueller Did he try to have a conversation with the neighbor? Mr. Forgue No. I will follow up on this and look to see if we can use the horse regulations. I can put something together and bring it before the board at the next meeting. Mr. Mueller Does the state have something? Mr. Forgue I will check on that. Mr. Mueller Are they being raised for food? Mr. Forgue I don't know.
- Collection of tipping fees we are chronically having difficulty collecting these fees. The Permitting Department has proposed that we impose a \$5,000 fee that they can draw against. In the past, I have had to call the tipping house to request that they refuse entry for a hauler in arrears. They don't like to do this. The Board is in agreement to pursue this.
- Mr. Mueller Vacated house on Quaker Rd/Surrey Drive Have you received any calls on this? A couple of people have approached me on this. There is no side door and a car on the property that has trees growing out of it. Mr. Forgue I have not; I can go check it out.
- Trailer excise bills were distributed for signing.
- New Mexican Restaurant Mr. Forgue They have come in for permits. They are aiming to open by the end of November.
- Mr. Mueller Trails End Stables Have we received payment on that? Mr. Forgue Not yet, I am still working on that.
