# CARVER CONSERVATION COMMISSION MINUTES OF JUNE 7, 2017 MEETING

Present: Jennifer Vaillancourt, Savery Moore, Alex Lovejoy were present. Tim Dempsey and Jim Nauen were not in attendance. Also present: Brooke Monroe, Environmental Scientist, Agent, and Marianne MacLeod, Recording Secretary.

Savery Moore will act as Chair for tonight's meeting. He opened the meeting at 7:03 P.M.

## APPOINTMENTS

Appointment with Pine Ridge residents regarding maintenance of the Pine Ridge Bog

Robert Paino represented the Pine Ridge residents. They own the middle-sized bog, which is located on top of their well system. It is deemed "unfarmable". They are looking for approval to keep the appearance of the cranberry bog. Jon Delli Priscoli is the lease holder. The property belongs to the Pine Ridge Condo Association. Makepeace may be contracted to do the work to maintain the bog. The Association tried to do this process four years ago. It was determined to be an upland bog. Board members did a site visit. Brooke offered to put together a letter to the Pine Ridge Condominium Trustees. Jennifer Vaillancourt made a Motion to allow the Trustees of Pine Ridge Condominiums to maintain the appearance of the bog on the north side of the condominiums and allow for cutting of trees and brush that are starting to grow, seconded by Alex Lovejoy. Voted and passed unanimously 3-0-0.

Savery Moore also brought up the access points to Sampson's Pond. He wanted to clarify that the Association is going to put the seasonal dock where there was already an existing path to the shoreline and where there are cinder blocks in the water. Mr. Paino confirmed this is correct. He will mention this to the Trustees and they will let Brooke know when the dock is delivered. Savery Moore also wanted to confirm that the dead leaves will be raked on the south end of the beach area and that is all that will be done. They confirmed there were dead trees that will be removed. Savery Moore confirmed they can rake sand up from the water on to the shoreline.

Chapter 131, Section 40) and the Carver Wetlands Protection Bylaw, that a public hearing will be held at 7:15 p.m. on Wednesday, June 7, 2017 in Meeting Room 1 at the Carver Town Hall to hear the Notice of Intent (NOI); submitted by the Applicant, Kevin Perkins; for the proposed construction of a single family dwelling, with associated driveway, septic system, grading and utilities. The work will occur within 100 feet of an isolated vegetated wetland (drainage basin/easement). The proposed work is outside the 65-foot buffer protected under the Carver Wetlands Protection By-law. The project is located at 1 Crow's Nest Road, Carver, MA, Map 122, Lot 34. All interested parties are invited to attend.

Kevin Flaherty came before the Board representing Mr. Perkins. He showed a plan that was previously approved. He then showed the new plan. The Board members did a site walk today.

Two abutters came forward to speak. 25 years ago they tried to build on this property. They bought the property next door instead. They have issues with the lot lines being moved. None of their concerns are issues that need to be addressed by the Board.

A Motion to approve the NOI was made by Alex Lovejoy, seconded by Jennifer Vaillancourt, voted and passed unanimously 3-0-0.

The project is located at 7 Pleasant Street, Carver, MA, Map 30, Lot 5-BEN-R. All interested parties are invited to attend.

Petitioner wants to put in a 24' above-ground pool. It is out of the 65' perimeter and this is a negative determination, with no impact. There will also be construction of a small deck after the pool is installed, approximately a 12'x14' wrap-around deck. This pool was a provided via a grant given to his daughter, who has polycystic kidney disease and it was given for therapy for his daughter. The deck wouldn't encroach the 65' perimeter. The Board can modify the RDA. A Motion was made by Alex Lovejoy, seconded by Jennifer Vaillancourt that the Board will issue the negative determination, with modification to add the 12'x14' deck included. Voted and approved unanimously 3-0-0.

A Motion was made to approve the NOI for the after-the-fact NOI by Jennifer Vaillancourt, 2<sup>nd</sup> by Alex Lovejoy, voted and passed unanimously 3-0-0.

Chapter 131, Section 40) and the Carver Wetlands Protection Bylaw, that a public hearing will be held at 7:15 p.m. on Wednesday, March 15, 2017 in Meeting Room 1 at the Carver Town Hall to hear the Notice of Intent submitted by Mr. Bob Belbin for improvements to the existing single family home; including: the replacement of the deteriorating driveway, with a drain/drywell; boulders to be installed along the upper slope of the driveway; second floor addition onto the existing house; replacement and addition of the side porch; replacement of grass from the side/back of the house; and removal of a tree for safety reasons. Alex Lovejoy made a Motion to adjourn at 8:16 p.m., seconded by Jennifer Vaillancourt, voted unanimously.
