B. Nominate and vote: Vice Chairman.
2. Member Sulger made a motion to elect Adam Holmes to the position as Vice-Chairperson of the Finance

Committee. Seconded by Member Zweigman. Voted and passed unanimously, 8-0
C. Grant applications: Health Imperatives and Shane Gives Thanks.

1. Health Imperatives Inc.
a. Jennifer Allison from Health Imperatives Inc completed an overview of the organization.
i. Health Imperatives serves mostly low-income individuals and families from South East Massachusetts, serving 68 communities.
ii. In 2019, Health Imperatives served 152 residents of Carver and in this current fiscal year served about 116 residents of Carver.
iii. Health Imperatives, to name a few, provides communities $24 / 7$ hotline for domestic violence, mental health counseling, support groups, educational classes, advocacy services, violence prevention education, WIC assistance, and sexual reproductive health care (HIV testing and prevention, STD testing, birth control, pregnancy testing, etc.).
iv. Jennifer Allison noted that $100 \%$ of the grant funding expended back to Carver residents. The cost to serve Carver community is approximately $\$ 90,000$ a year. Of that, $\$ 66,000$ covers personal cost and $\$ 24,000$ for program supplies etc.
v. Member Sulger made a motion approve the grant application for Health Imperatives Inc for $\$ 5,000$. Seconded by Member Holmes. Voted and passed unanimously, 8-0

## 2. Shane Gives Thanks

a. Krystle Cole from Shane Gives Thanks completed an overview of the organization.
i. Shane Gives Thanks is the only food pantry in the Town of Carver, it relays on $100 \%$ donation, all volunteers, and is open 4 days per week.
ii. Twenty-five (25) students are enrolled in the school system and Twenty-five (25) students enrolled that are home schooled or full remote in the organization.
iii. The pantry had 990 visitors last month and of those visitors, 722 were families from Carver. They There has been an increase in Senior Citizens and additional support to provide veterans with extra food.
iv. Member Holmes made a motion approve the grant request for Shane Gives Thanks for $\$ 5,000$. Seconded by Member Kenneally. Voted and passed unanimously, 8-0
