# Draft FY20 - Discussion:

Mr. Tracey – Last month we had \$22K to use. We can't combine that with the \$32K from this year. That \$32K doesn't become available until July 1. There's a possibility of the grant for the generator getting taken, we will stick with what we've got. Mr. Sinclair –Would we have time to make any changes before the town meeting? Mr. Tracey – Mr. Milanoski is going to want final numbers at some point. All in agreement to leave the budget as is.

# GAP 2 Grant / Generator Replacement:

Mr. Tracey –Someone at the state level, DOER is kicking the grant back to us, requesting that we have our own TAX ID number; we aren't able to do that while the government is shut down. Mr. Cole is continuing to work on that.

# Rte. 44 Development, Urban Renewal Plan:

Mr. Sinclair - The Walsh property has been sold. The RT 44 Developers purchased it. At tomorrow nights Redevelopment Authority meeting, I will be asking for approval to invite the developers in to see where they are at. I would like to find out what the issue is with bringing the fill in. There have been comments from the community, regarding traffic speed at the end of Montello. Carver PD has been made aware and according to them they are not seeing a speed issue. I will keep this Board up to date, as much as I can. Mr. Tracey – How many more properties do they still need to acquire? Mr. Tracey – I think there is only a handful left. My biggest concern is that the economy is taking a turn; we might miss the window. Interest rates are up and government is shut down. I did go by the Amazon site in Taunton; what a huge facility!
