Rules and Regulations –

Mr. Palimeri – When I first got on the Board I read the Rules & Regulations and found some to be very antiquated. It is one of the things that we will continue to have on the agenda, for discussion. One item would be that currently, we require iron pipe in the road. That is not the only or necessarily the right material. I would like to look at adopting something in the Rules & Regulations to allow plastic. Our plant is already plastic. Mr. Mueller – Things do change. Maybe we can get a complete copy to each member for review. Hopefully we will have another member soon. Mr. Palimeri – Our Rules & Regulations are on the Town Website or Jill can get you a copy.

Route 44 Development, Urban Renewal Plan:

Service Connections on Santana Way:

Mr. Palimeri – Are any new connections going to be done? Mr. Bachand – I believe all new connections are done.

Update from Small Water Systems Services:

Water Operator Report –

Mr. Bachand – Tomorrow we begin a 3 day process replacing the membranes. Mr. Palimeri – We do have some paperwork to sign regarding repair of one of the well pumps. Anything we can do while we are not in operation to make the system as good as we can, we should do. Mr. Bachand – I will update you if anything else is needed.

Discussion:

Credits and appeals on billing –

Mr. Palimeri – I would like to apologize for any mishaps for bottled water reimbursement, back in June/July. That has been rectified. In the last billing cycle, the bill contained instructions on how to go about the appeals process. I would strongly urge people that feel they are due reimbursement, that they give us a **copy** of original receipt and a **copy** of the original request letter. There was conversation about the credit on the last bill. There were 4 months billed on the last cycle; usually it is three. There were some delays due to the changeover. We felt this was the most expedient and fairest way to handle it. The meters don't determine which month is highest or lowest month in billing. Mr. Mueller – It was probably a better average using the 4 months.
