Meeting minutes for November 1, 2022, The North Carver Water District Commissioners met, today, at the Carver Town Hall, Meeting Room #4, 108 Main Street, Carver, Massachusetts.

Meeting called to order at 5:00 PM, by Mr. Palimeri

Discussion:

Rules and Regulations –

Mr. Palimeri – We all now have a written copy of the R&R. Does anyone have anything to discuss? None heard. Mr. Mueller – I have just started reviewing it but let's keep this on the agenda.

Route 44 Development, Urban Renewal Plan:

Mr. Mueller – I spoke with the Town Administrator and the Asst. Town Administrator late last week to discuss the future for the North Carver Project and the impact on the water supply for the NCWD. They advised me to meet with the Town Planner, who is currently on vacation. My next step will be to meet with the Town Planner and discuss the future plans and expectation on the development and what the future for NCWD is.

Mr. Palimeri – I noticed behind Quickeez off Main Street, there is a lot (Fuller Street/Forest Street) recently cleared. That is very close to a dead end on the water system and could be a discussion in the future.

Update from Small Water Systems Services:

Water Operator's Report -

Mr. Bachand -

- Both tanks, the mixing tank and the aeration tank, have now been cleaned.
- I spoke to Joyce today. The wet end that we were waiting for came in . She has to get back to
 me on a date that they can be out here to work on the well. After that, we begin the process of
 turning it back on.
- Mr. Palimeri Was there something on the Chemical room? Mr. Bachand That is in process
 of being done but is not part of the steps to being turned on. The chemical side that is used
 daily is all set. The part that is still in process is the cleaning place side and will be completed
 before it is needed.
- The dumpster is there as well.

Mr. Palimeri – What are you thinking for a time frame to get the system up and running and go online? Mr. Bachand – Realistically, I think to go totally online, for distribution, I would say the first of the year. I don't have a date for the well company yet so the first of the year is a safe timeframe. Mr. Palimeri – It is best to do it right, without rushing. Mr. Palimeri – I believe, up at the plant, we have a spare well pump? Mr. Bachand – Yes you do. However, you have two different size wells. You have a spare well pump but not the wet end. Mr. Palimeri – Down the road, I would like to try to have spare pumps/wet ends available as this has taken some time. Mr. Bachand -The one we just got in took so long as it wasn't a common size. Mr. Palimeri – I would like to come check out all the work you've done. Mr. Bachand – Absolutely, we are happy to answer any of your questions.
