MONTHLY PROGRESS REPORT - JUNE 2020

GENERAL COMMENTARY OF MONTHLY PROGRESS

During the month of June, sitework continued with Dig-It laying out the pre-cast concrete curbing by the library and installing it before the library reopened. They also removed two trees by the library. After curbing was completed, they began loam at the curbing and compacting that area. The fence was moved to allow the library employees access to their building for reopening. American Electrical was working on temporary power to the building and installing conduit within the masonry block wall. They tied in their electrical to all door frames at the Sally Port and cell blocks for access control. LaPan checked measurements and laid out plumbing piping at Sally Port. G&H was on site briefly to install control wiring within the masonry block walls as well. John Oliveira & Sons completed sidewalk preparation and pour and removed wood column boxes after the slab on grade pour. Commercial Masonry began their work in the Sally Port and cells, with Briggs inspecting their mortar and grout periodically. Structural Steel was delivered during the first week of June and erection began and was completed the following week with no issues. Empire began erecting their roof trusses using a Lull operator and Barber began exterior cold metal framing. Szewczak Associates visited the site to inspect the steel work and found no issues. Briggs also performed a steel inspection and seismic testing which passed. Fitzmeyer and Tocci also visited the site to do a preliminary walk-through, a kick-off meeting will be planned for August for MEP trades. The Town's Building Inspector visited the site to review progress on site and found no issues.

Town of Carver officials were contacted as the need arises and the client was made aware of any project challenges. We are continuing to track and verify the accuracy of certified payroll reports for Carver weekly. Construction Meetings are held weekly via Microsoft Teams conference calls. Notes are kept and distributed by CHA. CHA is tracking the construction progress versus the project schedule and coordinating and integrating the Owner's outside vendors into the contractor's construction schedule.

DESIGNER ACTIVITIES


JHA visited the site to confer, clarify and verify with the contractor and OPM. They provided documentation for agreed-upon changes. They are reviewing submittals and RFIs in a timely manner as they are being sent. CHA and JHA review the contractor's application for payment and adjust with JHA as the installed work dictates. The Team then recommends the adjusted payment sum to the Town's Procurement Officer.

QUALITY CONTROL

CHA and Tower's superintendent inspected the site daily and JHA inspects bi-weekly.

SAFETY COMPLIANCE

Ongoing safety walks are performed. No outstanding issues. Extra precautions are being taken due to COVID-19; a handwashing sink has been installed on site and all meetings are virtual. Tower Construction had a discussion with subcontractors on site on following safety protocol. They are each filling out a daily COVID-19 safety sheet. CHA is filling out daily health certifications as well.


