Notice is hereby given, in accordance with the Massachusetts Wetlands Protection Act (M.G.L. Chapter 131, Section 40) and the Carver Wetlands Protection Bylaw (Citation 9.2), that a public hearing will be held at 7:00 p.m. on Wednesday, October 25, 2023 in Meeting Room #1 at the Carver Town Hall to hear the request for a Notice of Intent submitted by NStar Electric Company d/b/a Eversource Energy for the construction of three (3) monopole structures on eight (8) inch diameter concrete foundations, associated underground cables, a 32-inch cast iron manhole and potential minor tree trimming/removal within the 100 ft.
