Chapter 131, Section 40) and the Carver Wetlands Protection Bylaw, that a public hearing will be held at 7:15 p.m. on Wednesday, November 6, 2019 in Meeting Room 1 at the Carver Town Hall to hear the Notice of Intent; submitted by 229 Tremont Street Realty Trust; for the "after the fact" construction of a kitchen addition and renovations to the existing accessory building associated with the existing restaurant; resurfacing of the stone parking lot, with clam shells; and replacement of patio blocks.
