# 7:15 – 20 SHOESTRING ROAD – SHADY ACRES – DEP# SE126-530 NOI

Notice is hereby given, in accordance with the Massachusetts Wetlands Protection Act (M.G.L. Chapter 131, Section 40) and the Carver Wetlands Protection Bylaw, that a public hearing will be held at 7:15 p.m. on Wednesday, March 16, 2016, in Meeting Room 1 at the Carver Town Hall to hear the Notice of Intent for Shady Acres Campground for the proposed addition of 18 Class "A" and 2 Class "C" campsites to the existing camp grounds. The sites will be served by sewer, water, and electric services. Each campsite will have a 10' x 38' permeable paver patio and will be accessed by a proposed crushed stone drive. This project occurs in a previously altered sand and gravel removal pit and is to be considered a "Redevelopment." Activities are proposed to take place in the 100-foot buffer
