Notice is hereby given, in accordance with the Massachusetts Wetlands Protection Act (M.G.L. Chapter 131, Section 40) and the Carver Wetlands Protection Bylaw (Citation 9.2), that a public hearing will be held at 7:00 p.m. on Wednesday, February 07, 2024 in Meeting Room #1 at the Carver Town Hall to hear the Notice of Intent submitted by Barbara L. Spaulding for the construction of a single family dwelling, portion of a septic system, driveway, grading, landscaping, well & its waterline and associated utility work within the 100 ft. Buffer Zone to a Bordering Vegetated Wetland. Some of the project work is also within the 65-foot Buffer Zone protected under the Carver Wetlands Protection By-law and will require a variance from the Bylaw.
