Notice is hereby given, in accordance with the Massachusetts Wetlands Protection Act (M.G.L. Chapter 131, Section 40) and the Carver Wetlands Protection Bylaw (Citation 9.2), that a public hearing will be held at 7:00 p.m. on Wednesday, May 17, 2023 in Meeting Room #1 at the Carver Town Hall to hear the Notice of Intent submitted by Gregory Pflaumer for the construction of a detached garage associated with an existing single family home in a previously developed portion of the property and a mitigation area within the 100 ft. Buffer Zone to a Bordering Vegetated Wetland and the 200-foot Riverfront Area. The project work is also within the 65-foot Buffer Zone to a Bordering Vegetated Wetland and Bordering Land Subject to Flooding protected under the Carver By-law and will require a variance from the Carver Wetlands Protection Bylaw. The project is located at 134 Main Street, Carver, MA; Map 104, Lot 2-0-R. All interested parties are invited to attend.
