The Chair reasonably anticipates that the following matters will be discussed and/or voted on at this meeting:

Old Business:

- Dedication Ceremony of the Commemorative Sign and Bench at Grumpys Brook on the Cole Property Conservation Land that took place on Saturday 12/19/2020.
- Approve minutes of 12/10/2020 meeting.

New Business:

- Committee's new name approved by Select Board and posted on website.
- New Scout project on the Orange Trail on the Cole Conservation Land.
- Savery Avenue Conservation Land connection to Mass Dept. of Fish & Game's 510-acre Atwood Reservoir Wildlife Management Area (WMA) and potential purchase by Fish & Game of town-owned Meadow Street property for conservation, outdoor recreation, and groundwater and wildlife habitat protection.
- Tasks remaining to be done on Savery Avenue Trail including parking areas, southern portion of trail, "stroller trail," new trail(s), and possible connections to property potentially to be acquired by Fish & Game on Meadow Street that would abut the Atwood Reservoir WMA.

- Begin work clearing path at Indian Brook Conservation Land so that public has some access.
- Finish all chain saw work on conservation land properties before spring.
- Discussion and possible vote on models / templates for advertising our work and need for volunteers.
- Discuss advertising clearing / flagging projects with volunteers at Indian Brook, Savery Avenue, and Cole Property.
- Date / place for next Conservation Land Trails Walk in February 2021
- Discussion about interpretive signage, "trail maintenance on-going," suggestion box with QR code, color coding of trails, etc., for all trails for a uniform look across properties. Volunteer offered to help with this—ask him for some design ideas
- "Conservation Photo Hunt" project: ask public for wildlife photos seen / taken on conservation land (or nearby? or on private property?) in Carver
