The Chair reasonably anticipates that the following matters will be discussed and/or voted on at this meeting:

Minutes:

- Approve minutes of 11/7/2020, 11/12/2020, 11/28/2020, 12/10/2020, 2/18/2021, 6/10/2021 meetings.

Eagle Scout Projects on Cole Property Conservation Land discussion and possible votes:

- Acknowledge our support for two Eagle Scout projects underway at the Cole Property Conservation Area—possible letter of support from CTCS and/or commemorative plaque

Safety Flyers/Language

- Approve Safety Flyers/Language to distribute either at Town Hall, on-site in Audubon-type boxes, on QR codes, or by other means

Safety/Leave No Trace/Waiver Discussion and possible votes:

- Generic Safety Briefings need to be done for all—committee and public
- Trail Crews all need **waivers**; those under 18 need to be accompanied by a parent/guardian. Possible vote to accept Town Waiver as our committee's own waiver. If not, committee to come up with its own waiver that we need to pass by KP Law/Town Counsel
- Safety/Clean-Up Training /OSHA-specific needs to be done by our members. Schedule a date for Safety training for committee—September
- Leave No Trace Awareness Workshop: schedule one for committee—September

- Leave No Trace Awareness Workshop: schedule one open to the public—September

Logo: discussion and possible vote

- Present examples of logos. Vote to approve a logo.

Savery Avenue and Indian Brook Conservation Lands discussion and possible vote:

- What remains to be done on the Cole Property Trails, Savery Avenue Trails, and Indian Brook Trail(s) including parking areas, southern portion of trail, “stroller trail,” new trail(s) and groups most likely to be interested in these particular trails.
- What is our goal for these two trails and what is the timeframe in which we can get it done?
- Schedule a meeting with Coalition for Buzzards Bay (CBB) to walk Indian Brook’s Camden Trail and how it can connect with CBB’s newly-acquired Conservation Land to the west.

Interpretive signage discussion and possible vote:

- Approve a sign layout that can go on all Conservation Land Properties
- “Trail maintenance on-going,” suggestion box with QR code, color coding of trails, etc., for all trails. Signage company (Liddell Bros.) used by DPW—do we go with them or choose another company?

- Suggestions for how to do this
- Committee can be up to nine (9) members; currently we have six (6).
