NEW BUSINESS

A. Receipt of Plans:

The Sign Permit request by Arc of Greater Plymouth was read into the record. Mr. Hunter introduced Mr. Peter Allegrini of Signs by Design which will be making the sign. Arc is going to train disabled people to work with customers at the bakery. The Board agreed the sign looked great and this would be a good move for Carver. Mr. Allegrini stated he was not sure if the business was going to request another sign for the marquis. Mr. Hunter asked about lighting. Mr. Allegrini was unsure but Mr. Hunter assured him the lighting would be grandfathered.

There are still tickets for the ball drop available at Rooney's Barbershop, the fire station, and Tauber Insurance.

Mr. Hunter notified the Board that Town Meeting had approved the Spring Street Innovation District. Nothing would be started until the fall. The grant for the directional sign study came through. Mr. Hunter had notified the owner renovating the Church that ground floor zoning had been approved at Town Meeting. Several questions had been asked of Mr. Hunter regarding the Mobil Station on Main Street. It was closed and sold. The new owner also owns Ron's in Middleboro and has applied for a Special Permit for the sign he put up. He was unaware of the requirement and seems sincere about clearing up issues.
