# North Carver Water District Minutes September 21, 2015

Posted in Accordance with the Provisions of M. G. L. Chapter 30A, Section 20B, authorized person Jack Hunter.

The North Carver Water District Commissioners met on September 21, 2015 at the Carver Town Hall, Meeting Room #3, 108 Main Street, Carver, MA. The meeting was opened by Mr. Kevin Tracey at 5:31pm.

#### 1. APPOINTMENT --

Mike Ohl has reviewed Mark E. Smith's revised claim for additional costs. (See Exhibit B) The bottom line revised claim amount is \$7,004.72. Mr. Smith states he would like to request 32 days-28 days were offered. Mr. Ohl stated the contract overage was 65 days. Mr. Tracey asked if NCWD was expected to take responsibility for the change order. The original offer was for 28 days and the change order would go away. Mr. Milanoski clarified the extremes as \$9,000 vs. \$25,500.00 Mr. Sinclair stated the proposal was \$25,500 less the change order equaling \$7,000. Mr. Milanoski stated the offer would then be \$14,000 vs. \$9,000. NCWD lost \$9,000 in revenue. Offer not acceptable to Mr. Smith. Mr. Smith stated he would go to 28 days and the change order would not need to be written up. He would appreciate not having the liquid damages noted in the new contract. Mr. Ohl stated \$14,000 was generous in his mind. The contract time would be extended and the amount would be reduced by \$12,750. The balance would be paid upon completion. Mr. Milanoski asked the amount of the original contract. Mr. Ohl replied \$189,000. Mr. Milanoski stated the final contract would be \$176,250. Mr. Smith wanted to clarify there would be no change order; Mr. Ohl stated the change was built in. This would remove potential liability. Mr. Smith replied he was not thrilled but he accepted the deal.

Billing may be moved to the Treasurer's Office and John Woods would be more involved. Mr. Hunter stated he had briefed the Board. Mr. Sinclair asked if anyone had spoken with John Woods. Mr. Milanoski stated yes and that he was more than willing to learn. Mr. Sinclair asked if there would be someone dedicated to NCWD. Mr. Milanoski replied probably John Woods and Dave Siedentopf. Mr. Hunter stated it would be helpful if Mr. Woods started coming to the meetings.
