

Carver “Transfer Station Permit” Policy

Eligibility Requirements for Transfer Station Use

Intent: The intent of Carver Transfer Station Policy is to ensure that only residential waste from Carver Residents is disposed of at the Carver, Marion, Wareham Regional Refuse Disposal District (CMWRRDD) transfer stations. It is also to control and monitor proper access to the transfer station(s). This policy acknowledges and emphasizes that providing services to Carver residents and maintaining proper usage must be balanced.

Definitions:

An Eligible Person is a Carver residential property owner or year-round tenant of a residential dwelling in the Town of Carver.

An eligible Vehicle is a passenger vehicle, van or pickup truck (3/4 ton or less).

Proof of Eligibility:

1. *Privately Owned Vehicles:* A current license & vehicle registration permanently assigned to the eligible vehicle must be provided that shows the name of the Eligible Person as the owner and a Carver Street address with a legally occupied residential structure.
2. *Leased Vehicles:* In the case of leased vehicles, the Eligible Person’s name and Carver address must appear on the lease agreement which must be presented with the registration at the time of sticker purchase.
3. *Out of Town Residential Registration:* If the vehicle is registered at a residential address outside Carver, additional documentation must be provided showing that the registered owner or lessee of the vehicle is the owner of residential property in Carver with a legally occupied residential structure. This documentation must be presented with the registration at the time of purchase.
4. *Out of Town Business Registration for Carver Resident:* If the vehicle is registered to a business located in or outside the Town of Carver, the Eligible Person must provide additional documentation showing that s/he is the sole operator or lessee of the vehicle and is the owner of residential property in Carver. Proof of his/her relationship to the business at the time of sticker purchase is also necessary. In addition, s/he must attest in writing that s/he will not dispose of commercial waste at the Transfer Station, and will only dispose of residential waste from the Eligible Person’s Carver household. All Support documentation must be presented with the registration at the time of purchase.

5. *Special Requirement for All Commercial Registration Plates:* Since the Town's Contract with CMWRRDD is for residential trash only, commercial plates are not eligible for transfer station stickers. Exceptions may be made by meeting with the Assistant Town Administrator and will require, at a minimum, proof that the vehicle will not be used to transport commercial waste. In addition, the individual applying must be an Eligible Person and be able to prove that the vehicle is an eligible vehicle (as defined above), it is only used by the eligible person, the individual has no other method to transport waste from his/her Carver residence, and s/he is the sole operator of the vehicle. In addition, the Eligible Person must attest in writing that s/he will not dispose of commercial waste at the CMWRRDD Transfer Station and will only dispose of waste from the residential household in Carver.
6. *Ineligibility:* Because their intended use is to be moved from one vehicle to another, General Registration Plates, including dealer and repair plates are not eligible for Transfer Station Permits.
 - Other Conditions of Permit:
Transfer Station Permits are not transferable to other vehicles. The registration on the Permit must match the registration on the vehicle.
 - Farm Plates
Farm plates shall be considered on a case-by-case basis only, and are to be approved by the Town Administrator or her/his designee.
 - Refund Policy
Refunds shall only be granted on a case-by-case basis after a request has been made in writing to the Town Administrator or her/his designee.
7. *Sticker Fees:* The following fees will be applicable for 2019:
 - \$50/year for Carver Residents only
 - \$25/year for 65 or older
8. Stickers are valid for each calendar year beginning January 1 and ending December 31
9. The fee for Stickers purchased on or after 10/01-12/31 of each year:
 - \$25 – No exceptions
