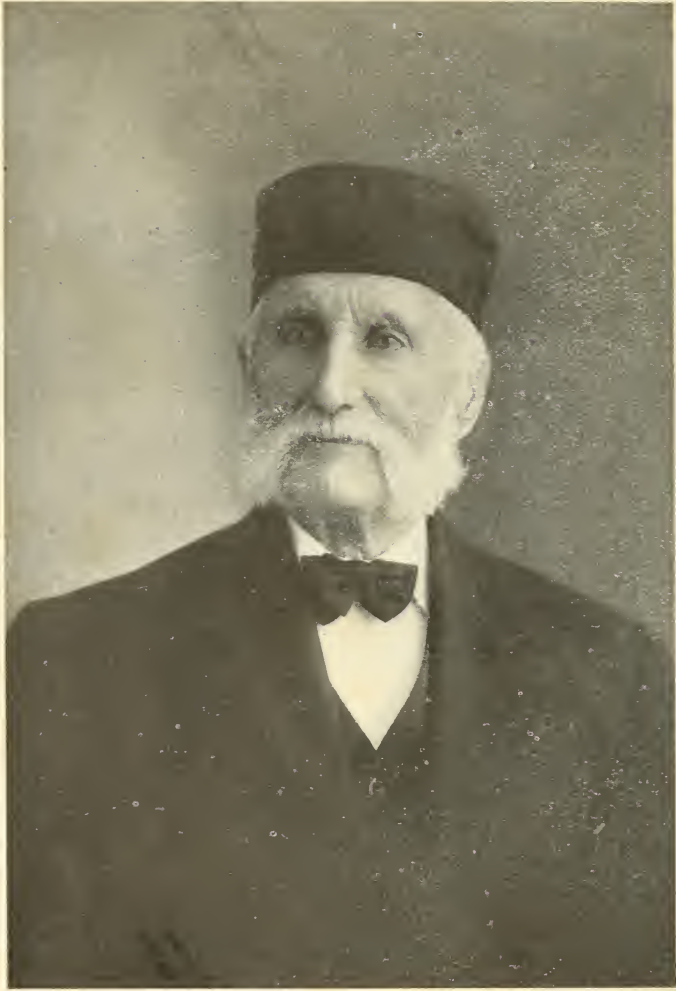

CAPTAIN WILLIAM S. McFARLIN

Captain William S. McFarlin

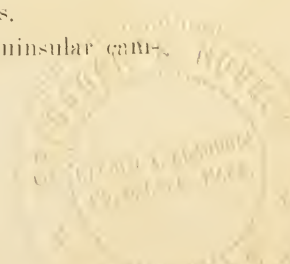
Capt. William S. McFarlin, a son of Sampson and Polly (Shurtleff) McFarlin, was born in South Carver, July 11, 1827, and died Jan. 17, 1914, in the house in which he was born.

Early in life he joined the Methodist Church and remained a loyal member to the time of his death. He was also prominently identified with the temperance movement, standing for prohibition and active in its societies, being a charter member of Wankinquoah, Echo Lake and Winthrop lodges. He was appointed a state constable under the prohibitory law of 1854, and inspired by a natural aversion to the liquor traffic, he proved a sincere and efficient worker. Working in conjunction with officers Collingwood and Baxter of Plymouth, he met with many exciting and amusing experiences, illustrative of the tricks of the trade when pressed by an incorruptible detective.

As a boy he joined the old state militia in 1852, became second lieutenant of Co. K of the 3rd Regiment of Bay State Light Infantry, in 1854 became first lieutenant, and in 1858 on the resignation of Capt. Seneca Thomas he became captain of the company. Capt. McFarlin proved to be an expert drill master, and his ability in this direction was recognized on the muster fields.

Capt. McFarlin with his company of "Minute Men of 61" had the honor of responding to President Lincoln's first call for men to serve at Fortress Monroe. The company was mustered out July 22, 1861 having completed its term of enlistment. Capt. McFarlin was immediately commissioned by Gov. Andrew to recruit another company, and as a result of his efforts Co. C, 18th Regiment, entered the service in the Army of the Potomac where its numbers were thinned by death, disease and disability that have marked it as one of the heroic regiments.

Capt. McFarlin suffered a sunstroke in the Peninsular cam-



paign that necessitated his retirement from active service in Oct. 1862 and from the effects of which he never fully recovered. He was an officer beloved of his company and regiment, and all who knew him pay tribute to his memory.

After leaving active service at the front Capt. McFarlin retired to Washington where he was detailed with various duties in connection with the army, among which was a position on the U. S. Sanitary Commission where he proved very efficient.

Capt. McFarlin cherished a pass to attend President Lincoln's funeral that was given him by Boston Corbett, who is credited with having fired the shot that killed John Wilkes Booth when he was hiding in a barn after the assassination of the President.

He was a member of the E. W. Pierce Post, G. A. R. of Middleboro and of other patriotic and military orders.

The Carver camp of the Sons of Veterans, known as the Capt. William S. McFarlin Camp, was named after him.

He was a pioneer in the cultivation of cranberries for which Carver is noted, and it was on his land that the McFarlin cranberry was propagated by his brother, Thomas Hewitt McFarlin.

Since he retired from his duties in connection with the army he has dealt in woodland and lumber, and has travelled extensively, having made several journeys across the continent and through the South. One of the most interesting incidents of his travel was his meeting in North Carolina with the Confederate Capt. Toms whose blanket, marked "Capt. Tom's, from his mother," he had picked up at Hanover Court House, twenty years before during the Peninsular Campaign, and now had the privilege of returning to its owner.

The gypsy moth is a more serious problem than in previous years, as it has been proven that the young, tender growth of the cranberry vine is very much to their liking and unless the greatest precaution is taken a great deal of damage will be done to both cranberry bog and forest.

We were fortunate in securing one of the large State sprayers to help us out in our work last season and with one on hand of our own this year we will be able to spray a much larger area, althought 5 tons of lead were used last year.

We already have the promise of funds from the State to carry on this work.

In addition to the moth spraying the street trees will need spraying this year as they were omitted last year on account of their good condition.

The Loan. The Town borrowed \$3,500 at 5 per cent, giving 10 serial notes therefor of \$350 each, payable one each year until all are paid.

At a later period we borrowed \$10,000 at 4 per cent, giving ten serial notes of \$1,000 each, payable annually until paid. We received a premium on our notes of \$42.14.

The Driveway. Owing to your vote instructing us to provide furniture and omitting the formality of making an appropriation therefor, we were unable to build a suitable driveway.

(The road commissioners estimate that it would cost \$300.)

Delay. We contracted and expected to have the building finished nearly a year earlier, but were disappointed in one of the contractors, who did not complete his work, and we acted under the advice of counsel in our delay.

Auditorium and Stage. We do not know of a town of our size that can equal us in these.

Offices. The offices are convenient for the transaction of the town's affairs.

Vault. A commodious fire-proof vault has been provided, built according to the wishes of the Commissioner of Public Records.

Library. We have given you two large rooms for a library. Something the town has long desired and needed.

Mistakes. While we have made mistakes—not having built Town Halls before—yet we call to your attention the fact that we have kept within the appropriations; that we have made good our promise to “construct a building of which none would be ashamed, that would be convenient and suitable for the uses of the officers and citizens of our town.”

And we congratulate the inhabitants of Carver on having a

modern building constructed in accordance with their wishes.

Dining Room and Kitchen. We have provided a commodious and convenient dining room and kitchen for your uses.

The Carver Old Home Week Association store their dishes in the capacious closets in our kitchen.

Other Necessities. We have provided Hot-air Heaters, Flush Closets, Pneumatic Water System, Modern Plumbing, etc.

We are pleased to state that we are located in the Library rooms of the new Town Hall. We have purchased furniture and erected stacks at a cost of a little over \$300.

We have been obliged to use some of the Rosa Cole fund for the same.

The cabinet of the Sealer of Weights and Measures which has been given a place in the reading room of the library has been made very attractive by the addition of glass doors and a coat of paint.

We, as library trustees, recommend an appropriation of \$200 for library expenses for the ensuing year.

TOWN WARRANT

Contents of warrant for Town Meeting to be held at the Town Hall on Monday, March 1, 1915, at 8 o'clock A. M.

The polls will be opened at 12 M. for the election of officers and will be kept open four hours at least.

Art. 1. To choose a Moderator to preside in said meeting.

Art. 2. To see if the Town will accept the report of the Selectmen and other town officers and committees.

Art. 3. To choose all necessary town officers not elected by ballot.

Art. 4. To raise and appropriate such sums of money as may be necessary to defray town charges the ensuing year.

Art. 5. To decide when taxes shall become due.

Art. 6. To see if the town will make the yards of field drivers town pounds, provided they are also chosen pound keepers.

Art. 7. To see if the town will authorize the Selectmen to prosecute, compromise, or defend any suits for or against the town.

Art. 8. To see if the town will make an appropriation for Memorial Day.

Art. 9. To see if the town will make an appropriation for a police force or act anything thereon or thereto.

Art. 10. To see what disposition the town will make of the dog fund.

Art. 11. To choose all necessary town officers. The following officers to be voted for, all on one ballot, viz.: Town Clerk, three Selectmen, Treasurer, Collector of Taxes, three Overseers of the Poor, one Assessor for three years, one School Committee for three years, two Auditors, one Tree Warden, one Road Commissioner for three years, one Trustee of the Public Library for three years, one Park Commissioner for three years, two Cemetery Commissioners, one for two years and one for three years, and to vote by ballot, "Yes" or "No," in answer to the following question, "Shall licenses be granted for the sale of intoxicating liquors in this town?"

Art. 12. To see if the town will authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning Jan. 1st, 1915, and to issue a note or notes therefor payable within one year, any debt or debts incurred

under this vote to be paid from the revenue of said financial year.

Art. 13. To see if the town will vote to raise and appropriate a sum of money for the purpose of macadamizing or otherwise improving the highway leading from the junction of Centre and Main streets to Middleboro line, provided an allotment is received from the State, and further provided that the town of Middleboro votes to improve its adjoining highway, and act anything thereon or thereto.

Art. 14. To see if the town will raise and appropriate a sum of money not exceeding one hundred and twenty-five dollars for the purpose of carrying into effect the vote of the town whereby it voted to purchase the seven cap stones of the Sons of Veterans and act anything thereon.

Art. 15. To see if the town will vote to complete the construction of the East Head Road which was laid out two years ago, make an appropriation for the same, and act anything thereon or thereto.

Art. 16. To see if the town will vote to repair the bridge near the home of Mrs. Maria Y. Shurtleff, make an appropriation for the same and act anything thereon or thereto. (By request of the Road Commissioners).

Art. 17. To see if the town will vote to purchase a road sweeper, make an appropriation for the same, and act anything thereon.

Art. 18. To see if the town will vote to raise and appropriate \$30 for the George Washington Memorial Building, at Washington, D. C.

Art. 19. To see if the town will vote to raise and appropriate a sum of money for the purpose of graveling or otherwise improving the highway leading from Everett Thomas' corner to the junction of Centre and Main streets, and act anything thereon or thereto. (By request of Jesse A. Holmes).

Voted, that the building committee, new town hall, be instructed to place a tablet over the front door of the new town hall.

Voted, that the building committee be instructed to place a cupola on the new Town Hall.

Voted, that the Town Treasurer be, and hereby is authorized to convey the title to real estate sold for taxes and bought for the town, whenever said estate or estates may be redeemed by parties having the right of redemption.

Voted, that the Town Treasurer, with the approval of the Selectmen, be and hereby is authorized to borrow money from time to time in anticipation of the revenue of the financial year beginning Jan. 1, 1914, and to issue a note or notes therefor payable within one year, any debt or debts incurred under this vote to be paid from the revenue of said financial year.

Voted, to appropriate the sum of three thousand dollars for the completion of the new Town Hall.

Voted, that the treasurer, with the approval of the Selectmen, be and hereby is authorized to borrow a sum not to exceed three thousand dollars for the purpose of meeting the appropriation authorized on account of the new Town Hall, and to issue a note or notes of the town therefor, said note or notes to be payable in not more than one year from date of issue, and

from the revenue of the financial year beginning Jan. 1, 1914.

Voted, that the Auditors be and hereby are instructed to make recommendations for appropriations at the ensuing annual Town Meeting, based upon the system in use by the Bureau of Statistics, and that said Auditors give one hearing properly advertised, in the Town Hall, to all boards, officers or persons, who may wish to be heard in the matter of appropriations.

(March 2).

Voted, that taxes become due Sept. 1st, and that interest to be computed monthly be charged after Nov. 1st.

Voted, that the Selectmen be, and hereby are, authorized to prosecute, compromise or defend any suit or suits for or against the town.

Defeated unanimously by aye and no vote.

Voted, that the Road Commissioners, at the next meeting of the town, be instructed to bring a report recommending the discontinuation of such roads as they deem advisable, and to specify the same by description.

Voted, that Constable N. G. Swift be reimbursed for loss of time sustained in consequence of injuries received while on duty.

Voted, to raise and appropriate the sum of one hundred and fifty dollars for the purpose of aiding Middleboro and other towns in the construction of a fire tower.

Voted, that the Selectmen be instructed to let the Town Hall for all public meetings not of an immoral character.

Voted, that the balance of \$42.97 in the old town house account be transferred to the contingent fund.

Voted, that the Selectmen be instructed to sell the two old safes and to turn the proceeds into the town treasury.

Voted, that the balance of \$9.45 in the Wenham Gravel road account be returned to the town treasury.

Voted, that the balance of \$2.32 in the Plympton St. Gravel road account be returned to the town treasury for the use of the Assessors.

SUPERINTENDENT'S REPORT

To the School Committee of Carver:—

I am pleased to report a smaller number of changes in teachers throughout the superintendency union for the years 1913-1914 than for the previous year. At the beginning of the school year in September, 1913, of the thirty-six teachers in the union there were twenty-two teaching in the district for the first time, and sixteen teaching their first schools; and in addition there were six changes during the fall term, making twenty-eight changes from the close of one school year to the end of the first third of the next. For the same period this year there were but fourteen changes, and but three of them in this town, one at the High School, one at Bates Pond, and one at the North Grammar school at the close of the fall term.

The present teachers, that were in town last year, are Miss Inez M. Bailey at the North Primary, Miss Miriam H. Braley at the Center Grammar, Miss Alice M. Russell at the Center Primary, Miss Marion Lyon at the South Grammar, Miss Amy L. Felton at the South Primary, Miss Helene E. Field at Pope's Point, Mrs. Lulu Pratt at East Carver, and Miss Viola L. Merri-field, principal of the High School. Those who were not in town last year are Miss Elizabeth Tillson at Bates Pond, Miss Helen C. Hodsdon of Fryeburg, Me., at the North Grammar, and Miss Marion Hutchins of Fitchburg at the High School.

There were 222 pupils in all schools at the close of the fall term December 18, 1914, 198 in elementary schools, and 24 in the High School. Last year there were 216, 192 in elementary schools and 24 in the High School. They are divided in schools and grades as follows:

For several years the ninth grade has been in the High School. At the beginning of this year four classes were fully represented in the High School, as had not been the case for several years previous. Two teachers could not teach all the subjects of four classes and those of the ninth grade in addition, even though the number of High School pupils is small. The

pupils entering the ninth grade in September remained in their respective grammar schools.

The fifth grades have been in the grammar schools until this year; but as the grammar school teachers must now have time for the ninth grades and some grade is lacking in each of the primary schools, the fifth grades remain in those schools another year.

For two years past the High school agent of the State Board of Education has strongly urged abolishing the ninth grade; making the minimum entrance age six years; and having but eight grades before the High School.

The objections to the plan are that children do enter at five, and that most of them could not do the usual elementary school work between five and thirteen. I think the work could be done, by most children, between six and fourteen. But a stronger objection is that the large majority of children do not go to High School, and by abolishing the ninth grade they would be deprived of one year of schooling.

The State Board of Education hope to adopt a plan for the division of schools into Elementary, Intermediate and High Schools, instead of into Elementary and High as at present. The elementary is to be composed of the first six grades, and range in time from six to twelve years; the Intermediate, of the seventh and eighth grades, and years thirteen and fourteen; and the High School remaining as at present. There is not space to describe the plan in detail. The expense of carrying it out in rural communities would, I think, make it impracticable.

It may be of interest to any High School pupils who contemplate attending a normal school in the state to know that there is to be a radical change in the work in Massachusetts normal schools. The change is to provide specialized training for the teaching that will be required for the distinctive work of the elementary and intermediate schools, as mentioned above.

There are now four distinct courses in some normal schools—the four years, three years, kindergarten-primary and two years

courses. For those entering from now on there are to be but two courses, an elementary course of two years, and an advanced course of three years. All students are to take the same work the first year. At the beginning of the second year the work is to be differentiated into elementary and advanced. The elementary course is to prepare for teaching in the first six grades only, and the advanced course for grades seven and eight only.

The student will not be left to make her own choice of the course. The school authorities are to decide in which grades she is most likely to succeed. If from lack of size an apparent lack of mental qualities they think she will not succeed in grades seven and eight she can take elementary work only, and can stay in the school but two years, and can have no opportunity to prepare for upper grade teaching. That any one can decide several years in advance what one can do successfully has not been shown by experience. The plan does not originate with the normal schools.

The above plan was explained to a group of superintendents by the Commissioner of Education.

At a recent meeting of superintendents representing twenty towns in Barnstable, Plymouth and Bristol counties, an estimate was made of the average salaries, cost of board and net incomes of the teachers in those towns, excluding high school teachers and principals of large schools. The average weekly salary was found to be \$13.30, cost of board \$5.84, net weekly salary, \$7.47, and net yearly salary \$269, an average net income above board of 85c per day. It had cost these teachers an average of two and one-half years and \$650 to prepare themselves for their work. This shows why we keep teachers but for one or two years.

The school savings bank has not been in operation this year. Mrs. Goetz, who had charge of it last year, found the work more than she could give time for, and no one else has been found willing to undertake it.

A bank has been in operation for two years in one of the towns of the district with marked success. But it is in one central

school of 130 pupils, and the work is done by one person who visits the school each week and makes collections from the different rooms. It is very difficult to conduct a bank successfully among scattered schools; it requires much time, and some expense.

The attendance for the year ending June 1914, was slightly better than the previous year. The following table compares the two years in average membership, attendance and per cent attendance.
