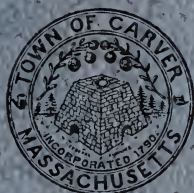

Sir:

As directed by you, I have made an audit of the books and accounts of the town of Carver for the period from December 9, 1951, the date of the previous examination, to November 5, 1953, preparatory to a transfer of the accounts and the cash and securities to a temporary treasurer, tax collector, and town clerk, and report thereon as follows:

The financial transactions, as recorded on the books of the several departments collecting or disbursing money for the town or committing bills for collection, were examined, checked, and verified with the books of the town treasurer.

General ledger accounts were compiled for the period covered by the audit, the appropriations and transfers as recorded were checked with the town clerk's records of town meetings and with the finance committee's records of transfers from the reserve fund, and a balance sheet showing the financial condition of the town on November 5, 1953 was prepared and is appended to this report.

The books and accounts of the town treasurer were examined. The recorded receipts were analyzed and checked with the records of the departments making payments to the treasurer and with other sources from which money was paid into the town treasury, while the payments were compared with the warrants approved by the board of selectmen authorizing the treasurer to disburse town funds. The cash balance on November 5, 1953 was proved by reconciliation of the bank balance with a statement furnished by the bank in which town funds are deposited and by actual count of the cash in the treasurer's office.

The savings bank books and securities representing the investment of the trust and investment funds in the custody of the town treasurer and the trustees were examined and listed. The income was proved and the withdrawals were checked with the receipts as recorded on the treasurer's cash book.

The recorded payments on account of maturing debt and interest were compared with the amounts falling due and checked with the cancelled securities on file.

The records of tax titles held by the town were examined and checked. The amounts added to the tax title account were compared with the tax collector's records, and the tax titles on hand were listed and checked with the records in the Registry of Deeds.

The books and accounts of the tax collector were examined and checked. The accounts outstanding according to the pre-

vious examination and all subsequent commitment lists were audited and proved. The collections as posted on the commitment books were compared with the cash book collections and with the recorded payments to the town as shown by the treasurer's cash book. The abatements of taxes and motor vehicle and trailer excise as entered on the commitment books were checked with the assessors' records of abatements granted, and the outstanding accounts were listed and proved.

Verification of the outstanding accounts was made by sending notices to a number of persons whose names appeared on the books as owing money to the town, the replies received thereto indicating that the accounts, as listed, are correct.

The total amounts outstanding on each of the tax and motor vehicle and trailer excise levies were given to the assessors for use in preparing the recommitments for the temporary collector, and detailed lists of all the outstanding accounts were prepared for the collector.

The records of departmental accounts receivable were examined and checked. The recorded receipts were checked with the payments to the treasurer and the outstanding accounts were listed and proved.

The records of licenses and permits issued by the selectmen, the town clerk, and the police department were checked, the payments to the town treasurer being compared with the treasurer's cash book.

The surety bonds of the town officials required by law to furnish them for the faithful performance of their duties were examined and found to be in proper form.

The records of the sealer of weights and measures and of the school, library, and cemetery departments, as well as of all other departments collecting money for the town, were examined and checked, and the payments to the treasurer were verified.

The inadequate methods used at present in keeping the accounts of the town are worthy of consideration on the part of the citizens. Under the present method of accounting it is impossible for the selectmen to know the actual financial condition of the town. The board of selectmen in a town is, in reality, the board of directors of the municipal corporation, and should have at its service books and records which furnish complete information as to the finances of the town, in order that it may be enabled to plan the work most essential to be done with the means at hand.

I do not believe in, nor do I recommend, a complicated set of books for towns; nevertheless, there should be kept in a single department certain general accounting records which show the assets and liabilities, the appropriations made and the charges against them, as well as the detail of all receipts and payments. These accounts, if kept up to date at all times, will enable the taxpayer to see at a glance the source from which revenue is received and the purposes for which payments are made, as well as the financial condition of the town.

Appended to this report, in addition to the balance sheet, are tables showing a reconciliation of the treasurer's cash, summaries of the tax, motor vehicle and trailer excise, tax title, and departmental accounts, together with schedules showing the transactions and condition of the trust and investment funds.

While engaged in making the audit cooperation was received from the officials of the town, for which I wish to express appreciation on behalf of my assistants and for myself.

When a decision to close schools has been made, this information will be broadcast through the courtesy of radio stations WBZ, WNBH and WBET. The no-school signal will also be given on the local fire warning apparatus. This signal is two short blasts sounded three times. From records of the School Committee:

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the members of the School Committee:

This report, together with the financial statements which precede it and the several reports and statistical tables which follow constitute the report for the School Committee, as per your decision to continue this type of report as submitted in recent years. It is assembled with the point of view in mind that it will place on the public record the most important of the developments which have taken place during the calendar year in the school.

If one were to try to synthesize the decisions of the committee with respect to the school and the services related to it, it could probably be best said that the year has, in great measure, been devoted to improving and developing the facilities of the plant, better regulating some of the functions relating to school and preparing the way so that the curriculum and the process of teaching can be most effectively handled for the best interests of the children. As such, then, this report has been prepared to cover three broad fields of activity. The headings of each section indicate the nature of the discussion. Attention should also be given to the reports of other persons as each gives added information, according to the duties for which he is responsible.

THE SCHOOL — ITS STAFF AND PROGRAM

One of the basic major efforts as related to the staff has been in the work of the committee and superintendent in setting up a salary schedule for teachers. Since the history of education within the town, there has been no regularly established plan for salary advancement for teachers. In years gone by this

was a perfectly acceptable way of handling the matter, but present times and trends require a different approach. These are times when teachers' salaries are moving ahead and Carver, if it is to keep up with the trend and be in a position to fill the vacancies as replacements are needed on the staff, must prepare in advance to be in an equally competitive position. The present salary schedule is not extreme but it does match favorably with schedules for towns within its own class (Class IV, towns of under 5,000 persons and not maintaining a high school). In this connection, though, there is still one limitation. Carver, by its geographical location, must compete for teachers in an area where there are, cities (Class I) and large towns (Class II) competing for teachers. Both of these classes of municipalities have more liberal salary schedules and this results in producing keener competition for the already too small supply of elementary teachers. It is probably a foregone conclusion that small towns will always find it a problem to compete on equal terms with the larger places but the effort which has been made is a worthy one. The teachers and principal cooperated with the committee in working out the details to be agreed upon in establishing the proposal; two or three years experience will determine how well the schedule is working. The space for this report being limited, it is not possible to print the schedule in full detail, but the basic essentials are given here and the complete detail is always available to any citizen, upon request.

Additional changes were made in the staff, as noted in the principal's report. Mrs. Florence L. Gordon resigned her position at the close of this calendar year to take up work in the Plymouth school system which is also the town of her residence. Mrs. Gordon began her service with Carver in September, 1928, and has served faithfully since that time in numerous teaching positions and at several of the town schools. Her conscientious efforts to do her best for the children under her charge have been an outstanding characteristic of her service as well as her spirit of cooperation in working with her fellow teachers and principal. It can be certain that her numerous pupils will remember her. Under the public statutes, Mrs. Betsy A. Burkhead was required to leave teaching, she having reached the legal age of retirement. It is unfortunate that Mrs. Burkhead's able service had to be terminated in such a manner, but there was no alternative. Staff changes were made as recorded in the directory and the report of the principal as a result of the resignation and retirement.

A change in the curriculum which placed the Mechanical Drawing for boys with Mr. Drake, so that it might be more closely related to the work in Practical Arts for Boys dictated the advisability of reducing the time of the Art Supervisor from two days weekly, to one day each week, and redistribute the art work, other than that which Mrs. Morrison might handle in one day.

A further change in the school organization has been the appointment of an assistant principal. There are occasions when the principal must be absent from his school and this has been the logical step to take. Mr. Drake, who joined the staff last year, was elected to this position and will serve well. Mr. Drake's status at the school as an athletic coach has also been recognized as one of his duties.

The problem of the numbers of children in the individual grades has received considerable attention this year. Referring to the official census, a majority of the groups are in the high thirties and two groups have forty or more children. If the teaching is to be efficient, the groups should run from between twenty-five to thirty children. This situation led to the election of Mrs. Vienna Cole, a teacher with a number of years experience, and several of these in Carver, who has a combination grade and plans are made for the election of one more person to teach a combination group in 1954. With these staff changes and additions, we look forward to 1954 as a year in which we shall be able to have sufficient teacher time per child so that each may obtain all the possible benefits which school can offer.

THE SCHOOL — ITS RELATED ACTIVITIES

Foremost in this category should be a summary of the activities of the Committee and superintendent with respect to the problem of future secondary education opportunities. It was on October 8 that the superintendent of Carver received a letter from the Plymouth superintendent transmitting the information from the Plymouth committee to the committee of Carver that all tuition pupils would have to be eliminated from Plymouth in June, 1954. In consideration of the best alternative to follow the superintendent was authorized to write and inquire if there might be any possibility of tuition pupils attending the new Regional Silver Lake high school and to make similar inquiries as to whether any opportunities might be open at Middleboro and Wareham. Meanwhile, the superintendent was also to ask if Plymouth might be willing to reconsider its position, in view of the problem which Carver would have under such a rule, and to arrange a meeting between the two school committees. This meeting was accomplished and has resulted in an agreement under which the Carver students will be able to continue at Plymouth until 1955 for Senior High purposes and up to fifteen Junior High pupils will also be admitted to the same date. This means that we shall have to make increased efforts to secure any

Vocational admission which the pupils may wish and it is entirely possible that other supplementary efforts will have to be made to secure remaining ninth grade placements. As the year closes, the committee has yet to have a definite word about admission to Silver Lake on a tuition basis and, meanwhile, intends to explore the possibilities of the regional school in this area, as well as any other openings which may be developed for reception of tuition pupils. It is too soon to be able to state what the ultimate solution will be.

Problems of discipline and control of pupils being transported to Plymouth continue to require more than their fair share of time but progress can be reported and the cooperation of Mr. Arthur P. Moskos in helping the committee to work out the solution has been much appreciated. At the first of the year two disciplinary officers were appointed to travel the buses for the purpose of relieving the drivers of the control of pupils. As matters seemed, on the whole, to improve, it was decided to eliminate this type of control when schools opened in the fall and Mr. Moskos has given the problem his attention since that time. It is firmly believed that the large majority of the high school youth want to cooperate and do what is right; it is regrettable that Carver must be known among those places where the problem is evident. It is encouraging to note more progress and as pupils arrive to a sense of responsibility for their own control and the native sense of fairness in the majority asserts itself, we look forward to the time when a wholesome situation will again prevail.

A plan for blanket coverage accident insurance was offered to parents and their children during the last year and approximately 57% of the children are covered. It is too soon to determine how effective this will be in meeting those costs relating to accidents, but the plan has proved very beneficial in other communities and a year's trial should demonstrate its usefulness here.

A plan for the encouragement of music study has been continued. The lack of a music supervisor to head up instrumen-

tal as well as vocal music tends to leave much to chance regarding individual interest and application in this field of effort. When school opened in the fall, the former instructors in instruments were not available for teaching. At length, arrangements were completed with Mr. Herman Young, of Hull, who teaches instruments at Middleboro, to undertake this work in Carver. The fees for the individual lessons are met by the parents. The school provides the time and place for the lesson to be held. We hope for increased interest in this effort so that there will be a sufficient number of pupils studying to form some sort of band or orchestral group.

The matter of whether support should be continued in the Evening Practical Arts school should receive the committee's attention for the coming year. During the past year classes were completed in Decorated Ware and Braided Rugs and it is certain that those who availed themselves of the opportunity found profit in the time spent. At the time when the exhibit was held last spring, an opportunity was offered for those interested in other classes to show their interest by signing the pre-registration sheets for certain classes. There were about fifty-three names on these sheets. On the basis of this list and the recommendations of the advisory committee for Practical Arts, the School Committee approved the establishment of three classes for this fall, Clothing I, Decorated Ware I and II and Furniture Refinishing. In spite of the fact that there were more than twenty names listed on each of the lists for Clothing I and Furniture Refinishing, the enrolments in these two classes have been very small and there is a serious question as to whether further effort should be made to support this work another year. Much more time than is realized is taken from the superintendent's work to find teachers, organize the classes, attend to publications, reports and records for the Department of Education; no one would object to the amount of time so consumed if it were felt that a sufficient number of persons were profiting thereby, but it is questionable whether or not the same time might not be better spent on the work of the regular day school, to the greater profit of all concerned.

In an effort to offer the classes when more might be able to attend, we took heed of the suggestion that the classes be not started until later in the season so as to permit residents to finish up opportunities for part-time employment which are abundant in Carver in the fall. Classes were opened November 18th, about a month later than the usual opening date around the state, but with the small enrolment. I recommend thoughtful consideration be given to this problem before additional classes are planned for another year.

The lunch program is covered in the principal's report so space need not be given to it here, except to point out that it is one of the most successful small-school programs to be found in the state, and is frequently visited by those who want to see such a program in operation. Worthy of note, too, is that fact that no town appropriation has been necessary to keep the program solvent nor is any need foreseen in this respect.

THE SCHOOL – THE TOOLS OF TEACHING and THE SCHOOL PLANT

Considerable effort has been expended this year in improving and augmenting the resources available to the teachers for use in the instructional program. The old projector which has seen many years use in Carver was exchanged and a new one provided to take its place, together with a suitable table on which to place it. A transcription player was also bought, together with a record player for the use of the smaller grades. A duplicator using the stencil process was also added to the equipment available for the teachers' use in preparing mimeographed materials for lesson purposes. All of the common types of duplicators are now available for the use of the teachers.

Several new series of textbooks were recommended to the committee by teachers and superintendent after suitable examination of the materials available. These are discussed in another report and it is needless to do so here again. With additional work in this field in the coming year, we shall have

all up-to-date textbook material available to the pupils by the close of 1954.

The work of improving and developing the school plant has continued through the past year. Corridor noise has always been excessive. Bids were sought, upon committee approval, for application of acoustical tile which was installed in December. The low bid was filed by the Pitcher Co. of Cambridge. All-metal, box-type lockers have been installed in both the locker rooms. Here the low bid was furnished by the Lyon Metal Products, Inc., and the lockers were installed by local help. A very favorable price was obtained through direct purchase from the factory and by also combining the order with a similar one from another town in this Union so as to give both towns the advantage of quantity purchase. Another deficiency was met by purchase, through bids, of the workbenches and tools for the shop so that a suitable grade of work might be conducted in that department. A contract was let for the annual servicing of the numerous controls which govern the heating and ventilating system. Modern controls are delicate by nature, and, if to give thorough and satisfactory service, must have a reasonable amount of checking and calibration from time to time if they are to do their best work. A program of boiler maintenance and care has been undertaken, as well as certain treatment to improve the efficiency of the heating plant and to insure a longer life of the boiler.

As of July 1, a change was made in the policy concerning the janitorial staff. It was decided that two full time janitors were not necessary and that the work could be handled less expensively and as satisfactorily by having one full-time man and permitting him to hire additional help from time to time, as needed, as at such times when it would be possible for two persons to work all day. This change has worked satisfactorily and appears to be a final solution to the matter.

In spite of anything we might wish to see otherwise, the costs for education continue to rise and there seems little likelihood of any change in this respect in the near future. Costs for

schools in Carver are in line with other communities of similar situation, as demonstrated by statistics recently released by the State Department of Education, as of June 30, 1953. Carver is listed in this report as having a per pupil cost, grades 1-8, of \$192.65. The average cost, among towns of Carver's class is \$191.39 per pupil, while the all-over state average for grades 1-8 is \$201.55.

In conclusion, the year has been more characterized than anything else by a program of improving the physical assets of the school, in reducing pupil-teacher ratio and strengthening the whole working situation. We look forward to the fullest development of these resources for the best interests of all the Carver children in the years to come.

Thus the average size of the grades continues to increase, this year reaching 37 pupils. We have extended a plan previously used to care for this increase, that is to have three home room teachers care for two grades. The plan is currently in use from grades 1 through 4. I strongly urge that this be applied to grades 5 and 6 and eventually a teacher be added for work with grades 7 and 8. To carry out the above plan Mrs. Vienna Cole who has previously taught in Carver has been added to the staff and teaches a combined grade 3 and 4. Mrs. Gordon was transferred from her remedial work to a combination grade 1 and 2. The vacancy created by the resignation of Mrs. Burkhead was filled by transferring Mrs. Hattei Griffith to grade 1. Mrs. Alice Shurtleff was assigned to grade 2. Two resignations marked the school year: that mentioned above of Mrs. Betsy Burkhead, and of Mrs. Florence Gordon. Both teachers will be missed by pupils, teachers, and by the people of the town.

Several changes in basic texts have been made during the year. The arithmetic series, MASTER KEY, introduced in Carver in 1941 has been replaced by MAKING SURE OF ARITHMETIC by Robert Lee Morton. For spelling, WORD POWER THROUGH SPELLING supplants CORRECT SPELLING also in use in Carver since 1941. New to the school is the Kittle Penmanship system. The above mentioned

texts are used in all grades. A history new to grades 7 and 8 is Wilder's THIS IS AMERICA'S STORY; McConnell's OUR WORKING WORLD was introduced as a text for seventh grade geography. Selection was made after careful study and comparisons with other works covering the field. Each text was selected by a committee appointed for that purpose. As yet it is too early to evaluate the success of the new series as the full worth of a basic text is evidenced only after three or four years of its use.

The instruction in musical instruments done during the first half of the year by Mr. Heyward and Mr. Churchill is now being carried on by Mr. Herman Young of Hull. At the present time we have four pupils studying the trumpet; three, the clarinet; and one each, the trombone and saxophone.

A course introduced this year is mechanical drawing for the boys of grades 7 and 8. This is taught by Mr. Drake. Much new equipment has been purchased for this instruction.

The shop has been much improved with the recent purchase of four work benches providing working space for sixteen boys. Also contributing to this improvement is the jointer presented by the PTA, and a new sander. The results of these additions can be seen in the ambitious projects now being undertaken by the pupils. The lumber used in these projects are being paid for by the students. Other additions to furnishings and equipment for the building include lockers for both shower rooms, the much needed and greatly appreciated acoustical treatment of the upper hall and of the four stair wells, a new film projector replacing one purchased in 1937, and a new three speed record player. The school yard was made more attractive by the hard top surfacing of the driveway and walks, and by the oil penetration of the parking area.

During the year game parties for the two upper grades were introduced. At these affairs pupils play games of their choice such as monopoly, clue, cribbage, and hearts, while others are

introduced to whist and bridge. Student committees plan the evening. The teachers have been most cooperative in providing adult supervision and instruction in games new to the children.

The sports program of the school has been carried on with great success. In basketball Carver lost one league game, but came out in the top position in the league tournament. Likewise in baseball Carver topped the league. In tag football we were defeated by Marion and tied by Rochester. Here the league championship was won by Marion. Carver's success rests largely on the excellent work of Mr. George Drake who has ably schooled the players in the basic skills of the game, in tactics, and in the necessity of team work.

Our lunch room continues with its success of the previous two years. Pupils participation is high, exceeded by few places in the Commonwealth of Massachusetts. As an example of this during the month of November we had an average daily attendance of 265 pupils, during this month an average of 260 pupils lunches were served daily. This degree of success is due to the enthusiastic supervision of Mrs. McLure aided by Mrs. Williams, and with the help of Mrs. Beatrice Raymond, as a part-time employee. Early in the fall Mrs. Lena Thomas was added to the kitchen staff. A financial report of the school lunch program follows:

The program is still maintained with no appropriations from the Town of Carver.

Several fund raising campaigns have been undertaken during the year. In the annual magazine drive subscriptions totaling \$1,074.31 were sold. From this a profit of \$258.13 was realized. The Poppy Drive carried on under the sponsorship of the American Legion Auxiliary netted \$16.37. The sum of \$86.63 was collected for the March of Dimes. \$144.79 was contributed by members of the Junior Red Cross under the leadership of Mrs. Hattie Griffith.

I wish to take this opportunity to express my thanks to all those connected with the school whose efforts and cooperation have made for the success of the school program. The members of the staff join with me in expressing our appreciation to you and to the members of the School Committee for your guidance and support.

REPORT OF SUPERVISOR OF ART

Mr. George R. Austin
Superintendent of Schools, Union No. 40

Dear Mr. Austin:

In compliance with your request, I submit my report as Supervisor of Art, in the Consolidated School, Carver, Massachusetts, for 1953.

“Art Education in the public schools holds a most important position, not only because of its ethical and aesthetic values, but also because it has a practical and vocational bearing upon the processes of education, leading the child to keener enjoyment of life, and opening the path to finer recreation.”

POSTERS

“Be Kind to Animals—Week” was observed by participation of the school children in the M. S. P. C. A. Annual Poster Contest, conducted by this Society. During my long term of teaching and planning this special phase of Art, many Carver boys and girls have been proud recipients of beautiful bronze and silver awards. In addition to these coveted prizes, arises the greater ETHICAL value; a development of a kind and gentle personality toward animals, and also a LOVE for pets is fostered by this phase of poster-making.

“Poppy Posters” were made by pupils of Grades 5, 6, 7 and 8, in the American Legion’s Auxiliary Annual Poster Contest. This was the first time that the Auxiliary had asked the pupils to participate in this nation-wide contest.

UNIT DEVELOPMENT & CORRELATED STUDY

Grades one through four developed several units of work. A very interesting and important one was; “How Art Contributed to the Home, School, and Community.” Art is closely

related to the child's home, school and community experiences. Community Helpers, Buildings, Father's Work, Mother's Shopping, the Neighborhood, Playground, Playing with Pets, were all demonstrated by individual drawings, murals, and posters.

Ability to translate concepts about the life of other people into Art expression, to become familiar with Creative Art products of people studied in these units, and to select and combine colors satisfactorily, and to blend and shade colors through the media of chalks, crayons, and paints, was developed in several murals and individual posters.

CORRELATION became essential for all grade levels, and it was carried out with Social Studies and Literature in the upper grades, and with Reading in the lower grades.

HANDCRAFT – PAPERCRAFT – WOODCRAFT

Girls in Grades seven and eight developed richness of experience through HANDCRAFT.

Wastepaper baskets, book covers, and many other usable projects were enhanced in beauty by finger-painting. This type of Art is exceptionally CREATIVE, and is greatly enjoyed by the pupils.

Wooden articles such as candlesticks, bowls, book ends, coasters, trays, salt and peppers sets, were designed and painted. When this work was completed, the projects were lacquered.

CERAMICS

Ceramics was the major attraction in Handcraft. Each pupil made one or two dishes or trays of clay. There is no better way of adding accents to individuality and good taste than with Ceramic accessories. The girls were immediately SOLD on this idea, and made numerous table decorations.

After the clay had been shaped to the desired contour and design, it was then completely air-dried. Next they were placed in a cool kiln, and the temperature was slowly elevated

to 1800 degrees. This remains at constant temperature for a period of time. After the process of firing, the article is then glazed. At first this process is quite difficult for the amateur, but after much experience the modeler counts it as FUN, and vies with his comrades to surpass him with a more perfect glaze. Here we create with color which is alluring.

After being air-dried again, the model is then fired at the same high temperature as previously. The model is then finished, and has a beautiful, high gloss glaze —“a thing of beauty” and a most satisfactory piece to keep or give away.

The firing was carried out by the instructor from whom I completed a full year course in Ceramics. She was amazed that children of that grade level could perform such beautiful work.

The transportation of all these articles for firing, (twice for each project) was my contribution to the pupils, so that they might have the most interesting results possible.

An exhibition of over 200 handcraft articles was held in the Art Room during the week of graduation. “This was really a very outstanding exhibition for a public school class”, say several Educators including Superintendents, Principals, and Teachers, who saw these Ceramics in various stages of progress. The comments were most enthusiastic and favorable concerning the beauty and artistry of the handwork.

SCHOOL NURSE

Middleboro, Mass.

December 31, 1953.

To the Superintendent of Schools:

Herewith I submit my annual report for the Town of Carver, year ending December 31, 1953.

We are living to-day in a constantly changing world. Parents' responsibilities have changed since the early days of our country, and so too changes have come to the Public Health Nurse. Her duties are largely prevention, they are hard to measure, even harder to prove.

Among the newer changes in our program is the annual physical examinations which were conducted again this year by Dr. Vernon Mayo. Pupils in Grades 1-4 and 7 were most thoroughly appraised in the presence of the Nurse, and in many instances a parent was also present.

All pupils were weighed and measured twice during the year, although the new law requires it to be done only once. In this way I feel I have a far better knowledge of the gain or loss of each pupil if checked Spring and Fall.

Too much cannot be said about our hot lunch program and the contribution it makes to the health and vigor of our children.

The Vision Testing was carried out in Grades 1, 3, 5 and 7. Of the 128 pupils examined, 9 failed and were referred for further examination. Five of these were seen by an Eye Specialist and five corrections have been made to date.

The Audiometer Test was also given in these grades and all passed with the exception of one pupil. He has already had a tonsillectomy, hoping by this some improvement may be noted; meanwhile he is under the care of a noted Otologist.

Several cases of chicken pox and mumps were reported in the Spring— otherwise we were free from contagion during the year.

We held a most successful diphtheria prevention clinic in April and May; 138 children being immunized. One hundred and seven of school age received the double antigen and 26 pre-schools were given triple antigen. The response from parents was most gratifying and I feel we are very well protected in the town against this disease which still takes too large a toll of our children.

I have made 86 visits to the Consolidated School and 62 to the homes of pupils. On several occasions I have been accompanied by Mrs. Murphy, Social worker from the State Department of Health where there were problems regarding referrals to the Child Guidance Clinic and Counselling.

In closing I am again grateful to Mr. Austin, School Committee, parents, teachers, Junior Red Cross and all others who have been so cooperative during the year.

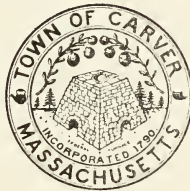
The Union committee wishes to express it's appreciation to Mr. Austin for his cheerful and efficient co-operation with them at all times.

TOWN WARRANT AND REPORT OF FINANCE COMMITTEE

The Commonwealth of Massachusetts
Plymouth, ss. To either of the Constables of the Town of
Carver, Plymouth County, Greetings:

In the name of the Commonwealth of Massachusetts, you are directed to notify and warn the Inhabitants of the Town of Carver qualified to vote in elections and in town affairs to meet at the Town Hall in said Carver on Monday, the first day of March, 1954, at twelve o'clock noon, then and there to act on the following article, namely:

Article 1. To choose all necessary town officials, the following officers to be voted for all on one ballot, viz: Three Auditors, Three Constables, Three Herring Committeemen, One Tree Warden, One Highway Surveyor, each for one year. One Assessor, One Moderator, One Selectman, One School Committeeman, One Cemetery Commissioner, One Park Commissioner, One Member of Board of Public Welfare, and Two Library Trustees, each for three years. One Library Trustee (to fill vacancy) for one year.

The polls will be open for at least seven hours.

And you are directed to further notify said Inhabitants of said Town that as soon as the ballots have been counted the meeting will adjourn to Saturday, March 6, 1954, at two o'clock P. M., and at that time will reconvene at said Town Hall in said Carver, then and there to act on the following articles, namely:

Article 2. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to bor-

row money from time to time in anticipation of the revenue of the financial year beginning January 1, 1954, and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 2. Recommended by the Finance Committee.

Article 3. To see if the Town will vote to appropriate a sum of money not to exceed one thousand dollars (\$1,000.00) from free cash in the Town treasury for the sole purpose of meeting charges against the cemetery funds in the town treasury.

Article 3. Recommended by the Finance Committee.

Article 4. To see if the Town will vote to accept the cemetery fund or funds paid into the town treasury under perpetual care statutes, or act anything thereon or thereto.

Article 4. Recommended by the Finance Committee.

Article 5. To see if the Town will authorize the Selectmen to prosecute, compromise or defend suits for or against the Town.

Article 5. Recommended by the Finance Committee.

Article 6. To see what disposition the Town will make of the Dog Fund.

Article 6. Recommended by the Finance Committee that the Dog Fund be transferred to the Library Account.

Article 7. To see what amount the Town will vote to raise and appropriate for the use of Plymouth County Trustees for County Aid to Agriculture and choose a Town Director as provided in Sections 41 and 45 of Chapter 128 of the General Laws, and act thereon.

Article 7. Recommended by the Finance Committee that the sum of \$100.00 be raised and appropriated for County Aid to Agriculture.

Article 8. To see if the Town will vote to fix the salary and compensation of all elective officers of the Town as provided by General Laws, Chapter 41, Section 108, as amended, namely:

Highway Surveyor	\$1.50 per hour
Town Treasurer	\$1,350.00
Town Clerk	800.00
Tax Collector	1,350.00

Moderator \$20.00 for the Annual Town Meeting and \$5.00 for each Special Town Meeting.

Members of School Board \$2.50 for each meeting, plus \$1.25 per hour for all meetings of over 2 hours.

All other elective Town Officers \$1.25 per hour.

Article 8. Recommended by the Finance Committee.

Article 9. To see if the Town will vote to transfer from the overlay reserve account to the 1954 Reserve Account the sum of five thousand dollars (\$5,000.00), and act thereon or thereto.

Article 9. Recommended by the Finance Committee.

Article 10. To choose all necessary Town Officers not elected by ballot.

Article 10. Recommended by the Finance Committee.

Article 11. To see if the Town will vote to raise and appropriate or transfer from unappropriated available funds in the treasury, a sum of money for Chapter 90 Highway Construction, or take any action in relation thereto.

Article 11. Recommended by the Finance Committee and the Selectmen that \$3,500.00 be raised and appropriated, and not over \$10,500.00 to be transferred from unappropriated available funds in the Treasury to meet the State's and County's shares of the cost of work, the reimbursements from the State

and County to be restored, upon their receipt, to unappropriated available funds in the Treasury.

Article 12. To see if the Town will vote to raise and appropriate, or transfer from unappropriated available funds in the treasury, a sum of money for Chapter 81 Highways, or take any other action in relation thereto.

Article 12. Recommended by the Finance Committee and the Selectmen that \$6,500.00 be raised and appropriated, and not over \$17,875.00 be transferred from unappropriated available funds in the treasury to meet the State's share of the cost of the work, the reimbursements from the State to be restored, upon their receipt, to unappropriated available funds in the Treasury.

Article 13. To see if the Town will vote to authorize the Cemetery Commissioners and the Park Commissioners to employ themselves as laborers in the Cemeteries and Parks, and act anything thereon or thereto.

Article 13. Recommended by the Finance Committee.

Article 14. To see if the Town will vote to raise and appropriate the sum of six hundred and fifty dollars (\$650.00) to be used to pay for all private work and material in Town Cemeteries, such as, opening graves, building foundations, etc., as according to General Laws, Chapter 44, Section 53.

Article 14. Recommended by the Finance Committee.

Article 15. To hear the report of any standing committees and act anything thereon or thereto and establish any new committees.

Article 15. Recommended by the Finance Committee to hear the report of any standing committees and to establish any new committee and/or committees and act anything thereon or thereto.

Article 16. To see if the Town will vote to transfer the sum of four thousand and ninety-five dollars (\$4,095.00) from the Road Machinery Fund to the Machinery Account, and act thereon or thereto.

Article 16. Recommended by the Finance Committee.

Article 17. To see if the Town will vote to raise and appropriate the sum of four hundred fifty-five dollars (\$455.00) for the purpose of installing a ceiling and a heating system in the Town Shed, and act thereon or thereto.

Article 17. Recommended by the Finance Committee.

Article 18. To see if the Town will vote to raise and appropriate the sum of one hundred thirty-three dollars and seventy-six cents (\$133.76) to pay the following unpaid bills for 1953, namely:

and act thereon or thereto.

Article 18. Recommended by the Finance Committee.

Article 19. To see if the Town will vote to appropriate from free cash in the town treasury the sum of five thousand dollars (\$5,000.00) for Assessors' Plans, and act thereon.

Article 19. Recommended by the Finance Committee.

Article 20. To see if the Town will vote to create a special unpaid committee to be known as a Regional School District Planning Committee, to consist of three members, including one member of the School Committee, to be appointed by the Moderator in accordance with the provisions of Section 14 of Chapter 71 of the General Laws, as amended, and to raise and

appropriate the sum of fifty dollars (\$50.00) for the expense of said committee, and act thereon.

Article 20. Recommended by the Finance Committee.

Article 21. To see if the Town will vote to appropriate the sum of five thousand six hundred and seventy-five dollars (\$5,675.00) from the Sale of Real Estate Fund, and a sum of money not to exceed eleven thousand three hundred and twenty-five dollars (\$11,325.00) from free cash in the town treasury, for the purpose of constructing a fire station at Center Carver, said fire station to be built on the Center School House Lot, and act thereon or thereto.

Article 21. Recommended by the Finance Committee that the sum of \$5,675.00 be appropriated from the Sale of Real Estate Fund, and that the sum of \$7,325.00 be appropriated from free cash, and that the building be constructed under the direction of a Building Committee, consisting of five (5) members, to be appointed by the Moderator.
