In Memoriam



ELLIS GRANT CORNISH

1868 — 1956

Ellis Grant Cornish was born in Bridgewater, Massachusetts, September 27, 1868, one of the thirteen children of Dr. and Mrs. Ellis Holmes Cornish.

He attended school in Carver and Mt. Herman, and received his Masters' degree at the Hyannis Normal School.

He was a teacher in the Carver schools from 1900 through 1908; Town Auditor from 1903 to 1910; Moderator from 1902 to 1911, and a Selectman from 1911 to 1922. He served also on the School Committee from 1910 to 1925, and on the Finance Committee from 1921 to 1925.

Always an enthusiastic supporter of Carver Old Home Day, he was president of the association for twenty years and served long on the Banquet Committee. On the fiftieth anniversary of the observance in 1951, he read his paper on "Recollections of the Fifty Years of Carver Old Home Day".

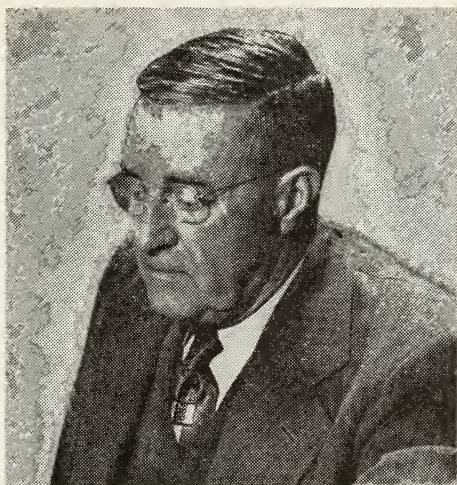
In 1925 he removed to Barnstable, Massachusetts where he was principal of the high school, retiring in 1944.

He was married to Mary A. Sears of Hingham, Massachusetts, on September 2, 1899.

He died on the Cape, July 26, 1956 and is buried in Sandwich, Massachusetts.

JACK LEWIS MARTIN

1880 — 1956

Jack Lewis Martin was born November 16, 1880 in Boston, Massachusetts, son of George B. and Jane E. Stevens Martin. He attended school in Boston, graduating from English High School.

He married Frances Louise Mahler in 1908.

Previous to coming to Carver in 1919 he had been in engineering work in Virginia and Connecticut.

He was treasurer of the Carver Old Home Day Association from 1926 to 1938; Library Trustee from 1932 to 1935; and Auditor from 1928 to 1933.

Having been an assistant to Henry S. Griffith for a number of years, he was appointed to fill the offices of Town Treasurer, Town Clerk and Tax Collector upon the death of Henry S. Griffith on April 26, 1937 for the remainder of the year, and in 1938 he was elected to fill those offices which he held until his death, September 24, 1956.

On July 30, 1947 he married Myrtle Louise Atwood.

Well liked by all who came in contact with him, devoted to his home and family, his philosophy of life is amply expressed by this poem he always carried in his wallet:

God, let me live each lovely day
So I may know that come what may,
I've done my best to live the way
You want me to.
Forgive me if I do not pray
The ultra sanctimonious way
In church on every Sabbath Day
As some folks do.
Just let me know if I should stray
That I may stop along the way
At any time of night or day
And talk with you.

In Memoriam



REV. WILLIAM I. WARD

1857 — 1956

Rev. William I. Ward was born in Fairhaven, Massachusetts, November 3, 1857. He attended school there and the School of Theology of Boston University, obtaining his preacher's license when he was seventeen.

At the age of twenty he was appointed as pastor of the Methodist Church, then located at Huckleberry Corner where he served one year. There he met Miss Emma L. Thomas, a teacher in the Benjamin Ellis School, whom he married in 1881.

He served for the forty-four years of his active ministry in the New England Southern Methodist Conference, and, upon his retirement in 1923 he settled in North Carver where he conducted an insurance agency, was a pulpit supply preacher, and active in various civic affairs of this town for the next twenty years.

He was a member of the School Committee from 1925 to 1934. During his term, the Carver High School was discontinued and the Special School for retarded pupils was set up. He was actively interested in the erection of the new Benjamin Ellis School in South Carver in 1932.

He served on the Finance Committee from 1925 to 1933; and was Moderator from 1930 to 1933.

In 1945 he removed to Sandwich, Massachusetts, and he died on the Cape September 7, 1956.

His funeral service was held at the North Carver Congregational Church on September 10, 1956. A beautiful service was conducted by many ministers of the Methodist Conference. Interment was in Union Cemetery, South Carver.

Thus ended a long, active life, useful to his fellow man and to the town he adopted for his own.



In Memoriam

EDWIN EUGENE BISBEE

1897 — 1956

Edwin Eugene Bisbee was born in Carver June 10, 1897, the son of Sylvanus Eugene and Grace (Jefferson) Bisbee.

He married Etta Marion Pratt on October 26, 1918. She died suddenly July 22, 1955.

Strictly a home-town man, Ted earned all his living in Carver. He was employed for over twenty years in the Holmes box factory and for several years was foreman in the Cole box factory until it was destroyed by fire in 1947.

He also had a long record of holding some of the lesser town offices which he discharged with exacting care. In 1932 he was elected as Constable which he was to hold continuously thereafter, except for the year of 1936. In 1934 he was appointed Sealer of Weights and Measurers, a post he held continuously for 22 years. In 1935 he was elected as one of the Field Drivers and Pound Keepers, holding that office for 21 years. In 1942 he was elected as one of the Fence Viewers and held that post until his death. From 1937 to 1947 he served as Inspector of Animals and Slaughtering. In 1943 he was appointed Cemetery Commissioner to fill out the unexpired term of Frank E. Barrows upon the latter's death, February 9, 1943. In 1944 he was elected Cemetery Commissioner, having charge of Central Cemetery until 1950.

He was a charter member of the Carver Sportsman's Club. He joined the Sons of Union Veterans in 1919, holding various offices and was Commander of the Capt. Wm. S. McFarlin Camp 132 at the time of his death.

Devoted to his home and family, he was a respected and loyal citizen of Carver, steadfast to the last which came December 17, 1956.

ARTHUR WARNER PETERSON

1870 — 1956

Arthur Warner Peterson was born in Plymouth, Massachusetts, August 19, 1870, the son of George and Elizabeth (Faunce) Peterson.

He attended school in Plymouth and Boston. His father died when he was seven years old and so he lived with an aunt in Boston for a few years.

He was married to Lucy Shaw on January 29, 1898, and lived in Carver thereafter, except for one year, 1912, when he was in Florida growing celery in the Sanford district.

For a number of years he conducted an ice route and carried the mail to and from the North Carver station on the Middleboro and Plymouth Railroad.

Upon returning from Florida he conducted a market garden at his home place on Main Street, specializing in strawberry and celery growing.

In town affairs he served on the Finance Committee from 1920 to 1936. In 1936 he was elected Selectman and Fence Viewer holding both offices until 1942. In 1945 he was elected Town Auditor.

While Arthur took great interest in growing fancy strawberries and celery as long as his health would permit, it was his home and family that he clung to above all else to the very last.

He died July 31, 1956 at the age of 86 years.

BOARD OF PUBLIC WELFARE

To the Honorable Board of Public Welfare:

I herewith submit my report on Old Age Assistance, Aid to Dependent Children, Disability Assistance and Public Welfare for the fiscal year ending December 31, 1956.

During the year 45 applications have been processed and disposed of as follows:

- 32 Approved
- 8 Denied
- 5 Withdrawn

During the year 42 cases have been closed for the following reasons:

- 3 Transferred to other towns and cities
- 12 Transferred to other categories
- 2 Transferred to State or County Hospitals
- 8 Employed
- 6 Ineligible
- 7 Deaths
- 1 Burial only
- 1 Hospitalization only
- 2 Medical only

There have been several changes due to new legislation and State Department directives.

Payments to public assistance recipients were increased in accordance with State Department policy effective 7/1/56. This requirement was brought about by an increase in the cost of living index as reported by the Division on the Necessaries of Life. Basic budgets were increased 5.8%.

The rising cost of medical care in the public welfare field is reflected chiefly in higher hospital rates. Chronic hospital rates at Tewksbury State Hospital and Infirmary have increased from \$24.87 to \$28.67 per week. Other hospital rates are certified annually by the Commission on Administration and Finance in accordance with the law and all rates show a substantial increase for 1957.

One of the 1956 amendments to the Social Security Act provided for an increase in the Federal participation on assistance payments and effective 10/1/56 the town has received increased reimbursements.

On 8/9/56 an act was passed extending the benefits of Old Age Assistance law to non-citizens who have been residents of the United States for a period of twenty years. This act was effective 11/7/56 and as a result seven cases were transferred from Disability Assistance to Old Age Assistance and one case from General Relief to Old Age Assistance.

An act transferring to the district courts jurisdiction to enforce the liability of certain kindred for the support of poor persons eliminates the necessity of taking such cases to the probate court.

Recoveries for the year have totalled \$4,222.64. Liens on real estate of Old Age Assistance recipients have been satisfied and recovery on a Disability Assistance case was received.

Due to the new provisions of the Old Age Assistance law which now includes non-citizens a greater case load is anticipated. On 12/31/55 there were 33 cases and on 12/31/56, 35 cases. Of the new cases added there were five persons on whose real estate a lien was taken. Two liens were satisfied in full and cases closed.

Cases receiving Aid to Dependent Children have changed little there being 5 cases on 12/31/55 and 4 cases on 12/31/56.

The average number of children aided during the year was 13. In three cases, non-supporting fathers have been brought before the court.

There has been a sharp drop in the number of Disability Assistance cases due to the transfer of 7 cases to the Old Age Assistance program. On 12/31/55 there were 13 cases and on 12/31/56 only 4 cases. There is one case pending.

On 12/31/55 there were 5 active General Relief cases and on 12/31/56 there were 3, however, during the year there were several cases opened for temporary assistance. The total cost of General Relief was greater than in 1955 due mainly to cases aided in other towns and cities holding a Carver settlement.

I wish to express my appreciation to the Board Members for their close cooperation.

Parents having a child whom they wish to be examined under this rule are required to make application to the Superintendent of Schools on or before August 15th preceding the opening of school in September. A special form will be furnished for this purpose upon written request from the parent.

CLOSING OF SCHOOLS

It is the policy of the School Committee to close school only under the severest weather conditions or on such occasions when it is dangerous to operate school buses. At other times, parents are expected to use their own judgment in sending children to school. When a decision to close schools has been made, this information will be broadcast through the courtesy of radio stations WBZ, WNBH and WBET. The no-school

signal will also be given on the local fire warning apparatus. This signal is two short blasts sounded three times. From records of the School Committee, January 14, 1957:

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the Members of the School Committee:

Herewith follows the annual report of the Superintendent of Schools. As it serves as part of the complete report of the School Committee, it is written not only from the point of view of an individual but, also, includes the various policies and general decisions which originate from the School Committee. Your attention is invited to the reports from others in the school department as each part helps to contribute information on the local school system.

In general, the enrollment in the local schools has shown only a slight growth since that of last year, about 10 pupils, and a similar growth is found in the numbers of pupils attending secondary schools outside of the town. A large first grade class was enrolled in September. After some consideration as to the best way in which to meet the problem the committee approved the employment of an additional teacher if one could be found. This is not the easiest matter in these times with scarcity of good teachers and some little search was necessary before a candidate could be found to accept the position. Two first grade groups were formed at mid-September and will be continued through the school year. The groups established are small in number and will enable the first grade children to get an excellent start in their school program.

The committee has approved and extended the policy of employing a school secretary and the position now has come to the point where twenty hours per week are provided for the principal and the work relating to his office and management of the school. This is a very desirable policy and enables the principal of the school to place his time where it will count for most in the work of the school.

The school committee, along with other boards in the town, joined in placing a proposal before the town meeting for the employment of a public health nurse, a part of whose time would be devoted to schools and a part to other responsibilities in community nursing. This change enables a nurse to be found on duty every morning at the school and should make for very easy communication between parents and school on matters relating to the health of the child. The frequency of the service in itself recommends its continuance and Mrs. Korpinen has been very cooperative in her new position.

Where necessary the school committee has approved a policy of instruction and/or necessary individual transportation for a home-bound child or one suffering from a physical handicap of any sort which either makes school attendance impossible or impractical for a full day. We do not always have such individual cases but this year there have been two such and the committee has provided the necessary approval for individual planning for their educational needs.

We are fortunate to have less change in staff to report for this year than the previous year. The last report touched upon Mr. McCarthy's joining the staff and the circumstances under which he came. Mrs. Clare D. Neal of Monument Beach was obtained to take the new first grade created for this fall. Mrs. Neal is a graduate of the Teachers College at Hyannis and holds the Masters Degree in Education from the Bridgewater Teachers College. Mrs. Eunice Hulbert, who formerly taught Sewing on a part-time basis for the girls in 7th and 8th grade, was unable to continue her work with us due to ill health in the family and her place has been taken by Mrs. Margaret Longhi of Plymouth who teaches in the Evening Practical Arts division. Mrs. Doris F. Moore resigned her position in Carver at the end of the school year in June to take up a teaching position in the neighboring town of Wareham. Although Mrs. Moore had agreed to take up the Special Class teaching work for Carver she later wished to be relieved

of this on the strength of a financially more attractive offer from the neighboring town of Wareham with the hope of a still better salary in the future. Mrs. Moore has served Carver well for nine and one-half years in the public schools and it is to be regretted that she felt it necessary to leave for another position but it is inevitable that these things will happen to any town.

A classroom devoted to the needs of the Special Education class has been opened this year with Mrs. Winifred Nickerson the teacher in charge, she being transferred from the first grade work in the regular school program. The class has an enrollment of 11 pupils in it and it has become a valuable added feature to the school program. The maintenance of such a class is beneficial to the school pupils as a whole in two ways. First, the child in need of the individualized instruction is placed in the class where the number permits this. His progress is entirely an individual matter. Second, the children who are in the regular grade classrooms can have the complete time of the instructor there as the time is not being taken by those who need individual instruction. The state assists in the cost of the operation of a class of this sort so that the financial responsibilities on a community are not excessive for this type of work.

Evening Practical Arts Classes have been continued this year with the combined Clothing I and II being offered again and with two new classes set for the first time this year; one in Hooked Rugs and the other in Cake Decoration. This latter class is a short term one, has already had one group complete its work and the second class is forming for the new year. A third class will more than likely be possible if there are enough interested to warrant its operation.

The committee has continued its policy of a certain amount of the maintenance work to be done each year. This last year bids were sought for painting a section of the second floor

rooms which included the library, the offices, the nurse's suite and classroom No. 23, together with the doors at the top and bottom of the two stair wells. Two bids were submitted on this; one by James Wilmot and Son, Middleboro, for \$638.00 and one by Harold Boyer and Son of Plymouth for \$535.00 and the award was made to Mr. Boyer. We have been well pleased with the results and hope to do another section of the building this next year. A school plant as large as this one will be cared for more easily if a section is done on a regular rotating schedule each year rather than leaving work to accumulate to a large degree.

The playground equipment which had been purchased the previous year has been set up this last year and the added facilities provide more recreational opportunities for the children during noon, recess and after school hours.

Transportation services for school pupils still remains a large item in the operation of the school system and a continuing effort is made to keep the service as efficient and safe as possible. Some time was spent last year in connection with the New Haven Railroad's North Plympton grade crossing to eliminate fault in the signal system there so that we might be assured as much as possible of the safe passage of the buses over the crossing which transport the high school pupils to Silver Lake. The late bus service was continued from Silver Lake School and some slight change was made in the routing so that the late bus might also serve pupils in the local school who stayed for athletic contests, music and other special purposes after the regular school hours and still be transported home. Late in the year 1956 Mr. Thomas exchanged one of his buses for a new 60 passenger bus.

The school committee in cooperation with similar committees in the other two towns of this union assisted in meeting the financial obligations of a conference for teachers which was held in late September of last year at the Rochester

School, in which the Carver teachers attended. The two-day program centered around the fields of Reading and instruction in Reading and Literature for the several grades within our school. It dealt also briefly with the question of the best approach to teaching classes which may contain a few very able learners, a few slow learners and a majority of average pupils. An effort was made in this conference to keep the discussion centered upon those classes similar in type to those in the local school.

The Pupil Insurance program was approved and continued for use in the school this year. We now have the greatest number ever enrolled, about 70%, and trust that others not enrolled will see the benefits of this and find it possible to join another year. Every reasonable effort is made to prevent accident but in spite of the effort unforeseen things do happen sometimes and the financial protection and assistance afforded by insurance is extremely valuable in time of need.

The committee sought bids for gas service and for fuel oil this year as in the past. There were no bidders who filed on the gas service. Two bids were received on furnishing the No. 5 fuel oil; one from the Volta Company of Plymouth and the other from Staples in Taunton. Staples Coal Company of Taunton submitted the better bid and it was accepted.

The budget prepared for the 1957 calendar year will have to be larger than the funds available to the use of the committee in the calendar year of 1956. In order to make progress in the matter of teachers' salaries there will have to be extra funds in this section and the tuition requirements will be rather markedly increased upward. The rate for tuition of the pupils at the Silver Lake Regional School for this school year has been \$300.00 per person. The committee was advised that the rate for the school year which will open in September, 1957, is to be set at \$400.00 per person. This is an increase of 33 1/3% and must be reflected in the budget for 1957 in re-

lation to that portion of the year. These two items, with small allowances for the transportation service, will constitute the chief increase in the budget.

In the matter of teachers' salaries it is well sometimes to reflect upon our relative position as compared with the state in general. A recent publication of the Massachusetts Teachers Association, Bulletin P 18-IV of 12/27/56, provides information on salaries paid to teachers in towns in the group of class IV A, which is to say over 1,200 population without high schools. The median salary among this group of towns for classroom teachers is shown at \$3,640.00. The salary for Carver teachers, exclusive of the principal and the small sums paid as payment for special services, results in an average teachers' salary in Carver for the current school year of \$3,536.36. This, you will note, is something behind the median salary already paid in the towns as they are today. The salary plans in the 1957 budget will raise the average teachers' salary, considered under the same conditions as above, to \$3,663.00 or just a few dollars above the median of last December. However, by this time next year we shall without doubt find the median salary somewhat advanced and more than likely we shall be just about behind the average and in a relatively same position next year as we are at this time. We are fortunate to have as little change as we have had, for good teachers are not easy to find. Moreover, the competition for teachers' services is increasing in this part of the state as school population rises and new classrooms are opened. There are not nearly enough teachers being graduated from the Teachers' Colleges. In recent years, our best source of supply has been found among those who previously taught and whose situation is such that they are ready to re-enter the profession.

The Committee has received some general indications that the time may not be too far in the future when the question of what to do for high school accommodations will again be before it. The Silver Lake Regional High School continues to

have growth in school population among its own membership. While no definite date has been set for withdrawal in the future, the statement has been made that the question of enrollment for the future will have to have attention after next September.

There has been some reason to hope that a regional plan can be worked out for submission to the voters which will call for regional high school for Plymouth and Carver. Some exploratory work has been done in this respect to date and the formation of a definite plan now awaits Plymouth's action on setting up a Regional School District Planning Committee at its next town meeting. When this formality has been met, a definite agreement can be worked out by the two committees for submission to the voters of each town.

We feel the year closed has been one of progress. We continue to try to refine and improve the program offered the pupils, we watch their progress in the outside secondary schools, we test them and compare the results with national norms and we aim to keep informed on all new worthwhile developments in the field of public education. We appreciate the interest and cooperation which the teachers, School Committee and superintendent receive from the parents and citizens and trust we may continue to serve upon this foundation.

REPORT OF THE PRINCIPAL OF THE GOVERNOR JOHN CARVER SCHOOL

To the Superintendent of Schools:

I herewith present my report as principal of the Governor John Carver School for the calendar year of 1956.

The school opened in January with one change in the teaching staff and with the creation of a new position. Mr. George McCarthy joined the faculty as the assistant principal and teacher of shop, mechanical drawing, and science to fill the vacancy created by the resignation of Daniel Marcelonis. The newly created position, that of the school clerk, was filled by the appointment of Mrs. Faith Young, who was with the school for fifteen hours a week. The duties of the position are varied, yet the bulk of the time is taken with the school lunch program. Other duties include the handling of school finances other than those appropriated by the voters of the town, typing, duplicating, and the keeping of the records of the school. Being relieved of these routine duties gives the principal more time for the more important, but often neglected, supervisory aspects of the position.

In February, Mrs. Eveline McLure took over the cooking of the domestic science program offered to the girls of grades seven and eight. The appointment places this area of the household arts program on a somewhat more permanent basis than we have been able to provide for the sewing classes.

A revision of the testing program was put into practice in the late spring. Under the present plan intelligence tests are given to pupils of grades one, three, and seven: achievement tests are administered to grades three, five and seven. The

latest revision of the Iowa test was used for this purpose. Of the three grades tested two scored above the national average for the grade, while unfortunately, the remaining grade scored below this average.

The monthly principals' meetings instituted during the latter part of 1955 were continued through the school year of 1955-1956. The above mentioned revision of the testing program was one of the outcomes of these meetings. Other topics discussed were the supervisory role of the principal, the financial reporting of the school lunch program, and the planning for special class instruction. From these meetings came many practical suggestions which were incorporated in the operating procedures of the school.

The athletic affiliations of the school continue to be with the recently formed Massasoit League comprised of Berkley, Carver, Dighton, Freetown, Lakeville and Rochester. Two basketball and one baseball games are played with each member of the league. The season closed with a track meet in Dighton in which twenty-eight Carver children took part. The coaching time spent in such a program is far in excess of the salary paid for such services. Mr. Eldridge and I greatly appreciate the help given to us by the alumni who make up opposition teams during practice— giving our youngsters experience against strong competition. The sports program for the girls has not kept pace of that for the boys. Coaching time and transportation needs militate against such an equality. During the year baseball games were played against one of the towns in the Massasoit League. At the present time plans are in the making for a ten game basketball schedule.

The school year of 1955-56 closed with the graduation exercises held on June 10, at which time thirty-four diplomas were presented. Two innovations marked the program. The school orchestra trained by Mr. Fred White made its first public appearance and made known to the parents Mr. White's

talents. The second feature new to Carver graduations was the presence of a guest speaker. Judge Frankland P. Miles proved to be an excellent choice to introduce this new feature. The American Legion Essay Award was won by Michael Pentt and James Jennings, whose essays were read during the program. The American Legion Auxiliary Poster Award was won by William Bisbee and the Humane Society Awards were won by Elizabeth Weston, Rebecca Shaw and George Young.

The opening of the new school year in September found us still faced with the usual problem of unequal distribution of pupils throughout the grades, and with an unexpected number of children entering grade one brought about by families moving to Carver during the summer. The problem of unequal sizes of grades was solved in part by a home room made up of two grades, and in cases where this was not possible, by relieving the teachers of large grades of certain clerical duties, such as keeping of the school register and the collection of lunch money. These duties were taken over by the school clerk whose time was increased from fifteen to twenty hours a week. A discussion of the special class will be presented by Mr. Austin in his report.

New texts have been added during the school year. Chief in importance is the new language series, "Our English Language" by Bailey and Walker, which provides the basic tests for grades three through eight. This replaces a series introduced in 1943. Other additions have been limited to specific grades; a new music series was provided for grades six and seven and the latest edition of the science texts in use since 1946 was purchased for grade seven.

We are much pleased with the operation of the recently introduced public health nursing service whose headquarters are in the building. By this plan the nurse is at the school the greater part of the time between 8:30 a. m. and 1:00 p. m. on every school day. The summer schedule gives the nurse the opportunity to interview all families moving to Carver during the vacation period so that all necessary school records are complete at the opening of school in September.

The annual magazine drive ended with a subscription sales totaling \$1,152.57 from which a profit of \$331.58 was netted. The sale of group photographs totaled \$145.40 giving the school a profit of \$21.15. The other drives of the school were

in the nature of public service— a list with the money collected follows:

The school lunch program is now in its sixth year of operation under the capable management of Mrs. McLure. Our rate of pupil participation still continues to be very high. During the month of December we had an average daily attendance of 269 pupils; during which time the daily number of pupil meals served averaged 245. SCHOOL SUPERINTENDENCY UNION NO. 36**Report of the Secretary**

The annual meeting of the School Superintendency Union No. 36 was held at the Governor John Carver School in Carver, April 23, 1956.

Officers elected for the year were as follows: Chairman, Harold L. Griffith, Jr., and Secretary Norma E. Perkins.

It was voted to terminate the services of Mrs. Madeline Baker as school nurse for the Union as of June 30, 1956, Carver having planned for the employment of a full-time nurse with the combined duties of school and town. By separate vote, Rochester and Lakeville are now utilizing the services of Mrs. Baker and have found this to be a very satisfactory arrangement.

On November 2, 1956, the semi-annual meeting of the Union was held at Assawompset School, Lakeville.

A most successful workshop for the teachers of the several towns on the subject of "Reading" was held in September. The Union committee agreed if the teachers were willing to volunteer their time to such a program which would benefit the children of our schools, we were also willing to cooperate by financially supporting the program for a similar workshop this year, and voted \$150.00 for this purpose.

The law has been drawn which provides for the position of a school adjustment counsellor and the time may not be too distant when such a person may be required to serve the towns of this Union.

Leave of absence was granted Mr. Austin to attend the annual convention of American Association of School Administrators at Atlantic City, February 16-21, 1957.

We, the members of the Union committee, believe we are very fortunate to have for our advisor a man of Mr. Austin's ability and experience and are grateful to him for his continued cooperation and counsel.

PUBLIC HEALTH NURSE

To the Public Health Committee:

My report as Public Health Nurse covers the period from July 2, 1956 to December 31, 1956.

The first part of my report will be devoted to what has been done for the past six months in connection with my work as Public Health Nurse for the Town of Carver but does not include my work in connection with the school. The second part will deal with my work at Gov. John Carver School as School Nurse.

Early in July, Miss Mildred Foster, Superintendent of the Southeastern Health District, visited me at the Gov. John Carver School and gave some very helpful information about public health nursing both in the community and in the school. Since her visit, much of this informative discussion has been most valuable to me in my work.

During the past six months 89 home visits have been made as follows:

Cardiac 8
Tuberculosis 5
Diabetes 37
Non-Communicable 39

The above listed visits have been disposed of as follows:

Unpaid cases 5
Paid cases 21
Old Age Assistance 45
Public Welfare 4
Disability Assistance 14

Two emergency visits on off duty time have been made as requested by doctors.

A pair of crutches has been donated to the town and these may be rented at a fee of \$1.00 a month.

In December, I transported one patient to Plymouth County Hospital, Hanson for medication and one unlisted visit was made at the request of Miss Foster in October.

We have had two polio clinics at the Gov. John Carver School. On August 16, Dr. Mayo administered:

187 second inoculations

15 first inoculations

44 delivered to family doctors to administer in Wareham, Kingston, Plymouth, and Middleboro by Mr. Mazzilli and me.

At our second clinic on Sept. 17, Dr. Mayo administered:

6 first inoculations

39 second inoculations

13 received by school personnel as suggested by Dr. Mayo 6 doctors to administer.

43 first and second inoculations delivered to Silver

Lake Regional High School, Kingston.

Twenty-six additional inoculations were administered on Monday mornings in Sept. and Oct. by Dr. Mayo. Some of these were first and some second inoculations. At both clinics, I was very ably assisted by Misses Edna and Elsie Salmi who volunteered their services. Miss Crownshield, the operating room nurse at Lakeville Sanatorium, very kindly autoclaved our supplies and for each clinic I have been able to borrow sufficient syringes from the Public Health Office in Lakeville.

I am at my office at the Gov. John Carver School Monday – Friday from 8:30 A. M. – 1:00 P. M. Anyone wishing my services should contact me before 9:30 A. M. if possible.

The following is my report on school health from Sept. 5, 1956 to December 31, 1956.

In July and August, I visited the home of each child entering the first grade to obtain the necessary information for the school health record. Twenty-five such visits were made, and parents were reminded of having the child vaccinated prior to entry. I was rewarded by these visits to have met the parents and to obtain additional information most helpful in understanding the child.

Early in October, Dr. Mayo began his examinations and continued one day a week until a total of 131 physicals were done. All children of grades one, four, and seven were examined, all those absent the previous year during examinations, all children new to the school who entered without an adequate health appraisal from the school previously attended, and all children who were participating in competitive sports.

Invitations were sent home with all children of the first and fourth grades requesting parents to be present during his child's physical. Only three were able to attend, but I do hope more could plan to be present to discuss the child's health with the school doctor. A urinalysis was done on all examined, and the findings were negative in every case. Notice of any defects found was sent home to the parent. They have been most cooperative in attending to these promptly.

On December 5, Mr. Reardon from the Division of Maternal and Child Health, Boston, came to the school to instruct me on the use of the Audiometric equipment. The Pure Tone Audiometer tests have been started and all first graders have been tested. Thus far two failures have been noted, and both have further consulted their own doctors in the matter.

Weighing and measuring has been done in all grades and notices have been sent home with children who are either overweight or underweight.

I have made 51 home visits since the opening of school. These were mostly transporting home children who were ill. Four home visits were made to check on the absences of several days duration who had not contacted the school. All were found to be ill. One other child was taken to the Medical Center, Plymouth and two to St. Luke's Hospital, Middleboro. Four were excluded, having been in contact with a contagious disease, two excluded with contagious conjunctivitis and one excluded with impetigo. One child received a finger injury serious enough to require two stitches. This was done by Dr. Mayo.

December was the month for the sale of T. B. Santa Claus pins. 300 pins at 5c each were sold at school and \$15.00 was sent to Brockton to help support the Plymouth County Health program.

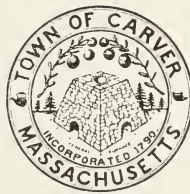

In the name of the Commonwealth of Massachusetts, you are directed to notify and warn the Inhabitants of the Town of Carver qualified to vote in elections and in town affairs to meet at the Town Hall in said Carver on Monday, the fourth day of March, 1957, at twelve o'clock noon, then and there to act on the following article, namely:

Article 1. To choose all necessary town officials, the following officers to be voted for all on one ballot, viz.: One Moderator, Three Auditors, Three Constables, Three Herring Committeemen, One Tree Warden, One Highway Surveyor, each for one year. One Assessor, One Selectman, One School Committeeman, One Cemetery Commissioner, One Park Commissioner, One Member of Board of Public Welfare, Two Library Trustees, each for three years. One Town Clerk (to fill vacancy), One Collector of Taxes (to fill vacancy), and One Town Treasurer (to fill vacancy), each for two years. One member of Planning Board for five years, and One member of Planning Board (to fill vacancy) for two years.

The polls will be open for at least seven hours.

And you are directed to further notify said Inhabitants of said Town that as soon as the ballots have been counted the meeting will adjourn to Saturday, March 9, 1957, at two o'clock P. M., and at that time will reconvene at the Gov. John Carver

Schoolhouse in said Carver, then and there to act on the follow articles, namely:

Article 2. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1957, and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 2. Recommended by the Finance Committee.

Article 3. To see if the Town will vote to appropriate a sum of money not to exceed one thousand (\$1,000.00) dollars from free cash in the town treasury for the sole purpose of meeting charges against the Cemetery funds in the town treasury.

Article 7. To see what amount the Town will vote to raise and appropriate for the use of Plymouth County Trustees for County Aid to Agriculture and choose a Town Director as provided in Section 41 and 45 of Chapter 128 of the General Laws and act thereon.

Article 7. Recommended by the Finance Committee that the sum of \$100.00 be raised and appropriated for County Aid to Agriculture.

Article 8. To see if the Town will vote to fix the salary and compensation of all elective officers of the Town as provided by General Laws, Chapter 41, Section 108, as amended namely:

Tax Collector	\$1,350.00

Article 9. To see if the Town will vote to transfer from the overlay reserve account to the 1957 Reserve Account the sum of three thousand (\$3,000.00) dollars, and, also, to transfer the additional sum of two thousand (\$2,000.00) dollars, from a-

available funds in the treasury to the said 1957 Reserve Account, and act thereon.

Article 9. Recommended by the Finance Committee.

Article 10. To choose all necessary Town Officers not elected by ballot.

Article 10. Recommended by the Finance Committee.

Article 11. To see if the Town will vote to raise and appropriate the sum of five thousand (\$5,000.00) dollars for Chapter 90 Highway Construction, and to transfer the sum of twenty thousand (\$20,000.00) dollars from unappropriated available funds in the Treasury to meet the State's and County's shares of the cost of work, the reimbursements from the State and County to be restored, upon their receipt, to unappropriated available funds in the Treasury, and act thereon.

Article 11. Recommended by the Finance Committee.

Article 12. To see if the Town will vote to raise and appropriate the sum of six thousand five hundred (\$6,500.00) dollars for Chapter 81 Highways, and to transfer the sum of seventeen thousand eight hundred seventy-five (\$17,875.00) dollars from unappropriated available funds in the Treasury to meet the State's share of the cost of the work, the reimbursements from the State to be restored, upon their receipt, to unappropriated available funds in the Treasury, and act thereon.

Article 12. Recommended by the Finance Committee.

Article 13. To see if the Town will vote to authorize the Cemetery Commissioners and the Park Commissioners to employ themselves as laborers in the Cemeteries and Parks, and act anything thereon or thereto.

Article 13. Recommended by the Finance Committee.

Article 14. To see if the Town will vote to raise and appropriate the sum of eight hundred and fifty (\$850.00) dollars to be used to pay for all private work and material in Town Cemeteries, such as, opening graves, building foundations, etc., as according to General Laws, Chapter 44, Section 53.

Article 14. Recommended by the Finance Committee.

Article 15. To hear the report of any standing committees and act anything thereon or thereto and establish any new committees.

Article 15. The Finance Committee recommends that the Town Moderator appoint a committee to investigate the cost of a new fence at Union Cemetery.

The Finance Committee recommends that a committee be appointed by the Town Moderator to investigate the possibilities of establishing Town Beaches for the residents of Carver.

Article 16. To see if the Town will vote to transfer the sum of four thousand five hundred thirty (\$4,530.00) dollars from the Road Machinery Fund to the Machinery Account, and act thereon.

Article 16. Recommended by the Finance Committee.

Article 17. To see if the Town will vote to accept as a gift from Norman G. Young a certain set of "Prang's War Pictures", subject to the following conditions, namely: that said pictures be framed and kept available for display at the Governor John Carver School, and that in the event that the School authorities no longer wish to keep said pictures that they be returned to the donor or to his heirs. (By request).

Article 17. Recommended by the Finance Committee.

Article 18. To see if the Town will vote to raise and appropriate a sum of money not to exceed two thousand five hundred (\$2,500.00) dollars for the purpose of purchasing a new "Station Wagon" type Police Cruiser, and to authorize the Selectmen to trade the present Police Cruiser for the new Cruiser and apply the trade-in value thereof toward the purchase price of said new Cruiser, and act thereon.

Article 18. Recommended by the Finance Committee.

Article 19. To see if the Town will vote to raise and appropriate the sum of eighty-eight dollars and eighty-one cents (\$88.81) to pay the following unpaid bills of 1955 and 1956, namely:

Public Welfare (1955)	\$53.16
Veterans' Benefits (1956)	\$29.15
Schools (1956)	\$6.50

and act thereon.

Article 19. Recommended by the Finance Committee.

Article 20. To see if the Town will vote to raise and appropriate a sum of money not to exceed five thousand (\$5,000.00) dollars for Assessors' Plans, and act thereon.

Article 20. Not recommended. Finance Committee recommends a reduction of \$2,000.00 due to upward trend in taxes. Recommend \$3,000.00 be appropriated.

Article 21. To see if the Town will vote to transfer the sum of two thousand (\$2,000.00) dollars from the proceeds received from the State under the provisions of Chapter 718 of the Acts of 1956, for the purpose of meeting the Town's share

of the cost of reconstructing the bridge over Crane Brook on Cranberry Road, and act thereon.

Article 21. Recommended by the Finance Committee.

Article 22. To see if the Town will vote to abolish the office of Town Planning Board, as established by vote of the Town under Article 18 at the Annual Town Meeting held on March 12, 1955, and act thereon. (By petition).

Article 22. Not recommended. Finance Committee feels the Planning Board has served a useful purpose and will continue to do so.

Article 23. To see if the Town will vote to adopt the Zoning By-Laws proposed by the Carver Planning Board, or to take any other action relative thereto. (By petition).

Article 23. Not recommended by Finance Committee in present form. Suggest further study by Planning Board.

Article 24. To see if the town will vote to appropriate a sum of money by taxation, by transfer from available funds, or by a loan issued in accordance with the provisions of Chapter 44, General Laws, for the purchase of a parcel of land, containing 32.2 acres, located along the East side of Savery Ave., in the Town of Carver and to be used for a Town Forest or as recommended by the Carver Planning Board, or take any other action relative thereto.

Article 24. Not recommended. The Finance Committee believes purchase price of land too high. The Finance Committee recommends Selectmen report to town at later date as to the taking of a protective strip of land, the length of Savery's Avenue, on both the easterly and westerly side of said Savery Avenue.

Article 25. To see if the Town will vote to raise and appropriate the sum of one hundred sixty-six (\$166.00) dollars for Town Shed repairs, and act thereon.

Article 25. Recommended by the Finance Committee.

Article 26. To see if the Town will vote to appropriate the sum of twelve thousand six hundred (\$12,600.00) dollars for the purpose of purchasing a new fire truck, together with the necessary equipment, and to meet said appropriation the sum of six thousand three hundred (\$6,300.00) dollars be transferred from the unexpended balance of the appropriation for the new fire truck voted under Article 20 at the Annual Town Meeting on March 10, 1956, and that, in addition, the sum of six thousand three hundred (\$6,300.00) dollars be raised by taxation in the current year, and to authorize the Moderator to appoint two members of the Fire Department to act with the Selectmen in the matter of purchasing said truck, and act thereon. (By request).

Article 26. Recommended by the Finance Committee.

Article 27. To see if the Town will vote to raise and appropriate a sum of money not to exceed one thousand (\$1,000.00) dollars for the purpose of painting the Union Cemetery fence, and act thereon. (By request).

Article 27. Not recommended. The Finance Committee after due consideration, believes fence rusted beyond repair and believes paint a waste. Under Article 15 in Town Warrant the Finance Committee recommends that the Town Moderator appoint a committee to investigate cost of new fence at Union Cemetery.

Article 28. To raise and appropriate such sums of money as may be necessary to defray town charges for the ensuing year.

Article 28. Recommended by the Finance Committee.

And you are directed to serve this warrant by posting attested copies thereof, at the several places designated by vote of the Town, seven days at least before the time of holding said meeting.

Hereof fail not, and make due return of this warrant, with your doings thereon, to the Town Clerk at the time and place of meeting aforesaid.
