In Alemoriam



ERNEST W. SHAW

1875 - 1957

Ernest Wakefield Shaw was born in Cambridge, Mass., Nov. 29, 1875. He was the son of Samuel and Harriet E. (Wakefield) Shaw. His great grandfather once owned the late Wm. M. Shaw place on Main Street, now the property of Matti R. Saisa.

It was in Newton Highlands that Ernest spent his childhood and went to school.

As a young man, he participated in the famous gold rush to the Klondike in 1898, carrying a letter of introduction from the Hudson Bay Company to its various outposts.

Returning to Newton in 1900 to be married, he took his bride to Colorado where his father had mining interests. He settled on a small ranch and in 1903, joined the United States Forest Service as ranger. Later, he became Forest Supervisor and transferred to Montana in the same service for twenty years.

In 1923, he returned to South Carver to live in the home of his late aunt, Eliza Bowers, on Rochester Road. He took up cranberry growing on the bogs of the estate and of those he later purchased, all in the Cranberry Road district of South Carver.

He became an enthusiastic and painstaking grower of the little red berry, soon to reach its pinnacle in Carver as a very thriving business.

In 1927, he was elected to the office of Town Road Commissioner for a term of three years. In 1936, he was appointed a member of the Finance Committee for a term. Both offices duties he discharged with care and exactness in purpose.

He was much interested in cranberry organizations. He was a member at one time of the New England Cranberry Sales Company; of the Southeastern Mass. Cranberry Club; the Cape Cod Growers Association and the Cape Cod Cranberry Co-operative Association.

In town affairs he took an active interest. He attended the Annual Town Meetings and expressed his opinion on any important matter in a clear-cut way.

He was caretaker of Union Cemetery for many years and president of Union Church Society. He was probably a record borrower of books from the Carver Library, an ardent reader.

His first marriage was to Florence Edith Taylor of Newton Highlands in 1900. To that union, two sons were born, the late Colonel Bradford, killed in a plane crash in Maryland shortly after the war, and Donald W., now living in Paonia, Cal., who is in the Forest Service.

In 1922, he married Kathleen M. Arthur of Two Dot, Montana, to whom were born Mrs. Kathleen Elizabeth (Betty) Anderson of Middleboro, Mass.; Mrs. Barbara S. Lagan of Providence, R. I. and John A. of Carver.

He died very suddenly in his home on Nov. 8, 1957. His funeral was in his home and he is buried across the street in Union Cemetery.

In Memoriam

ALEXANDER C. McLURE

1890 - 1957

Alexander Colin McLure was born April 6, 1890, in Kelleter, Castle Dearg, County of Tyrone, Northern Ireland.

He was the son of Donald and Jeanie (McCallum) McLure. He attended school in Argylleshire, Scotland. As a young man, he lived in Glasgow, Scotland, working in the shipyards. In 1905, he emigrated to America with his parents. He was a lover of cattle and became a herdsman for the late C. W. Barron, Oaks Farm, Cohassett; then for H. L. Timken, president of Douglas Shoe Co. on his Rambleton Farms, Buzzards Bay, and later for Benjamin W. Shaw, Tispaquin Farm, Middleboro.

In 1927, he moved to Carver, purchasing the Ed. Shaw place on Purchase Street.

In 1951, he was elected to the Board of Assessors. In 1949, he was appointed Town Inspector of Animals and Inspector of Slaughtering. All of these offices he filled up to the time of his death.

In his work, he was conscientious, painstaking, quiet and unassuming. Always pleasant to meet, a neighborly soul, kind alike to man and beast.

He was married to Eveline Bain, June 30, 1927. They had one son, Ian, and a daughter, Mrs. Mordina Batchelder of Middleboro, Mass.

He was a member of the North Carver Congregational Church and a member of Lakenham Grange.

The community was deeply shocked by his sudden and untimely death June 1, 1957. He was buried in Lakenham Cemetery.

In May 1957, the Plymouth Mayflower II Reception Committee invited the towns in the Plymouth area to participate in a grand parade with floats to wind up the festivities incident to celebrating the arrival of the Mayflower II in Plymouth, Massachusetts.

Since the Town of Carver had no funds for such purposes, the Selectmen turned the matter over to a citizen committee.

This Committee, as above organized, set about securing a designer and the necessary costumes and truck to display the theme that was adopted, that of "The Signing of the First Treaty" with the Indians by the Pilgrims. Incidentally, this was the same theme displayed by the Carver float in the Plymouth Tercentenary parade in 1921 and Mrs. Annie Shurtleff Boardway was the Chairman of the Carver Committee at that time.

The Committee also proceeded to raise funds to defray the expenses by soliciting the various organizations in town and the Carver citizens.

While the response from 34 individuals and 9 organizations was very good, there still remains a sizeable deficit at this date. The Committee extends its thanks and appreciation to Mrs. Virginia Shaw for her skillful work in designing and making the Pilgrim costumes; to Mr. Angelo Giberti for securing the Indian costumes; to the Weston Bros. for the use and operation of their truck and platform trailer and lumber for the stage thereon; to Egger's for the loan of the grass rugs; to the personnel of the characters on the float; and especially to all those who contributed money and effort to make the job a success.

The Committee takes pleasure in noting here that our float received a great deal of applause all along the line of parade on that beautiful warm day of Saturday, June 22, 1957.

All of those who were on the float declared they had a wonderful time and experience.

Carver lived up to her name.

REPORT OF TOWN DIRECTOR COUNTY AID TO AGRICULTURE

70

At present, there are but two dairy farms in Carver, both in North Carver. They have been in operation for a number of years and especially the Embert Eames farm for a very long time.

We regret to report that the one fruit and vegetable farm which started production only a few years ago has been obliged to suspend operations due to poor market and declining prices.

Strawberries do well in Carver, but only a limited crop can be marketed profitably principally at road-side stands.

Weather conditions, with almost annual droughts, make it a great gamble to grow cultivated crops without available irrigation and very often like the past season, a sprinkling system for cranberry bogs is invaluable.

Cranberry growing is the principal farming industry in Carver, but plagued by poor marketing and small returns, the past few years, there is not so much interest in the business as formerly. Many good bogs have deteriorated from lack of funds to keep them in prime condition. Last summer's long drought caused severe damage on many bogs. With a nationwide crop of over one million barrels last season and the per capita consumption of cranberries having fallen off sharply from what it was 25-30 years ago, the short term improvement in the business does not look too promising. But still, the fact remains that per acre for acre cranberries still give better return than any other crop.

In order that the citizens of Carver may understand what is meant by County Aid to Agriculture, a copy of the report by the County Agent, Robert B. Ewing is given in full below

Mr. Herman B. Dine Director of Accounts Department of Corporations and Taxation State House, Boston Sir:

As directed by you, I have made an audit of the books and accounts of the town of Carver for the period from September 22, 1956, the date of the previous examination, to March 16, 1957, preparatory to the transfer of the books and accounts and of cash and securities to the newly elected treasurer, tax collector, and town clerk, and report thereon as follows:

The records of financial transactions of the several departments receiving or disbursing money for the town or committing bills for collection were examined and checked with the records of the town treasurer. The appropriations and transfers, as recorded, were checked with the town clerk's record of town meetings and with the finance committee's records. General ledger accounts were compiled for the period of the audit, and a balance sheet showing the financial condition of the town on March 16, 1957 was prepared and is appended to this report.

The books and accounts in the treasurer's office were examined and checked. The recorded receipts were analyzed and compared with the records of the departments making payments to the treasurer and with other sources from which money was paid into the town treasury, while the payments by the treasurer were checked with the selectmen's warrants authorizing the disbursement of town funds.

The treasurer's cash balance on March 16, 1957 was proved by actual count of the cash in the office and by reconciliation of the bank balance with a statement received from the bank in which town funds are deposited.

The recorded payments on account of maturing debt and interest were checked with the amounts falling due and with the cancelled securities on file.

The savings bank books and securities representing the investments of the trust and investment funds in the custody of the town treasurer and the trustee were examined and listed. The income was proved and the transfers to the town were checked with the receipts as recorded on the treasurer's cash book.

The records of employees' payroll deductions for Federal taxes and the county retirement system were examined and reconciled with the records of the town treasurer.

The tax title records were examined and the amounts transferred to the tax title account by the tax collector were verified, the tax titles on hand being listed and proved. The books and accounts in the tax collector's office were examined and checked. The poll, personal property, and real estate taxes, as well as motor vehicle and trailer excise, outstanding at the time of the previous examination, together with all subsequent commitments, were audited and proved. The payments to the treasurer were checked with the treasurer's cash book, the recorded abatements were compared with the assessors' records of abatements granted, and the outstanding accounts were listed and proved.

The records of departmental accounts receivable were examined and checked. The charges were proved, the payments to the treasurer were compared with the treasurer's cash book, and the outstanding accounts were listed and proved.

The outstanding tax and departmental accounts were further verified by mailing notices to a number of persons whose names appeared on the books as owing money to the town, and from the replies received it appears that the accounts, as listed, are correct.

The total amounts outstanding on each of the tax and motor vehicle and trailer excise levies were given to the assessors for use in preparing the recommitments to the new collector, and detailed lists of all the outstanding accounts were prepared for the tax collector's use.

The financial records of the town clerk were examined and checked in detail. The collections on account of dog and sporting licenses issued, as well as from miscellaneous receipts, were verified and compared with the payments to the treasurer.

The surety bonds of the town officials required by law to furnish them for the faithful performance of their duties were examined and found to be in proper form. The records of receipts of the selectmen and the sealer of weights and measures, as well as of the police, school, library, and cemetery departments, and of all other departments collecting money for the town, were examined and checked, the payments to the treasurer being verified.

Appended to this report, in addition to the balance sheet, are tables showing a reconciliation of the treasurer's cash, summaries of the tax, motor vehicle and trailer excise, tax title, and departmental accounts, together with schedules showing the condition and transactions of the trust and investment funds.

While engaged in making the audit, cooperation was received from all officials of the town, for which, on behalf of my assistants and for myself, I wish to express appreciation.

BOARD OF PUBLIC WELFARE

To the Honorable Board of Public Welfare:

I herewith submit my report on Old Age Assistance, Aid to Dependent Children, Disability Assistance and Public Welfare for the fiscal year ending December 31, 1957.

During the year 33 applications were processed and disposed of as follows:

- 27 Approved
 - 2 Denied
 - 3 Withdrawn
 - 1 Pending

During the year 17 cases have been closed for the following reasons:

- 2 Transferred to State Hospitals
- 2 Transferred to other categories
- 1 Ineligible
- 5 Employed
- 2 Hospitalization only
- 3 Resources available
- 2 Deaths

There have been many changes due to new legislation and State Department directives which have entailed considerable administrative work.

Public Law 880 and Public Law 85-110, enacted in 1957, initiated new rules and a revised medical care plan which became mandatory on 9-1-57. The decision to abandon in part the universal vendor payment plan imposed a heavy, continuing workload on local boards of public welfare.

Also effective on 9-1-57 payments on Old Age Assistance, Aid to Dependent Children, and Disability Assistance were increased 5.7%. This was brought about by an increase in the cost of living index as reported by the Division on the Necessaries of Life. An increase of the item for fuel was also made at that time because of exhorbitant increases in fuel prices over those currently used in the Budget Cost Schedule. Funeral and burial expenses also advanced effective 7-1-57.

In accordance with the provisions of Chapter 7, Section 30L of the General Laws, the Director of the Division of Hospital Costs and Finances established a rate of \$5.75 per diem for all licensed nursing homes. This was an increase of \$.75 per diem and was effective 9-15-57. Hospital rates certified by the Commission on Administration and Finance increase annually and the three hospitals which serve this community now charge a higher per diem rate.

Chapter 614 of the Acts of 1957 increased the exemptions of children of Old Age Assistance recipients and effective 10-29-57 few cases are found in which a child of aged parents is legally liable for support.

Three liens were filed on real estate of Old Age Assistance applicants. This is a condition of granting Old Age Assistance. The purpose of the lien is to secure payment of assistance grants.

During the year the number of Old Age Assistance cases has increased from 35 on 1-1-57 to 41 on 12-31-57.

Cases receiving Aid to Dependent Children have changed little, there being 4 cases on 1-1-57 and 4 cases on 12-31-57. The average number of children aided was 9.

One Disability Assistance case became eligible for Old Age Assistance during the year. On 1-1-57 there were 4 cases and on 12-31-57 there were 5 cases with one application pending the decision of the Medical Review Team. On 1-1-57 there were 3 active General Relief cases and on 12-31-57 there were 5. Because there is little employment during the winter months there is increased activity in the caseload. Employment has been found for two recipients resulting in closed cases. Because of the unemployment situation in this vicinity, it is expected that there will be increased assistance in this category during the early part of 1958. This agency has processed cases for other cities and towns, the applicants being residents of rest homes.

REQUIREMENTS FOR ADMISSION TO FIRST GRADE

2. A child whose birthday occurs in the two months after December 31st may be admitted the preceding September if readiness for school can be demonstrated by means of appropriate tests. Parents having a child whom they wish to be examined under this rule are required to make application to the Superintendent of Schools on or before August 15th preceding the opening of school in September. A special form will be furnished for this purpose upon written request from the parent.

CLOSING OF SCHOOLS

It is the policy of the School Committee to close school only under the severest weather conditions or on such occasions when it is dangerous to operate school buses. At other times, parents are expected to use their own judgment in sending children to school. When a decision to close schools has been made, this information will be broadcast through the courtesy of radio stations WBZ, WNBH and WBET. The no-school signal will also be given on the local fire warning apparatus. This signal is two short blasts sounded three times. From records of the School Committee, January 6, 1958 Voted: That the report of the Superintendent of Schools and other officers of the school system be hereby adopted as the report of the School Committee for 1957.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the Members of the School Committee:

I hereby submit my annual report as Superintendent of Schools and in writing the report also include those items of major importance relating to policy as determined by the members of the committee for the calendar year. Your attention is invited to the report of the principal and others and to the statistical tables which accompany this report.

The enrollment at the Governor John Carver School is up somewhat slightly from the figure of last year. It represents a gain of approximately twenty children. The enrollment in the Silver Lake Regional High and Vocational Schools is also somewhat larger than that of the previous year by about ten pupils. While Carver does not seem to experience the rapid growth which some of the small towns have in southeastern Massachusetts, it does seem to be showing a slow and steady growth in the upward direction. You will note, particularly, that there are forty-six children predicted to enter school next September as first grade. Experience teaches us that there are sometimes small increases in this number so that we might readily assume that there may be from fifty-one to fifty-four children in the first grade next fall.

In the matter of considering the growth at the school we find one factor which makes it difficult to form conclusions as regarding grade groupings, etc. We have several grade groups where the number of pupils is in the vicinity of forty. While this number of children per grade is too large for satisfactory individual attention it likewise results in a very small grouping if two sections of the same grade are employed as a solution. If the decision is made in favor of two sections for such a group one is open to the criticism of extravagance; yet if one leaves the group as it is and maintains only one section then we are equally open to the claim of failing to give adequate individual help for the child. Over the years past we have resorted to the device occasionally of dividing one grade group in such a manner that a combination room results as has been the case this last year of the fifth-sixth combination. We feel that an instance of this sort is about the best practical solution that can be offered and we may find in the years to come that we will have to use this device in other situations in order to more adequately divide the pupils among the teaching staff.

In trying to prepare adequately for the future the committee has given some thought as to the future location for Carver pupils. If additional sections of grade groups are to be set up within the school then we shall have to adapt other spaces to care for them. It is possible in the coming year we may have to use the library for a classroom and move other groups around so that the Domestic Arts room is used more for a full-time classroom than is the present practice. In line with thinking ahead for the best provision for the town's children as they seem to increase in number in schools, the committee gave considerable thought as to what should be done with the Benjamin Ellis School and whether or not it should request the vote of the town to restore it to the custody of the School Committee to serve as possible insurance against the need for additional classrooms. The question in the minds of the authorities of the school department centered around this one item, - whether it would be better to add to the Governor John Carver School or better to retain the Benjamin Ellis School for the time being until the future could be more readily determined. It seemed in weighing all the factors that it would be likely better to retain the Benjamin Ellis School for the time being which would give the assurance of two small classrooms and would, at least, provide a time during which the town could more carefully consider the total future picture.

It is most difficult to predict what Carver's future solution shall be for its secondary school problem. We have been advised this year that Silver Lake will no longer take grade nine from Carver beginning September, 1958, due to the growth of their own pupil enrollment. The committee has completed arrangements with the Middleboro School Department for this grade to be accommodated there on that same date and there is little question but as the years come by Carver will gradually have to withdraw from the Silver Lake School. Middleboro has also offered to accept up to eight or ten other pupils of other grades who can meet the admission requirements regarding scholarship and conduct if these requests are made by Carver students and parents. The Middleboro School Department has also written that Carver's opportunities for the future "will be dependent upon more specific information as to the future of Lakeville" in their schools.

Considerable thought and time has been placed by the members of the School Committee and of the Regional School Planning Committee on finding possible solutions for Carver's high school pupils. The following steps have been taken along from time to time:

- 1. Investigated the possibilities of a regional school with Plymouth and Carver so far as it was possible for committee members to go. However at the present writing there seems to be little likelihood that this event can come to pass.
- 2. Explored somewhat the possibilities as to whether Carver might become a permanent partner with Silver Lake at the 10-11-12 level.
- 3. Some brief study has been given to the cost of adding onto the Governor John Carver School so that grade 9 might be contained locally and with the chance taken

that grades 10-12 could be accommodated in some neighboring community.

4. Make arrangements with the Middleboro School Department to place grade 9 at Middleboro.

We are fortunate to be able to report very slight change in staff this year as compared with last year. One resignation was presented to the committee in the late spring of 1957, that of Mrs. Clare Neal, who was teaching one of the primary grades. Mrs. Neal submitted her resignation for personal reasons but later discovered that it would be necessary for her to remove her home to the state of New Jersey. Her position thus vacated was filled with the appointment of Mrs. Mabel J. Eayrs, of Middleboro, who is a graduate of one of the Boston Training Schools for primary education and comes to us with twelve years' experience in the primary grades in the town of Milton. Too much cannot be said in favor of a permanent staff and the fact that our teachers continue from year to year enable us to give consistently a steady and worthwhile pattern of education.

The committee and superintendent engaged in considerable study and discussion concerning the possibilities of a ruling for setting a policy to be applied in cases of pupils who were over the mandatory legal age of school attendance but who were not making the effort to profit in their opportunities. As a consequence of this the following regulation was adopted by the committee on August 27, 1957:

"Effective on the above date, the Carver School Committee has voted that a pupil having reached the age of 16 and failing in his work at school because of poor conduct, attendance or attitude will be denied his tuition and transportation expense. A statement from the Principal or Director of the school showing the condition prevails will be sufficient for the Committee to take action under this rule. Parents of a pupil denied his tuition and transportation expense will have to make their own arrangements with the school if such a pupil is to continue in attendance."

It is not the intent of the committee to penalize any pupil but rather it is the intent that students enrolled in schools outside of the town and at considerable expense to Carver shall realize they have an obligation to do as well as their capacities and circumstances will permit. One can be sympathetic with a pupil who, in spite of good effort, conduct and attendance, cannot succeed perhaps as well as he might like to; but contrasted with this there seems little need for patience for the pupil who wastes his effort and opportunity and who admittedly goes to the school "for the ride." Carver is fortunate in that it has very few pupils of this latter category, but it is the intent of the Department that we shall not support and encourage this sort of approach to school.

Considerable work has been done this year on the Governor John Carver School in order to get the maintenance caught up and keep the building in first class appearance. During the summer a contract was let to the low bidder, John Wholan of Middleboro, for the painting of rooms No. 21, 22, 25, 26, stairwells south wing, fire doors and the second floor corridor. During the summer, pointing work was done on the certain parts of the brick work in need of this attention and that portion of the building sealed with a water repellent sealer where it had never been previously applied. As the end of the year drew near it became apparent there would be some surplus funds to permit additional work of this sort and the committee thought it better to proceed with it rather than to leave it to the 1958 budget. Accordingly, the rooms No. 14, 27, 28 and 29 were painted, together with the north rear stairwell and the corridor on the first floor. It will probably require only two more steps in the future and the building will have been completely redecorated. Since its occupancy in 1951 both inside and out our building always remains clean, neat and attractive and it should be entered in the public record here that our janitor, Mr. H. Albert Raymond, ably assisted by Mrs. Raymond, keep it in first class order. It is often a subject for conversation by those visiting our school when they see the neat and clean condition in which we live.

There are no major changes to report in curriculum content for the year past. Mr. Shaw's report discusses very adequately our aims as relates to teaching, curriculum, etc. This last year we were able to bring out a publication which has been long in the making and represents the work and effort of the teachers of the union school system; in fact, it includes work and contributions by some who have since left us and gone to other systems. For the first time we have been able to get our Course of Study material mimeographed and bound together into one copy so that each teacher now has in her possession a complete book of the Course of Study for the entire system. This is a valuable aid not only to the teacher in the immediate classroom with a particular grade but as well permits the teacher of any grade to see where her part fits into the total picture of the education of the child of the eight grades. We expect to continue to enlarge and refine this as time permits and to change it, revise and bring it up-to-date as needed. A change was authorized this year in the Penmanship system, both for reasons of economy and for better use of the time as relates to the school week. It is our policy at the moment to try to train our pupils as intensively as possible in the first six grades and to use the time in grades seven and eight strictly for remedial purposes for those pupils who cannot make the standards of reasonable legibility and conformity.

We recognize that the costs of maintaining schools do not decrease as the years go by but we also point out that we remain in a favorable comparative position in these times. In the matter of tuition rates we have the following items:

Silver Lake Regional	\$400.00 per pupil
New Bedford Vocational School	325.00 per pupil
Middleboro High School	286.00 per pupil

Of these rates quoted here, the two higher ones have a marked influence upon the amounts of money required for the education of the secondary school pupils. The committee members have given considerable thought from time to time as to the problem of teachers' salaries, in fact this is one of the major problems of any school committee today. For this school year, 1957-1958, the average teachers' salary in Carver, considering all salaries except those administrative in nature or having any administrative allowance attached to them, comes to \$3,872.00. This salary is slightly below the median salary reported by the Massachusetts Teachers Association in its bulletin No. Q16-IVa of November 15, 1957 which shows the median salary in towns of group 4A (towns similar to Carver) is \$3,960.00. We are probably approaching the time when some equitable form of salary plan will have to be devised which will enable us to offer an attractive future to teachers entering the system but equally permit variations to enable us to recognize worth to the school system. There is a growing interest in all school systems in the so-called "Merit Plan" for payment of salaries. The teachers of this school union already have a committee working on the subject to study it, become acquainted with it and to see if some ideas can be advanced which will be useful in the future years. There is a growing feeling in this nation that teachers' salaries ought to be more professionally comparable to other professions having to do with people and if we are at all alert to the needs we probably shall have to have a plan worked out within the next three or four years that will offer some positive approaches to the whole question of adequate pay for teachers.

The year just closed in Carver is one in which we have continued to try to solve problems and develop and strengthen our school system. Steps have been taken to raise the aims of the secondary pupils and efforts have been made toward a permanent solution for the secondary school question as relates to Carver. Only time alone can prove or disapprove the value of decisions made to this date, but whatever has been said or done has been so because of the evidence at hand at the time the decision was made. The interest which the principal and teachers take in the success of their school and the concern and care which the school committee takes in making its decisions are all factors which help us to maintain a good school system, one which is progressive in the best sense of the word.

REPORT OF THE PRINCIPAL OF THE GOVERNOR JOHN CARVER SCHOOL

To the Superintendent of Schools:

I herewith present my report as principal of the Governor John Carver School for the calendar year 1957.

Mention should be made of three activities which took place during the school year which ended in June: the special class, the School and the Public Health Nursing Program and the graduation.

The special class, under the capable instruction of Mrs. Winifred Nickerson, completed its first year as a part of Carver's educational program. The results were most pleasing. The class members made substantial progress in the academic areas of the program and were introduced to crafts and manual arts work. Small classes, specialized instruction, and a sympathetic environment have produced good educational results. The children involved were experiencing success in the basic subjects of reading, arithmetic, and English, which would have been denied them had they been enrolled in the regular classes of the school. The program is varied and challenging; pupil interest is high. A commendatory report from the State Department of Education followed its inspection of our special class program.

Another new feature of our program, which completed its first year in operation, was that of the Public Nursing Health Program. We at the school feel that this project is working out most favorably. Under the present program Mrs. Mary Korpinen is in attendance for the greater part of the time between 8:30 and 1 o'clock for each school day. The school duties of the nurse are many and varied. During the summer months the Family Data Sheet for each child

entering the first grade is completed by home visits, and such sheets must be made out for children transferring to the school. A health card is prepared for each child enrolled in the school. With the aid of the school doctor the nurse carries out the state prescribed physical examinations for pupils of grades 1, 4, and 7, and for all children taking part in the school's sport program. The school nurse administers the eye and ear tests, and records weight and height. In cooperation with the State Department of Health, dental clinics are held annually. The nurse is in attendance for children who are ill at school and arranges transportation for those too ill to remain at school. Another duty is the giving out of health information. All children who have been absent from school report to the nurse on returning to school. Under the present arrangement all excuses for absence are submitted to the school nurse. I can report most favorably on the program at the end of its first year in operation.

The school year closed with an enrollment of 293. The average daily attendance approximated 94% of the enrollment. A child who was absent 7 days during the school year exceeded the absence of the average child. 13 children had perfect attendance.

Graduation exercises were held on June 6, 1957. The American Legion Essay Award was won by Kenneth Heleen for his essay "The Symbol of a Nation." The Legion Auxiliary Poster Awards were given to Ronald Pimental and Albert Thomas; the Humane Society Poster Awards were presented to Elizabeth Weston, Rebecca Shaw, Kathleen Halunen and George Young. The evening's program was prepared by the students under the direction of Miss Barbara Trombley and dealt with the story of American music. A list of the graduates follows:

The school year 1957-58 opened in September with an enrollment of 288 and since that time reached 307, and at the close of December had leveled off to 297. This gives us an average of 37 pupils per grade, but our lower grades are exceeding that number. One change in the teaching staff was made necessary by the resignation of Mrs. Clare Neal. We were very fortunate to be able to fill the position with a teacher of eleven years of experience with grade one by the appointment of Mrs. Mabel Eayrs of Middleboro.

Every effort is being made to increase the efficiency of our teaching, and to add to the value of the work taught at

the school. During the year four teachers availed themselves of the help offered by educational courses given at The State Teachers College in Bridgewater. The introduction of the Study Guide discussed in Mr. Austin's report is of great value to the teachers in planning the school work. The teachers of the three upper grades are experimenting with a series of diagnostic tests in arithmetic and English. Each skill taught is isolated in a test situation - so that failure in a certain area of the test shows that the student has not mastered that particular skill. An analysis of the test indicates zones of strength and of weakness. In this way the child can see what he has mastered and where he is in further need of instruction and self effort. We have indications that such information creates an incentive in the child to master where he has failed. These tests are being drawn up by the teacher to cover the course of study offered here in the Governor John Carver School. The tests are not used for marking purposes; rather, they serve as a guide to instruction.

An accounting of the various drives held during the year is in order. The following amounts were collected:

With the exception of the magazine drive the funds collected are turned over to the proper authority. 61% of the children enrolled availed themselves of the protection offered by the Insurance program. From the student fund two reproductions of chairs used by Governor John Carver were purchased; these made their local debut in the Carver float in the Mayflower II Parade, and they are now housed in the teachers' room. The Prang Civil War Pictures given to the town by Mr. and Mrs. Norman Young have been framed and are on display in the school library. On December 31, 1957, there was a balance of \$327.39 in the school fund, — money raised largely by the annual magazine drive.

The lunch program offered still continues to be a credit to the school and to the town. Its success is recognized by the fact that Mrs. McLure has been elected to serve on the state-sponsored panels discussing the problems of the school lunch. We have found it unnecessary to increase the cost of the meal which is still twenty cents per day. The financial side of the program is given below:

Within the last two years three college scholarships for Carver students have been established in the Town of Carver. While this may not strictly fit into the province of this report, I believe that the existence of these scholarships should be brought to the attention of the public. All are granted to pupils in degree-conferring institutions. The Teachers' Association Scholarship Fund is given by the teachers of the union—two of every three years a Carver pupil is open for the award. The scholarship is limited to those studying for the teaching profession. The second scholarship is offered by the Parent Teachers Association, and the third is donated by the Carver Kiwanis Club. All scholarships are for one hundred dollars.

I will close with an expression of gratitude for the cooperation of all those who take part in the school program. The staff is ever aware of the support given it by you, Mr. Austin, and by the School Committee of the Town of Carver.

ANNUAL REPORT OF

DIRECTOR OF MUSIC EDUCATION

To the Superintendent of Schools:

Our music program is designed to include various types of musical experience including areas of listening, singing and rhythm.

In the singing area, all grades are given opportunity to perform with a group and alone if they so desire. We teach note reading from the board to Grades I and II. At the end of Grade II, we present books, and the children then sing notes from the book. From Grade III to Grade VI, we continue to teach the mechanics of music to make the children more able to sing independently, even though the songs are previously unfamiliar. Grades VII and VIII sing in two and three parts, and we try to make the groups as proficient as possible.

In the listening area, we try to help the children to become familiar with good music. We feel that they cannot discriminate between good and poor music unless they are exposed to all types. We also try to correlate art and music by use of musical color and moods.

In the rhythmic area, we have done much work with dancing. We began with folk dances to insure the ability of the children to follow directions. They are also taught to coordinate strong and weak beats of the rhythms used. We then taught the children to waltz correctly. They also learned proper ballroom courtesy. We found that the children learned these rhythmic activities very well and with much enjoyment.

This year we have placed added emphasis on a special singing group from Grade III to VIII. We have selected students who sing well, have interest and ability. We are endeavoring to train this group for performance. They are also taught correct stage deportment. They are beginning to become aware of the marriage of music and lyrics in song.

We believe that the most important function of a music program is to give the children a variety of experiences. We feel that in this way, we can help the children to become aware of their musical interests and capabilities.

The annual meeting of School Superintendency Union No. 35 was held at the Consolidated School in Rochester on April 29, 1957.

The most important question for discussion at this meeting was the future organization of the Union Committee. As Lakeville is concerned with the regional school program with the town of Freetown, Mr. Austin explained to the members that the best arrangement for any town would be to have both elementary and secondary administration under one supervision.

A committee consisting of teachers from the three towns of the Union are studying the plan concerning a "merit" system for salary increments for outstanding personnel in the school department.

The semi-annual meeting of the Union was held at the Governor John Carver School on November 8, 1957.

At this meeting Mr. Griffith informed the members that the school committees of Freetown and Lakeville had met separately and voted in favor of forming a union together when the plans for their regional school are in operation. He requested an expression of opinion from the Carver and Rochester committee members to present for approval to the Department of Education concerning the withdrawal of the Lakeville committee from this present union. It was voted that Lakeville be allowed to withdraw in the advent it will be advantageous to do so in the near future.

The Lakeville members appreciate the cooperation of the other members of the Union committee and feel our association has been congenial.

As the many changes in our educational program occur, the Union committee is grateful for the extra time and effort Mr. Austin has so ably and unselfishly given. We feel that we have received the full benefit of our superintendent's guidance to meet the needs of the individual towns and the union.

14 trips were made to Plymouth County Hospital, Hanson for medication and I transported those scheduled for chest X-rays and other tests there. One unlisted visit was made at the request of Dr. Fred Allen, Boston.

We held 6 polio clinics during the year of which 3 were held in the evening. 34 doses were administered by Dr. Mayo at the January 14 clinic, 58 on January 17, 255 on May 9, 97 on May 22, 51 on June 20, and 20 on December 9. Our total polio count through December 1957 stands as follows: First doses 67 Second doses 77 Booster Doses 461

On the evening of December 3, a flu clinic was held at the school for essential town personnel with 20 doses of vaccine administered by Dr. Mayo.

My office hours at the Gov. John Carver School are from 8:30 A. M. to 1:00 P. M. All calls for home visits should be in by 9:30, if possible.

The following is my report on school health from January 1957-June 1957 and from September 1957-December 1957:

In July and August, 40 pre-school visits were made to obtain information for each child's health record prior to entrance to school. These visits prove most satisfactory in that they give the opportunity to meet the family and to obtain information for an accurate record of the child.

The Community Service Group donated new gloves, slacks, boots, shoes, underwear, socks and many articles of used clothing which were distributed to needy children at school and in the community.

In January, we held our annual polio drive at school. \$21.19 was collected and a check for the amount sent to Mrs. Florence Sand, Chairman of the drive.

160 home-school visits were made during the school year. Most of these were children transported home due to illness during the school day. Other visits were made because of prolonged absence with no known reason, impetigo, to check on evidence of communicable disease, conjunctivitis, and pediculosis. All known cases of communicable disease were reported to the Board of Health. In regards to absences from school, each child, upon returning to school must see the nurse before school accompanied by an excuse as to the reason for the absence. Most children have reported faithfully, but there are some who must be reminded.

There were many minor injuries treated at school. The most serious conditions and accidents were: a hard stonelike mass removed from an infected area (was under a Doctor's care), one hit on head by a swing, with 3 stitches taken by Dr. Nye, 3 dog bites reported, 1 dislocated finger treated by Dr. Mayo, 1 concussion admitted to Jordan Hospital, Plymouth, 1 asthma attack, 1 taken to St. Luke's Hospital, Middleoro to have lead from pencil removed from cheek by Dr. Silliker.

One trip was made to St. Luke's, Middleboro for a chest X-ray and two trips were made to Dr. Gibbons', optometrist, to have eyes examined and fitted for glasses.

In September, and October, Dr. Mayo examined 138 pupils. Invitations were sent home with all first and fourth graders requesting parents to be present during his child's physical if he wished. Only 2 parents accepted and were present during the examination to discuss the child's health with the doctor. A urinalysis was done for each one examined. Two urine re-tests were done and were negative. All those examined and found to be in need of attention by the family doctor were given notices. In November, Dr. Mayo examined 16 children competing in basketball. All were found fit to play.

In March, Mr. Reardon from the Division of Maternal and Child Health came to the school to instruct me in the use of the vision testing equipment. Children of all grades were tested and those failing were given notices. 16 failed the test. Of these 16, 3 were unable to be corrected with glasses due to muscle imbalance, 4 failed to see the family doctor, 4 obtained glasses, 1 seen by his doctor but no glasses needed, and 3 who failed with glasses had them checked and corrected.

T.B. Santa Claus pins at 5¢ each were again sold in school in December. 214 pins were sold and \$10.70 was sent to help support the Plymouth County Health program.

On March 22nd and 18th, Mrs. Bernadine Tassinari, dental hygienist, visited the school and examined the teeth of all present. Notices were sent home for those whose teeth needed attention. About half of those receiving notices consulted the dentist for necessary treatment.

On November 20, Mrs. Mary Wolfe, from the M.S.P.C.C., Brockton visited to check on health records of some school children. She was concerned with the condition of their teeth and, in the meantime, we have been discussing the possibility of making arrangements to have them cared for. Thus far there has been no conclusion to this.

I wish to thank the Public Health Nurse Committee, Mr. Shaw, the teachers, and parents for their wonderful help and cooperation.

TOWN WARRANT AND REPORT OF

FINANCE COMMITTEE

The Commonwealth of Massachusetts

Plymouth, ss. To either of the Constables of the Town

of Carver, Plymouth County, Greeting:

In the name of the Commonwealth of Massachusetts, you are directed to notify and warn the Inhabitants of the Town of Carver qualified to vote in elections and in town affairs to meet at the Town Hall in said Carver on Monday, the third day of March, 1958, at twelve o'clock noon, then and there to act on the following article, namely:

Article 1. To choose all necessary town officials, the following officers to be voted for all on one ballot, viz.: One Moderator, Three Auditors, Three Constables, Three Herring Committeemen, One Tree Warden, One Highway Surveyor, each for one year. One Assessor, One Selectman, One School Committeeman, One Cemetery Commissioner, One Park Commissioner, One Member of Board of Public Welfare, Two Library Trustees, each for three years. One Assessor (to fill vacancy), for two years, One Cemetery Commissioner (to fill vacancy), for one year, and to vote by ballot "yes" or "no" on the following question:

"Shall the town vote to accept the provisions of Section 6C of Chapter 40 of the General Laws, which authorize cities and towns to appropriate money for the removal of snow and ice from private ways therein open to public use?"

The polls will be open for at least seven hours.

And you are directed to further notify said Inhabitants of said Town that as soon as the ballots have been counted the meeting will adjourn to Saturday, March 8, 1958, at two o'clock P.M., and at that time will reconvene at the Gov. John Carver Schoolhouse in said Carver, then and there to act on the following articles, namely:

Article 2. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1958, and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 2. Recommended by the Finance Committee.

Article 3. To see if the Town will vote to appropriate a sum of money not to exceed one thousand (\$1,000.00) dollars from free cash in the town treasury for the sole purpose of meeting charges against the Cemetery funds in the town treasury.

Article 3. Recommended by the Finance Committee.

Article 4. To see if the Town will vote to accept the bequest of One Thousand (\$1,000.00) Dollars in accordance with the provisions of paragraph three of the will of the late Betsey Crowell Look, said sum of money to be invested in a Savings Bank and to be known as The Betsey C. Look General Care Fund for the Central Cemetery, the interest from said Fund to be used for the general care of Central Cemetery as the Cemetery Commissioners may determine.

Article 4. Recommended by the Finance Committee.

Article 5. To see if the Town will authorize the Selectmen to prosecute, compromise or defend suits for or against the Town.

Article 5. Recommended by the Finance Committee.

Article 6. To see what disposition the Town will make of the Dog Fund.

Article 6. Recommended by the Finance Committee that the Dog Fund be transferred to the Library Account.

Article 7. To see what amount the Town will vote to raise and appropriate for the use of Plymouth County Trustees for County Aid to Agriculture and choose a Town Director as provided in Section 41 and 45 of Chapter 128 of the General Laws and act thereon.

Article 7. Recommended by the Finance Committee that the sum of \$100.00 be raised and appropriated for County Aid to Agriculture.

Article 8. To see if the Town will vote to fix the salary and compensation of all elective officers of the Town as provided by General Laws, Chapter 41, Section 108, as amended namely:

Highway Surveyor\$1.7	5 per hour
Town Treasurer	\$1,350.00
Town Clerk	\$800.00
Tax Collector	

Moderator \$20.00 for the Annual Town Meeting, and \$5.00 for each Special Town Meeting.

Members of School Board \$3.00 for each meeting, plus \$1.50 per hour for all meetings of over 2 hours.

All other elective Town Officers \$1.50 per hour.

Article 8. Recommended by the Finance Committee.

Article 9. To see if the Town will vote to transfer from the overlay reserve account to the 1958 Reserve Account the sum of two thousand (\$2,000.00) dollars, and also, to transfer the additional sum of three thousand (\$3,000.00) dollars, from available funds in the treasury to the said 1958 Reserve Account, and act thereon.

Article 9. Recommended by the Finance Committee.

Article 10. To choose all necessary Town Officers not elected by ballot.

Article 10. Recommended by the Finance Committee.

Article 11. To see if the Town will vote to raise and appropriate the sum of five thousand (\$5,000.00) dollars for Chapter 90 Highway Construction, and to transfer the sum of twenty thousand (\$20,000.00) dollars from unappropriated available funds in the Treasury to meet the State's and County's shares of the cost of work, the reimbursements from the State and County to be restored, upon their receipt, to unappropriated available funds in the Treasury, and act thereon.

Article 11. Recommended by the Finance Committee.

Article 12. To see if the Town will vote to raise and appropriate the sum of six thousand six hundred (\$6,600.00) dollars for Chapter 81 Highways, and to transfer the sum of eighteen thousand one hundred fifty (\$18,150.00) dollars from unappropriated available funds in the Treasury to meet the State's share of the cost of the work, the reimbursements from the State to be restored, upon their receipt, to unappropriated available funds in the Treasury, and act thereon.

Article 12. Recommended by the Finance Committee.

Article 13. To see if the Town will vote to authorize the Cemetery Commissioners and the Park Commissioners to employ themselves as laborers in the Cemeteries and Parks, and act anything thereon or thereto.

Article 13. Recommended by the Finance Committee.

Article 14. To see if the Town will vote to raise and appropriate the sum of six hundred and fifty (\$650.00) dollars to be used to pay for all private work and material in Town Cemeteries, such as, opening graves, building foundations, etc., as according to General Laws, Chapter 44, Section 53.

Article 14. Recommended by the Finance Committee.

Article 15. To hear the report of any standing committees and act anything thereon or thereto and establish any new committees.

Article 15. Recommended by the Finance Committee.

Article 16. To see if the Town will vote to transfer the sum of two thousand six hundred forty (\$2,640.00) dollars from the Road Machinery Fund to the Machinery Account, and act thereon.

Article 16. Recommended by the Finance Committee.

Article 17. To see if the Town will vote to instruct the Selecmen to petition the Director of Accounts for the installation of an accounting system as provided by Section 35, Chapter 44, General Laws.

Article 17. Recommended by the Finance Committee.

Article 18. To see what action the Town will take on the Proposed By-Laws for the Town of Carver, and act anything thereon.

PROPOSED BY-LAWS FOR THE TOWN OF CARVER

Article I

Section 1. The annual town meeting shall be held for the election of officers on the first Monday in March at 12 noon. The polls shall be open for at least seven hours, and as soon as the ballots are counted the meeting will be adjourned to the following Saturday at 2 P.M. for the transaction of municipal business.

Section 2. Twenty-five votes shall be necessary to constitute a quorum at town meetings provided that a number less than a quorum may from time to time adjourn the same.

Section 3. All articles in the warrant shall be taken up in order until all articles in the warrant have been acted upon.

Section 4. No motion to adjourn without day shall be in order until all articles in the warrant have been acted upon.

Section 5. In all town elections the counting of ballots shall not begin until the polls have been open for four hours.

Section 6. The check list shall be used in admitting voters to a town meeting, except that non-voters may be admitted to a defined and separate portion thereof, and nonvoters may address the meeting if the town so votes.

Section 7. The articles to be acted upon at the annual town meeting in March shall be in the hands of the Board of Selectmen on or before February first preceeding said meeting.

Article II

The town warrant shall be posted in the Town Hall and in each Post Office in town.

Article III

The moderator shall be elected for one year, the name to appear on the official ballot.

Article IV

The powers and duties of the presiding officer not especially provided for by law shall be determined by rules of practice as contained in Cushing's Manual so far as they are adapted to the conditions and powers of the town.

Article V

Section 1. The Board of Selectmen shall consist of three members, each elected for a three year term, one term expiring annually.

Section 2. The Board of Selectmen shall serve as the Board of Public Welfare.

Section 3. The Board of Selectmen shall have the power to prosecute, compromise or defend suits for or against the town and employ counsel at any time if in its judgment the interests of the town so require.

Section 4. It shall be the duty of the Board of Selectmen to transmit a copy of any warrant for any regular or special town meeting as soon as said warrant is drawn, to the Finance Committee.

Section 5. The Board of Selectmen shall appoint an Inspector of Wires, as provided in Chapter 66, Section 32 of the General Laws, as amended by Chapter 529 of the Act of 1949.

Section 6. The Board of Selectmen shall notify all department heads and all committees appointed or elected by the town of any special town meetings at least seven days prior to the posting of the warrant of said meeting.

Article VI

The following officers are to be chosen from the floor at the annual town meeting to serve a one year term:

> Three field drivers and pound keepers Three surveyors of lumber and measurers of wood Three fence viewers Three members to serve as a herring committee.

Article VII

Section 1. The Finance Committee shall consist of nine members, each of whom shall be appointed for a term of three years, provided that the Finance Committee as presently constituted shall continue in office until the expiration of their respective terms, and when the membership falls below nine the Moderator shall fill such vacancies. No member of the Finance Committee, after having served two consecutive terms, shall be eligible for appointment to said Committee until one year shall have passed.

Section 2. All qualified voters on the voting list for the Town of Carver are eligible for appointment to the Finance Committee except that no elected or appointed town officer is eligible for membership on such committee, and no member of a special town committee shall have a vote as a member of the Finance Committee on any matter pertaining to the duties of that special committee. Section 3. On or before the first day of May it shall be the duty of the Moderator to call the organization meeting of the Finance Committee.

Section 4. The Finance Committee at its organizational meeting shall elect a chairman, vice-chairman, and a secretary, all who shall serve until the next annual town meeting. Within ten days after the organization the secretary shall notify the Town Clerk in writing of such organization.

Section 5. Any vacancies occurring in the Finance Committee shall be filled by the Moderator within seven days of the notification in writing of said vacancy by the chairman of the Finance Committee.

Section 6. Three consecutive absences of any member of the Finance Committee at a duly called meeting, except for reason of sickness, shall constitute a vacancy.

Section 7. The report of the Finance Committee to the annual town meeting shall be in print and shall contain the request of all departments and the appropriations recommended by the Finance Committee, together with such recommendations on other matters in such warrant as in its judgment should be brought to the attention of the town, but reports to all other town meetings shall be in such form as the Finance Committee shall deem advisable.

Section 8. The Finance Committee shall have authority at any time to investigate the town's accounts and management of any department, and the books, records and accounts of all departments of the town shall be open to the inspection of the Finance Committee, or any of its authorized sub-committees, or any person authorized to act for said committee. Section 10. The members of the Finance Committee excepting chairman and secretary shall serve without pay, but may be reimbursed for actual expenses incurred in the discharge of their duties. Salary for chairman and secretary of said committee to be set by a vote of the town.

Section 11. On or before December 21 of each year the Officers, Boards, or Committees having charge of expenditures of the town's money shall transmit, in writing, to the Finance Committee their estimate of expenditures for the conduct of their departments for the next municipal year. On or before January 15 of the following year these same officers shall present to the Finance Committee, in writing, a detailed list of the expenditures for the year previous.

Article VIII

A summary of all town meetings and results of all elections shall be included in the annual town report.

Article IX

Valuation lists for the Town of Carver shall be published every five years unless otherwise voted by the town.

Article X

Any of these by-laws may be modified or amended or repealed at any annual town meeting by a majority of votes of those present and voting, any article or articles for the purpose having been inserted in the warrant for such meeting.

Article XI

No person shall commence within the town any new construction of a building of any type or description, or commence major alterations, additions or improvements of any existing building, without first having applied for and obtained a permit therefor from the Board of Selectmen. No permit shall be required for ordinary repairs or renovations. The application shall be in triplicate and contain information as to the name and address of the applicant and the name and address of the owner, and the nature and location of construction or proposed work. One copy of the application shall be kept on file, one copy given to the applicant, and one copy given to the Board of Assessors. The Selectmen shall grant the permit in written or printed form within fifteen days of the filing of the application if all information required is given. The permit shall become void unless operations thereunder are commenced within six months of the date of issuance.

Any person who violates any provision of this law shall be subject to a fine of not more than twenty dollars (\$20.00) to be paid to the Treasurer of the town.

Article XII

All by-laws in force are hereby repealed.

Article 18. Recommended by the Finance Committee.

Article 19. To see if the Town will vote to raise and appropriate the sum of three hundred eighty-six dollars and thirty cents (\$386.30) to pay the following unpaid bills of 1957, namely:

Article 19. Recommended by the Finance Committee.

Article 20. To see if the Town will vote to raise and appropriate a sum of money not to exceed three thousand (\$3,000.00) dollars for Assessors' Plans, such sum to be used by the Board of Assessors together with any unexpended amounts appropriated for the purpose and act anything thereon or thereto. (by the request of the Finance Committee)

Article 20. Recommended by the Finance Committee.

Article 21. To see if the Town will vote to appropriate from the Lakenham Cemetery Sale of Lots Fund the sum of two hundred and seventy (\$270.00) dollars for the purpose of erecting a Tool Shed at Lakenham Cemetery.

Article 21. Recommended by the Finance Committee.

Article 22. To see if the Town will vote to appropriate from the Lakenham Cemetery Sale of Lots Fund the sum of eighty (\$80.00) dollars for improvements on the Thomas Tillson and Lucinda Tillson Lots at Lakenham Cemetery.

Article 22. Recommended by the Finance Committee.

Article 23. To see if the Town will vote to raise and appropriate the sum of two hundred fifty (\$250.00) dollars for the purpose of putting the field in the rear of the Central Fire Station into condition for carrying on athletic activities, the expenditure of such sum of money to be under the direction of the Board of Selectmen and a committee of three elected from the floor in Town Meeting and act thereon.

Article 23. Recommended by the Finance Committee.

Article 24. To see if the Town will vote to raise and appropriate the sum of nine hundred ninety-three (\$993.00) dollars for Tremont Street Land Damage, to meet the Town's share of the additional award ordered by the Plymouth County Commissioners' Decree No. 1108.

Article 24. Recommended by the Finance Committee.

Article 25. To see if the Town will vote to return to the treasury the following unexpended appropriation balances, namely:

Article 25. Recommended by the Finance Committee.

Article 26. To see if the Town will vote to return to Lakenham Cemetery Sale of Lots Fund the unexpended appropriation balance of twenty-eight dollars and ninety-four cents (\$28.94) in Lakenham Cemetery Driveways Account.

Article 26. Recommended by the Finance Committee.

Article 27. To see if the Town will vote to return to Central Cemetery Sale of Lots Fund the unexpended appropriation balance of twelve dollars and thirty cents (\$12.30) in Central Cemetery Driveways Account.

Article 27. Recommended by the Finance Committee.

Article 28. To raise and appropriate such sums of money as may be necessary to defray town charges for the ensuing year.

Article 28. Recommended by the Finance Committee.

And you are directed to serve this warrant by posting attested copies thereof, at the several places designated by vote of the Town, seven days at least before the time of holding said meeting.

Hereof fail not, and make due return of this warrant, with your doings thereon, to the Town Clerk at the time and place of Meeting aforesaid.
