TOWN ELECTION MARCH 5, 1960

The Annual Town Meeting for the election of officers, etc. was held at the Governor John Carver School on March 5, 1960. The meeting was called to order at 12:00 o'clock, noon, and the polls were closed at 8:00 o'clock P.M. The ballot box registered a total of 479 votes cast at the close of the polls. ANNUAL TOWN MEETING

March 12, 1960

The Annual Town Meeting was called to order at 2:00 o'clock, P.M., on Saturday, March 12, 1960, by the Moderator, Bradford H. Cole. The Invocation was given by the Rev. Fr. Leo V. Dwyer of Our Lady of Lourdes Church. Dana E. Thomas and Raymond A. Parent were appointed Tellers to count the votes, and were sworn to the faithful performance of their duties. Thereupon, the meeting proceeded to act upon the Articles in the Warrant, beginning with Article 2 (Article 1, relating to the election of officers having been disposed of on March 5, 1960) as follows:

Article 2: VOTED to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1960, and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 3: VOTED to appropriate the sum of \$1500.00 from free cash in the town treasury for the sole purpose of meeting charges against the Cemetery funds in the town treasury.

Article 4: VOTED that the Dog Fund be transferred to the Library Account.

Article 5: VOTED to raise and appropriate the sum of \$100.00 for the use of Plymouth County Aid to Agriculture. Mr. Earl E. Boardway was unanimously chosen Town Director, County Aid to Agriculture.

Article 6: Voted to Transfer from the Overlay Reserve Account to the 1960 Reserve Account the sum of \$2500.00, and to transfer the additional sum of \$2500.00 from the available funds in the treasury to the said 1960 Reserve Account.

Article 7: VOTED to fix the salary and compensation of all elective officers of the Town as provided by General Laws, Chapter 41, section 108, namely: Highway Surveyor, \$1.75 per hour; Town Treasurer, \$1700.00; Town Clerk, \$800.00; Collector of Taxes, \$1700.00; Moderator, \$20.00 for the Annual Town Meeting, and \$5.00 for each Special Town Meeting; Members of the School Board, \$3.00 for each meeting, plus \$1.50 per hour for all meetings of over 2 hours. All other elective Town Officers, \$1.50 per hour.

Article 8: The following officers, not elected by ballot, were unanimously elected: Fence Viewers: Dana E. Thomas, Raymond A. Parent, and Louis A. Bryant, Jr.; Field Drivers and Pound Keepers: Dana E. Thomas, Raymond A. Parent, and Louis A. Bryant, Jr.; Surveyors of Lumber and Measurers of Wood: Toivo J. Kallio, Bradford H. Cole, Homer F. Weston. Herring Committee: Frank A. Mazzilli, Gordon W. Fountain, Clark A. Griffith.

Article 9: VOTED to raise and appropriate the sum of \$7,000.00 for Chapter 90 Highway Construction, and to transfer the sum of \$21,000.00 from free cash in the treasury to meet the State's and County's shares of the cost of work, the reimbursements from the State and County to be restored. upon their receipt, to free cash in the Treasury.

Article 10: VOTED to raise and appropriate the sum of \$6,600.00 for Chapter 81 Highways, and to transfer the sum of \$18,150.00 from free cash in the treasury to meet the State's share of the cost of the work, the reimbursements from the State to be restored, upon their receipt, to free cash in the treasury.

Article 11: VOTED to authorize the Cemetery Commissioners and the Park Commissioners to employ themselves as laborers in the cemeteries and parks.

Article 12: VOTED to raise and appropriate the sum of \$650.00 to be used to pay for all private work and materials in the Town Cemeteries, such as, opening graves, building foundations, etc., as according to General Laws, Chapter 44, section 53.

Article 13: To hear the report of any standing committees, etc.

Mr. Alan I. Dunham, Chairman of the Building Code Committee, presented a report setting forth that the Committee had met several times, and that a proposed Code would soon be ready for presentation to the voters at a Special Town Meeting. The Committee consists of Alan I. Dunham, Chairman, Louis A. Bryant, Jr., Simon Majahad, Francis X. Mills and John A. Shaw. The report was unanimously accepted.

Mr. John A. Shaw presented a report of the Town Beach Committee wherein it was set forth that after various attempts to find land for sale at Carver ponds, the Committee found that the only possibility was to acquire a parking lot site opposite the existing right of way to Dunham's Pond, on land owned by the Federal Cranberry Company. It was the recommendation of the Committee that the Board of Selectmen take appropriate action toward making arrangements for the acquisition of this land. The members of this Committee are George Harriman, Chairman, Mary Gomes, Robert Hitchcock, Joyce Dunham and John A. Shaw. The report was unanimously accepted.

Mr. Erwin K. Washburn presented a report of the Regional School District Planning Committee, setting forth that meetings had been held with the Plymouth School Building and Plymouth School Committees, with a view toward forming a Ply-

mouth-Carver Regional School District. It was the opinion of the Regional Committee that if the Town of Carver is prepared to solve the secondary school problem, it would do well to work for a Regional High School with the Town of Plymouth. The report was unanimously accepted.

Article 14: VOTED to raise and appropriate the sum of \$3,000.00 for Assessors' Plans.

Article 15: VOTED to raise and appropriate the sum of \$793.00 for Main Street Land Damage.

Article 16: VOTED to raise and appropriate the sum of \$373.49 to pay a 1959 Veterans' Benefits unpaid bill.

Article 17: (Passed)

Article 18: VOTED to take the sum of \$20,000.00 from available funds to reduce the tax rate.

Article 19: VOTED to appropriate the sum of \$5,000.00 from free cash, and an additional sum of \$5,000.00 from the Road Machinery Fund for the purpose of purchasing a new Tractor Shovel for the Highway Department, and to authorize the Selectmen to dispose of the present Tractor Shovel and apply the proceeds thereof to the purchase price of the new Tractor Shovel.

REPORT OF THE HIGHWAY SURVEYOR

To the Honorable Board of Selectmen

Carver, Mass.

Gentlemen:

The Chapter 81 allotment of \$24,750.00, of which the town appropriated \$6,600.00 and the State \$18,150.00, must be used for maintenance purposes only. Out of this amount approximately \$13,462.00 was used to purchase and apply 40,982 gallons of asphalt for sealing the streets. The remainder of the account was used for patching, catch basins, culverts, shoulders and other miscellaneous maintenance operations.

The Chapter 90 allotment of \$28,000.00 of which the town appropriated \$7,000.00, the County \$7,000.00 and the State \$14,000.00 was used on two streets. Twenty thousand dollars was allotted for Main Street, Route 58, where 3550 feet of road was completely built to a width of 26 feet with proper drainage, 9 inches of new gravel and approximately 1475 tons of Bituminous Concrete Type I surface applied.

The remaining \$8,000.00 was spent on Tremont Street where 1400 feet of road built the previous year was topped with 3 inches of Bituminous Road Mix Type C-1. An additional 1400 feet of the existing 18 foot road was widened to 26 feet with 9 inches of gravel foundation and a Bituminous Road Mix Type C-1 used on the widened area and existing road as a base and leveling course.

There were 8 visits on off duty time, 17 admissions, 16 discharges, and 2 expirations. One trip was made to the Plymouth County Hospital, Hanson to transfer patient to Fair Haven's Rest Home, Middleboro. One trip was made to ac-

company an infant to the Floating Hospital, Boston.

One polio clinic held in 1960 as follows:

June 9, 62 doses administered by Dr. Mayo.

The following is my report on school health for 1960:

33 pre-school visits and 159 home school visits were made. Of these 5 required stitches, 1 asthma attack, 8 excluded with impetigo, 7 excluded with conjunctivitis, and 1 excluded with German Measles. All known cases of communicable diseases were reported to the Board of Health.

105 physical examinations were done by Dr. Mayo in September and October, vision and hearing tests were completed in all grades, and heights and weights were recorded for all pupils. All children requiring medical or dental care were given notices to take home.

Three pair of eyeglasses for school children were donated by the Middleboro Community Fund. The Community Service Group, Carver, donated new clothing for school children, new scales for the Health Room, and the cost of a tooth extraction for a school child.

At school, \$9.57 was collected to help support the Plymouth County T. B. program by selling pins in December.

I wish to thank the Public Health Nurse Committee, school principal, teachers, and parents for their help and cooperation.

REPORT ON PUBLIC WELFARE

To the Honorable Board of Public Welfare

Carver, Mass.

Gentlemen:

I herewith submit my report on Old Age Assistance, Medical Assistance for the Aged, Aid to Dependent Children, Disability Assistance, and Public Welfare for the fiscal year ending December 31, 1960:

In the Old Age Assistance category of Public Assistance, the year opened with forty-one cases receiving this type of assistance. On September 30, 1960, five cases were closed as they became eligible for the new Medical Assistance for the Aged program effective October 1, 1960. The year closed with thirty-seven cases being granted Old Age Assistance. Expenditures decreased from \$49,255.70 to \$44,839.11, but five cases normally aided under this program were included in the new Medical Assistance for the Aged program.

Aid to Dependent Children cases totalled two on January 1, 1960, and one case remained at the close of the year. The average number of cases was three, and the number of children aided were eight. Expenditures increased from \$2,900.38 to \$3,872.57.

On January 1, 1960, there was one Disability case, and at the end of the year there were two cases. Expenditures decreased from \$3,242.80 to \$1,462.95 primarily because the cases involved were not nursing home cases.

Eleven cases received short term assistance under the Public Welfare program during the year with reimbursement from either state or other cities or towns in seven cases. At the close of the year, three cases were being aided. Expenditures decreased from \$4,591.95 to \$1,141.06 as all cases were of very short duration.

A new program entitled "Medical Assistance for the Aged" was enacted and became effective as of October 1, 1960. The Act prohibits the granting of Old Age Assistance in nursing homes, chronic hospitals, and public medical institutions, where the patient needs no other residence. The basic formula for this particular type of aid apportions the cost as follows: Federal 50%, state 33 1/3%, local 16 2/3%. We can use the federal funds, but the state funds must be held as an estimated receipt for the following year.

As the program has been in effect only since October 1, 1960, it is difficult to estimate how many elderly folks would be apt to seek help from the new program set in motion by the Congress last year and adopted in Massachusetts which has been one of the first states taking advantage of its provisions. Under the new program, any person 65 or over with \$2,000 or less in collateral assets can qualify. Persons may own their own homes and still qualify if they are not deriving rental income from the property. There are no lien provisions in the law. It is entirely a MEDICAL program. From October 1 to December 31, 1960, expenditures were \$3,045.21. Six cases are currently being aided under this program.

Effective July 1, 1960, payments under Old Age Assistance, Aid to Dependent Children and Disability Assistance were increased by 5.2%. This requirement was brought about by an increase in the cost of living index as reported by the Division on the Necessaries of Life in accordance with Chapter 118A.

Town money is being saved at the rate of approximately \$80 a month through the efforts of this agency in keeping close check on the earnings of children of Old Age recipients who must contribute toward the support of these recipients if the amount of their earning is sufficient.

I wish to express my appreciation to the Board members for their cooperation during the year.

REQUIREMENTS FOR ADMISSION TO FIRST GRADE

1. A child who will reach his sixth birthday on or before Dec. 31st may be admitted to the first grade in September, 1961, without examination.
2. A child whose sixth birthday occurs in the two months after December 31st may be admitted the preceding September if readiness for school can be demonstrated by means of appropriate tests. Parents having a child whom they wish to be examined under this rule are required to make application to the Superintendent of Schools on or before August 15 preceding the opening of school in September. A special form will be furnished for this purpose upon written request from the parent.

CLOSING OF SCHOOLS

It is the policy of the School Committee to close school only under the severest weather conditions or on such occasions when it is dangerous to operate school buses. At other times, parents are expected to use their own judgment in sending children to school. When a decision to close schools has been made, this information will be broadcast through the courtesy of radio stations WBZ and WNBH. The no-school signal will also be given on the local fire warning apparatus. This signal is two short blasts sounded three times.

It should also be remembered there are occasions when under the stress of storm conditions the telephone service cannot keep up with the demands and it is impossible to reach radio stations in order to have an announcement made.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the Members of the

Carver School Committee:

Herewith is submitted the report of the Superintendent of Schools for the year 1960 and with it the customary reports and statistical tables. Your attention is called to the report of the principal in which he touches upon enrollment and some of the aspects of the school work for the year.

Generally speaking, we see a trend toward increased enrollment. There has been a slow but steady gain since the opening of the session in September and signs point to a continuation of the trend. Moreover, the latest information concerning the incoming first grade for the next year shows the

need for two straight sections of this grade for the first time since the new school building has been occupied. While the grand total of children reported in the census is not too much greater than that of last year, it is significant that there are more children of ages 7 to 16 in the town. This will reflect an increase in the Chap. 70 aid greater than shown in the table of estimated receipts for 1961.

The prospect of Carver being able to occupy a high school in 1962 in which it shall be a part owner in the regional plan with Plymouth is a significant step toward settling, for all time the secondary problem for Carver. To review the past a little, it is within the memory of this superintendent when Carver pupils attended Middleboro High School. In fact, at the time of his arrival on the scene in 1941, Carver was in the process of withdrawing from Middleboro and entering Plymouth. There were those who said there would never need to be any further change but it had to come, nevertheless, and Carver entered the Silver Lake Regional High School. After a few years more, the word came through that this school would have to be occupied to the limit by the residents of that area and once more Carver was on the march looking for new accommodations. And so Carver finally completed the circle and re-entered Middleboro High School. Word in our files from the Middleboro department gives the warning that we cannot expect a home there, except for the seniors, after June, 1962, as their space requirements will be more than existing accommodations can offer for their own pupils. It is a fortunate thing that the Regional plan has been accepted and carried forward with Plymouth.

It is beneficial to both parties to the agreement; academically, financially, and, in fact any way one chooses to look at it. It ends the uncertainty for Carver and permits the town to take its rightful place in the responsibility for ownership of the plant as well as instruction for its secondary age youth.

In anticipation of the close relationship of the Plymouth and Carver school systems in the years to come, the Committee, Principal and Superintendent have been reviewing the course offerings for the grades seven and eight for the purpose of planning extensions and improvements therein. We expect to make the initial start next year when school sessions are resumed in September. Plans have been made for joint employment of teachers in the special areas, as Music, Art, Home Economics and Industrial Arts and the two sections of grade eight wherein the program followed by each of the two groups will be planned in relation to ability and future plans.

In order to do this, added building space will be required. For this reason, it was decided to renovate the Benjamin Ellis building in South Carver, so that primary groups could be placed there, thereby relieving classroom space at the Governor John Carver School. Plans for the program include the extended use of the library and added efforts to build up the reference book equipment there. Time of a staff member will include some provision for librarian's work with the older grades.

A number of staff changes must be incorporated into the record for the year, as follows:

Miss Susan Bailey, resigned to travel

Mrs. Margaret Atwood, resigned, to be at home

Mr. Edward Morgan, a graduate of Stonehill College, 1959, to teach grades 7 and 8

Mr. William Levesque, a graduate of Bridgewater Teachers College, 1960, to teach grade 8

Mrs. Harriet Campbell, Transferred from the Jr. High to the fourth grade.

One other change in the faculty deserves more than passing mention. Mr. Henry M. Shaw, a teacher in Carver since 1937 and principal since 1943, decided to heed the call to return full-time to the classroom and resigned his position as principal in June, 1960, to accept an appointment as teacher of advanced Junior High pupils at the Apponequet Regional High School, Lakeville. Carver has many reasons to reflect gratefully upon Mr. Shaw's many years of service to the parents and children of the town.

It is a rare situation when a town has a school man who will devote so many years to a single administrative unit. Mr. Shaw is now a tradition in Carver but his influence shall be felt for many years to come, in his help with the Building Committee, his care and concern in planning the work of the school, his genuine interest in the children and their progress through school, and with it all, his rare sense of humor and friendship to all. Children will forget some of the things they have learned in school but they will not forget the principal who was in charge of the school while they were there.

Mr. Richard J. Eldridge was appointed to succeed Mr. Shaw. Mr. Eldridge has taught in Carver since 1955 in various grades, 5 to 8. In his association with us he has demonstrated the qualities of leadership we want and we are happy to have had Mr. Eldridge available for appointment.

High school graduates living in Carver now have a chance at scholarship aid. During the course of the year we have investigated the provisions of the will of the late Philip Jackson of Plymouth who provided for scholarship aid to "a young man" who has expressed the intention to attend Massachusetts Institute of Technology or the University of Massachusetts". The scholarship is to rotate in the order of: Plymouth, Kingston and Carver. The first opportunity for a Carver resident will come in 1961. Awards appear to be amounting to between \$100.00 and \$150.00.

Among the miscellaneous items, bids were sought for the feeder route transportation at South Carver, and also bids for fuel oil and gas services, as is customary each year. Insurance coverage on the property was extended further this year to include protection against vandalism and malicious mischief. A small insurance claim was filed as a result of the September hurricane, although the damage was extremely light. Repairs have been continued as needed to the property. A complete examination was conducted of the heating system at the Governor John Carver School and new controls were installed at the boiler for better service. The wells required further attention this year and, although no action was taken, consideration was given to other methods of obtaining water for the school. A good start has been made in developing the grounds in the immediate area around the building. This was accomplished through the joint use of funds from the school budget, gifts from the Carver Kiwanis Club, The Community Service Group of South Carver and a portion of the profits from the annual school magazine fund-raising drive. This evidence of public spirit and interest has been much appreciated and the courtesy is acknowledged through this report.

A project of some major dimensions was undertaken in the renovation of the Benjamin Ellis school building so that it would be ready for use next September. The cost was met through surplus funds which were seen in the school budget in the last months of the year. The expenses under the costs of instruction and in the area of the budget known as auxiliary agencies has not gone to the anticipated figure so that it seemed possible to accomplish this without having to ask additional funds another year. The matter was carefully discussed with a sub-committee of the Finance Committee and plans were made to go ahead with the work in December. The work included repairs and improvements in the heating system, revised lighting in the classrooms and corridor, new floor covering in the corridor and classrooms and redecoration. The

building is now attractive and ready for use in all respects. Plans will provide for the extension of the lunch service to this school when it is open.

An evening Practical Arts class was organized for those who wished it in Decorated Ware 1, with the approval of the school committee, using George-Barden funds for the teacher's salary which were already on hand in the treasurer's accounts.

As the new year comes up, we look forward to a new era in Carver Educational plans, both in the local school and in the high school areas. We have appreciated the opportunity to serve in Carver; we are happy to see the final definite plans for secondary education of Carver youth. The Committee members are to be commended for their consistent pursuit of the best possible plans for education of children in Carver.

REPORT OF THE PRINCIPAL OF THE
GOVERNOR JOHN CARVER SCHOOL

To the Superintendent of Schools:

I hereby submit my report as principal of the Governor John Carver School for the calendar year 1960.

The school year, ending in June, numbered 178 days. During this period 334 names appeared in the school registers, although at no time was the enrollment greater than 321. The year ended with an enrollment of 319.

The average attendance for the year was 161 days with 15 children having perfect attendance.

Achievement tests were administered during the month of May. Once again our grades scored well. All but two grades exceeded the national average. These two grades failed to reach this average by only two months.

Graduation exercises were held on Thursday evening, June 16. Two awards were made to those who had written the most deserving essays on the Hall of Fame. The American Legion Essay Award was presented to Beverly Johnson, and the Kiwanis Essay Award went to Joyce Sand. Mr. Erwin K. Washburn presented diplomas to the following graduates:

During the past year Mrs. Margaret Atwood and Miss Susan Bailey resigned their positions as teachers. Mrs. Harriet Campbell took over the duties of Mrs. Atwood. Mr. Edward Morgan was then engaged to teach English, Literature and Physical Education in the Junior High program.

Mr. Henry M. Shaw resigned as Principal of the Governor John Carver School after 23 years of faithful service to the Town of Carver. The Staff and I wish to take this opportunity to express our appreciation for his outstanding service. It has been a pleasure to have him as our leader, because of his enthusiasm, energy, and high educational ideals. The school children have also expressed their appreciation by donating a picture of Mr. Shaw and a plaque in recognition of his faithful service.

The School year 1960 to 1961 opened with an enrollment of 320. This figure has been somewhat unstable during the fall. The figure dropped to 317 and then rose until it reached 326 at the end of December. It is expected that this will be increased in the next month.

Only one addition was made to the teaching staff this fall.

Mr. William Levesque was engaged to teach Science and Geography and has started this work with much enthusiasm and ability.

We are grateful to the South Carver Community Service Group for its contributions to the school program. This year the club has made possible the purchase of an aquarium for our Science Department and some scales for the Nurse's office. The combined efforts of the Community Service Service Group Kiwanis Club also made possible much needed landscaping at the school. It is encouraging to see local groups showing such interest in our School and its program.

As a part of American Education Week, parents and Town Officials were invited to visit the school lunch program and eat with the children. A typical school lunch was served each day. Sixty-three people responded enthusiastically to the invitation.

Plans are being made for the preparation of a handbook for Junior High School students. By this method we expect to inform the incoming seventh graders as to what is expected of them and to help orient them to their new program.

In the future a general study of our reading program will be made also. This study will be made to determine the type of program which will be most beneficial to the pupils, and to determine what reading system or systems will facilitate this type of program.

The profits from these activities are placed in the School Fund. The fund is separate from Town Funds, and is used at the discretion of the School. The money in the fund is used to buy equipment, books, and mainly to provide money for the Eighth Grade's trip to Boston, which has become an annual affair.

The School Lunch Program is a valuable asset to the health of our pupils. Our lunch program, under the capable direction of Mrs. Irene Williams, continues to be self-supporting and to meet the nutritional standards set up by the National School Lunch Program. During the year the school lunch room was inspected by State Inspectors from the Office of School Lunch Programs. The result of this inspection was very satisfactory.

The American Legion, The South Carver Community Group, the Tuesday Club, as well as private donors, graciously made contributions to provide free lunches for children. The financial summary of this program for the year is as follows:

In the name of the Commonwealth of Massachusetts, you are directed to notify and warn the Inhabitants of the Town of Carver qualified to vote in elections and in town affairs to meet at the Governor John Carver School House in said Carver on Saturday, the Fourth day of March, 1961, at twelve o'clock noon, then and there to act on the following article, namely:

Article 1. To choose all necessary town officers, to be voted for all on one ballot, viz.: One Moderator, Three Auditors, Three Constables, One Tree Warden, One Highway Surveyor, each for one year. One Assessor, One Selectman, One School Committeeman, One Cemetery Commissioner, One Park Commissioner, Two Library Trustees, each for three years. One Park Commissioner (to fill vacancy), for one year. One member of the Regional District School Committee, for three years.

The Polls will be open for at least seven hours.

And you are directed to further notify said Inhabitants of said Town that as soon as the ballots have been counted the meeting will adjourn to Saturday, March 11, 1961, at two o'clock, P. M., and at that time will reconvene at said Governor John Carver School House, then and there to act on the following articles, namely:

Article 2. To see if the Town will vote to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning January 1, 1961 and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with Section 17, Chapter 44, General Laws.

Article 2. Recommended by the Finance Committee.

Article 3. To see if the Town will vote to appropriate a sum of money not to exceed fifteen hundred (\$1,500.00) dollars from free cash in the Town Treasury for the sole purpose of meeting charges against the Cemetery funds in the Town Treasury.

Article 3. Recommended by the Finance Committee.

Article 4. To see what disposition the Town will make of the Dog Fund.

Article 4. Recommended by the Finance Committee that the Dog Fund be applied to the Library Account.

Article 5. To see what amount the Town will vote to raise and appropriate for the use of Plymouth County Trustees for County Aid to Agriculture and choose a Town Director as provided in Section 41 and 45 of Chapter 128 of the General Laws and act thereon.

Article 5. Recommended by the Finance Committee that the sum of \$100.00 be raised and appropriated for County Aid to Agriculture.

Article 6. To see if the Town will vote to transfer from the overlay reserve account to the 1961 reserve account the sum of five thousand (\$5,000.00) dollars.

Article 6. Recommended by the Finance Committee.

Article 7. To see if the Town will vote to raise and appropriate the sum of eleven hundred (\$1,100.00) dollars and to transfer the sum of twenty-nine hundred (\$2,900.00) dollars from the Machinery Fund for the purpose of purchasing a new dump truck for the use of the Highway Department.

Article 7. Recommended by the Finance Committee.

Article 8. To see if the Town will vote to fix the salary and compensation of all elective officers of the Town as provided by General Laws, Chapter 41, Section 108, as amended, namely:

Moderator \$20.00 for the Annual Town Meeting, and \$5.00 for each Special Town Meeting.

Article 8. Recommended by the Finance Committee

Article 9. To choose all necessary Town Officers not elected by ballot.

Article 10. To see if the Town will vote to raise and appropriate the sum of eight thousand (\$8,000.00) dollars for Chapter 90 Highway Construction, and to transfer the sum of twenty-four thousand (\$24,000.00) dollars from Free Cash in

the Treasury, to be restored, upon their receipt, to free cash in the Treasury and act thereon.

Article 10. Recommended by the Finance Committee.

Article 11. To see if the Town will vote to raise and appropriate the sum of six thousand six hundred (\$6,600.00) dollars for Chapter 81 Highways, and to transfer the sum of eighteen thousand one hundred fifty (\$18,150.00) dollars from the Treasury to meet the State's and County's shares of the cost of work, the reimbursements from the State and County to be restored, upon their receipt, to free cash in the Treasury, and act thereon.

Article 11. Recommended by the Finance Committee.

Article 12. To see if the Town will vote to authorize the Cemetery Commissioners and the Park Commissioners to employ themselves as laborers in the cemeteries and parks, and act anything thereon or thereto.

Article 14. To hear the report of any standing committees and act anything thereon or thereto and establish any new committees.

Article 14. Recommended by the Finance Committee.

Article 15. To see if the Town will vote to raise and appropriate a sum of money not to exceed three thousand (\$3,000.00) dollars for Assessors' Plans, such sum to be used and expended by the Board of Assessors and act anything thereon or thereto.

Article 15. Recommended by the Finance Committee.

Article 16. To see if the Town will vote to appropriate from the Lakenham Cemetery Sale of Lots Fund the sum of three hundred (\$300.00) dollars for the purpose of filling in deep walks around burial lots—Loam, Fertilizer, Lime, Lawn seed, and Labor, and act anything thereon or thereto.

Article 16. Recommended by the Finance Committee.

Article 17. To see if the Town will vote to raise and appropriate the sum of one thousand one hundred forty-one dollars and eighty-six cents (\$1,141.86) to pay the following unpaid bills, namely:

Article 17. Recommended by the Finance Committee.

Article 18. To raise and appropriate such sums of money as may be necessary to defray town charges for the ensuing year.

Article 19. To see if the Town will vote to take from available funds in the treasury, a sum of money for the purpose of reducing the tax rate, or take any action in relation thereto.

Article 19. Recommended by the Finance Committee.

Article 20. To see if the Town will vote to accept Section 42 of Chapter 48 of the General Laws of this Commonwealth which provides for the establishment of a Fire Department and appointment of a Fire Chief under the direction of Selectmen, and act anything thereon.

Article 20. Recommended by the Finance Committee.

Article 21. To see if the Town will vote to raise and appropriate the sum of nine hundred (\$900.00) dollars for the purpose of purchasing and installing a 2,000 gallon capacity underground gasoline storage tank, together with pump, said tank and pump to be located on Town property adjacent to the Town Hall.

Article 22.
