




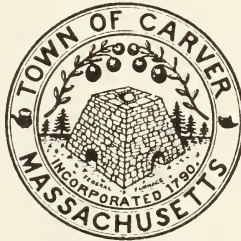

ANNUAL TOWN MEETING

March 11, 1967

The Annual Town Meeting of the Inhabitants of the Town of Carver was held at the Gov. John Carver School on Saturday, March 11, 1967. The meeting was called to order at 2:00 o'clock, P.M., by the Moderator, Thomas C. Barham, there being a quorum present. The Invocation was given by Father James P. Donohue of Our Lady of Lourdes Church at North Carver. Reading of the Warrant being dispensed with and Article 1, relating to the election of officers, having been disposed of at a prior meeting, the meeting thereupon proceeded to act upon the Articles in the Warrant as follows:

Article 2. VOTED to authorize the Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue for the financial years beginning January 1, 1967 and January 1, 1968, in accordance with the provisions of General Laws, Chapter 44, Section 4, and to renew any note or notes as may be given for a period of less than one year, in accordance with the provisions of General Laws, Chapter 44, Section 17.

Article 3. VOTED, unanimously, to raise and appropriate the sum of \$29.42 to pay the following unpaid bill of 1966, namely: Plymouth Oil Company (Gasoline Account) - \$29.42.

Article 4. VOTED, unanimously, to fix the salary and compensation of all elective officers of the Town, such salaries to be retroactive to January 1, 1967, as provided by General Laws, Chapter 41, Section 108, as amended, namely:

Article 6. VOTED, unanimously, to authorize the Tree Warden, Cemetery Commissioners and Park Commissioners to employ themselves as laborers in the cemeteries, parks, and tree departments.

Article 7. VOTED, unanimously, to transfer from the Overlay Reserve Account to the 1967 Reserve Account the sum of \$10,000.00.

Article 8. VOTED, unanimously, that the County Dog Fund be added to the Library Account (\$786.94)

Article 9. VOTED, unanimously, to raise and appropriate the sum of \$100.00 for the use of the Plymouth County Trustees for County Aid to Agriculture, and to choose a Town Director as provided in Section 41 and 45 of Chapter 128 of the General Laws. Thereupon, Mr. Roger V. Weston was duly elected Town Director County Aid to Agriculture

Article 10. VOTED, unanimously, to raise and appropriate the sum of \$4000.00 for Assessors' Plans, such sum to be used and expended by the Board of Assessors.

Article 11. VOTED to choose all necessary Town officers not elected by ballot. Thereupon, the following officers were unanimously elected:

Field Drivers and Pound Keepers: Theodore E. Halunen, Raymond A. Parent, Arnold T. Sherwood.

Surveyors of Lumber and Measurers of Wood: Toivo J. Kallio, Homer F. Weston, Bradford H. Cole.

Herring Committee: Frank R. Mazzilli, Clark A. Griffith, Bradford H. Cole.

Article 12. VOTED, to hear the reports of any standing committees and to establish any new committees. Thereupon, the following reports were heard and accepted:

1. Mr. Erwin K. Washburn reporting for the School Building Committee stated that the new addition was almost complete, and that the building was open for inspection.

2. Mr. Erwin K. Washburn, reported for the Vocational School Study Committee that two other towns in the group had turned the proposal down; therefore, Carver could forget the proposal at this time, and that the Committee would continue its study of the matter.

3. Mr. Frank R. Mazzilli reported for the Plumbing Code Study Committee that the State had taken over and that the State Plumbing Code was now in effect as the Town's population is over 2000.

4. Mr. Homer F. Weston reported for the Fire Truck Committee and stated that Civil Defense would not go along with the purchase and have refused to participate financially. Therefore, the Town has gone ahead and is seeking bids for the completion of the Fire Truck.

5. Mrs. Virginia K. Ford introduced the following resolution:

"Whereas, the Town of Carver has inadequate play-grounds; and

"Whereas, Public playgrounds suitably located throughout the Town are an essential public facility for the general welfare of the community; therefore be it

Resolved, That public playgrounds should be provided for our children without delay; and be it further

Resolved, That a committee of five (5) be appointed by the Honorable Board of Selectmen and Park Commissioners and that this committee report its factual findings and recommendations at the next Town Meeting."

Thereupon, upon motion duly made and seconded, it was unanimously VOTED that a committee of five be appointed by the Board of Selectmen and Park Commissioners to study the matter of public playgrounds as set forth in the foregoing resolution.

6. Mr. Frank R. Mazzilli moved that the Town vote to establish a committee of nine (9) members to study the Town By-laws and to make recommendations as to the revision thereof, the membership of said Committee to include the Town Clerk, one member of the Finance Committee, the Board of Selectmen, two members to be elected from the floor, and two members to be appointed by the Moderator, and report at the next Annual Town Meeting. The motion was duly seconded and was unani-

nously adopted. Thereupon, the following persons were duly elected to serve on said By-laws Study Committee:

Mary D. Gomes, High Street
John A. Shaw, Shaw Road

Article 13. VOTED, unanimously, to raise and appropriate the sum of \$1,000.00 for Chapter 90 Highway Maintenance, and to transfer the sum of \$2,000.00 from available funds in the treasury to meet the State's and County's shares of the cost of the work, the reimbursements from the State and County to be restored, upon their receipt, to free cash in the treasury.

Article 14. VOTED, unanimously, to transfer the sum of \$8,008.04 from the proceeds received, or to be received, from the Commonwealth under the provisions of Chapter 579 of the Acts of 1965, said sum of money to be used for the purpose of resurfacing Wenham Street and a portion of Center Street.

Article 15. Mr. Frank R. Mazzilli moved to amend the Article by inserting the words "on Wareham and Tremont Streets" after the words "Chapter 90 Highway Construction"; the motion was duly seconded and the amendment was duly voted. Thereupon, it was unanimously VOTED to raise and appropriate the sum of \$7,000.00 for Chapter 90 Highway Construction on Wareham and Tremont Streets, and to transfer the sum of \$21,000.00 from free cash in the treasury to meet the State's and County's shares of the cost of work, the reimbursements from the State and County to be restored, upon their receipt, to free cash in the Treasury.

Article 16. VOTED, unanimously, to raise and appropriate the sum of \$6,700.00 for Chapter 81 Highways, and to transfer the sum of \$18,425.00 from available funds in the treasury to meet the State's share of the cost of the work, the reimbursement from the State to be restored, upon its receipt, to free cash in the treasury.

Article 17. VOTED, unanimously, to appropriate the sum of \$2,000.00 from available funds in the treasury for the sole purpose of meeting charges against the Cemetery Funds in the Town Treasury.

Article 18. VOTED, unanimously, to raise and appropriate the sum of \$650.00 to be used to pay for all private work and material in Town Cemeteries such as opening graves, building foundations, etc.

Article 19. Shall the town accept the provisions of Section Sixteen to Sixteen I, inclusive, of Chapter Seventy-one of the General Laws, providing for the establishment of a Regional School District, together with the Towns of Carver, Duxbury, Halifax, Kingston, Marshfield, Pembroke, Plymouth, Plympton and the construction, maintenance and operation of a regional school by the said district in accordance with the provision of a proposed agreement filed with the Selectmen?

Mr. Erwin K. Washburn moved that the Article be "laid on the table," stating that Carver's vote would be ineffective as the article had been voted down in two other Towns that were included in the contract. Motion being duly seconded, it was unanimously VOTED to lay the article on the table. Thereupon, Mr. John A. Shaw called for an informal vote on the Article to obtain the consensus of the meeting. On a voice vote the motion was carried by an "overwhelming majority but not unanimously."

Article 20. This Article called for an appropriation of a sum of money for the purpose of paying the Town's share of the initial operating and maintenance cost of the proposed Regional Vocational High School District. Upon motion duly made and seconded, it was unanimously VOTED "to lay on the table."

Article 21. VOTED, unanimously, to authorize the Board of Selectmen to negotiate a lease for a Police

Cruiser Car, and to purchase a radio, upon such terms and conditions and from such persons as the Board of Selectmen deems advisable, and to raise and appropriate the sum of \$2,730.00 therefor.

Article 22. VOTED, unanimously, to raise and appropriate the sum of \$1,365.00 for the purpose of purchasing the present leased Police Cruiser from Colonial Car Lease Co., Inc.

Article 23. VOTED, unanimously, to authorize and empower the Board of Selectmen to sell the town-owned 1961 Chevrolet Police Cruiser.

Before the meeting began acting on the Articles in the Warrant, Selectman Frank R. Mazzilli introduced the Honorable Charles A. MacKenzie, Representative in the General Court from the 6th District. Mr. MacKenzie spoke briefly about his duties at the State House and told the assembly that he was always ready to listen and to help the people of his District with any problems they might have with the State.

There being no further business to come before the meeting, the meeting adjourned at 3:20 P.M.

PLYMOUTH COUNTY MOSQUITO CONTROL PROJECT

The record rains in 1967 contributed to the most serious mosquito problem in years. The rising water table not only re-hatched what are normally one brood a year species, but also immersed dormant eggs deposited years ago. These conditions were responsible for an over-lapping of emerging adults throughout the warm season. Our budget is inadequate for satisfactory control under normal years. The rains in 1967 made conditions nearly hopeless.

The Project has extended itself during the past few years spraying individual properties of those who have had an acute problem. This has been accomplished both by aerial sprays and ground equipment. Continuation of this adult phase is becoming next to impossible, as calls compound annually. We are asked to provide insect-free cookouts, weddings, and general outdoor living in the evenings. Indiscriminate aerial applications for nuisance mosquitoes are becoming too complex, costly, and a subject of controversy. DDT, the old insecticide standby, is a thing of the past in most instances. We, as well as conservation groups, are concerned with the future of wildlife and will do our utmost to minimize any potential hazards in this regard.

Our job is to seek out breeding areas and to destroy the larvae or to eliminate the areas where possible and feasible. Time and money spent in backyards spraying adult mosquitoes is accomplishing nothing toward a permanent abatement program. Our budget remains constant and does not allow for the increasing costs of wages, insecticides and equipment, nor rising fiscal expenditures. Towns are growing tremendously, and each home is a probable contributor to the mosquito problem in many ways. Catch basins, toys, open rubbish and garbage

containers, flowerpots, bird-baths, and open over-flowing sewage are just a few of the breeding sites created by new construction. There are also old tires and car bodies plus drainage ditches plugged with leaves dumped by those who are too unconcerned with our problem to discard them in the dump. All too often, these same persons will call demanding individual treatment, informing us of their tax levy, and how little they are receiving from their tax dollar for public service. The filling of trenches and waterways reclaimed and constructed by this Project is a violation of state statutes, and subject to prosecution. Adequate sewage disposal is also a must, but is already a serious problem in most towns.

We will continue our pre-hatch treatments in the winter months, plus larvaciding programs during the breeding months. We will continue to spray the municipal parks and playgrounds, dumps and disposal areas, schools and churchyards, plus our weekly inspections and treatments to known breeding areas. As in the past, our plans are to reclaim more open trenches and waterways. Our trenching phase of control is active most months of the year, although our budget necessitates our utilizing trenching crews on spraying equipment during the biting months. Several waterways and streams were brushed and reclaimed in Carver this past year.

I wish to again thank your town officials and department superintendents for their interest and cooperation.

PLYMOUTH COUNTY EXTENSION SERVICE

As a citizen of Plymouth County, you have the privilege of calling on the Plymouth County Extension Service for information in the fields of Agriculture, Home Economics and 4-H Club Work, for the legislation passed by Congress states that the Cooperative Extension Service is “to aid in the diffusing among the people of the United States, useful and practical information relating to agriculture, home economics and to encourage the application of same.”

Because funds from three levels of government (Federal, State and County) are provided, we are also known as the “Cooperative Extension Service.” The office is located in the Court House, Brockton.

Resources of the University of Massachusetts and the U.S.D.A. are available to all Extension Agents; often the University of Massachusetts personnel participate with the Agent/Specialist in conducting meetings, tours, seminars, schools and demonstrations.

The Southeast Extension Region consists of Barnstable, Bristol, Norfolk and Plymouth Counties. Commercial farmers in this region are serviced by Regional Agricultural Agents and Regional Agricultural Specialists who have specific commodity program responsibilities such as dairy and livestock; fruit and vegetable; floriculture; nurseries; poultry and turkeys.

The Home Economists have been called upon by other organizations to: (1) teach or act as coordinators of educational programs for homemakers in underprivileged families; (2) to teach the elderly, blind and handicapped.

The Extension Home Economists' Programs can be called "Adult Education" with emphasis on Consumer Education; Human Relations; and Human Development; Leadership Development and Homemaking Techniques. For assistance with everyday household problems or questions and information about current programs, contact our Home Economists.

4-H Club work offers much to young people between the ages of 9-19 in the broad areas of careers; citizenship; clothing; conservation; crafts; foods, plant and animal science; recreation; science and Junior Leadership.

4-H Club Work, as do all other youth organizations, contributes to the character development of the young people.

Adult 4-H club leaders in the community supervise the local club meetings, activities and special programs. Their contributions toward the success of the 4-H program is recognized by Parents, Town Committee Members and others who assist with the 4-H Program. For information about the 4-H Club Program, contact our 4-H Club Agents.

Sir:

In accordance with your instructions, I have made an audit of the books and accounts of the town of Carver for the period from March 22, 1964, the date of the previous examination, to May 10, 1967, the following report being submitted thereon:

An examination and verification was made of the financial transactions as recorded on the books of the several departments receiving or disbursing money for the town or committing bills for collection.

An analysis was made of the accounting officer's ledger for the period covered by the audit. The receipts were checked with the treasurer's books, and the payments were compared with the warrants authorizing them and with the treasurer's records of payments. The appropriation accounts were checked with the town clerk's records of town meeting proceedings, and the recorded transfers from the reserve fund were verified by comparison with the records of the finance committee. The necessary adjusting entries resulting from the audit of the several departments were made, and a balance sheet, which is appended to this report, was prepared showing the financial condition of the town on May 10, 1967.

The books and accounts of the town treasurer were examined and checked. The receipts were checked with

the records of the several departments collecting money for the town and with other sources from which money was paid into the town treasury, while the payments were compared with the selectmen's warrants authorizing the treasurer to disburse town funds.

The cash book footings were verified, and the cash balance on May 10, 1967 was proved by actual count of the cash in the office and by reconciliation of the balance in the checking account with a statement furnished by the bank of deposit.

The records of tax titles held by the town were examined. The taxes, interest, and costs transferred to the tax title account were compared with the collector's records, the reported redemptions were checked with the treasurer's cash book, and the tax titles on hand were listed, reconciled with the accounting officer's ledger, and compared with the records at the Registry of Deeds.

The transactions of the trust and investment funds in the custody of the town treasurer and the trustees were verified, and the savings bank books and securities representing the investment of these funds were examined and listed.

The recorded payments on account of maturing debt and interest were verified by comparison with the amounts falling due and checked with the cancelled securities on file. The outstanding coupons on May 10, 1967 were listed and reconciled with the balance in the bond and coupon account as shown by the statement received from the bank of deposit.

The records of payroll deductions on account of Federal and State taxes, the retirement systems, and for group insurance were examined and checked. The payments to the proper agencies were verified, and the balances on hand to the credit of the employees were proved with the town treasurer's records.

The books and accounts of the tax collector were examined and checked. The commitments of taxes and excise were proved with the assessors' warrants issued for their collection, the payments to the treasurer by the collector were checked with the treasurer's cash book, the abatements, as recorded, were compared with the records of the assessors, the transfers to the tax title account were verified, and the outstanding accounts were listed and proved.

The departmental accounts receivable were audited and proved. The payments to the treasurer were checked with the treasurer's recorded receipts and the outstanding accounts were listed and proved.

The outstanding tax, excise and departmental accounts were verified by mailing notices to a number of persons whose names appeared on the books as owing money to the town, the replies received thereto indicating that the accounts, as listed, are correct.

The records of receipts from licenses and permits issued by the selectmen, the town clerk, the police department, the building and plumbing inspectors, and the inspector of gas piping were examined and checked, and the payments to the State and to the town treasurer were verified.

The surety bonds of the town officials required to file them for the faithful performance of their duties were examined and found to be in proper form.

The available records of receipts of all other departments collecting money for the town were examined and checked, and the payments to the treasurer were verified.

In addition to the balance sheet, there are appended to this report tables showing a reconciliation of the treasurer's cash, summaries of the tax, excise, tax title, and departmental accounts, as well as schedules showing the condition and transactions of the trust and investment funds.

While engaged in making the audit cooperation was received from the officials of the town, for which, on behalf of my assistants and for myself, I wish to express appreciation.

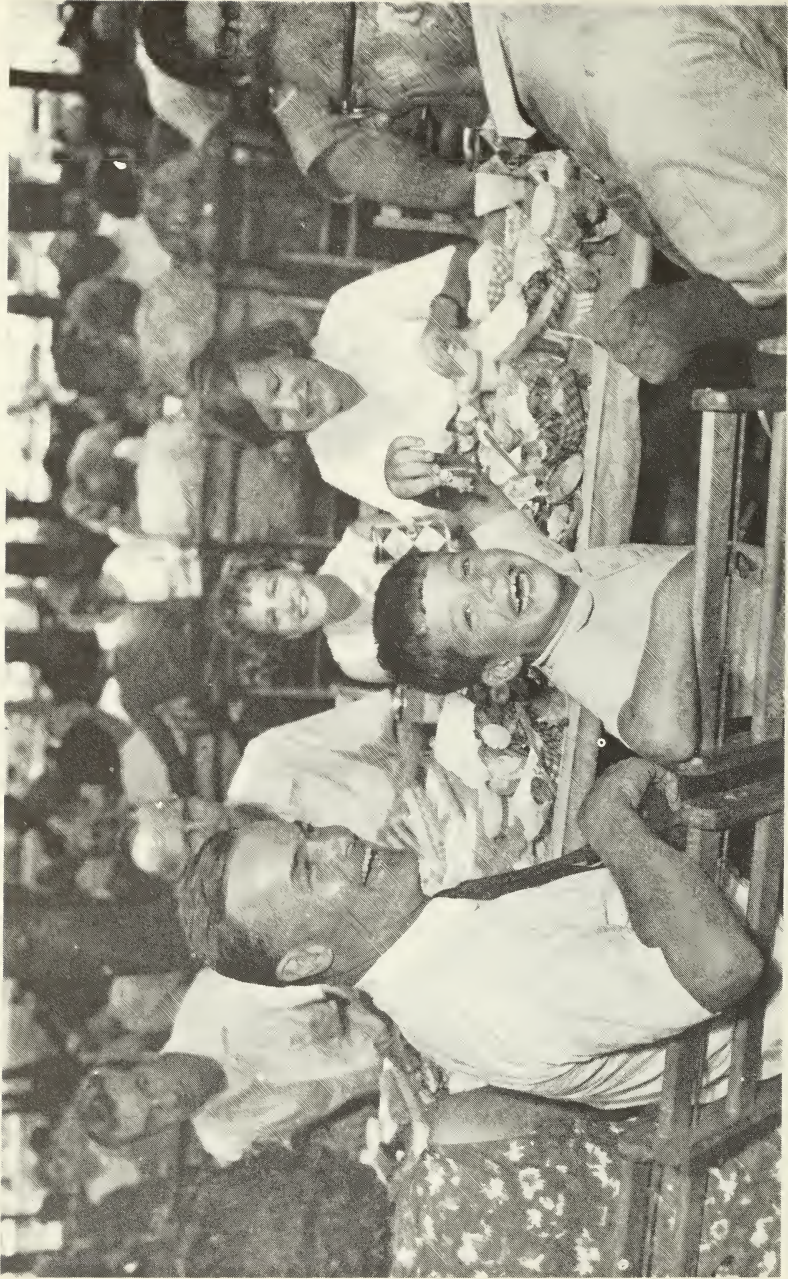

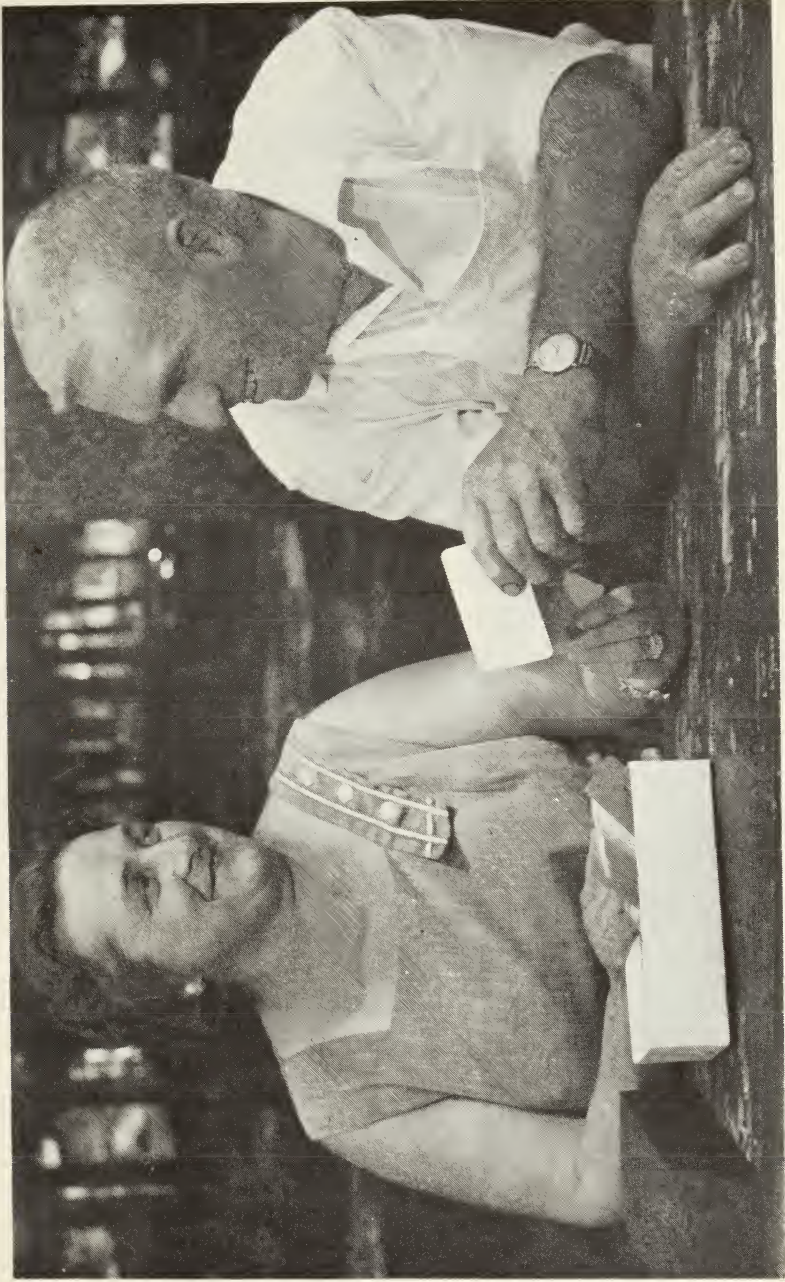

The Chapter 90 Maintenance allotment of \$3,000.00 of which the town appropriated \$1,000.00, the state \$1,000.00 and the county \$1,000.00 was used on Seipet Street where 3000 feet of class I 1 Bituminous Concrete surface was constructed over existing surface

The Chapter 81 allotment of \$25,125.00 of which the town appropriated \$6,700.00 and the state \$18,425.00 must be used for maintenance purposes out of which approximately \$12,000.00 was to purchase 40,000 gallons of asphalt for sealing the streets.

The remaining \$13,125.00 was used for patching, catch basins, culverts, brushing, mowing, shoulders and other miscellaneous maintenance operations.

The Chapter 90 allotment of \$28,000.00 was used to completely reconstruct and resurface 3600 feet of road on Wareham Street.

The \$1,000.00 appropriated in the general highway funds for asphalt was used to apply 4500 gallons of Mc 250 asphalt to Wareham Street.

The \$8,008.04 appropriated for Wenham and Center Streets was to purchase in place 12,000 tons of class I 1 Bituminous Concrete where 4500 feet of pavement were resurfaced.

To the Honorable Board of Public Welfare:

My report on Old Age Assistance, Aid to Families with Dependent Children, Disability Assistance, Medical Assistance, and General Relief for the year ending December 31, 1967, is as follows:

\$51,587.16 was spent for Medical Assistance which includes all medical services for cases eligible under Old Age Assistance, Aid to Families with Dependent Children, Disability Assistance and General Relief as well as those aided under Title 19, Medicaid. As of December 31st there were ninety-five active cases—categorically related to OAA, nineteen, categorically related to DA, seven, categorically related to AFDC, eleven, and Children Under 21, fifty-eight. 101 cases were added during the year and 16 cases closed.

At the beginning of the year there were twenty-seven Old Age Assistance cases. Four new cases were added and nine cases closed leaving twenty-two active cases as of December 31st. Expenditures decreased from \$27,365.20 to \$21,496.90.

Disability Assistance expenditures decreased from \$3,100.40 to \$1,975.79. On January 1st there was only one case. Five new cases were added and one case closed leaving five active cases on December 31st.

Aid to Families with Dependent Children cases totaled twelve on January 1, 1967, thirteen cases were added and eleven cases closed leaving fourteen active cases on December 31st. Expenditures increased from \$13,662.88 to \$27,390.67.

General Relief costs changed little, \$1,254.01 being expended in this category.

On October 3, 1967, Governor John A. Volpe signed into law Chapter 658, an act reorganizing the Department of Public Welfare and providing for the direct administration of the Public Welfare System of the Commonwealth.

Gentlemen:

In the past year the entire emphasis in the Department of Veterans' Service work has changed. Today, we are primarily charged with the responsibility of providing services to the ever expanding veteran population in matters of hospitalization, training, pensions, compensations and other related Veterans' Administration functions.

It is because of these increased benefits which the Federal Government is providing that we have not seen a noticeable increase in Town funded expenditures. Nevertheless, we can anticipate that at any time we may be asked to provide aid to any veteran and/or his dependents which will be our responsibility, shared with the Commonwealth, to furnish.

There are bills to be acted upon in the 1968 Legislature proposing that the Department of Veterans' Services be taken over entirely by the Commonwealth as will be the Department of Public Welfare in July of 1968. We can expect that this will receive serious consideration, however, as this Department provides services other than in matters of economics we can expect that no take over by the Commonwealth will be finalized until the entire problem is thoroughly studied.

It has been an extreme pleasure to work for the veteran and his dependents in 1967 primarily due to the

Cooperation which we have received from both the American Legion and the Veterans of Foreign Wars Posts in Carver. The Board of Selectmen, the Office of the Town Clerk and the entire Police Department are commended for all which they have done when any problem has arisen. The Town of Carver should be proud of its entire veteran population for these men and women have proven again and again that though their war is over that they are 100% behind those men and women in the service of the country today—who are the veterans of tomorrow.

REPORT OF THE SWIMMING INSTRUCTOR

Swimming instructions were given this summer (1967) for the first time in recent years in Carver. They began on July 11, 1967 and were completed on August 31, 1967. Over two hundred children registered for the classes, which were held on Tuesday, Wednesday and Thursday from 9:00 A.M. to 4:00 P.M. Each lesson lasted one half hour to one full hour, depending upon the age level of the children. There were six categories in which the children were placed, depending upon their skill: Beginning Swimmer, Advanced Beginner Swimmer, Intermediate Swimmers, Junior Life Saving, and Senior Life Saving. Children actively participated in four of these six available categories. Thirty-seven children received badges in Beginning Swimmer, sixteen in Advanced Beginner Swimmer, thirty-one in Intermediate, and ten in Junior Life Saving. A Swimmer and Senior Life classes were not worked into my program, due to lack of adequately skilled children, but this year the children are ready to take these classes. Ninety-four children in all received their badges.

I was paid three hundred dollars for instructing the classes, and in order to qualify to teach under the Red Cross program, I successfully completed a ten week course at Bridgewater State College. After completing this course, I was awarded my Water Safety Instructor's badge.

I personally feel the program was a complete success in every way. People whom I have directly and indirectly spoken to about the program were also completely pleased with the results. I feel this is definitely a program from which the children of Carver can benefit. Water sports have become an increasingly popular sport but it

can be dangerous unless we take the time and effort necessary to properly train our young children.

In conclusion, I wish to express my pleasure to have been able to have the opportunity to work with the children. I know it was both beneficial to the children, as well as to myself. I have learned many things in this past summer, and I know I can constructively put these teachings to use, benefiting both myself, and the children in the future Red Cross programs.

REQUIREMENTS FOR ADMISSION TO FIRST GRADE

1. A child who will reach his first birthday on or before December 31st may be admitted to the first grade in September, 1968, without examination.
2. A child whose sixth birthday occurs in the two months after December 31st may be admitted the preceding September if readiness for School can be demonstrated by means of appropriate tests. Parents having a child whom they wish to be examined under this rule are required to make application to the Superintendent of Schools on or before August 15 preceding the opening of school in September. A special form will be furnished for this purpose upon written request from the parent. The School Committee reserves the right to withhold the examination privilege whenever the number of children eligible to enter without examination is equal to the capacity of the available classrooms.

CLOSING OF SCHOOLS

It is the policy of the School Committee to close school only under the severest weather conditions or on such occasions when it is dangerous to operate school busses. At other times, parents are expected to use their own judgement in sending children to school. When a decision to close schools has been made, this information will be broadcast through the courtesy of radio stations WBZ and WPLM.

PLYMOUTH-CARVER REGIONAL SCHOOL DISTRICT SCHOOL COMMITTEE REPORT

We have arrived at the end of another calendar year and feel that it has been one filled with activities that have contributed to the growth and development of our high school program. Our greatest rewards have come from the successes achieved by our young people in their many different endeavors. It is our pride that through your support we have helped to develop improved opportunities for the resident members of our communities.

In addition to our regular high school offering, we have seen increased advantage to our services to adults. Our evening courses have continued to flourish. In addition we have participated in training programs under the guidelines of the Manpower Development Training Act. All of these programs represent our desire to serve as widely as possible the educational needs of Carver and Plymouth.

Following our baptism of last year, 1967 has become a year of increased maturity for procedures under the Collective Bargaining Act. We began the year by ratifying our first major contract, and our year has ended with bargaining sessions taking much of our time and attention. It is our belief that both sides, and sides there must be, have behaved in the good faith that is so essential to the successful functioning of a school system.

We were disappointed to learn of Mr. Harry Doyle's decision that for reasons of health he felt obliged to resign his position as an appointed member of our committee. We believe that you may know as well as we the sincerity of

effort with which Mr. Doyle served our school. The Plymouth School Committee appointed its chairman, Mr. Alton Cavicchi, to serve as replacement. We feel fortunate that we have served with such gentlemen as these.

Not long after this we were informed that Mrs. Mary D. Gomes would not seek reelection from the Town of Carver. Certainly her efforts cannot go without our highest congratulations. Mr. Arne Erickson, a former teacher at Plymouth-Carver and at that time an administrator in the Rockland schools, was elected and has brought both energy and experience to his membership.

We were pleased that so many of you chose to participate in the Exchange Band Concert in which we held exchange concerts with the high school band of Hebron, Connecticut. Our youngsters served us well, not only in the quality of their musical performances, but also in their manner of conduct as guests and as hosts.

We were aware throughout the spring of the tremendous amount of planning that was undergone in the development of our first outdoor graduation. We were given cause to fear the weather and its power for unpleasant interruption. Fortune smiled as it so often has upon our school, and we enjoyed a particularly fine ceremony from which no one was barred because of a limit of attendance imposed by seating capacity. We hope that you shared with us the sense of pride evidenced by both staff and students in this culminating event.

In September we were joined by Mr. Francisco Alen Garcia, a visiting teacher under the Fulbright program, as a member of our foreign language department. Mr. Alen has

brought a richness to our Spanish program that has been much appreciated. He will remain with us for the duration of his exchange grant and will return to Spain to complete the intended purpose of this cultural exchange program.

This year has marked the coming-of-age of our Work Study Program under the careful direction of Mr. Dennis Aresta. Here is an effort to supply a long-needed assistance to make our school a more meaningful experience for a number of our young people. The intent here is to serve to improve our retention rate and to effectively create a needed bridge between the academic program of the school and the world of work into which these people must soon enter. Our thanks are here extended to the many employers who have helped these youngsters through their own personal efforts.

We were pleased to receive petitions from both the Plymouth and the Carver School Committees requesting our action in seeking to amend the Regional Agreement to include Grades 6, 7, and 8. Because we quite truly believe that the sharing of responsibility by the two towns has worked so well to improve the educational program for the grades presently covered, we have voted unanimously to seek the necessary approval from the towns.

This year marks our first acceptance of fiscal responsibility for all students in a group insurance program. This is a non-duplicating coverage that will assure protection to all students during the hours of their school attendance.

Our school grounds knew continued improvement throughout the year. We were particularly pleased by the increased lighting provided in our parking area and by our

new sign which allows us to indicate the many activities in which our students are engaged.

Again this year we have taken pride in the many efforts of our staff to move about in search of that which was of advantage to our program. They have participated in conferences and institutes that have afforded self improvement which accrues in advantage to their department within the school. They have visited widely among schools and colleges in an effort to determine ways in which we may more effectively serve our student body. The status quo has not been regarded as sacrosanct. We have asked that changes be implemented in an ongoing effort to keep current the finest educational practices of which we are capable.

The year had not come to its end before we knew the tragedy of loss which is felt by all in the death of Mr. Louis Cappannari. Here is a man who served well as both teacher and friend to the thousands of young people who knew him in his many years of service to our schools. To the very end, Mr. Cappannari took an immense pride in his school and in its students. This was matched only by the pride we have felt in being associated with so fine a man, so completely dedicated a teacher.

It was indeed a year of beginnings and endings. The task that lies before us is filled with new challenges to suit the needs of new and different times. We renew our promise to keep faith with all of you in our continued effort to maintain our school as one upon which our students may in years to come look back with full knowledge that they were served with the utmost of

community interest and solicitude. Your continued help will be sought that their young dreams may come true.

ANNUAL REPORT OF THE PRINCIPAL OF THE PLYMOUTH-CARVER HIGH SCHOOL

A number of significant events highlight the year 1967 at Plymouth-Carver High School.

Pupil enrollment showed a slight increase from September, 1966 to September, 1967. Average daily attendance was approximately 94%, which was slightly higher than the previous year. This creditable percentage of attendance is attributable mainly to the health services provided to our students within the school and the personal contact maintained with the home by the school nurse and the supervisor of attendance.

During the year 3.4% of the student body dropped out of school. While this figure is considerably less than the state and national average of 20% and 35% respectively, it is nevertheless a condition about which we should all be concerned and which we should attempt to minimize. Thirty-five students dropped out of school: sixteen left because of poor self-motivation; five left because of ill health; five married; two entered the service; two were needed at home; two were committed to the Youth Service Board but re-entered later in the year; and three withdrew because of disciplinary action. The Work-Study Program, a Health Program, a Remedial Reading Program, and more conferences involving parents, students, teachers, and community specialists have been initiated in an effort to reduce the drop-out rate.

Among the professional staff there was approximately a twenty per cent turnover: everyone who knew Mr. Cappannari laments his tragic death; four other teachers

improved their positions through professional advancement; two continued their education, two resigned, and three did not return. Mr. William Levesque returned from his Teaching Fellowship at Michigan State, and Mr. Angelo Medici assumed the responsibility of department chairman in mathematics.

The staff also grew in number as a direct result of curriculum development and improved teaching conditions. A third Special Education teacher, a second Remedial Reading teacher, a full-time band instructor, a second permanent substitute teacher, and a full-time IBM operator augmented the competency of the staff.

The social and cultural program involved many students and a great number of activities: a play, a variety show, and talent assembly were the highlights; there were also proms, dances, and exchange concerts, as well as visits to the theatre and to the museums of art and science and various field trips. Students participated in a panel discussion with parents on youth today, and health assemblies on cancer and the danger of smoking, drinking, and drugs were offered.

School activities which offered enriching extra-curricula experiences were received with enthusiasm by many of the students. Successes of the athletic teams were major highlights during the year, the most significant being the basketball team crowned as league champions. The introduction of soccer for the first time on an informal basis was highly successful, and next year the team will be represented in the South Shore Soccer League

We were honored to have been selected by the Lincoln Filene Center for Citizenship and Public Affairs at Tufts University to participate in their Youth Conference. Miss Phyllis Boucher, Dept. Chairman of Social Studies, and two students, Stephen Conroy and Margaret Bastoni, were chosen to represent Plymouth-Carver High School at this two-day conference.

The Class of 1967 was a record-breaking class in the amount of scholarship aid they received. The information that has been received from these students and from the schools they are attending merits strong words of praise and thanks to all who have provided scholarship aid.

The A.F.S. Chapter, faculty, and student body at Plymouth-Carver High School were pleased to welcome David Choque from Peru as our third American Field Service student in September 1967. The selection of the American family to take David Choque into their home, as a member of the family during the year, was Mr. and Mrs. Edward Buckley of Arlington Road, Manomet.

We at Plymouth-Carver High School were extremely elated by the honor brought us by Hilarie Gibbs, a junior, who was selected to go abroad and is now studying in Jylland, Denmark.

We were appreciative of the effort of the Department of Education in assisting us in arranging workshops for our faculty members in English and mathematics to develop guidelines that might be offered to us for improving our curriculum.

These are the highlights of the year 1967 at Plymouth-Carver High School. They are significant because they

required exceptional service. The communities of Carver and Plymouth can well be proud of these accomplishments. We highly commend those who earned them.

REPORT OF THE SCHOOL ADMINISTRATORS

In an effort to make our overall report on schools more concise, we shall this year combine the reports of the central office, and building administrators. It has been a good school year, and we are anxious that you share in the pride which we have taken in our school programs.

Building Committee

The work of this committee extended throughout this year in a continued effort to make serviceable this important addition to our school plant. It is only as a result of the timely addition of these four classrooms that our youngsters have enjoyed the important benefit of class sizes of reasonable proportion. In working with the School Committee, it has become evident that this addition will provide adequate service for only a limited time. We are a growing community, and our school needs must grow apace.

Curricula

We have continued our efforts to strengthen and improve the several areas of instruction. Ours is not a seeking after change for its own sake; it is instead a recognition that the status quo must not be regarded with reverence in these days of educational innovation. There exists a wide range of improved educational practices; we assure you that our teachers are being kept aware of these developments and are themselves working to determine their most successful applications within our classrooms.

The committees on mathematics and science have continued to meet with teachers from Plymouth and

Plymouth-Carver and have had their recommendations implemented as they have been developed. There is much work still to be done in science before a formal report can be prepared.

The addition to staff of a part-time physical education teacher has allowed an increase in the time allotment for this important activity. There has been an increase in the availability of our music teacher under the new arrangement within the Union. This has allowed introduction of a strings program and increased activity with Glee Clubs in Grades 6, 7, and 8.

This year we have entered the Massasoit League for intra-school sports competition among schools that compare favorably in size with our own. The young people have taken deserved pride in the performances of their teams. The enthusiasm of the cheerleaders has spoken well for the fine spirit of the school.

In May our Arts Festival was held with students from all grades participating in many different delightful ways. Particular credit must be given Mrs. Ormsbee and Mr. Peterson for their direction of this outstanding performance.

Staffing

While we believe that we have been most fortunate in the fine quality of new teachers who have come to us, we have been made painfully aware of the shortage of teachers, particularly in special areas of preparation. In an effort to lend administrative assistance to our system, we appointed Mrs. Agnes Fitch as Head Teacher at Benjamin Ellis; this has proved most beneficial to our first grade program.

Summer Programs

This year Operation Head Start had its best year to date. We had made several insistences for change and feel that they brought distinct advantages to the program. This year these pre-schoolers shared the Governor John Carver facility with our Honest Effort youngsters. We have been most pleased by the many reports from parents that have given commendation to these summer activities. There have been satisfactions in these efforts to make the school a more helpful institution.

**REPORT OF THE
REGIONAL VOCATIONAL DISTRICT
PLANNING BOARD**

By a vote of the 1967 Town meetings Regional Vocational School District Planning Committees were authorized and duly appointed.

Committees from the Towns of Carver, Duxbury, Marshfield and Plymouth, acting under the provisions of Section 14 of Chapter 71 of the General Laws, formed the Regional Vocational School District Planning Board.

The Board has made the following findings:

1. The region under consideration will have by 1971 3,219 students in grades 9 through 12.
2. From 30% to 50% of all high school graduates in this region do not continue their education at the college level.
3. Capacity, limited entrance requirements, transportation, and course offering are at present denying students in this region a vitally needed vocational training experience.
4. The division of Vocational Education of the State Department of Educational estimates that a co-educational Vocational school for 560 students would be required for this region.
5. Industrial growth in the area depends upon a reservoir of trained personnel having a degree of skill greater than heretofore and at present vocational school graduates are in great demand by industry.

6. The mobility of labor today will allow this region to include courses that previously could not be presented in a limited industrial area.
7. Greater education value at a lower pupil cost can be realized by the four towns joining a regional district than would be possible by individual school vocational programs.
8. 161 Towns within the Commonwealth already are operating Vocational High Schools either as a part of their own school system or as a member of a region, and 49 other towns are in the regional planning stage.

The Board therefore recommends:

1. That a Regional Vocational School District including the towns of Carver, Duxbury, Marshfield, and Plymouth, be formed according to the provision of the attached agreement which is a part of this report.
2. That the region be operated by an elected Regional School Committee with each town being represented as set forth in the attached agreement. That such Regional School Committee shall have all the powers and duties and responsibilities as set forth by law and this agreement. This agreement further sets forth the provision for Capital and Operating costs budgeting, amendments to the agreement for admission and withdrawal of member towns, transportation, admission of tuition students, employment of teachers and extension of tenure.
3. Further recommend the construction of a Regional Vocational High School within the confines of the region described, for approximately 560 students at a

currently estimated net cost of construction and financing of \$3,734,250. This capital cost will be shared by the member towns on the basis of pupil enrollment in the Regional Vocational School. For the purpose of estimating apportioned costs per town the estimated pupil enrollment of the member towns in grade 9 through 12 for the year 1972 has been used. Operating costs are also estimated to be about \$875.00 per pupil at full enrollment and is similarly apportioned.

This sum of money to be raised by a Regional District Bond issue the cost of which will be prorated to the member towns substantially in accordance with the above schedule.

The Vocational High School may include grades 9 through 14 offering 12 to 16 subject area, courses.

In addition the facilities will be utilized for adult education, trade extension courses and special training courses.

It is further recommended that an initial operating and planning budget of \$25,000.00 be provided the Regional Vocational District for the balance of the year. This amount to be raised by the member towns as follows:

Plymouth ss. To either of the Constables of the Town of Carver, Plymouth County, GREETING:

In the name of the Commonwealth of Massachusetts, you are directed to notify and warn the Inhabitants of the Town of Carver qualified to vote in elections and in town affairs to meet at the Governor John Carver School House in said Carver on Saturday, the second day of March, 1968, at 12:00 o'clock, noon, then and there to act on the following article, namely:

Article 1. To choose all necessary town officers, to be voted for all on one ballot, viz.: One Moderator, Three Auditors, each for one year, One Selectman, One Assessor, One member of School Board, One Park Commissioner, One Cemetery Commissioner, Two Library Trustees, Three Constables, One Town Clerk, One Town Treasurer, One Collector of Taxes, each for a term of three years, and one member of Planning Board for a term of five years, and to vote by ballot "Yes" or "No" on the following Question:

"Shall the Town accept Chapter 31, Section 48, of the General Laws, said section and chapter placing the positions of the regular or permanent members of the police force and the Chief of Police of the Town of Carver under Civil Service?"

The polls will be open for at least eight hours.

And you are directed to further notify said Inhabitants of said Town that as soon as the ballots have been counted the meeting will adjourn to Saturday, March 9, 1968, at 2:00 o'clock P.M., and at that time will reconvene at said

Governor John Carver School House, then and there to act on the following articles, namely:

Article 2. To see if the town will vote to authorize the treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue for the financial years beginning January 1, 1968 and January 1, 1969, in accordance with the provisions of General Laws, Chapter 44, Section 4, and to renew any note or notes as may be given for a period of less than one year, in accordance with the provisions of General Laws, Chapter 44, Section 17.

Bonney's House Lots, Carver, Mass., 1901" and being described as follows:

"Beginning at intersection of the northerly sideline of Plymouth Street and the easterly sideline of Hines Avenue, said avenue being 18 feet, more or less, in width at this point:

Thence northwesterly in the easterly sideline of Hines Avenue, 200 feet, more or less, to the point where said avenue widens to 40 feet:

thence northeasterly in the southerly sideline of Hines Avenue 22 feet, more or less, to the southwesterly corner of lot 20 as shown on the above mentioned plan:

thence southeasterly parallel to and 40.00 feet distant from the westerly sideline of the above mentioned Hines Avenue, 205 feet, more or less, to the northerly sideline of Plymouth Street:

To see if the Town will vote to accept an amendment to the Plymouth-Carver Regional School District Agreement proposed by the Regional District School Committee and entitled "Amendment No. 1 to the Agreement for the Establishment of the Plymouth-Carver Regional School District," which Amendment provides in substance (a) that the regional district schools shall comprise grades six through twelve, (b) that the regional district school committee may establish state-aided vocational education, (c) that the regional district schools shall be located within a radius of seven miles from the junction of Route 3 and the present Route 44, (d) that capital costs shall be apportioned 89% to Plymouth and 11% to Carver except that all capital costs incurred on or after April 1, 1968 which are related wholly to a particular school shall be apportioned on the basis of pupil enrollment in such school and (e) that the annual tentative maintenance and operating budget shall be prepared on or before November 15.

Article 26. Recommended by the Finance Committee.

Article 27. To see if the Town will vote to establish a development and industrial commission for the promotion and development of the Industrial resources of the town, as set forth in Chapter 40, Section 8A, of the General Laws.

Article 27. Recommended by the Finance Committee.

Article 28. To see if the Town will vote to raise and appropriate the sum of two hundred (\$200.00) dollars to pay the rent of the Veterans of Foreign Wars Post #7421 of Carver.

Article 28. Recommended by the Finance Committee.

Article 29. To see if the Town will vote to designate the South Shore Community Action Council, Inc., a Massachusetts General Laws Chapter 180 non-profit corporation, as the agency to carry out the anti-poverty program as defined in the Federal Economic Opportunity Act of 1964 (and as later amended) (Public Law 90-222) in the Town of Carver.

Article 29. Recommended that Article 29 be postponed indefinitely.

Article 30. To see if the Town will vote to adopt the following resolution:

“The citizens of the Town of Carver hereby reaffirm their full support of the goal of equality of opportunity in employment, housing, education and individual rights, freedom, and justice without regard to race, creed, or national origin.” (By petition)

Article 30. Recommended by the Finance Committee.

Article 31. To see what action the Town will take on the Proposed By-Laws for the Town of Carver, and act anything thereon.

Proposed By-Laws for the Town of Carver

Article 1.

Section 1. The Annual town meeting shall be held for the election of officers on the third Saturday in March at 12:00 o'clock noon. The polls shall be open for at least seven hours, and as soon as the ballots are counted the meeting shall be adjourned to the following Saturday at 2:00 o'clock, P.M., for the transaction of municipal business.

Section 2. Seventy-five (75) qualified voters shall be necessary to constitute a quorum at any town meeting, including special town meetings; provided, however, that one hundred fifty (150) qualified voters shall be necessary

to constitute a quorum at any town meeting where any bonded indebtedness is to be voted upon, and provided, also, that a number less than a quorum may from time to time adjourn the same.

Section 3. All articles in the warrant shall be taken up in order of their arrangement unless otherwise ordered by two-thirds vote.

Section 4. No motion to adjourn without day shall be in order until all articles in the warrant have been acted upon.

Section 5. The check list shall be used in admitting voters to a town meeting, except that non-voters may be admitted to a defined and separate portion thereof, and non-voters may address the meeting if the town so votes.

Section 6. The articles to be acted upon at the annual town meeting in March shall be in the hands of the Board of Selectmen on or before February first preceding said meeting.

Article II

The town warrant shall be posted in the town hall and at each fire station in the town.

Article III

The moderator shall be elected for one year, the name to appear on the official ballot.

Article IV

The powers and duties of the presiding officer not especially provided for by law shall be determined by rules of practice as contained in Robert's Rules of Order so far as they are adapted to the conditions and powers of the town.

Article V

Section 1. The Board of Selectmen shall consist of three members, each elected for a three year term, one term expiring annually.

Section 2. The Board of Selectmen shall serve as the Board of Public Welfare.

Section 3. The Board of Selectmen shall have the power to prosecute, compromise or defend suits for or against the town and employ counsel at any time if in its judgment the interests of the town so require.

Section 4. It shall be the duty of the Board of Selectmen to transmit a copy of any warrant for any regular or special town meeting as soon as said warrant is drawn, to the Finance Committee.

Section 5. The Board of Selectmen shall appoint an Inspector of Wires, as provided in Chapter 66, Section 32 of the General Laws, as amended by Chapter 529 of the act of 1949.

Section 6. The Board of Selectmen shall notify all department heads and all committees appointed or elected by the town of any special town meetings at least seven days prior to the posting of the warrant for said meeting, except in case of emergency as determined by the Selectmen.

Article VI

The Following officers shall be appointed by the Selectmen for a term of one year:

1. Three field drivers and pound keepers.
2. Three surveyors of lumber and measurers of wood.
3. Three fence viewers.
4. Three members to serve as a herring committee.

Article VII

Section 1. There shall be a Finance Committee of nine (9) members, who shall hold no other town office in or be a permanent employee of the Town. A Committee consisting of the Moderator, the Chairman of the Board of Selectmen and the Chairman of the Finance Committee shall annually appoint three members for a term of three

(3) years. No member shall hold office for more than two consecutive terms. Appointments to the Finance Committee shall be made within twenty (20) days after the Annual Town Meeting.

Section 2. All qualified voters of the Town of Carver are eligible for appointment to the Finance Committee, except that no elected or appointed town officer, or regular town employee, shall be eligible for membership on said committee, and no member of a special town committee shall have a vote as a member of the Finance Committee on any matter pertaining to the duties of such special committee.

Section 3. On or before the fifteenth day of April it shall be the duty of the Moderator to call the organization meeting of the Finance Committee.

Section 4. The Finance Committee at its organizational meeting shall elect a chairman, vice-chairman, and a secretary, all who shall serve until the next annual town meeting. Within ten days after the organization the secretary shall notify the Town Clerk in writing of such organization.

Section 5. Any vacancies occurring in the membership of the Finance Committee shall be filled by the original appointing authority within seven days of the notification in writing of said vacancy by the chairman of the Finance Committee.

Section 6. Three consecutive absences of any member of the Finance Committee at a duly called meeting shall constitute a vacancy.

Section 7. The report of the Finance Committee to the annual town meeting shall be in print and shall contain the request of all departments and the appropriations recommended by the Finance Committee, together with such recommendations on other matters in such warrant as in its judgment should be brought to the

attention of the town, but reports to all other town meetings shall be in such form as the Finance Committee shall deem advisable.

Section 8. The Finance Committee may appoint such sub-committees as it may deem advisable.

Section 9. The Finance Committee shall have authority at any time to investigate the town's accounts and management of any department, and the books, records, and accounts of all departments of the town shall be open to the inspection of the Finance Committee, or any of its authorized sub-committees, or any person authorized to act for said committee.

Section 10. The members of the Finance Committee excepting chairman and secretary shall serve without pay, but may be reimbursed for actual expenses incurred in the discharge of their duties. Salary for chairman and secretary of said committee to be set by a vote of the town.

Section 11. On or before December 21 of each year the Officers, Boards, or Committees having charge of expenditures of the town's money shall transmit in writing, to the Finance Committee their estimate of expenditures for the conduct of their departments for the next municipal year. On or before January 15 of the following year these same officers shall present to the Finance Committee, in writing a detailed list of the expenditures for the year previous.

Article VIII

A summary of all town meeting and results of all elections shall be included in the annual town report.

Article IX

Valuation lists for the Town of Carver shall be published every five years unless otherwise voted by the town.

Article X

Any of these by-laws may be modified or amended or repealed at any annual town meeting by a majority of votes of those present and voting, any article or articles for the purpose having been inserted in the warrant for such meeting.

Article XI

The by-laws adopted by the Town on March 6, 1959, and approved by the Attorney General on June 1, 1959, are hereby repealed.

Article 31. Recommended by the Finance Committee.

And you are directed to serve this warrant by posting attested copies thereof at the several places designated by vote of the Town seven days at least before the time of holding said meeting.

Hereof fail not and make due return of this warrant, with your doings thereon at the time and place of meeting aforesaid.
