SPECIAL TOWN ELECTION

JANUARY 9, 1971

A Special Town Election was held at the Governor John Carver School on Saturday, January 9, 1971, for the purpose of electing a Selectman to fill the vacancy caused by the resignation of Clark A. Griffith, said term of office to expire in March 1972. The polls were open from 12:00 o'clock, noon, until 8:00 o'clock, P.M. A total of 794 ballots were cast, of which 12 were absentee ballots and 782 were cast by voters in person. The results of the election as follows:

ANNUAL TOWN MEETING

MARCH 27, 1971

The Annual Town Meeting of the Inhabitants of the Town of Carver was held on Saturday, March 27, 1971, at the Governor John Carver School House, pursuant to a Warrant of the Board of Selectmen dated February 10, 1971. The meeting was called to order at 1:00 P. M., by the Moderator, Richard F. Ward, there being a quorum present. The Invocation was given by the Rev. Robert H. Merritt, Pastor of the United Protestant Church of Carver. The Moderator then appointed Elizabeth F. Ryder, Dorothy M. Lindros, William J. Harriman and William Turpin, Jr. to serve as Tellers to count the votes, and they were duly sworn to the faithful performance of their duties.

Reading of the Warrant being disposed with, and Article 1 relating to the election of officers having been disposed of at a prior meeting, the meeting thereupon proceeded to act upon the Articles in the Warrant as follows:

Article 2. Upon motion duly made and seconded, it was unanimously VOTED to authorize the Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue for the financial years beginning January 1, 1971 and January 1, 1972, in accordance with the provisions of General Laws, Chapter 44, Section 4, and to renew any note or notes as may be given for a period of less than one year, in accordance with the provisions of General Laws, Chapter 44, Section 17.

Article 3. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate the sum of \$2379.00 to reimburse the Treasury of the County of Plymouth for awards for land damages on South Meadow Road, as ordered by the Plymouth County Commissioners under Decree No. 1384, said awards to be paid from the Treasury of the County of Plymouth.

Article 4. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate the additional sum of \$675.00 to reimburse the Treasury of the County of Plymouth for the land damages assessed under Plymouth County Commissioners' Decree No. 1268 (Right of Way to Wenham Pond), said land damage award to be paid from the Treasury of the County of Plymouth.

Article 5. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate the sum of \$189. 19 to pay the following unpaid bills of 1970:

Article 8. Upon motion duly made and seconded, it was unanimously VOTED to authorize the Tree Warden, Cemetery Commissioners and Park Commissioners to employ themselves as laborers in the cemeteries, parks and tree department.

Article 9. Upon motion duly made and seconded, it was unanimously VOTED to transfer from the Overlay Reserve Account to the 1971 Reserve Account the sum of \$10,000.00.

Article 10. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate for the use of the Plymouth County Trustees for County Aid to Agriculture the sum of \$100.00 and to choose a Town Director as provided for in Section 41 and 45 of Chapter 128 of the General Laws. Thereupon, nomination being had, Mr. Roger V. Weston was unanimously elected Town Director County Aid to Agriculture.

Article 11. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate the sum of \$1500.00 for Assessors' Plans, such sum to be used and expended by the Board of Assessors.

Article 12. Upon motion duly made and seconded, it was

unanimously VOTED to hear the report of any standing committees and to establish any new committees. Thereupon, Att'y. Paul Record, Chairman of the Public Works Study Committee, requested that his report be heard in connection with Article 13. Mr. Frank R. Mazzilli, Chairman of the Library Building Study Committee, requested that his report be heard in connection with Article 19.

Thereupon, Mr. Keerock Rook moved that the Town create an Advisory Committee, with a minimum of fifteen members. The motion was duly seconded.

Thereupon, Mr. Rook read the camplete text of his motion. (The full text of the motion creating the Advisory Committee is available in the office of the Town Clerk). Mr. Clark A. Griffith moved that the Advisory Committee report annually to the Town and the motion was duly seconded. Thereupon, it was VOTED to create an Advisory Committee as set forth in the motion herein-before referred to, said Committee to report annually to the Town.

Motion by Mr. Richard S. Phippen, duly seconded, that the Town vote to instruct the Moderator to appoint a committee to study the necessity of establishing a Council for the Ageing; said committee to consist of a minister, a priest and nine citizens of Carver. This committee report should be heard at the next annual or special town meeting. So VOTED.

Upon motion made by Mr. Richard S. Phippen, duly seconded, it was VOTED, 96 in the affirmative and 44 in the negative, to instruct the Moderator to appoint a committee to study the need and advisability of establishing a separate Board of Health under the town by-laws; such a committee should consist of one Selectman, one member of the Planning Board, one member of the Finance Committee and two citizens of the Town. This committee's report should be heard at the annual or special town meeting.

Thereupon, the Moderator declared a 10 minute recess at 3:45 P.M.

The meeting resumed after the recess, and upon motion duly made and seconded, it was unanimously VOTED to take up Article 26 out of order, the Police Chief being interested and being desirous of leaving the meeting because of illness.

Article 26. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate the sum of \$8,274.34 to purchase two (2) station wagon ambulance-type police cruisers, and to authorize the Selectmen to dispose of the 1967 Town-owned station wagon.

Article 13. Article moved by Attorney Paul Record, Chairman of the Public Works Study Committee, duly seconded. Attorney Record then explained the Article, read the Committee report and the Enabling Act., etc. Thereupon, it was unanimously VOTED to accept the report and recommendations of the Study Committee and to instruct the Moderator to appoint a committee consisting of the Senator and Representatives from this District to introduce legislation in the General Court for an Act authorizing the Town of Carver to establish a Department of Public Works exercising the powers of certain other Departments and Town Officials.

Article 14. Upon motion duly made and seconded it was VOTED to instruct the Moderator to appoint a committee to study the Zoning By-Laws of the Town of Carver with the view of seeing whether any change should be made therein and bring said Zoning laws up to date; said committee to consist of the Chairman of the Board of Selectmen, Chairman of the Planning Board, Chairman of the Finance Committee, Chairman of the Board of Appeals, Town Clerk, and two other citizens and vot ers of the Town, and that the Committee report be submitted to

the Town Clerk before December 1, 1971.

Article 15. To see what action the Town will take on the proposed amendment to the Protective By-Laws, as submitted by the Carver Planning Board, or to take any other action relative thereto.

Page 6. Section V. Intensity Regulations.

A. Minimum Lot Dimension

Area in square feet (a) 40,000

Thereupon, on motion duly made and seconded, the foregoing Amendment to the Protective Zoning By-Laws was unanimously VOTED.

Article 16. Upon motion duly made and seconded, it was unanimously VOTED to establish a committee of five (5) members, to be appointed by the Town Moderator, to up-date and revise the Town's Building Code.

Article 17. Upon motion duly made and seconded, it was VOTED (81 in the affirmative and 36 in the negative) to raise and appropriate the sum of \$2500.00 to be used for professional services in making studies pertinent to Town growth, expenditures of said amount to be under the Selectmen's supervision.

Article 18. Upon motion duly made and seconded, it was VOTED to raise and appropriate the sum of \$1,000.00 for the purpose of numbering buildings along the line of public ways in Carver.

Article 19. Article duly moved and seconded. Mr. Frank R. Mazzilli, Chairman of the Library Building Study Committee, presented the report of the Committee and the report was accepted. The Article was discussed at considerable length. Discussion of the Article being completed, the Moderator called

for a standing vote, as a two-thirds majority vote was required for the motion to carry. Thereupon, standing vote being had, 73 voting in the affirmative and 36 in the negative, it was VOTED to appropriate the sum of \$66,500.00 for the purpose of constructing and originally equipping and furnishing a building to be used as a Public Library, said appropriation to include engineering and architectural fees and expenses, and said building to be located on the Town Hall Lot adjacent to and Northerly from the Town Hall; and that to meet such appropriation the sum of \$55,000.00 be transferred from the Stabilization Fund, and the sum of \$11,500.00 be transferred from the Lawrence E. Blenheim Public Library Building Fund.

Article 20. Upon motion duly made and seconded, it was unanimously VOTED to retain the Library Building Study Committee, with its present membership, to serve as a Library Building Committee until completion of the building.

At this time, upon motion duly made and seconded, it was VOTED to adjourn until Saturday, April 3, 1971, at 2:00 P.M. Adjourned, at 5:45 P.M.

ANNUAL TOWN MEETING

ADJOURNED SESSION

APRIL 3, 1971

Meeting called to order at 2:00 o'clock, P.M., on Saturday, April 3, 1971, by the Moderator, Richard F. Ward, there being a quorum present. The meeting proceeded to act on the remaining Articles as follows:

Article 21. To see if the Town will vote to authorize the Library Building Committee and Board of Selectmen to enter into and sign contracts for the new Library Building, and act anything thereon or thereto. Article was duly moved and seconded. Mr. Erwin K. Washburn moved to amend the original motion by adding the following words: "providing that said contracts with the exception of the engineers' and architects' (fees) have prior Town Meeting approval." Motion duly seconded. Thereupon Mr. Washburn proceeded to talk on the motion. After consultation with Town Counsel, John P. Ryan, Esquire, the Moderator ruled the motion out of order, a point of order having been raised by Selectman Frank R. Mazzilli. After some further discussion, the question being moved, it was VOTED by standing vote (98 voting in the affirmative and 34 in the negative) "to authorize the Library Building Committee and the Board of Selectmen to enter into and sign contracts for the new Library Building."

At this time Attorney Paul Record moved to reconsider Article 12, relating to the appointment of the Advisory Committee to the Planning Board. The Moderator ruled the motion out of order. However, he did allow Attorney Record to discuss the matter at some length. Mr. Record said that in his opinion the appointment of the Advisory Committee was illegal, as con-

stituting an unlawful delegation of power by the Planning Board, an elected Board. Mr. Keerock Rook was then allowed to speak on the matter; he took the view that the appointment of such a Committee was legal and proper.

Article 22. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate the sum of \$1,000.00 for Chapter 90 Highway Maintenance, and to transfer the sum of \$2000.00 from available funds in the Treasury to meet the State's and County's shares of the cost of the Work, the reimbursements from the State and County to be restored, upon their receipt, to Free Cash in the Treasury.

Article 23. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate the sum of \$8,500.00 for Chapter 90 Highway Construction on High, Holmes, Plympton, Plymouth, and Tremont Streets, and to transfer the sum of \$25,000.00 from Free Cash in the Treasury to meet the State's and County's shares of the cost of the work, the reimbursements from the State and County to be restored, upon their receipt, to Free Cash in the Treasury.

Article 24. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate the sum of \$6,700.00 for Chapter 81 Highways, and to transfer the sum of \$18,425.00 from available funds in the Treasury to meet the State's share of the cose of the work, the reimbursements from the State to be restored, upon their receipt, to Free Cash in the Treasury.

Article 25. Upon motion duly made and seconded, it was VOTED to raise and appropriate the sum of \$2,634.93 and to transfer the sum of \$3,803.07 from the Road Machinery Fund

to purchase a new truck (cab, chassis and dump body) for the use of the Highway Department.

Article 26. (Article 26 previously VOTED.)

Article 27. Upon motion duly made and seconded, it was unanimously VOTED to appropriate the sum of \$2,500.00 from available funds in the Treasury for the sole purpose of meeting charges against the Cemetery Funds in the Town Treasury.

Article 28. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate the sum of \$750.00 to be used to pay for all private work and material in Town Cemeteries such as opening graves, building foundations, etc.

Article 29. Upon motion duly made and seconded, it was unanimously VOTED that the County Dog Fund be applied to the Library Account.

At this time Frank R. Mazzilli, Chairman of the Board of Selectmen, moved to reconsider Article 7, dealing with the budget. Motion was duly seconded, and it was unanimously SO VOTED. Thereupon, on motion duly made and seconded, it was unanimously VOTED that the sum of \$2,365.00 be substituted in place of \$1,865.00 for Item 10, Elections, Registrations and Street Listing. (This was to take care of additional expense in connection with the 1971 State Census).

Upon motion duly made and seconded, it was unanimously VOTED to substitute the amunt of \$1,131.72 in place of \$1,000.00 for Item 26, Public Prosecutor.

Meeting adjourned at 2:55 P.M.

SPECIAL TOWN MEETING

OCTOBER 30, 1971

A Special Town Meeting of the Inhabitants of the Town of Carver was held at the Governor John Carver School House on Saturday, October 30, 1971, pursuant to a Warrant of the Board of Selectmen dated October 12, 1971. The meeting was called to order at 7:11 P.M. by the Moderator, Richard F. Ward, there being a quorum present. The meeting thereupon proceeded to act on the Articles in the Warrant as follows:

- Article 1. VOTED to appropriate from available funds in the treasury the sum of \$3500.00 to be used at the junction of Plymouth and Main Street for the installation of a warning flasher and renovation to the existing road surface, said sum to be 75% reimbursed by the State under Chapter 519 Safety Projects Act 1971.
- Article 2. VOTED to appropriate from available funds in the Treasury the sum of \$300.00, and to transfer the sum of \$2700.00 from the Road Machinery Fund to purchase a new sander for the Highway Department.
- Article 3. VOTED to appropriate from available funds in the Treasury the sum of \$544.20 for the Municipal Insurance Account for added coverage to Benjamin Ellis School and Town Hall.
- Article 4. VOTED to appropriate from available funds in the treasury the sum of \$1200.00 for the Law Account.
- Article 5. VOTED to appropriate from available funds in the treasury the sum of \$300.00 for the Zoning Board of Appeals.

Article 6. To see if the Town will vote to appropriate from available funds in the treasury the sum of \$300.00 for the Dutch Elm Disease Account. Article duly moved and seconded. Thereupon, voice vote being had and the preponderance of the vote being in the negative, the motion was declared lost.

Article 7. VOTED to appropriate from available funds in the treasury the sum of \$599.14 for the Police Cruiser Lease Account.

Article 8. VOTED by show of hands, 132 in the affirmative and 4 in the negative, to appropriate from available funds in the treasury the sum of \$1089.46 to pay the following unpaid bills of 1970:

Lawson Products, Inc. (Snow Account) \$29.46 Dyar Sales and Machinery Co. (Snow Account) 1060.00

Article 9. To see if the Town will vote to appropriate from available funds in the treasury the sum of \$2239.11 for the General Highway Account. Motion duly made and seconded. Thereupon, standing vote being had, 63 voted in the affirmative and 66 in the negative; the motion was declared lost.

Article 10. VOTED to appropriate from available funds in the treasury the sum of \$1392.50 for the Machinery Account.

Thereupon, Selectman Richard S. Phippen moved to reconsider Article 9. The motion was duly seconded and it was VOTED to reconsider Article 9. Thereupon, Mr. George E. Young, Chairman of the Finance Committee, moved that the amount of \$2239.11 be amended to \$1500.00. Motion was duly seconded. Voice vote being had, the motion to amend was declared lost. Thereupon, voice vote being had on the original motion, it was VOTED to appropriate from available funds the

sum of \$2239.11 for the General Highway Account.

Article 11. VOTED to appropriate from available funds in the treasury the sum of \$200.00 for Elections, Registrations and Street Listing.

Article 12. VOTED "to authorize to grant, insofar as they have the right to do so, to the New Bedford Gas and Edison Light Company, its successors and assigns, the perpetual and exclusive easement right to construct, relocate, operate and maintain a pole and electric distribution lines with all equipment and appurtenances deemed necessary therefor, over, across and upon a certain parcel of land in which the Town may have an interest, namely: Town Public Library Lot, Main Street, Carver."

Article 13. VOTED to appropriate from available funds in the treasury the sum of \$8568.00 for a ten wheel cab and chassis for the Fire Department to replace the present cab and chassis for the tank wagon. Old chassis to be disposed of by order of Selectmen and Fire Chief.

Article 14. VOTED, unanimously, to create a Council on Ageing and to adopt the following by-law in accordance with the provisions of Chapter 40, Section 8B of the General Laws:

Section 1. The Board of Selectmen shall appoint a Council on Ageing for the purpose of co-ordinating or carrying out programs designed to meet the problems of the Ageing in co-operation with programs of the Commission on Ageing established under Chapter 6, Section 73 of the General Laws.

Section 2. The Board of Selectmen shall

appoint the Council on Ageing consisting of seven (7) members. Upon acceptance of this by-law, the Board shall appoint three (3) members for three (3) years, two (2) members for two (2) years, and two members for one (1) year term. Members can be re-appointed for concurrent terms. The members of the Council shall serve without pay.

Section 3. Whenever a vacancy shall occur in the membership of the Council, by reason of death, resignation, inability to act or for any other reason, the vacancy shall be filled by appointment by the Selectmen for the remainder of the term.

Section 4. The Council on Ageing at its first annual meeting and thereafter, annually in April of each year, shall elect from its membership a President, 1st Vice President, 2nd Vice President, Secretary and Treasurer. Each officer shall hold office until the next annual election. In the event a vacancy occurs in any of the offices above, the Council shall hold a special meeting for the purpose of electing one of its members to fill such vacancy.

Section 5. The Council shall prepare and submit an annual report of its activities to the Town and shall send a copy thereof to the Commission on Ageing.

Section 6. The Council may appoint such clerks and other employees as it may require.

Article 15. VOTED to appropriate from available funds in the treasury the sum of \$1500.00 for the use of the Council on Ageing.

Article 16. VOTED to create a special unpaid committee to be known as a Vocational Regional School District Planning Committee, to consist of three (3) members, including one (1) member of the School Committee, to be appointed by the Moderator, in accordance with the provisions of Section 14 of Chapter 71 of the General Laws as amended; and that there be appropriated from available funds for the use of said Committee the sum of \$250.00.

Article 17. Upon motion duly made and seconded, standing vote being had, and 129 voting in the affirmative and 18 in the negative, it was VOTED "to approve the amount of debt, \$6,040,000.00, authorized on October 5, 1971, by the Plymouth-Carver Regional School District Committee for the purpose of financing the construction and equipping of a regional intermediate school."

No further business. Meeting adjourned at 9:30 P.M.

According to Section 14, Chapter 132, General Laws of Massachusetts, it is the duty of this office to notify each city and town in the Commonwealth on or before January first of its financial liability. The amount actually needed to affect good control of the public nuisances listed in Section 11, Chapter 132, General Laws is also noted.

Following careful consideration of the shade tree insect and disease problems in your community it has been determined that the following appropriations be made:

Insect Pest	Control	\$800.00
Dutch Elm	Disease Contro	2,500.00

Insect and diseases which beset our valuable shade and forest trees can be controlled. Community involvement is necessary, however, and your Local Superintendent of Insect Pest Control needs your support to accomplish this end.

Pursuant to the requirements of Chapter 132, Section 14 of the General Laws, I have determined that the financial liability of your municipality for 1972 to be \$2,079.82, including a sum of \$800.00 for insect pest control and a sum of \$1279.82 for Dutch elm disease control. Any sum expended in excess of these amounts will entitle your community to request state assistance in the form of a tree removal crew for a period of time determined by the amount of the expenditure and the time available.

Please do not fail to notify me of the appropriations and the name and address of your local superintendent.

PLYMOUTH COUNTY MOSQUITO CONTROL PROJECT FOR CARVER 1971

Concern for the environment has again been a factor in the Project's activities this past year. Our continued efforts will be to consider the problems of pollution and ecology while carrying out an effective mosquito control program. Obviously, indiscriminate mass applications of hard pesticides by aircraft or ground equipment is a thing of the past. By carefully following control outlines, provided by the entomologist for the State Reclamation Board, as well as the University of Massachusetts, the Project has been able to provide adequate mosquito control in almost every area of the county.

Logically, reduction in mosquito population can best be accomplished before the mosquito becomes a flying adult. We, therefore, direct a substantial amount of monies into eliminating or controlling breeding areas. This is carried out by water management, trenching and clearing waterways, especially those that have become polluted or stagnant.

This past year throughout the county, approximately 14,505 man hours were spent working in the field. Included in this were 5,028 hours in spraying, applying a total of 20,173 gallons of spray material. 1,464 hours were given to pre-hatch, larvaciding, and inspection work. In addition, 4,320 catch basins were treated.

As indicated, water management is an important part of the Project's work. With attention being given to problem areas, our two backhoes worked 1,504 hours with a total of 29,755 feet of

trenching. Field crews spent 5,099 hours clearing 36,345 feet of clogged streams and ditches.

Prime consideration is always given to those areas prone to Eastern equine encephalitis. The cases were reported in the county last year. Secondly, those sections known to have a high mosquito producing potential are considered.

The following is a brief summary of the Project's activities in your town. 144 hours were spent applying 1,019 gallons of spray material, 53 hours in pre-hatch treatment, 8 hours cleaning 400 feet of waterways, making a total of 205 man hours.

We have attempted to come close to the actual assessment of 4.244%, which is Carver's share of the Project's appropriation.

We express our appreciation for the assistance of the various town departments.

REPORT OF THE OFFICE OF THE PUBLIC PROSECUTOR

FOR THE YEAR ENDING DECEMBER 31, 1971

To The Honorable Board of Selectmen Carver, Massachusetts

Gentlemen:

During the year of 1971, the Office of Public Prosecutor processed and assisted the Police Departments of Carver, Rochester, Marion, Mattapoisett, and Wareham, in handling approximately 7,660 complaints brought before the Fourth District Court of Plymouth County. These complaints involved approximately 4,287 alleged offenders, who were charged during the past year with various types of criminal activity, local ordinance, or motor vehicle violations.

We have been sucessful in handling numerous delinquent tax cases for the Towns when requested. Court action has been resorted to in order to collect outstanding personal property and excise taxes. We have also engaged in the enforcement of State Statutes in regards to shellfish violations, animals, leash law, and licensing requirements. Public hearings in regards to dangerous dog complaints have been conducted and Court action has been resorted to in order to compel compliance. The office has drafted proposed by-laws for enactment at Town Meeting. We have effectively coordinated activities, information, and programs with other governmental agencies, such as the Office of Attorney General, Plymouth County District Attorney's Office, and the Registrar of Motor Vehicles. On numerous

occasions, we have assisted local school officials in regards to habitual truancy and discipline problems and have prosecuted, when requested, school children who have come before the Court as a result of this type of conduct.

At the request of the Plymouth County Police Chief's Association, we have been in contact with the State legislature in order to present the position of our local police departments in regards to eliminating the crime of public drunkenness and also the bill which would eliminate the immunity of cities and towns for torts of their police officers.

In addition to the prosecution and processing of criminal complaints, this office has rendered legal advice and assistance to all the police departments on various criminal matters, especially in the field of search and seizure, the rights of the individual, as well as the legal rights and duties of our law enforcement officers.

In a further attempt to give the Towns a more efficient judicial system at the District Court level, the Selectmen of the Town and myself have been pressing the County Commissioners for their vigorous support in seeking the necessary appropriations to construct a court house for the Fourth District Court of Plymouth County, which facility is definitely needed.

The Conservation Commission, recognizing the extent of its responsibility, felt the need for more meeting time. As of June 1971, the Commission has been meeting on the second and fourth Thursday of each month at 8:00 P.M. in the Planning Board Room at the Town Hall. We invite any interested conservationists and like minded citizens to attend meetings.

If there are any persons interested in becoming Associate members of the Commission we would be happy to welcome them.

At a regular meeting held on July 8, "Bud" Reese, Gary Parker and Chris Moustaches of the U.S. Soil Conservation Service presented a program on Soil Surveys. At that time the Commission voted to have a soil survey of Carver, conducted by the U.S. Department of Agriculture.

The survey will be completed in mid-year of 1972. The soil survey consists of soil maps, names and descriptions of types of soils, and narratives and tables describing the suitability of

soils for various uses. The details of this survey will provide information for planning purposes. The survey and maps will be available for use by all the Town Departments, most specifically the Planning Board, Board of Health and Conservation Commission will use the information provided for future planning and for determining soil limitations for sewage disposal, wetland wildlife sites, far roads, home sites, etc.

This project is made available to us through the services of the U.S. Department of Agriculture and the funds we provide are being matched with Federal Funds.

A joint meeting was held with the Board of Selectmen to acquaint them with our plans for the near future and to accept any suggestions they may have had. We thank them for their cooperation throughout the past year.

We have at this time several projects in the planning stage. Several private individuals have been contacted in hopes of procuring land for a Town Forest and other uses. At this time we have no definite committments. The Ford Foundation is offering grants to Conservation Commissions for long range and costly projects, however land purchase is excluded. With the financial aid available to us through a grant we are presently making a selection as to a project that we will undertake if we obtain a grant.

The Commission regretfully accepted the resignation of Lawrence Pink from the Commission in December.

We are looking forward to a productive and interesting year in 1972. The Commission offers assistance to private individuals who wish to set up game preserves, wildlife feeding stations, wildflower areas, etc. There are many ways in which the individual can participate in Conservation without being part of the formal board, we invite you to do so.

In 1971 the total number of home visits was 628, continuing the steady rise in the caseload of the last few years. Five hundred and eighty four of these visits were for nursing care and health guidance, and the remaining 42 were home-school visits. A total of \$468.00 was collected in fees, and one resident received physical therapy through the Easter Seal Society.

Because of both the greater amount of time required for home visits and the increased number of school children, additional assistance was provided to carry out the vision and hearing testing and to furnish better coverage for the school health program.

Three pre-school immunization clinics were held in the spring, with 42 children receiving a total of 89 immunizations. This represents a substantial increase in clinic participation. Mrs. Barbara Flanders and Mrs. Genelda Johnson generously gave their time and efforts in assisting at these clinics.

Many conferences with individuals, school and professional personnel, and official agencies have been held throughout the year to improve and increase the services offered to both the children at the schools and the other residents of Carver.

The Chapter 81 allotment of \$25,125.00 of which the Town appropriated \$6,700.00 and the State \$18,425.00 must be used for maintenance purposes out of which \$13,847.89 for labor, Hired Equipp. \$5,114.46, Materials \$3,859.85 and Town Equipp. 2302.80. Work completed 10 miles of road surface treated, 4,650 ft, resurfaced, all catch basins and manholes cleaned and approximately 15 miles of roadsides were brushed.

The Chapter 90 Construction allotment of (1970) balance of \$11,849.95 was expended on Tremont, Seipet and High St.

The (1971) construction monies have a balance of \$34,000.00. This money has been allotted to Tremont and High St.

SCHOOL ADMINISTRATION

FOR THE YEAR ENDING

DECEMBER 31, 1971

The following represents a summary listing of some of the valuable changes that have occured during the past year:

The Lippincott Reading Program is now being used in Grades one, two, and three.

The Houghton Mifflin Mathematics Program has been extended into grades four and five. This now completes the new Mathematics Program in Grades One through Eight.

The AAAS Science Materials have been purchased for Grade Five. This completes the program for Grades One through Six. The new Science program for Grades Seven and Eight was started in September. This completes the new Science Program for Grades One through Eight.

Honest Effort and Head Start were once again held for six weeks at the Covernor John Carver School during last summer.

Mrs. Gladys Burgess and Mrs. Vienna Cole retired at the end of the school year. Mrs. Madeleine Owens terminated her services in December. Their services will be missed by all of us.

The basketball team under Coach Philip Bangs completed a most sucessful year in the Massasoit Junior High School

League. The team won the championship. The team, Cheerleaders, and coach are to be commended.

The individual needs of students are now being much better met with the addition of a full-time guidance counselor and a part-time assistant principal.

This year saw a steady climb in the student enrollment in the schools. At certain grade levels this has for the first time led to overcrowding.

PLYMOUTH-CARVER REGIONAL SCHOOL COMMITTEE REPORT

The first part of 1971 was given over to the exciting and critically important task of planning both the educational program and the physical facility for our new Intermediate School. The teachers and other staff members have done a tremendous job of planning a series of truly viable learning experiences for the youngsters as they move through Grades 6, 7, and 8.

It was with this educational plan firmly formed that we invited the architect to work closely with staff to design teaching spaces and learning areas that would facilitate the purposes of our planned program. Truly, this represented a shared experience in the creative development of a school plant that would be sufficiently flexible to allow for the educational changes that are every day more upon us.

A vote of deserved approval is offered to Mr. David Crawley and his associates for the technical skill they displayed in bringing together the essential elements of sound architicural design that would prove capable of satisfying the needs expressed by educational theory.

These were the advantages provided last year by your approval of our \$270,000 request for the development of plans and specifications sufficient in detail to allow for the processes of public bidding. We were able to have a building designed according to our carefully determined needs and to come before you with an accurate description of the building plan you were asked to support and firm figures to allow a community under-

standing of the actual costs and the impacts to be had on local tax rates.

In the brochure presented for your consideration before the Special Town Meetings we tried to do four things: 1) to present a visual conception of the school plant; 2) to alert you to the burgeoning enrollment patterns of our communities; 3) to answer objectively the questions that we had found most often asked; and 4) to provide a comprehensive breakdown of building costs and the expenses of financing the project.

We were most gratified by the levels of support you gave to our proposal at both Town Meetings. We believe that this was the result of your being able to have facts sufficient to your development of an informed opinion. As our year comes to an end, we are very certain that our figures will hold. The ground has been broken and the New Year will find us as underway as our New England weather will allow.

In all of our work with the Intermediate School we have not lost sight of the continued development of our High School and the ever expanding needs that must be met if we are to retain the high standards of which we have always been so proud.

Plans are presently underway for an addition to the present building. High school enrollments have placed an undue strain upon curriculum development. Once again we shall develop a comprehensive plan for your consideration. These are community schools. It is our intention that they shall have the

continued support of the citizens of Carver and Plymouth even as they continue to serve the educational needs of our Towns.

ANNUAL REPORT OF THE PRINCIPAL

OF THE

PLYMOUTH-CARVER HIGH SCHOOL

The year 1971 proved to be a year of continuing growth. Pupil enrollment continued to increase from 1298 students in September 1970 to 1402 students in September 1971.

Among the proffessional staff there was less than a 20 percent turnover. Mr. Andrew Dietlin of the Foreign Language Department and Mr. Silas Wade of the Science Department returned from sabbatical leaves. Mr. John Smith, English Department Head, returned from Crewkerne, Somerset, England where he participated in a Foreign Exchange Teacher Program. Miss Linda Bartoccini replaced Miss Muriel Stern in the Guidance Department.

The staff also grew in number as a direct result of curriculum development and improved teaching conditions. A third Special Education teacher, a Remedial Reading teacher, a full-time drafting teacher and the implementation of an Automotive Program augmented the competency of the staff.

There were significant events which highlighted the year 1971. "Man and His World" is a unique educational experience now in its first year at Plymouth-Carver High School. It was developed by our own teachers who involved students in the planning process. The course is taught by a team of four teach-

ers, one each from the English, social studies, art and music fields. These teachers range widely, exposing the youngsters to a heady mixture of materials and ideas within the flexible structure of a double class period. Great emphasis is placed on "doing" rather than merely listening, on discovering, rather than accepting passively. Hopefully this humanistic, intergrated approach will "help the student develop an awareness and an appreciation of the relationship that exists between man and his environment, particularly as that relationship pertains to aggression, love, and justice."

In expanding the present Home Economics program an off-campus Child Care Center has been formulated at the Parish House of the Unitarian Church as a pilot project. It is felt that skills required in our everyday living are much more meaningful and relevant if they can be directly applied and integrated into a program of study which does not attempt to isolate skills without practical application. In addition, follow-up studies of recent Plymouth-Carver High School classes indicate that 25 per cent of the girls and 15 per cent of the total class are married within one year after graduation and 76 per cent of the girls and 53 per cent of the total class are married within five years of graduation. This program would provide for a complete intergration of skills built around the central theme of child development and care. Mrs. Nancy Larose, teacher of Home Economics at Plymouth-Carver High School, will assume responsibility for the instruction and general supervision of the off-campus program. She will be assisted by a Boston University counselor-intern who is both certified in Home Economics and

has had previous teaching experience in a similar program. The program will also be supported with services provided by the pupil personnel staff.

The National Honor Society of Plymouth-Carver High School, with Miss Karen Martin as its advisor, has been busy during the school year organizing two major programs; one for the benefit of students, and one for the benefit of the local elderly. The Cultural Enrichment Program, aimed at broadening the experiences of students outside of the school, consists of eight well-planned day trips, focusing on places (Sturbridge Village), on experiences (Shakespearean play), significant in our culture. A typical cultural trip, and one enjoyed in November by sixty students, was the Freedom Trail, the open air North End market, Durgin Park restaurant, and the New England Aquarium in Boston. The responsibility for successfully operating these trips lies with members of the National Honor Society.

The second major effort the Honor Society sponsored was a "Happening" comprised of students particularly talented in the musical or comic field. Again Honor Society students assured a sucessful outcome of the show by making tactful suggestions to performing students during their rehearsal sessions. The "Happening" proved overwhelmingly sucessful and its profits were put to good use: two Xmas trips, one to Edaville railroad in Carver and one to Arthur Fiedler's "Nutcracker Suite" in Boston were organized for the elderly. The remainder of the profits was sent to the Plymouth Unit of the Taunton State Hospital to buy Xmas gifts and necessities for those who would be receiving none.

Last year we started a program in the automotive field to produce a graduate with technical background. The academic portion of the auto mechanics class consists of English, Related Math, Drafting, and Related Science. These courses provide specific training related to the auto service industry.

The shop portion deals with tools and equipment, both hand and power, used in the auto industry; identification and parts selection; general service and lubrication; tire changing; and topics generally related to service stations and garages in the first year. Second year students study the mechanical aspects of engines and drive trains, including the actual rebuilding of engines and transmissions.

This year there are 14 juniors and 14 seniors participating in the program. Of the seniors 6 are already employed part-time in the auto field, and the local dealerships have asked about employing others upon graduation. This employment will be the ultimate judge of the program's effectiveness.

This year Plymouth-Carver High School again gave juniors and seniors two days off from regularly scheduled activities to explore areas of interest to the students. For the most part the project is student directed under the sponsorship of Mrs. Urann. Many of the seminar leaders were former students, namely, Mr. Brooks Johnson, Reverend Peter Gomes, and Mr. John Adrews. Other distinguished guests were Mr. Richard Govone, Executive Director of Camps for deserving boys and girls; Mr. Joseph McCormack, former Chairman of the Massachusetts Parole and Advisory Board; Dr. Ruth Fox, Fellow, Child Psychiatry, Harvard College; Miss Basilla Neilan, Consultant, Norfolk County

District Attorney's Drug Abuse Program; Father Bernard Lane, Founder, Adolescent Counseling Alienated and Drug Dependent Youth; Mr. Steven Minter, Commissioner, Public Welfare; Miss Sue Ann Chan, Youth Advisor, U.S. Delegation, United Nations; Mr. Jeffrey Newman, Staff member, Association of Indian Affairs.

The subjects ranged from Race Relations, Peace, The Effect of the News Media, To-Day's Hang Ups, and the Crisis in Family Life to Commitment Instead of Protest- Involvment Instead of Evasion. The sucess of the program was clearly indicated by the students' enthusiatic participation as well as by the comments of the guests. Mr Jeffrey Newman, of the Association of Indian Affairs wrote as follows: "Your Operation: RAP was an excellent program and I continue to be impressed with the taste and quality with which it was produced. Plymouth-Carver High School must surely be a leader in this most important kind of activity." We, in turn, are grateful for the support of the Plymouth-Carver Regional School Committee, without whose support such quality programs would not be possible.

The Class of 1971 received \$65,924 from scholarships and financial aid. Of the total received \$53,832 is being accepted and \$23,387 is the amount of the local program. To you, the loyal citizens of Plymouth and Carver, we express our deepest gratitude for your warm generosity, support, and faith in our young people.

The progress made I consider to be a tribute to the faculty and the student body who made it possible. We consider ourselves fortunate to have had the continued support of the citizens of our communities, and are deeply appreciative for the support of the superintendent's office and community agencies. We offer you the very singular promise of continued service towards a sound education as the only heritage that we can leave our students.

REPORT OF THE DIRECTOR

PUPIL PERSONNEL SERVICES

1970 - 1971

The 1970-71 school year has offered a continued challenge to Pupil Personnel Staff of Plymouth-Carver schools. In most cases, meeting the challenge was a rewarding experience. However, increased school population has placed a greater demand on the frequency of staff services required and we are sometimes left with a feeling of frustration in the attempt to provide for the individual needs of some students. It is with this objective in mind that we continue to stress parental and community involvment in the educational process. The importance of the significant adults in each child's life plays a major role throughout the formative years a child spends in school. The pupil personnel staff has devoted many hours during the past year to the improvement of communication between home, community and school. Some of the specific activities directed toward this end during the past year are: the formulation of parent discussion groups in the Plymouth schools with additional groups to be formed in Carver in the very near future; in-service programs for teachers studying the individual needs of children; increased frequency of home visits by counselors and nurses; evening counseling sessions available to the community twice a month at Plymouth-Carver High School; increased orientation programs for parents and students at both the elementary and secondary grades; expanded inter-agency cooperation between

the schools and the various local and state social agencies; the development of a more refined referral procedure for those students who require in-depth study and individual assessment; and increased utilization through coordination, cooperation, and consultation of area medical andmental health personnel. It is hoped that we can continue to make significant progress through the cooperative efforts of the community especially as it concerns the welfare of our students.

There have been several staff changes and additions during the past year. Mrs. Edith Whiting, R.N., tendered her resignation as an elementary school nurse for the Plymouth schools in June and Mrs. Joan Stevens, R.N., elected to submit her resignation as head school nurse in the Plymouth schools in January. We wish them both well and thank them for their dedicated service. Mrs. Elizabeth Vacchino, R.N., was appointed to the position of Nurse Coordinator in addition to her duties at the Nathaniel Morton School. Mrs. Mary Baietti, R.N., and Mrs. Jane Montanari, R.N., were appointed to fill the health staff vacancies in the Plymouth schools. The increased enrollment of Plymouth-Carver High School necessitated the addition of a part-time health aide in the person of Mrs. Cecilia Borgatti to assist Mrs. Ruth Volta, R.N., in the performance of her duties.

The Carver schools added their first full-time counselor in September. It is felt that this increased service greatly expands the total staff potential for the future and that Mrs. Virginia Delaney has to date proved to be a valuable addition to the staff of the Governor John Carver School. Miss Muriel Stern resigned her counseling position at Plymouth-Carver High School to return to Watertown in a similar capacity. Miss Linda

Bartoccini joined the high school staff in August with sound experience in both school counseling and social work. In order to provide a more efficient guidance and counseling service at Plymouth-Carver High School, Mrs. Jean Patenaude was appointed as Head Counselor. This new position provides for a more coordinated effort as the responsibilities of the Director of Pupil Personnel Services expand requiring more time away from the high school. It is anticipated that as the school population grows increased student, parent, and community needs will demand a greater number of personalized services for our population. Every attempt is being made to assess these needs in preparation for the future.

REPORT OF THE

PUBLIC WORKS STUDY COMMITTEE

TO THE VOTERS OF CARVER

In accordance with the vote of the Regular Town Meeting held on March 28, 1970 the Committee appointed by the Moderator under Article 18, to make a study and report relative to a Department of Public Works, herewith submits its report and recommendations for your consideration.

The Committee met and organized on July 6, 1970 electing Paul Record, Chairman and Onni H. Erickson, Clerk. Plans were formulated to cover all phases on the question of a Department of Public Works for Carver and to recommend the acceptance or rejection of such a proposal. Field trips and meetings were held with representatives of outside towns including Marion, which has operated a Department of Public Works for several years; Whitman, which has operated under a Department of Public Works since 1949; and reports on the town of Scituate, town of Pembroke and the town of Marshfield. Meetings were also held with Park Commissioners, Highway Surveyor, Cemetery Commissioners and Tree Warden. A further meeting was held at Town Hall with the heads of all Town Departments wherein, among other matters, the establishment of a Public Works Department was discussed.

As a result of many hours of dicussion and interchange of ideas and opinions from among the groups with whom the Com-

mittee met, the following ideas have been expressed:

- (1) A Department of Public Works would provide for the utilization of similar skills, materials, equipment and methods of administration.
- (2) Most Departments of Public Works centralize the elements of engineering and planning.
- (3) Under a Department of Public Works planned coordinated work programs and long range planning are more likely to result.
- (4) A Department of Public Works provides for a beneficial interchange of personnel and pooling of equipment thereby providing better distribution of work loads of different departments.
- (5) Personnel policies and practices may be standardized to utilize to a greater degree available manpower and work programs.
- (6) Under a Department of Public Works there is a greater chance for maximum efficiency, more value for each dollar spent, which in turn would result in better service and more completed projects.
- (7) All Department of Public Works activities would be coordinated under one authority, thereby rendering better service for solving the individual problems of the taxpayers.
- (8) Under a Department of Public Works there may be centralized purchasing for the various divisions which would result in monetary savings.

Due deliberation and careful consideration has been given to the proposed act. Basically it is similar to those drawn by other towns but with certain variations which the Committee believes are more suitable for the needs of the town. A commission of three members is recommended on the basis that such number would provide fair and equal representation throughout the town. The Committee suggests that the Commissioners serve without compensation.

The Committee is of the opinion that the departments named in the act should be the nucleus of a Public Works Department, with changes or additions from time to time as the town may determine. The act further provides for the appointment and compensation of a superintendent. Salaries of superintendents in various localities have a various price range depending on their duties and the size of the community which they serve. It is felt for this town a salary range of \$9,000 to \$12,000 would be within reason and the means of the town.

The act also provides that there shall be no reduction or dismissal of permanent personnel because of its establishment.

The Committee has devoted considerable time to the cost of a Public Works Department. It was discussed with representatives of towns operating under a Department of Public Works. From information and facts obtained it is the opinion of the Committee that there would be a definate savings through the establishment of such a department. This would be accomplished in part by a coordination of available manpower, pooling of equipment and centralized purchasing, as well as coordinated and long range planning.

The increase in services and efficiency would tend to provide for greater economy. This appears substantiated by the fact

that no town has repealed its action having once established a Department of Public Works.

Due recognition is given by the Committee to the various individuals, Departments and Commissioners for their loyal and faithful service rendered to the town. The Committee also wishes to express its thanks for their cooperation and expression of opinions and ideas.

The Committee therefore is of the strong belief that a Department of Public Works is needed, recommends the acceptance of its report and further recommends the establishment of a Department of Public Works for the Town of Carver in accordance with the following act.

TOWN WARRANT AND REPORT OF FINANCE COMMITTEE

PLYMOUTH, ss. To either of the Constables of the Town of Carver, GREETING:

In the name of the Commonwealth of Massachusetts, you are directed to notify and warn the Inhabitants of the Town of Carver qualified to vote in elections and in town affairs to meet at the Governor John Carver School House in Said Carver on Saturday, the eighteenth day of March 1972, at 12:00 o'clock, noon, then and there to act on the following Article, namely:

Article 1. To choose all necessary town officers, to be voted for all on one ballot, viz.: One Moderator, Three Auditors, One member of School Board (to fill vacancy), each for one year; One Selectmen, One Assessor, One Highway Surveyor, One member of School Board, One Park Commissioner, One Cemetery Commissioner, Two Library Trustees, One Tree Warden, each for a term of three years; One member of Planning Board for a term of five years, and to vote by ballot "Yes" or "No" on the following questions:

QUESTION No. 1

"Shall an act passed by the General Court in the year nineteen hundred and seventy-one, entitled 'An Act authorizing the Town of Carver to establish a department of public works exercising the powers of certain other departments and town officials', be accepted?"

QUESTION No. 2

"Shall licenses be granted in this town for the opera-

tion, holding or conducting a game commonly called beano?"

The polls will be open for at least eight hours.

And you are directed to further notify said Inhabitants of said Town that as soon as the ballots have been counted the meeting will adjourn to Saturday, March 25, 1972, at 1:00 o' clock P.M., and at that time will reconvene at said Governor John Carver School House, then and there to act on the following Articles, namely:

Article 2. To see if the Town will vote to authorize the Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue for the financial years beginning January 1, 1972 and January 1, 1973, in accordance with the provisions of General Laws, Chapter 44, Section 4, and to renew any note or notes as may be given for a period of less than one year, in accordance with the provisions of General Laws, Chapter 44, Section 17.

amended by adding after the words "sheathing is used" the following words "framing lintels over openings in bearing walls or partitions of one and two story structures shall consist of double joists not less than herein specified or trussed construction bearing on Jack studs or other approved construction affording adequate strength".

Spans four (4) feet to six (6) - two 2"x6"
Cpans six (6) feet to eight (8) - two 2"x8"
Spans eight (8) feet to ten (10) - two 2"x10"
This does not include plates.

Section 10, paragraph K to be deleted and the following Section 10, paragraph K to be inserted in lieu thereof "all ceiling joists shall have a 2'0" lap or by-pass at bearing partition. Rafters shall be selected and spaced not to exceed the requirements specified in the following data and rafter table:

The use of White Pine may be permitted by using a 20 per cent safety factor under the above allowable spans for spruce.

For flat roofs and roofs having a slope of less than 20 degrees, use the tables for floor joists shown under Section 10, paragraph C.

Where collar ties are used, rafter lengths may be increased 50 per cent over the allowable spans noted in the above table. The increase in rafter length may be allowed only when collar ties are placed within the limits of the middle one third of the rafter length. On page 5, Section IV A 2: amend by adding a new paragraph after "d" as follows:

"e. Apartment Buildings: The operation of those portions of the Protective By-Law providing for construction of Apartment Buildings, whether or not subject to approval by the Board of Appeals, is hereby suspended so as not to permit such construction in any district of the town until positive action is taken by the Town Meeting relative to adoption of a Building Code applicable to such construction and until adoption of further revisions of the Protective By-Law as it applies to such use, but in any event, not later than April 17, 1973. Nothing in this action shall be deemed to affect any permits or variances previously granted by the Board of Appeals or any application pending before them prior to March 25, 1972.

On page 5, Section IV-A-3: add the following new paragraph: "b" Removal of gravel, loam, peat, turf, sand, stone, etc. to points outside the Town of Carver."

On page 7, Section V-A-(d): change the period at the end of the sentence to a comma and add the following: "provided that the formula (perimeter in feet, squared, and divided by the area in square feet shall equal not more than 22) shall apply to all lots." (by Planning Board)

Article 35 Recommended by the Finance Committee.



COVER PICTURE STORY



The cover depicts the new and elegant building to house the Carver Public Library, in a pen and ink sketch by Janet Webster Norton, of Harrub House, Harrub Corner, Plympton. Mrs. Norton, a distinguished artist is well known for her murals on the walls of the Plymouth Five Cent Savings Bank. Her sketch shows the library with planned landscaping as it will appear in the not too distant future, an ornament worthy of a place beside the Town House.

The Carver Public Library dates back to the last decade of the Nineteenth Century, about the time when there was a renaissance of interest in all sorts of local enterprises. It will be remembered that the Old Home Day Association had its inception, and the Carver High School, too, under Principal Henry H. Rice, at about this same time.

Lodged in the upper chamber of the Old Town House near the home of the former town clerk, Mr. Albert Shurtleff, it provided an outlet for the inhabitants to broaden their horizons. Open on Saturday afternoons and lighted by wall-bracked kerosene lamps at dusk, it was the place where North and South had opportunity of much social concourse.

Among the early trustees were Albert Shurtleff, a veteran of the War between the States, and wounded at Shiloh, and Town Clerk of Carver; Myrick Bump, whose daughter, now a trustee herself, and a present help when assistance is needed to recall the past; and Seth Finney.

Mrs. Laura Hudson, the daughter aforementioned, well remembers the first cataloging of the books under the direction

of a librarian imported from Boston. The firse regular librarian was Bernice Barrows, the wife of Frank Barrows, Esq., who served as a representative to the Massachusetts General Court from the Plymouth District.

Later the library was moved to the Town Hall and occupied the basement. Later it went upstairs and then top-side where it is today until the volumes are moved to the new and ample edifice.

Among the early librarians were the wife of Rev. Hidden of the Baptist Society, Eleanor Shaw, Lucy Atwood, Lillian Vaughan and more recently Myrtle Martin, second wife of Jack Martin who served many years as Town Clerk.
