Eino F. Harju was in a Boston hospital recovering from heart bypass surgery when he decided that the time had come----if he successfully overcame the major surgery and before any further time passed----to bring to fruition his longtime plans to memorialize the Carver residents who served gallantly and loyally in World War I and World War II.

Upon his return to Carver from his hospitalization Eino, using the Carver Legion Post as a starting point, suggested a committee be formed to plan and design a suitable stone monument and to create as complete a list as possible of the men and women from Carver who served in both World Wars. This committee initially was made up of Harju, George J. Harriman, Myron T. Weston, Nelson Thomas, Roger H. Parent, and Domingo G. Thimas. These men, with assistance from Wilho Harju and Winston A. Weston, worked many hours on a list of Carver veterans of the two wars which came from Town records and the extremely valuable Red Cross records and recollections of Olive Ward McKay. The committee made lists available to all Carver residents for additions and corrections.

Eino Harju purchased the monument, had it engraved, transported to Carver and placed on the spot in Shurtleff Park where it now rests, a spot that Eino and Frank R. Mazzilli felt was suitable and fitting. Two shrubs were given by Domingo Thatcher and the monument was unveiled during the 1984 Memorial Day ceremonies. A proper dedication of the World War I and II stone was accomplished following a parade organized by the Carver V.F.W. Post on Veterans Day 1984.

Those who contributed to the planning, procurement and erection of this fitting memorial should be jsutly proud and the Town of Carver, its residents, the families and friends of those whose names are etched on this granite should also be proud and thankful to Eino F. Harju for his generosity and remembrance to those who served from Carver in the two World Wars....Thank you Eino....Well done!

**Paul Anthony Ford, 74, former chairman of Carver Health Board.** Born in Boston, son of the late Jeremiah J. and Mary F. (Carroll) Ford, he lived in South Boston before moving to Carver 23 years ago. Mr. Ford had been a letter carrier with the Milton Post Office and was also retired from the Registry of Motor Vehicles in Plymouth, where he had been a clerk.

During World War II he served in the U. S. Army in the Italian Campaign, and was recipient of the Infantry Combat Award, Bronze Star and European Theater of War Ribbon, as well as several others.

He was former chairman of the Carver Board of Health and also served on the the town's Board of Appeals. He was a member of the Senior Citizens, American Association of Retired Persons, National Association of Letter Carriers, Retired State, County and Municipal Employees Association, Democratic Town Committee, Plymouth County Democratic Committee and American Legion Post 164. In addition, he was a life member of the DAV in Middleboro and VFW Post 7421 in Carver.

# **Special Town Meeting**

#### February 27, 1984

A Special Town Meeting of the Inhabitants of the Town of Carver was held at the Governor John Carver School on Monday, February 27, 1984, pursuant to a Warrant of the Board of Selectmen dated February 8, 1984.

The meeting was called to order at 7:30 P.M. by the Moderator, Robert O. Mott, there being a quorum present. In the absence of the Town Clerk, Alan I. Dunham was duly elected Temporary Town Clerk. The meeting then proceeded to act on the Articles in the Warrant as follows:

Article 1. Upon motion duly made and seconded, it was unanimously VOTED to authorize the Treasurer to establish in the Town Treasury a revolving fund which shall be kept separate and apart from all other monies by the Treasurer and in which shall be deposited all funds received by way of grant, gift or donation in behalf of the Marcus Atwood House. The principal and interest thereon shall be expended for maintenance of the Marcus Atwood House only at the direction of the Marcus Atwood House Trustees and with the approval of the Board of Selectmen.

Article 2. Upon motion duly made and seconded, it was unanimously VOTED to transfer from the Revenue Sharing Trust Fund Account the sum of Sixteen Thousand Two Hundred (\$16,200.00) Dollars to the Public Health Nurse Physical Therapy Account for the purpose of paying therapy bills for the remainder of the fiscal year ending June 30, 1984.

Article 3. Upon motion duly made and seconded, it was VOTED to purchase two (2) cruisers to be used by the Police Department and to transfer the sum of Twenty-one Thousand Three Hundred Thirty-four (\$21,334.00) Dollars from the Revenue Sharing Trust Fund Account. Said account to be under the direction of the Selectmen.

Article 4. Upon motion duly made and seconded, it was unanimously VOTED to transfer the sum of Sixteen Thousand Five Hundred (\$16,500.00) Dollars from the Ambulance Fund Account to the Ambulance Operating Account, said sum to be under the control of the Board of Selectmen.

Article 5. To see if the Town will vote to allow a building to be built on town property across from the Police Station, said building to be used to house the town ambulance service, or take any other action relative thereto.

Upon Motion duly made and seconded, it was unanimously VOTED to take no action on Article 5.

Article 6. Upon motion duly made and seconded, it was VOTED to transfer the sum of Ten Thousand Six Hundred Sixty-seven (\$10,667.00) Dollars from the Revenue Sharing Trust Fund Account for the purpose of purchasing a new cruiser for the Fire Department.

Article 7. Upon motion duly made and seconded, it was unanimously VOTED to transfer the sum of Twelve Thousand One Hundred Ninety-five (\$12,195.00) Dollars from the Revenue Sharing Trust Fund Account for the purpose of paying the second of three payments on a 1983 John Deere Loader used by the Department of Public Works, all in accordance with the Lease/Purchase Agreement (including insurance) executed on May 24, 1983 with John Deere.

Article 8. Upon motion by Erwin K. Washburn, duly seconded, it was unanimously VOTED to approve the amount of \$1,010,000.00 debt authorized on January 10, 1984, by the Plymouth-Carver Regional District School Committee for the purpose of financing costs of purchasing and installing portable or relocatable classrooms to be located initially at the Plymouth-Carver High School, including costs incidental thereto.

**Article 9.** Upon motion by Erwin K. Washburn, duly seconded, standing vote being had, with 71 voting in the affirmative and 23 opposed, it was VOTED that the Town petition the General Court for the passage of a special law relating to the Town of Carver in substantially the following form:

#### AN ACT RELATING TO TAXES ASSESSED IN THE TOWN OF CARVER

#### Be it enacted, ect., as follows:

SECTION 1. In addition to the amounts by which the total taxes assessed by the Town of Carver may be increased in any fiscal year pursuant to the provisions of section 210 of Chapter 59 of the General Laws, the total taxes assessed in the Town of Carver for the current fiscal year may be further increased by an amount determined by multiplying the approved amount assessed by any regional school district of which the Town of Carver is a member upon all of its member towns for such then current fiscal year by a percentage equal to the increase, if any, in (a) the percentage share of the total regional school district assessment which is to be borne by the Town of Carver for the then current fiscal year over (b) the percentage share of the total regional school district assessment which was borne by the Town of Carver for the preceding fiscal year.

SECTION 2. This act shall take effect upon its passage.

Article 10. Upon motion duly made and seconded, it was unanimously VOTED to transfer from available funds in the Treasury the sum of Two Thousand Five Hundred Twenty-seven Dollars and Fifty Cents (\$2,527.50) to reimburse the Treasury of the County of Plymouth for awards payable from the Treasury of said county for damages caused by the taking of land on Ward Street, under the provision of Plymouth County Commissioners' Decree No. 1491, dated January 17, 1984.

Article 11. Upon motion duly made and seconded, it was VOTED to accept in fee simple a 40-foot wide 1250 foot long right of way at the end of Ward Street, The right of way being as shown on a plan entitled "Plan of Right of Way, Carver, Massachusetts or granted by Daniel F. & Janice L. O'Connor to Mobile Village Realty Trust, Scale 1'' = 80' dated August 28, 1981, drawn by Lawrence E. Hughes, Registered Land Surveyor, Kingston, Massachusetts" and recorded in the Plymouth County Registry of Deeds. The right of way to be used for Highway purposes. The right of way to be named Ward Street.

Article 12. To see if the Town will vote to remove the Town of Carver from the Plymouth County Dog Fund and to instruct the Selectmen to petition the legislature for their approval.

Upon motion by Frank R. Mazzilli, duly seconded, it was VOTED to "withdraw" the Article.

Article 13. Upon motion by Erwin K. Washburn, duly seconded, it was unanimously VOTED to transfer from free cash, in the Treasury, the sum of Thirty-nine Thousand (\$39,000.00) Dollars to meet interest charges on a temporary loan in anticipation of bond issue for the construction of an addition to the Governor John Carver School, and, also, to defray all charges and costs in connection with said bond issue.

Article 14. Upon motion by Erwin K. Washburn, duly seconded, it was unanimously VOTED to transfer the sum of Twenty-four Thousand Thirty (\$24,030.00) Dollars from the Revenue Sharing Trust Fund Account for the purpose of purchasing, equipping and insuring one new school bus for the School Department, said amount to be expended under the direction of the School Committee.

Article 15. Upon motion duly made and seconded, it was unanimously VOTED to instruct the Selectmen to petition the legislature to allow the Town of Carver to be

exempt from that part of sentence number three in Chapter 44, section 53D that reads "provided that such funds in said revolving fund shall not be used to employ or pay the salary of any employee or for the purchase of equipment."

At this time motion was duly made and seconded to reconsider Article 6. Voice vote being had, the motion to reconsider was DEFEATED.

There being no further business to come before the meeting, and upon motion duly made and seconded, it was unanimously VOTED to adjourn.

# **Presidential Primary**

March 13, 1984

The Presidential Primary Election was held at the Governor John Carver School on Tuesday, March 13, 1984, pursuant to a Warrant of the Board of Selectmen dated February 14, 1984. The meeting was called to order at 7:00 A.M. by the Warden, Eugene P. Souza. The following named Election Officers were present at the opening of the polls and were duly sworn to the faithful performance of their duties by the Town Clerk; thereafter they were assigned to their respective duties, as follows:

A total of 1760 Republican Ballots and 3298 Democratic Ballots were delivered to the Ballot Clerks by the Town Clerk. The Warden ordered the polls open at 7:00 A.M. and announced that the polls would close at 8:00 P.M. The Ballot Box registered zero at the opening of the polls.

The election proceeded without interuption until 8:00 P.M., at which time the Warden declared the polls closed. At closing time the ballot box registered a total of 1002 ballots cast. Of the 1002 ballots cast 848 were Democratic Ballots of which 12 were absentees; there were 154 Republican Ballots cast, of which 3 were absentees. This tallied with the lists of the Ballot Clerks.

The ballots were then removed from the Ballot Box, audibly counted, and delivered to the Tellers for canvassing and counting, they having been duly sworn to the faithful performance of their duties.

# **Annual Town Meeting**

#### April 23, 1984

The Annual Town Meeting of the Inhabitants of the Town of Carver was held at the Governor John Carver School on Monday, April 23, 1984, pursuant to a Warrant of the Board of Selectmen dated March 14, 1984. The meeting was called to order at 7:30 o'clock P.M., by the Moderator, Nancy A. Seamans, there being a quorum present. The Invocation was given by Rev. Robert H. Merritt, followed by the Pledge of Allegiance. The Moderator appointed Robert Bentley, Peg Wiltshire, Andrew Herf, Ron Mitchell and Dorita Cunningham to serve as Tellers to count the votes, and they were duly sworn to the faithful performance of their duties.

Upon motion duly made and seconded, it was unanimously VOTED to dispense with the reading of the Warrant. Article 1, relating to the election of Town Officers, etc. having been disposed of at a prior meeting, the meeting then proceeded to act on the Articles in the Warrant, as follows:

Article 2. Upon motion duly made and seconded, it was unanimously VOTED to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning July 1, 1984, in accordance with the provisions of General Laws, Chapter 44, Section 4, and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with General Laws, Chapter 44, Section 17.

Article 3. Upon motion duly made and seconded, it was unanimously VOTED to transfer from free cash in the treasury the sum of Six Thousand (\$6,000.00) Dollars to meet interest charges on temporary loans.

Article 4. Upon motion duly made and seconded, it was unanimously VOTED to transfer from free cash in the treasury the sum of Forty Thousand (\$40,000.00) Dollars to the 1985 fiscal year Reserve Account.

Article 5. Upon motion duly made and seconded, it was VOTED to hear the report of any standing committees and to abolish any special committee not submitting a report unless otherwise voted, and to establish any new committee.

Thereupon, the following Committee reports were presented:

1. William R. Holmes presented a written report for the Town Barn Study Committee. Report was accepted and it was VOTED to continue the Committee.

2. Robert E. Wiltshire presented a written report for the Carver Youth Needs Committee. Report was accepted and VOTED to continue Committee.

3. Charles Erwin reported (orally) for the School Needs Study Committee. Report accepted and VOTED to continue Committee.

Article 6. Upon motion duly made and seconded, it was unanimously VOTED to transfer from free cash in the treasury, the sum of \$100.00 to be expended by the Trustees for Plymouth County Cooperative Extension Service and choose a Director in accordance with the provisions of General Laws of Massachusetts, Chapter 128, Section 41 and 42. Thereupon, Jean O. Gibbs was unanimously chosen Director.

Article 7. Upon motion duly made and seconded, it was unanimously VOTED to transfer the sum of \$661.68 from the County Dog Fund to the Library Operating Account.

Upon motion duly made and seconded, it was VOTED to transfer from available funds in the Treasury the sum of Thirty-Thousand Fifty-four (\$30,054.00) Dollars to reimburse the Treasury of the County of Plymouth for awards payable from the Treasury of said County for damages caused by the taking of land on Plymouth Street—Section 11, under the provisions of Plymouth County Commissioner's decree No. 1499, dated February 21, 1984.

Article 13. Upon motion duly made and seconded, it was VOTED to transfer the sum of Ten Thousand One Hundred Fifty (\$10,150.00) Dollars from the Revenue Sharing Trust Fund Account for the purpose of purchasing large diameter hose for the Fire Department.

Article 14. Upon motion duly made and seconded, it was unanimously VOTED to transfer the sum of Three Thousand Five Hundred (\$3,500.00) Dollars from available funds in the Treasury for the purpose of meeting the charges against the Cemetery Fund in the Town Treasury.

Article 15. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate the sum of Two Thousand (\$2,000.00) Dollars to be used to pay for all private work and materials in Town Cemeteries such as opening graves, building foundations, etc.

To see if the Town will vote to transfer from available funds in the Treasury the sum of \$11,233.00 which may be used for State Aid Construction or Improvements under Chapter 289 (FY 83) in conjunction with available State funds of \$33,697.00 and, in addition, to transfer from available funds in the Treasury the sum of \$33,697.00 to meet the State's share of cost of work, reimbursement received therefrom to be returned to the Treasury.

Motion duly made and seconded that the Article be "withdrawn." It was unanimously SO VOTED.

Article 19. Upon motion duly made and seconded, it was unanimously VOTED to transfer from available funds in the Treasury the sum of Ten Thousand Eight Hundred Forty-nine (\$10,849.00) Dollars which will be used for State Aid Construction or Improvements under Chapter 637 (FY 84) in conjunction with available State Funds of Thirty-two Thousand Five Hundred Forty-seven (\$32,547.00) Dollars.

Article 20. Upon motion duly made and seconded, it was unanimously VOTED to transfer from available funds in the Treasury the sum of Ten Thousand Eight Hundred Forty-nine (\$10,849.00) Dollars which will be used for State Aid Construction or Improvements under chapter 637 (FY 85) in conjunction with available State Funds of Thirty-two Thousand Five Hundred Forty-seven (\$32,547.00) Dollars.

Article 21. To see if the Town will vote to raise and appropriate the sum of Two Thousand Five Hunded (\$2,500.00) Dollars to purchase tools and equipment to be used by the men from MCI, Plymouth, in their work for the Town of Carver.

Upon motion duly made and seconded, it was VOTED that Article 21 be "withdrawn."

Article 22. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate the sum of Three Thousand Two Hundred Twenty Dollars and Fifty Cents (\$3,220.50) to pay the following unpaid bills of 1983:

Article 23. Upon motion duly made and seconded, it was unanimously VOTED to raise and appropriate the sum of Five Thousand (\$5,000.00) Dollars for the purpose of conducting a State Census and local redistricting as per Massachusetts Constitution. A reimbursement of twenty five cents per resident will be returned to the Town of Carver.

Article 24. Upon motion duly made and seconded, it was unanimously VOTED to allow the Carver Fire Department to use a portion of Lot 12 of Sheet 16 of the Assessor's Plans on Green Street, better known as the "Poor House Lot" in North Carver for the purpose of constructing a new Fire Station, said area to be decided by the Selectmen.

At this Town Meeting the Finance Committee made oral recommendations on each Article and item appearing in the Warrant.

There being no further business to come before the meeting, and upon motion duly made and seconded, it was unanimously VOTED to adjourn.

# **Special Town Meeting**

#### June 28, 1984

A Special Town Meeting of the Inhabitants of the Town of Carver was held at the Governor John Carver School House on Thursday, June 28, 1984, pursuant to a Warrant of the Board of Selectmen dated June 13, 1984. The meeting was called to order at 7:35 P.M., by the Moderator Nancy A. Seamans, there being a quorum present. The Moderator opened the meeting with the Pledge of Allegiance. Joan White, Margaret Lamprey, Helen Copello and Beverly Chinetti were appointed by the Moderator to serve as Tellers to count the votes, and they were duly sworn to the faithful performance of their duties.

Article 1. The entire Article was duly moved and seconded and unanimously VOTED after the Amendments were presented by Erwin K. Washburn, which was to accept the Amendments as printed (on file in the Town Clerk's Office). This Article was recommended by the Finance Committee.

Article 2. Upon motion by Erwin K. Washburn, duly made and seconded, it was unanimously VOTED to approve the \$25,000,000.00 debt authorized on May 22, 1984 by the Plymouth-Carver Regional District School Committee. This Article was recommended by the Finance Committee.

Article 3. Upon motion by Erwin K. Washburn, duly made and seconded, it was unanimously VOTED to approve the \$14,000,000.00 debt authorized on May 22, 1984 by the Plymouth-Carver Regional District School Committee. This Article was recommended by the Finance Committee.

Article 4. Upon motion by Erwin K. Washburn, duly moved and seconded, it was unanimously VOTED to transfer the sum of \$12,526.29 from the Liquid Investment Account to the Elementary School Addition Account. This Article was recommended by the Finance Committee.

Article 5. Upon motion made by Erwin K. Washburn, duly moved and seconded, standing VOTE being had, with 114 voting in the affirmative and 86 opposed, it was SO VOTED that the town petition the General Court for the passage of a special law relating to the Town of Carver in substantially the following form: As printed. This Article was recommended by the Finance Committee.

Article 5. To see if the Town will petition the General Court for the passage of a special law relating to the Town of Carver in substantially the following form:

SECTION 1. Notwithstanding the provisions of any general or special law to the contrary, the total taxes assessed in the Town of Carver for any fiscal year may be increased in addition to any increases authorized by chapter fifty-nine of the General Laws by an amount determined by multiplying the approved amount assessed by any regional school district of which the Town of Carver is a member upon all of its member towns for such then current fiscal year by a percentage equal to the increase, if any, in (a) the percentage share of the total regional school district assessment which is to be borne by the Town of Carver for the then current fiscal year over (b) the percentage share of the total regional school district assessment which was borne by the Town of Carver for the preceding fiscal year.

SECTION 2. The state secretary shall cause to be placed on the official ballot to be used at the biennial state election to be held in the year nineteen hundred and eighty-four in the Town of Carver the following question: "Shall an act passed by the general court in the year nineteen hundred and eighty-four, entitled 'An act authorizing an increase in the taxes assessed in the Town of Carver for increases in cost assessed by a regional school district', be accepted?". If a majority of votes in answer to said question is in the affirmative, then this act shall thereupon take full effect, but not otherwise.

(FY 84) (by Carver School Committee)

Article 6. Upon motion made by Police Chief, Thomas S. Orr, duly moved and seconded, it was unanimously VOTED, to amend the sum of \$8,000.00 to \$7,000.00 and to transfer it from the Police Officer's Work Detail Service Charge Account for the purchase of portable radios. This article was recommended by the Finance Committee.

Article 7. Upon motion duly made and seconded, it was unanimously VOTED to transfer from the Police Salary Account the sum of \$1,922.00 to pay William F. Donaldson for unused vacation for the Fiscal Year 1982-1983. This Article was recommended by the Finance Committee.

Article 8. Upon motion duly made and seconded, it was unanimously VOTED to transfer from the Police Salary Account to the Police Overtime Account the sum of \$2,000.00. This Article was recommended by the Finance Committee.

Article 9. Upon motion duly made and seconded, it was unanimously VOTED to transfer from the Police Salary Account to the Police Overtime Account the sum of \$3,000.00. This Article was recommended by the Finance Committee.

Article 11. Upon motion duly made and seconded, it was unanimously VOTED to transfer the sum of \$200.30 from the Work Zone Protection Kit Account and the sum of \$250.00 from the Insect and Pest Control Salary Account to the Board of Public Works Salary Account. This Article was not recommended by the Finance Committee.

Article 12. Upon motion duly made and seconded, it was unanimously VOTED to transfer the sum of \$340.00 from the Supt. of Public Works Salary Account to the Department of Public Works Operating Expense Account. This Article was recommended by the Finance Committee.

Article 13. Upon motion duly made and seconded, it was unanimously VOTED to transfer the sum of \$200.00 from available funds in the Treasury to the Oiling and Paving Account. This Article was recommended by the Finance Committee.

Article 14. Upon motion duly made and seconded, it was unanimously VOTED to transfer the sum of \$32.72 from the Dutch Elm Salaries Account to the Cemetery Operating Account. This Article was recommended by the Finance Committee.

Article 15. Upon motion duly made and seconded, and after some discussion, it was unanimously VOTED for the Town of Carver, to raise and appropriate the sum of \$15,000.00 for the purpose of constructing Ward Street. This Article was not recommended by the Finance Committee.

Article 16. Upon motion duly made and seconded, it was unanimously VOTED to transfer the sum of \$25,000.00 from the Ambulance Fund Account to the Ambulance Operating Account. This Article was recommended by the Finance Committee.

Article 17. Upon motion duly made by Frank R. Mazzilli and seconded, this Article was amended to raise and appropriate the sum of \$5,000.00 to be added to the Council On Aging Marcus Atwood Operating and Maintenance Account. It was unanimously VOTED. This Article was recommended by the Finance Committee.

Article 18. Upon motion duly made and seconded, it was SO VOTED to authorize the Selectmen to purchase and have installed a closed-circuit TV system in the Police Station, and to transfer the sum of \$5,000.00 from the Revenue Sharing Trust Fund

Account for this purpose.

Article 19. Upon motion duly made and seconded, it was VOTED to table motion, by Selectman Arthur P. DeCoursey until the end of the meeting.

**Article 20.** Upon motion duly made and seconded, it was unanimously VOTED to establish the following wage scale as part of Section II of the Wage and Personnel Plan for all new employees to be hired on or after July 1, 1984:

A) *Full-Time Personnel (Clerical):* Would start at \$4.50 per hour the first year and receive an additional .25¢ per hour increase each year for the next two years.

B) *Part-Time Personnel (General & Clerical):* Would start at an hourly rate of \$4.25 per hour for the first year and receive an additional .25¢ per hour increase for the next two years.

C) Any Part-Time employee required to obtain an E.M.T. Certificate would receive an additional .25¢ per hour.

Article 21. Upon motion duly made and seconded, this Article was withdrawn by Selectman Daniel B. Daly, Jr.; a member of the Wage and Personnel Board.

Article 22. Upon motion duly made and seconded, and motion to amend this article by Selectman Daniel B. Daly, Jr.; from \$25,000.00 to \$15,551.00, it was SO VOTED that the Town will vote to raise and appropriate the sum of \$15,551.00 to be used to upgrade all of the non-union full and part-time present employees (any person on the payroll as of 5/1/84), the exact amount of steps and grades to be determined by the Wage and Personnel Board with Department Head input. This Article was not recommended by the Finance Committee.

Article 23. Upon motion duly made and seconded, it was unanimously VOTED that the Town raise and appropriate the sum of \$6,240.00 to hire a Clerk/Secretary to fulfill the clerical duties required by the Board of Health. This Article was not recommended by the Finance Committee.

Article 24. Upon motion duly made and seconded, it was unanimously VOTED that the Town raise and appropriate the sum of \$898.56 for the purpose of increasing the Public Health Nurse Clerical Account from 26–30 hours per week. This Article was recommended by the Finance Committee.

Article 25. Upon motion duly made and seconded, it was unanimously VOTED to transfer the sum of \$1,500.00 from the Superintendent of Public Works Salary Account to a Planning Board Engineering Account. This Article was recommended by the Finance Committee.

Article 26. Upon motion duly made and seconded, and discussion by Selectman Daniel B. Daly, Jr., it was SO VOTED to instruct the Planning Board to pepare for consideration at the 1985 Annual Town Meeting a Residential Growth Policy as recommended by the Carver Master Plan. This Article was recommended by the Finance Committee.

Article 27. Upon motion duly made and seconded, it was unanimously VOTED to accept the sum of \$3,000.00 as a gift from Alden E. and Eleanor L. Cousins, said sum to be added to the 1984-85 School and Vocational Education Appropriation for the sole purpose of hiring first grade teacher's aides. This Article was recommended by the Finance Committee.

Article 28. To see if the Town will vote to raise and appropriate a sum of money for the purpose of purchasing, equipping and insuring a new school bus for the School Department, said amount to be expended by the School Committee. Article was duly moved and seconded.

Upon motion duly moved and seconded, by Erwin K. Washburn, and amendment being Voted, it was unanimously VOTED to transfer the sum of \$24,030.00 from the

Revenue Sharing Trust Fund Account. This Article was recommended by the Finance Committee.

Article 29. To see if the Town will vote to raise and appropriate the sum of \$54,535.00 said sum to be added to the 1984-85 School and Vocational Education appropriation. Motion duly made and seconded, it was unanimously VOTED to accept this Article. This Article was recommended by the Finance Committee.

Article 19. Upon motion duly made and seconded, to see what amount the Town will vote to raise and appropriate to the Stabilization Fund. The Chairman of the Finance Committee Nicholas Femia, motioned to recommend \$30,000.00. Motion DEFEATED.

Article 28. This Article was reconsidered. It was duly moved and seconded to transfer from raise and appropriate to Revenue Sharing Trust Fund account, the amount of \$26,000.00 instead of \$24,030.00. It was SO VOTED.

There being no further business to be brought forth at the meeting, and upon motion duly made and seconded, it was unanimously VOTED to adjourn.

(By Carver Planning Board)

A total of 4850 ballots were delivered to the Ballot Clerks by the Town Clerk. The Warden, Eugene P. The Ballot Box registered zero (0) at the opening of the polls.

### **Office of Emergency Preparedness**

The emergency plans for the Town of Carver were updated and submitted to the State Civil Defense Agency.

The required Federal Emergency Management Agency test for the Pilgrim I EPZ was held on June 23, and successfully passed by Carver.

Members of the civil defense staff attended state and federal seminars on emergency planning and radiological accident handling.

An emergency power system was established at the EOC for the radio system.

The Civil Defense Office was appointed the town coordinator office for handicap services.

Emergency assistance was rendered to a mobile home park when a water systems failure occurred and the participation of the National Guard was achieved in providing emergency water sources.

New telephone service was installed at the EOC and the Civil Defense telephone number changed to 866-9919.

#### **Director's Report**

The Carver Council on Aging provides many services to people in the Town of Carver, who are 59 years of age or older or handicapped. A list of these services, I.D. cards for discounts, names placed on mailing list and a list of surrounding area stores who have discounts for the elderly may be obtained at the Marcus Atwood Multi-Purpose Center in So. Carver, which is open daily Monday through Friday from 9:00 A.M.-4:30 P.M. for information and referral.

The Service Director for the Council on Aging has co-ordinated all mini-bus reservations, mall trips, shopping trips, lunches at Atwood Nutrition Center, medicals, minibus drivers, newsletters, business calls and information and referral calls during the past year. The Director also assisted many people, of all ages, in making out fuel assistance applications and distributed free commodity foods to all who qualified.

The director attends many meetings throughout the year. Most of these meetings pertain to the needs of the elderly, such as: Medicare and Medicaid problems, Social Security and Supplementary Security Income (SSI) Benefits, Fuel Assistance and other energy-related problems. Other meetings include Senior Aide, CIRCA, Area Association of Plymouth County Directors, Old Colony Planning Council, and Old Colony Elderly Services. Also attended were various staff meetings.

The Drop-In Center at the Marcus Atwood Multi-Purpose Center is open daily from 12 Noon to 4:30 P.M. Many activities are enjoyed at the Center and all seniors and handicapped are invited to attend.

Newsletters are mailed out bi-monthly, keeping the elderly informed on any new legislation, changes in Medicare and Medicaid, tax information, and a two month calendar of activities and services. Over the past year the mailing increased from 5,511 to 6,068.

There are three Senior Aides, whose salaries are paid by the Department of Labor, that work at the Carver Council on Aging. Each Aide works twenty hours per week. One of the Aides works out in the Nutrition Center and also makes visits to the sick in hospitals, nursing homes, and the homebound. Another Aide assists in the office and they both take turns handling business affairs in the absence of the Director. The third Aide is acting maintenance man for the Nutrition Center and is a mini-bus driver on a volunteer basis.

During the past year the daily meals served in our Nutrition Center has increased from two days per week to three days per week and are now being served five days per week. The donation for these meals is \$1.00 and all persons who are residents of Carver, 59 years of age or older, or handicapped are welcome to participate.

Since the Nutrition Center has been operating, our "Meals on Wheels" program has grown rapidly, all meals are made on the premises.

The Carver Council on Aging continues to thank the Honorable Board of Selectmen, the Town Boards, and the Townspeople for their continuing outstanding support of their programs.

### **Carver Public Library**

Each year the White House has a conference on Library and information services. This past year they ended their conference by stating: "Information is a national resource and libraries are key to providing equal access to the information people need to live full and effective lives. Today's search for excellence in education makes it imperative that libraries are strengthened as a vital link in the lifelong learning process." There are 14,000 public libraries in America and they circulate more than 1 billion books and materials a year to the public. That is a national average of 5 books per person in America each year. Five books per person is also the Town of Carver's average per year. To strengthen our availability to the Town, we opened more hours. We are now open 34 hours a week instead of 30. Library use has dramatically increased with these 4 extra hours a week open. We are striving to bring Carver Public Library into the future of a strong public information link through technology and print materials. We have added a VCR for public use and will be compiling 'How-to' videos for patron use in the library or at home. Our future plans are for a public access computer.

This past year we alleviated a great concern of most of our patrons—overdue fines. Instead, we send patrons with overdue books a bill informing them of how much the book they have is worth to the Town. If they return the book, they do not pay for the book. We are finding this a much more humane way of getting overdue material returned on time. Thank you to all who have returned your books on time.

To bring information to the people of Carver, we have had programs available at the library for children and adults. Children's and family film series, how to study courses, introduction to computer courses, craft classes such as basketmaking and wreathmaking, local businesses sponsoring contests such as Dr. Lakin's tooth contest and Cranberry Connection giving the cranberry juice for the Cranberry Count contest. Children's storytimes have increased this year with a walk-in storytime added on Saturday's at 11:00 a.m. A Carver Arts Lottery Grant enabled 3 times the ordinary number of children to attend the summer programs at the library. We also had a vote for Carver's favorite books. Children voted for "Charlotte's Web" by E. B. White and Adults voted for all of Stephen Kings's books.

As usual the library is helped by so many people in town that it is hard to thank all of them. Without our regular volunteers, much of the time consuming work would not be done. Thank you to Phyllis Partridge, Celia Thurston, Keri Mansfield, Cindy Borden, the Mazalewski family, Jennie Mott, Eleanor Allard, Anita Palmerino, Deborah Kenneally, Ann Caron and Lawrence Hemingway. The Friends of Carver Public Library donated many supplies, charts and also the outside bike rack. Cranberry Village Association and South Meadow Village Association have donated money for book, magazines, and newspapers. A reference book "Strongs' Bible Concordance" was given in memory of Marjorie Griffith, a past board of trustees member. We have also received gifts from Winnona Strachern, Ruth Hawkes, Jeff and Judy Cutter, Linda Herzner and Brownie Troop 162, Mary Corthell of Cranberry Country Florists, and Paul Anderson for original artwork done for the library of President Lincoln.

We have had some changes in the library staff. Aides, Marsha Penti and Maureen Knott left in August. We have hired Nancy Stanwood and Mary Anne DeLucia as replacements.

Use of our meeting room increased this year with groups such as Scouts, Arts Lottery Council, Acid Rain Study Committee, and Cranberry Festival using the room.

We have many goals and plans for making the library more accessible and useful to the town. Thank you for your support and please continue to think of the library as a part of a valuable national resource.

We have had many staffing changes this year. Cynthia Guarino, RN was hired to fill the position when Sharon Lamond, RN resigned this spring. Delores Peru, RN joined our staff in August when Mary Boudreault, RN resigned. A third nurse has been hired to work on an On-Call basis when the caseload is high. Beverly Chinetti, Secretary, resigned in December to pursue a full-time nursing career. She has been replaced by Pamela Gallagher. All our best wishes are extended to our former staff members as they pursue new career opportunities.

The Agency has been greatly assisted by our Carver Board of Health, Professional Advisory Committee and its Subcommittees. Many dedicated area health professionals and consumers continue to offer their support and direction in reviewing and recommending policies: administrative, personnel and service.

An additional monthly Blood Pressure and Health Monitoring Clinic has been added at the Meadowbrook Apartments. We now are able to offer 2 clinics each month: first Tuesday at the Marcus Atwood House and Third Thursday at the Meadowbrook Apts.

The "Friends of the Carver Public Health Nurses," a Volunteer, non-profit organiza-

tion that supports the activities of the nursing agency, is finally formally organized and free-standing. All of the incorporation papers and applications for tax-exempt status have been filed with the appropriate State and Federal Agencies. The "Friends" offered free BP Screening during Carver Old Home Days. Approximately 200 residents and visitors were tested. A select mailing to area businesses and tables at Old Home Days generated the first income of the new "Friends." A special thank you to Kathy Murray and George Harriman for all of their work in this endeavor.

The agency continues to be involved with other area home health agencies to better meet mutual goals. Efforts include periodic supervisor's meetings to share new information, quarterly record reviews, and inservice programs. This co-operative effort is cost-effective, improves productivity and quality.

The past year has been a busy and productive one for all of us at the Carver Public Health Nurses. It has been my pleasure to work with such a dedicated, hard working staff. We are all committed to providing high quality home health care to all residents of Carver.

### **Report of the Department of Public Works**

Honorable Board of Selectmen:

During the past year the accomplishments of your Board of Public Works are as follows:

The following streets were sealed in our ongoing street maintenance program: Cranberry Road, Forest St., Fosdick Road, Fuller St., Green St., Indian St., Plymouth St., Pond St. and Wareham St. 3574 feet of overlayment (Type I) was placed on Meadow St. This is a program of great importance because of the fact that once we lose a road surface it is extremely expensive to bring back.

Some drainage was done at Crystal Lake area but an extensive program in small areas is planned for next year.

The second year of highway line painting was completed with about fifteen (15) miles of single and double lines being laid. The Commonwealth of Massachusetts no longer helps us on this.

The Federal (75%) State (25%) Aid project of rebuilding of Route 58 is 99% completed. Contract date was November 1984 but an extension to April 1985 was granted to the contractor for wrapping up small details. The problem with the pavement settlement of the new Route 58 about <sup>1</sup>/<sub>4</sub> mile north of the Wareham-Carver line is fully understood by the Mass. D.P.W. and has so informed us that it will be taken care of by them. In spite of the deplorable condition the first winter, Route 58 has given us an excellent highway through town.

Carver has been very fortunate with Federal-State Aid in the last several years. Of 26 miles allocated to the district, Carver received 13 miles, namely South Meadow Road and Route 58 from Wareham to Plympton.

The building and rebuilding of Ward Street has been completed with the exception of the final overlayment which will be completed this summer. This overlayment will be paid by State Aid.

Rochester Road has been completed to the extent of the original project request. Our plans are to continue this street on a future project request.

The remaining 1500 feet of High St. was penetrated and sealed leaving us with only one dirt road left in Carver.

We had the misfortune to lose one of our trucks and sanders as the result of a hit and run accident (the culprit was apprehended) at a time when we sorely needed this equipment. We contacted the Bureau of Accounts and found that through Mass. General Laws, Chapter 44, Section 31, we could acquire the necessary units to replace the ones we lost immediately. We acquired a Chevrolet Diesel Truck and Torwel Sander. The third and final payment of our big John Deere Loader will be made this year.

Our Superintendent, Leighton F. Peck, tendered his resignation in April. He acquired the Superintendent's position in Middleboro at a substantial increase in salary. Our Working Foreman, Brian Thayer, was moved up to fill the position and has done a commendable job under the circumstances.

All catch basins were cleaned with the exception of Route 58 which was under construction.

There were 22 burials attended to.

Parks and cemeteries were maintained in the usual manner by the inmates of MCI contributing greatly to them. We are very fortunate to have this ongoing program every year. The service and production that Carver gets from this group is invaluable. What it would cost if we had to hire it would be prohibitive.

A big thank you to Richardo Gomes and his crew of school children who were also

a tremendous help to us in the cemeteries, parks and public grounds around town.

We do have a problem with some of the excess water run off retention areas in town due to the high water table problems at certain times of the year. These are not a year round problem but we are seeking an elimination of the situation.

Indications are that there may be a return of some Gypsy Moth problem this year because of weather conditions that prevailed this winter. We are keeping a close watch on this matter.

The Board of Public Works would like to express its appreciation to the various town departments which worked with us, especially to the Board of Selectmen and Alan Dunham; also to the dedication of the DPW employees for their faithfulness to duty.

### **Plymouth County Mosquito Control Project**

The Commissioners of the Plymouth County Mosquito Control Project are pleased to submit the following report of our activities during 1984.

The Project is a special district created by the State Legislature in 1957, and is now composed of 21 Plymouth County towns, the City of Brockton, and the Town of Cohasset in Norfolk County. The Project is a regional response to a regional problem and provides a way of organizing specialized equipment, specially trained employees, and mosquito control professionals into a single agency with a broad geographical area of responsibility. The Project continues to provide environmentally sound mosquito control at no increase in per capita cost.

1984 was a year of transition. Gary Benzon, Superintendent of the Project for nearly four years, left to pursue a PhD at North Carolina State University. He was replaced by Dr. Kenneth Ludlam, a native bay stater formerly associated with Maryland mosquito control programs; who is aided by Assistant Superintendent Michael King, a Delaware mosquito control veteran; and by an able, experienced, and knowledgeable staff of foremen, inspectors, and support personnel.

1984 was also a year of repeat challenges. The Project was again tested by an increased threat of the mosquito transmitted disease Eastern Equine Encephalitis (EEE). The Project responded by increasing the level of control and by targeting areas of highest risk. Additional costs for overtime and insecticide are to be funded by a special appropriation and not charged to member towns. The recurrent problem of EEE in southeastern Massachusetts has led to increased cooperation between the Project and the Massachusetts Department of Public Health.

1984's new challenges included the addition of the Town of Marshfield, which became part of the Project in July. Control activities were targeted at the adult mosquitoes until late in the season when most of the larval development sites were finally catalogued. More emphasis on control of the mosquitoes in the larval stage can be expected in this town next year.

Again this year with the aid of a computer the figures specific to the Town of Carver are given below. While mosquitoes do not respect town lines the information given below does provide a tally of the activities which have had the greatest impact on the health and comfort of Carver residents.

1. Insecticide Application. 16,662 acres were treated using truck mounted sprayers for control of adult mosquitoes. More than one application was made to the same site if mosquitoes reinvaded the area. The first treatments were made in May and the last in September. The use of quiet electric sprayers has ended completely complaints about noise.

Our greatest effort has been targeted at mosquitoes in the larval stage, which can be found in woodland pools, swamps, marshes, and other standing water areas. Inspectors continually gather data on these sites and treat with highly specific larvicides when immature mosquitoes are present. Last year a total of 176 inspections were made to 50 catalogued breeding sites totaling 611 acres.

Finally, a total of 350 treatments were made to storm sewer catch basins to prevent mosquito production in this man made habitat.

We encourage citizens or municipal officials to call our office for information about mosquitoes, mosquito-borne diseases, control practices, or any other matters of concern.

### **Report of Trustees for Plymouth County Cooperative Extension Service**

The Plymouth County Cooperative Extension Service's office is located on High Street, Hanson (on the grounds of Plymouth County Hospital) and can be reached by calling 293-3541 or 447-5946.

The Extension Service is the educational arm of the University of Massachusetts and the United States Department of Agriculture at the county level. This is where the name "Cooperative Extension" is derived. It is a nationwide informal educational network with more than 3,000 offices throughout the country.

For 70 years the County Extension Service has provided county residents with free, informal education, emphasizing practical, self-help solutions to everyday concerns and needs. Our program areas include:

\*Home Economics and Family Living

- \*4-H (Youth Development)
- \*Agriculture: Food Marketing and Production
- \*Community Resource Development (C.R.D.)
- \*Food and Nutrition (Expanded Food and Nutrition Education Program)

Our staff is comprised of a director, two regional agricultural specialists, a community resource development specialist, two home economists, three 4-H agents, and a split position 4-H/Home Horticulture. In additon to this, we administer a federally funded nutrition education program for families with limited food dollars. This is staffed by one supervisor and eight part-time paraprofessionals.

In Plymouth County last year 92,974 face-to-face contacts were reported by Plymouth County agents. Total enrollment for 4-H clubs was 768. In addition to that 12,009 youth participated in short-term or school projects. 44 lectures were presented by county agents, by requests in the areas of financial planning, home economics, home horticulture and agriculture.

Major county-wide events that the Extension Service staff is responsible for include: 4-H Fairs, Small Farms Day (March), Home & Harvest Day (October), Fisherman's Harvest Festival (June) in addition to departmental lecture series offered in various county locations throughout the year.

Over 6,974 residents receive one of our 4 informational newsletters;

- 1) Garden Clipping-for the backyard gardener,
- 2) Kitchen Quotes-for basic nutrition facts and recipes,
- 3) Extension Post-written by county Home Economists,
- 4) 4-H Newsletter-for our 300 active club leaders.

Newsletters are also available for commodity groups, commercial growers, farmers and special interest areas. In addition to face-to-face learning situations, correspondence courses are available; last year we featured a popular microwave series.

Telephone inquiries continue to come in at a rapid rate particularly in the areas of food preparation and preservation, stain removal, home grounds and insect identification.

We continue to provide free testing of soil pH and pressure gauge accuracy testing of home canners. Free fact sheets are available in the above subject areas, along with U.S.D.A. publications for a minimal handling charge.

In accordance with the General Laws of the Commonwealth, Chapter 128, the Trustees for Plymouth County Cooperative Extension Service are empowered to receive, on behalf of the County, money appropriated by any town, or by the Federal Government for carrying out the provisions of the law, under which they are appointed.

Their agents have made contacts during the past year in every community, either by public meetings, individual visits, group discussions, demonstrations, or otherwise, in attempting to assist the needs of the citizens toward helping to solve management problems, better living, and better community service, and have been ably assisted by many local volunteer leaders.

A total expense of \$100.00 was incurred during the year for the purchase of material needed in carrying on the various Extension Programs. The appropriation made by your town was used for residents of the town and expended as follows:

### **Carver Public Schools**

The 1984 school year opened with 1149 students enrolled in grades kindergarten through six. Regional grades seven and eight numbered 362 students and were housed in the front building along with grade six students. We were able to eliminate the double session for grades seven and eight because the new eight-room pod was completed just before the September opening date. Kindergarten classes continue to be held at the Benjamin Ellis building.

There were numerous changes in personnel from the previous year. Mr. Norman Bossio resigned in June after five years as Superintendent/Principal to accept a similar position in another school system. The Carver School Committee decided to divide the dual superintendent/principal position into two distinct positions for 1984-85. Following numerous interviews, the committee appointed Mr. Robert Krieger of Syracuse, New York to the principal's position and Mr. William DeStefano of Baltimore, Maryland to the superintendent's position. The employment of a Superintendent of Schools is a first for the Town of Carver. Recent increases in student enrollments and the continued expectation of increasing enrollments, coupled with the planning for a new secondary school in Carver, gave impetus to the committee's decision to employ a superintendent. The position is part-time this year with anticipation that eventually Carver will need a full-time superintendent.

The completion of the new eight-room pod helped alleviate some of the space needs problems as well as ending the need for double sessions. Attention is now focused on the building of a new 1,000 pupil secondary school on the Pond Street site. Mr. Erwin K. Washburn is chairman of the new building committee which includes members, Mr. Charles Erwin, Mrs. Pamela Santino, Mrs. Johanna Leighton, Mr. David Katz, Mr. Arnold Greene and Mr. Paul MacDonald. This new facility will house grades eight through twelve and is expected to be ready for occupancy in late 1986 or early 1987.

New programs were implemented in spelling, handwriting, and mathematics. A new social studies curriculum is nearing completion for full implementation in 1985. Grade four and six students for the fifth year attended the week-long Nature's Classroom program. Grant funds continued to help support curriculum development projects and provide both in-school and outside placement programs for special needs students.

Many persons continued to assist the school system through volunteerism. Mrs. Kathy Skrabut is the P.T.O President for 1984-85. Last year the P.T.O. held enrichment programs for Carver students by bringing in the nationally famous team of Stromberg and Cooper; donated funds for transportation of students to the P.C.I.S. Planetarium program; and continued a scholarship fund for a Carver graduate. The printing of "Our Schools Favorite Recipes" resulted from the combined efforts of the committee, school staff, and community. Mrs. Helen Walsh ran the highly successful volunteer program for the third year. Mrs. Paula Witham again headed the Chapter I Parent Advisory Council.

Each year finds new successes as well as challenges. 1985 promises to be an exciting time as we plan our new secondary school, continue to seek adequate funding to move our system upward, and fight the battle of finding physical spaces to house current programs.

### Southeastern Regional Planning and Economic Development District

During 1984 the Town of Carver continued its membership for the fifteenth year in the Southeastern Regional Planning and Economic Development District. SRPEDD is a planning and economic development agency formed under state law to serve twentyeight communities in southeastern Massachusetts by providing a cooperative approach to regional issues.

The District is governed by a Commission consisting of a chief elected official or designee and a planning board representative from each participating municipality and six low-income and minority representatives. Carver's representatives from the Board of Selectmen and Planning Board respectively, are Bernard Gill and Timothy M. McGillicuddy, Jr. In addition to regional planning and economic development, SRPEDD assists member cities and towns. Through the free municipal assistance program, each community receives time for local projects and assistance in preparing applications for federal and state funds.

The agency's purpose is to plan for regional land use, economic development, housing, transit, transportation, solid waste, energy resources and conservation, and air and water quality. Local participation in these regional plans enables communities to be eligible for federal and state dollars.

Services to Carver this past year included:

• Master Plan Review

Regional plans and other activities conducted this year benefiting all communities included:

- Approval of over \$60 million in regional grant applications to federal and state agencies and of over \$196 million in Industrial Revenue Bonds which will create approximately 1,700 new jobs in the region.
- Environmental assessment reviews of state and federally funded projects, and reviews of all local zoning amendments. The reviews are advisory and are oriented toward making proposals more cost-effective and feasible.
- The annual update of the Overall Economic Development Program (OEDP) which makes member communities eligible for U.S. Economic Development Administration funding and a 10 percent bonus for public facility projects.
- The annual update of the *Transportation Improvements Program* (TIP) which lists major projects in each community for federal and state funding. A project must be included on the TIP in order to be eligible for these funds.
- Conducting a community education effort on the safe handling of industrial hazardous wastes under a contract with Southeastern Massachusetts University.
- SEED, South Eastern Economic Development Corporation, established and staffed by SRPEDD, provides low-interest, long-term financing to small businesses in southeastern Massachusetts through the U.S. Small Business Administration's "503" Program and a newly established \$1 million revolving loan fund. In 1984 SEED assisted three businesses which resulted in total investments of over \$1.7 million and created 96 jobs.

SRPEDD represents the collective will of its member communities. As the responsibilities and problems of municipalities become increasingly complex, the District can provide technical assistance to local boards, encourage cooperation among communities, and provide a comprehensive approach to issues that cross local boundaries.

#### **Report of the Finance Committee**

Due to the increased population over the last five years, the Finance Committee is finding it more and more difficult to recommend a budget that will satisfy all departments.

Because of the increased number of school children we must increase our school budgets to provide adequate education.

There are increased demands on our operating costs for all other departments also.

The DPW has more miles of roads to maintain and plow than they did a few years ago. There is more of a demand on our police and fire departments and also on our library and town hall employees due to our population growth.

Five years ago, you could spend as much money as you felt was needed and then your tax rate would be set accordingly. We can no longer do this.

We are now limited to how much we can spend. Our recommendations, therefore, are not based on how much money a department needs, but on how much money is available to insure adequate services from all departments.

To choose all necessary town officers to be voted for all on one ballot, namely: One Moderator for a term of one (1) year; One Selectman, One Assessor, One Member of School Board, One member Board of Public Works, Two Library Trustees, One member Board of Health, One member Regional District School Committee, each for a term of three (3) years; One member Planning Board, One member Carver Housing Authority, each for a term of five (5) years; One Assessor (to fill vacancy) one (1) year; One member Board of Health (to fill vacancy) one (1) year; One Library Trustee (to fill vacancy) two (2)years.

The polls will be open until 8:00 o'clock, P.M.

And you are further directed to notify said Inhabitants of said Town that as soon as the votes have been counted the meeting will adjourn to Monday, April 22, 1985, at 7:30 o'clock, P.M., and at that time will reconvene at said Governor John Carver School House, then and there to act on the following Articles, namely:

Article 2. To see if the Town will vote to authorize the Town Treasurer, with the approval of the selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning July 1, 1985, in accordance with the provisions of General Laws, Chapter 44, Section 4, and to issue a note or notes therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with General Laws, Chapter 44, Section 17.

#### **Municipal Finance Terminology**

The following terms are frequently used in the Annual Town Report and at Town Meetings. In order to provide everyone with a better understanding of the meaning, the following definitions are provided.

#### SURPLUS REVENUE: (often referred to as "Excess and Deficiency")

This fund represents the amount by which the Cash, Accounts Receivable and other floating assets exceed the liabilities and reserve. This is a bookkeeping item.

#### AVAILABLE FUND: (often referred to as "Free Cash")

Available Funds is the amount certified annually by the State Bureau of Accounts by deducting from surplus revenue all uncollected taxes for prior years. This fund may be used by a vote of the Town Meeting.

#### **OVERLAY:**

The Overlay is the amount raised by the Assessors in excess of appropriations and other charges for the purpose of creating a fund to cover abatements granted and avoiding fractions.

#### **OVERLAY RESERVE:**

This is the accumulated amount of the Overlay for various years not used or required to be held in the specific Overlay account for a given year, and may be used by vote of the town for extraordinary or unforeseen purposes or voted into the Reserve Fund.

#### **RESERVE FUND:**

This fund is established by the voters at an annual town meeting only and may be composed of (a) an appropriation (not exceeding 5% of the tax levy of the preceding year), (b) money transferred from Overlay Reserve, or (c) both.

#### **STABILIZATION FUND:**

This is a fund created to provide a reserve for capital expenditure. Appropriations from the Stabilization Fund may be made at an Annual Town Meeting by a two-thirds vote for any purpose the town is authorized to borrow money for under Section 7 or 8 of Chapter 44 or for such other purpose as is approved by the Emergency Finance Board.

#### **CHERRY SHEET:**

Named for the cherry colored paper on which the Massachusetts Commission of Corporations and Taxation traditionally has printed it, the cherry sheet carries the figures which must be used by the Assessors in determining the amount to be raised by taxation.

It lists the amounts of county tax and state assessments, as well as the estimated tax distributions from the General Fund, reimbursements, agency funds, and the Sales and Use Taxes.
