# Growth in the Town of Carver

The building shown on the back cover is a picture of the Town of Carver's first High School. The photograph was taken in the year 1906. The school building, as shown, consisted of two (2) rooms plus one (1) outdoor toilet. At the time the picture was taken, the school building was located on the site of what is now the Carver Central Fire Station.

The picture on the front cover is the new Carver High School that opened to Carver students in January 1988. The building is designed for 1,000 students, grades 7-12, and is expandable to 1,500 students. It contains many specialized and regular classrooms to accommodate all programs in support of the 1,000 students. In addition, it features a two-level library; air-conditioned auditorium capable of seating 700 persons; preparing kitchen for school lunch programs; provision for closed circuit TV; internal telephone communications system; three station gymnasium with a seating capacity of 1,600; computer area; science facilities; planetarium; and a second floor designed to house grades 7 and 8 exclusively.

In addition, the following athletic facilities exist:

- a. Football/outdoor track/soccer/stadium with bleachers to seat 1,400 persons.
- b. Two full-size baseball fields.
- c. Two practice fields—accommodate softball.
- d. Practice football/soccer field.
- e. Four tennis courts.

In summary, the new High School features the most up to date educational facilities which were designed for Adult Education Programs and Community use as well as for the students in Carver.

# **Annual Town Election**

# Saturday, April 11, 1987

A total of 4,000 Ballots were delivered to the Ballot Clerks by the Town Clerk. The Warden, Eugene P. Souza, declared the polls open at 8:00 o'clock A.M., and announced that the polls would close at 8:00 o'clock P.M. The Ballot Box registered zero (0) at the opening of the polls. The keys to the Ballot Box were placed in the custody of the Police Officer on duty. The election continued without incident until 8:00 o'clock P.M., at which time the Warden declared the polls closed. At the close of the polls the Ballot Box registered a total of 2,147 ballots cast, of which 71 were Absentee Ballots and 2,076 were cast by voters in person. This tallied with the voting lists of the Ballot Clerks. The ballots were then removed from the Ballot Box, audibly counted and delivered to the Tellers for canvassing and counting. The Tellers having been first duly sworn to the faithful performance of their duties.

# **Annual Town Meeting**

Monday, April 27, 1987

The 196th Annual Town Meeting of the Inhabitants of the Town of Carver was held at the Governor John Carver School on Monday, April 27, 1987 pursuant to a Warrant of the Board of Selectmen.

The meeting was called to order at 7:45 P.M., by the Moderator, Nancy A. Seamans, there being a quorum present. The Invocation was given by Rev. Robert H. Merritt, followed by the Pledge of the Allegiance to the flag. The Moderator appointed Susan Locke, Robert Anderson, Andrew Herf, Maureen Knott and Lynne Demeo to serve as tellers to count the votes. They were duly sworn to the faithful performance of their duties by the Moderator.

Upon motion duly made and seconded by Selectman, Daniel B. Daly, Jr., it was Unanimously Voted to dispense with the reading of the Warrant as Article I, relating to the election of Town Officers, etc., having been disposed of at a prior meeting. The

meeting then proceeded to act on the articles in the Warrant as follows:

At this time, upon motion duly made and seconded by Selectman, Daniel B. Daly, Jr., it was Unanimously Voted that the Town not consider at this evening session of the Annual Town Meeting articles dealing with "Raise and Appropriate or Free Cash."

- Article 2. Upon motion duly made and seconded, it was Unanimously Voted to authorize the Town Treasurer, with the approval of the Selectmen, to borrow money from time to time in anticipation of the revenue of the financial year beginning July 1, 1987, in accordance with the provisions of General Laws, Chapter 44, Section 4, and to issue a note or notes, therefor, payable within one year, and to renew any note or notes as may be given for a period of less than one year in accordance with General Laws, Chapter 44, Section 17.
- Article 5. Upon motion duly made and seconded, it was Unanimously Voted for the Town to authorize the Town Treasurer to enter into a compensating balance agreement or agreements for the Fiscal Year 1988 pursuant to Chapter 44, Section 53F of the General Laws.
- **Article 6.** Upon motion duly made and seconded, it was Unanimously Voted to hear the report of any standing committees and to abolish any special committee not submitting a report unless otherwise voted, and to establish any new committees.
- 1. Mr. John Peritzian, submitted a report of the Carver Youth Needs Committee. He reported that the Committee is beginning its 7th year and last year was a very successful year. He also stated in the report that it is time to start looking for activities within the town to involve the greatly increased numbers of youth. The committee requests to continue. Mr. Peritzian announced his resignation at this time due to other commitments. The report was accepted and it was Unanimously Voted to continue this Committee. At this time, Selectman, Arthur P. DeCoursey, commended John for his dedication to the Carver Youth Needs Committee for the past 7 years. When Arthur DeCoursey finished, the citizens gave him a standing ovation.
- 2. William Pierce of the Town Barn Study Committee requested that this Committee continue on as an ongoing active committee. Report accepted and it was Unanimously Voted to continue this committee.
- **Article 8.** Upon motion duly made and seconded, it was Unanimously Voted that the County Dog Fund in the amount of \$4,106.24 be credited to the Library Operating Expense Account.

At this time, upon motion duly made by Selectman, Arthur P. DeCoursey, and seconded, it was Unanimously Voted to adjourn and proceed to Special Town Meeting at 8:00 P.M.

Meeting adjourned at 7:58 P.M.

# **Special Town Meeting**

Monday, April 27, 1987

A Special Town Meeting of the Inhabitants of the Town of Carver was held at the Governor John Carver School House on Monday, April 27, 1987, at 8:00 P.M. by the Moderator, Nancy A. Seamans. There being a quorum present, the meeting then proceeded to act on the Articles in the Warrant as follows:

- Article 1. Upon motion duly made and seconded this Article was Unanimously Voted. To see if the Town will vote to authorize the Selectmen to grant, insofar as they have the right to do so, to COMMONWEALTH ELECTRIC COMPANY, and NEW ENGLAND TELEPHONE COMPANY, their successors and assigns as tenants in common, or any licensee from either of them (hereinafter called the Grantees), the perpetual right and easement to locate, relocate, erect, construct, reconstruct, install, lay, dig up, operate, maintain, patrol, inspect, repair, replace, alter, change the location of, extend or remove one or more lines for the transmission and/or distribution of electricity for light, heat, and/or power and/or one or more lines for the transmission and/or distribution of intelligence by electricity or otherwise, and all necessary and proper wires, cables, conduits, conductors, transformers, transformer enclosures, foundations, platforms, pedestals, terminals, insulators, fittings, switches, poles, crossarms, guys, braces, anchors supports, manholes, handholes, street light standards and fixtures, and other apparatus, equipment and fixtures deemed necessary for the purposes specified above, along, upon, across and over that certain parcel of Town owned land, namely: Being that parcel as described in deed dated April 29, 1983, recorded with Plymouth County Registry of Deeds in Book 5350 Page 182. Being the same parcel shown as Lot 11 on Sheet 105 of Town of Carver Assessors Plans. (CARVER HIGH SCHOOL)
- Article 2. Upon motion duly made and seconded, it was Unanimously Voted for the Town to transfer from free cash in the treasury the sum of Six Thousand Two Hundred (\$6,200.00) Dollars for the purpose of conducting a comprehensive study in which they would provide a set of Job Descriptions, a Classification Plan and a Master Salary Schedule showing pay ranges by classification, which would be turned over to the Wage and Personnel Board for review and presentation to the Town for final approval.
- **Article 3.** Upon motion duly made and seconded, it was Unanimously Voted for the Town to transfer the sum of Three Thousand (\$3,000.00) Dollars from the Home Health Aide Account to a newly established Medicare Payback Account.
- Article 4. Upon motion duly made and seconded, it was Unanimously Voted for the Town to transfer the sum of Seven Thousand Two Hundred Five Dollars and Twenty-three cents (\$7,205.23) from Library Incentive Grant —(\$3,394.00 Municipal Equalization Grant (\$3,711.23) for the purpose of capital improvements to the library (repair, maintenance and equipment).
- Article 5. Upon motion duly made and seconded, it was Unanimously Voted for the Town to amend "Article XVI" Public Ways and Places of the Town of Carver By-Laws to read "Article XIX" because Article XVI—Temporary Repairs on Private Roads was duly noted on September 28, 1978.

- **Article 6.** Upon motion duly made and seconded and by a Standing Vote of YES-48 and NO-128, this article to authorize the Police Chief to hire a Confidential Secretary was DEFEATED.
- Article 7. Upon motion duly made and seconded, it was Unanimously Voted for the Town to add two fulltime Police Officers, one to become effective May 3, 1987, and the second position to become effective June 30, 1987.
- Article 8. Upon motion duly made and seconded, it was Unanimously Voted for the Town to transfer the sun of Eleven Thousand (\$11,000.00) Dollars from the Revenue Sharing Trust Fund Account and transfer from available funds in the Treasury the sum of Nine Thousand (\$9,000.00) Dollars for the purpose of repairing Engine #1 for the Fire Department.
- Article 9. Upon motion duly made and seconded, it was Unanimously Voted to rename that section of road between Route 58 and Forest Street in North Carver, formerly known as Old Main Street, to "Fuller Street."
- Article 10. Upon motion duly made and seconded, it was Unanimously Voted to spend the following amount for the requests of various Town departments to purchase Department Equipment from the proceeds of bonds or notes as part of the authorization to borrow for this purpose voted under Article 1 of the Special Town Meeting of April 28, 1986. Adjourned Session of May 5, 1986.

Article 11. Upon motion duly made and seconded, it was Unanimously Voted for the Town to approve the amount of \$250,000.00 debt authorized on March 10, 1987 by the Plymouth-Carver Regional District School Committee for the purpose of financing additional costs of constructing, equipment and furnishing the new secondary school

located in Carver including costs of the maintenance facility and athletic fields and other costs incidental and related thereto.

Article 12. Upon motion duly made and seconded, it was Unanimously Voted to transfer from available funds in the Treasury the sum of Five Thousand Five Hundred (\$5,500.00) Dollars to the Municipal Employees Insurance Account for the purpose of paying the Town's share of the so-called Medicare Tax for the Fiscal 1987 year.

Article 13. This article was withdrawn by Selectman, Daniel B. Daly, Jr.

**Article 15.** Upon motion duly made and seconded and after much discussion from the floor the tellers were called forth for a count on this Article:

85 YES-54 NO-Total voters 139, 3rd vote required—this article was DEFEATED.

Article 15. To see if the Town will vote to authorize the Board of Selectmen, acting as the Town Board of Water Commissioners, to acquire by eminent domain a restriction and easement in, over and upon those parcels of land shown as Parcel A containing approximately 1,865 square feet, parcel B containing approximately 20,510 square feet, Parcel C containing approximately 9,965 square feet and Parcel D containing approximately 31,715 square feet, all as shown on a plan entitled "Plan of land for Myles Standish Village, Inc. in Carver, Massachusetts scale one inch equals 60 feet, September 6, 1985, G.A.F. Engineering, P.O. Box 617, South Carver, MA 02336, Revised November 19, 1985," the terms of such restriction and easement being as follows:

- 1. The storage, transportation or disposal of sewage, petroleum products or other substances detrimental to a public water supply system and the application of fertilizers, herbicides or pesticides shall be prohibited on such parcels.
- 2. The construction of any buildings or other structure shall be prohibited on such parcels.
- 3. The Town of Carver, acting by and through its Board of Water Commissioners and designees thereof shall have a perpetual easement of access to enter upon said parcels for purpose of inspecting the premises and enforcing the foregoing restriction and remedying any violation thereof. The right and easement hereby taken shall be in addition to any other remedies available to the Town for the enforcement of the foregoing restriction.

At this time, upon motion duly made and seconded, and Special Town Meeting being completed, it was Unanimously Voted to adjourn. The next scheduled meeting on Monday, May 4, at 7:30 P.M.

# **Annual Town Meeting**

Adjourned Session Monday, May 4, 1987

The Adjourned Session of the Annual Town Meeting of the Inhabitants of the Town of Carver was held at the Governor John Carver School on Monday, May 4, 1987. The meeting was called to order at 7:40 P.M. with a quorum present. The Moderator, Nancy A. Seamans, appointed Frank Holton, Edward Hoey, Carolyn Brennan, Helen Copello and Susan Locke to serve as tellers to count the votes and they were duly sworn to their faithful performance of their duties.

Before this meeting began, Selectman Chairman, Daniel B. Daly, Jr., asked to have the Chairman of the Carver School Committee, Erwin Washburn, to talk to all those present, due to the fact that we are going to have an over-ride election and perhaps Mr. Washburn could enlighten us. Erwin stated that if all departments are voted their budgets, the 1988 budgets will be over and the over-ride will be for the School only. The Moderator thanked Mr. Washburn for his explanation at this time.

- Article 3. Upon motion duly made and seconded, it was Unanimously Voted to transfer Twenty-Two Thousand (\$22,000.00) Dollars from free cash in the Treasury to meet interest charges on temporary loans.
- Article 4. Upon motion duly made and seconded, it was Unanimously Voted to transfer the sum of Fifty Thousand (\$50,000.00) Dollars from available funds in the Treasury to the 1988 Fiscal Year Reserve Account.
- Article 7. Upon motion duly made and seconded, it was Unanimously Voted to transfer the sum of One Hundred Twenty-Five (\$125.00) Dollars from available funds in the Treasury to be expended by the Trustees for Plymouth County Cooperative Extension Service and choose a Director in accordance with the provisions of General Laws of Massachusetts, Chapter 128, Section 41 and 42. Thereupon Jean O. Gibbs was Unanimously chosen Director.
- Article 9. Upon motion duly made and seconded, it was Unanimously Voted to raise and appropriate the sum of \$7,500.00 for the purpose of conducting an audit of the Town for fiscal year 1987.
- Article 10. Upon motion duly made and seconded, it was Unanimously Voted to transfer the sum of Forty Thousand (\$40,000.00) Dollars from the Ambulance Fund Account to the Ambulance Operating Account, said sum to be under the control of the Board of Selectmen.
- **Article 11.** Upon motion duly made and seconded, it was Unanimously Voted to amend the Town's General By-Laws as voted at the Annual Town Meeting in 1975, and inserting a new Section 6 which shall read:
  - "Articles to be acted upon at the Annual Twon Meeting shall be submitted to the Board of Selectmen at a date determined by said Board. No Board shall be allowed less than Thirty (30) days notice in which to prepare its annual budget."

- Article 12. Upon motion duly made and seconded, it was Unanimously Voted to amend this article to raise and appropriate the sum of Eighty-Six Thousand Six Hundred Twenty (\$86,620.00) Dollars to reimburse the Treasury of the County of Plymouth for awards payable from said Treasury of said County for damages caused by the taking of land on Pond Street under the provisions of Plymouth County Commissioner's Decree No. 1471, dated September 30, 1986.
- **Article 13.** Upon motion duly made and seconded, it was Unanimously Voted to raise and appropriate the sum of Five Thousand (\$5,000.00) Dollars for the purpose of establishing a Line Painting Roads Account.
- **Article 14.** Upon motion duly made and seconded, it was Unanimously Voted to raise and appropriate Five Thousand (\$5,000.00) Dollars for the purpose of establishing a Street Sweeping Account.
- **Article 15.** Upon motion duly made and seconded, it was Unanimously Voted to transfer the sum of Three Thousand Five Hundred (\$3,500.00) Dollars from available funds in the Treasury for the purpose of meeting the charges against the Cemetery Fund.
- Article 16. Upon motion duly made and seconded and after some discussion by Alan I. Dunham, Town Treasurer and Tax Collector, it was Unanimously Voted to raise and appropriate the sum of Two Thousand (\$2,000.00) Dollars to be used to pay for all private work and materials in Town Cemeteries such as opening graves, building foundations, etc...
- Article 17. Upon motion duly made and seconded, it was Unanimously Voted to transfer from available funds in the Treasury, the sum of Nine Thousand, Nine Hundred Fifty-five (\$9,955.00) Dollars which may be used for State Aid Construction or Improvements under Chapter 234 of the Acts of 1984 in conjunction with available State Funds of Twenty-Nine Thousand Eight Hundred Sixty-Six (\$29,866.00) Dollars and, in addition, to transfer from available funds in the Treasury the sum of Twenty-Nine Thousand, Eight Hundred Sixty-six (\$29,866.00) Dollars to meet the State's share of the cost of work reimbursement received therefrom to be returned to the Treasury.
- **Article 18.** Upon motion duly made and seconded, it was Unanimously Voted to transfer from available funds in the Treasury the sum of Thirty-Five Thousand Nine Hundred Four (\$35,904.00) Dollars which will be used for State Aid Construction or Improvements under Chapter 811, Section 30, in conjunction with available State funds of \$107,710.00.
- **Article 19.** To see if the Town will vote to remove Town Mechanic's position from the Department of Public Works Account and establish a Town Mechanic's Account to be under the direction of the Board of Selectmen. It was Unanimously Voted to take no action on this article.
- **Article 20.** To see if the Town will vote to raise and appropriate the sum of Forty Thousand (\$40,000.00) Dollars for the purpose of paying the salaries of the Town Mechanics. It was Unanimously Voted to take no action on this Article.

Article 21. Upon motion duly made and seconded, and after discussion, it was Unanimously Voted to raise and appropriate the sum of One Thousand (\$1,000.00) Dollars for the purpose of establishing a salary account for a Sealer of Weights and Measures under Chapter 98, Section 35 of the Massachusetts General Laws and to authorize the Board of Selectmen to appoint a Sealer of Weights and Measures.

Article 22. Upon motion by Erwin K. Washburn, duly made and seconded it was Unanimously Voted for the Town to accept for the Carver Public Schools an educational opportunity grant for fiscal year 1988 under the provisions of Massachusetts General Laws, Chapter 70A, Section 5, as inserted by Chapter 188 of the Acts of 1985. Said grant of \$238,000.00 shall be expended by the School Committee for direct service expenditures.

Article 23. Upon motion by Erwin K. Washburn, duly made and seconded it was Unanimously Voted for the Town to accept for the Plymouth-Carver Regional District Schools an equal educational opportunity grant for fiscal year 1988, under the provisions of General Laws, Chapter 70A, Section 5, as inserted by Chapter 188 of the Acts of 1985. Said grant shall be expended by the School Committee.

Article 24. Upon motion duly made and seconded after discussion and amendment by Erwin K. Washburn, it was Unanimously Voted to raise and appropriate the sum of (\$146,349.00) Dollars for the purpose of operating buses to provide transportation of Carver students to and from the Regional Schools, said sum to be offset by estimated receipts from Plymouth-Carver Regional School District and Old Colony Regional Vocational Technical High School District.

Article 25. Upon motion duly made and seconded, it was Unanimously Voted to raise and appropriate the sum of One Thousand Three Hundred Eighty-two Dollars and Fifty Cents (\$1,382.50) to pay the following unpaid bills of 1984/85/86.

**Article 26.** Upon motion duly made and seconded, it was Unanimously Voted to raise and appropriate the sum of \$1,000.00 to South Shore Women's Center for the purpose of providing services to victims of domestic violence.

Article 27. Upon motion duly made and seconded and to be amended by Nick Femia, it was Unanimously Voted to raise and appropriate the sum of \$1,000.00 for the Town's participation in the Plymouth County Rape Crisis Center.

Article 28. Upon motion duly made and seconded and amended by Nick Femia it was Unanimously Voted to raise and appropriate the sum of \$1,000.00 to be contributed to the Mayflower Mental Health Association, Inc. which in conjunction with the Department of Mental Health, forms the partnership which constitutes the Plymouth Area Mental Health Center.

**Article 29.** Upon motion duly made and seconded, it was Unanimously Voted to accept and adopt Article XX of the Town of Carver By-Laws as follows:

# **BURGLAR ALARM SYSTEMS BY-LAW**

# A. Definitions

- 1. The term "Burglar Alarm System" means an assembly of equipment and devices or a single device such as, but not limited to, a solid state unit which plugs directly into a 110 Volt AC line, arranged to signal the presence of a hazard requiring urgent attention and to which police are expected to respond. Fire Alarm systems and alarm systems which monitor temperature, smoke, humidity or any other condition not directly related to the detection of an unauthorized intrusion to a premises or an attempted robbery at a premises are specifically excluded from the provisions of this bylaw. The provisions of Section C of this bylaw shall apply to all users.
- 2. The term "False Alarm" means (a) the activation of an alarm system through mechnical failure, malfunction, improper installation or negligence of the user of an alarm system or his employees or agents; (b) any signal or oral communication transmitted to the Police Department requesting or requiring or resulting in a response on the part of the Police Department when in fact there has been no unauthorized intrusion, robbery or burglary, or attempted threat. For the purposes of this definition, activation of alarm systems by acts of God, including but not limited to power outages, hurricanes, tornadoes, earthquakes, and similar weather or atmospheric disturbances shall not be deemed to be a false alarm.

# B. Control and Curtailment of Signals Emitted by Alarm Systems

- 1. Every alarm user shall submit to the Police Chief the names and telephone numbers of at least two other persons who are authorized to respond to an emergency signal transmitted by an alarm system and who can open the premises wherein the alarm system is installed. It shall be incumbent upon the owner of said premises to immediately notify the Carver Police Department of any changes in the list of authorized employees so named in the business listing to respond to alarms.
- 2. All alarm systems installed after the effective date of this bylaw which use an audible horn, bell, or device shall be installed with a device that will shut off such bell, horn or device within fifteen (15) minutes after activation of the alarm system. All existing alarm systems in the Town of Carver must have a shut-off device installed within six (6) months of passage of this bylaw.
- 3. Any alarm system emitting a continuous and uninterrupted signal for more than fifteen (15) minutes which cannot be shut off or otherwise curtailed due to the absence of unavailability of the alarm user or those persons designated by him under paragraph (1) of this section and which disturb the peace, comfort or repose of a community, a neighborhood or a considerable number of inhabitants of the area where the alarm system is located, shall constitute a public nuisance.
- 4. No alarm system which is designated to transmit emergency messages or signals of intrusion to the Police Department will be tested until the Police Dispatcher has been notified.
- 5. All alarm systems which are designed to transmit emergency messages or signals of intrusion to the Police Department will be of a type approved by the Police Chief.
- 6. There will be an annual \$25.00 fee for each alarm plugged into the Police Station. This fee is aside from any penalties that might occur.

# C. Penalties

- 1. The user shall be assessed twenty-five (\$25.00) dollars as a false alarm service fee for each false alarm in excess of three (3) occurring within a calendar year. The Police Chief shall notify the alarm user either by certified mail or by service in hand by a Police officer of such violation. Fines shall be paid in accordance with applicable state and local law.
- 2. The owner of a system which occasions six (6) or more false alarms within a calendar year, and/or installer who is not in conformance with this bylaw, may be ordered to disconnect and otherwise discontinue the use of the same by the Board of Selectmen.
- 3. Any user, owner or installer found to be in violation of any provision of this bylaw for which no other penalty is specified shall be punished by a fine of Twenty (\$20.00) Dollars.
- 4. In the event that any provision, section or clause of this bylaw is hereafter judicially found to be invalid, such decision, invalidity or voidance shall not affect the validity of the remaining portion of this bylaw.
  - 5. This bylaw will not apply to any town-owned property.

Article 30. To see what amount the Town will vote to raise and appropriate for the purpose of establishing a General Equipment and Office Supply Account as established by the Annual Town Meeting of April 28, 1986. These monies to be taken from the Annual Operating Budget of each Department, excluding the Library and School Department.

Upon motion made by Selectman Chairman, Daniel B. Daly, Jr., duly moved and seconded, it was UNANIMOUSLY VOTED to take "NO ACTION" on this Article.

- Article 31. Upon motion made by Selectman Chairman, Daniel B. Daly, Jr., duly moved and seconded and with further discussion by Mr. Daly and Selectman, Arthur P. DeCoursey, it was Unanimously Voted to amend the Carver Wage and Personnel Plan as follows:
- 1. By deleting all existing references to the Board of Selectmen and insert the words "Wage and Personnel Board" in its place, except in the second paragraph of Section IV, Part A.
  - 2. To delete Section II of said Plan and insert the following language:

The Wage and Personnel Board shall consist of five members to be appointed by the Chairman, Board of Selectmen, Chairman of the Finance Committee and Moderator.

The Appointing Authority shall initially appoint one member for a one year term; two members for two year terms; and two members for three year terms. Thereafter, all members shall be appointed for three year terms.

In the absence of a quorum, the Board of Selectmen shall appoint one or more of the members to serve on the Wage and Personnel Board, on a temporary basis, so as to allow said Board to continue to function until the necessary number of permanent members are appointed.

Any proposed Article for a Town Meeting that relates to personnel as covered by this Plan, conditions of employment, compensation, etc., shall first be submitted to the Board of Selectmen.

3. And further by amending Section IV, Part D, by adding a second paragraph to read:

"New employees may be compensated at a rate greater than Step 1, with the approval of the Wage and Personnel Board, depending on experience and budget appropriation."

4. Add a Number 3 to Part V. Section G:

"A decision to determine or suspend an employee may be appealed to the Board of Selectmen for a final disposition."

5. Amend Section VII by deleting the last sentence and adding the following language:

Grievances may be appealed to the Board of Selectmen if the action of the Wage and Personnel Board are unsatisfactory to the employee or Department Head. The Board of Selectmen shall be subject to the same time limitations as previously listed in this section.

- 6. Further amend the Wage and Personnel Plan by adding a Section VIII Filing of Records:
  - A. Minutes of all meetings shall be filed with the Board of Selectmen within 10 days of the completion of any meeting.
  - B. Copies of all decisions involving interpretation or enforcement of this Plan shall be filed with the Town Clerk and Board of Selectmen within 10 days of the decision being rendered.
- Article 32. Upon motion duly made and seconded, it was Unanimously Voted to Amend the action of the Special Town Meeting, held on June 28, 1984, Article 20, Wage and Personnel Salary Schedule by deleting all present language and replacing it with the following:
  - "1. Full-time non-union Clerical and General Personnel
    - A. Starting salary, \$5.50 per hour.
    - B. Annual increases for personnel in their second and third years of employment shall be equal to the cost-of-living increase as voted by the Town Meeting and shall take effect on their anniversary of hiring.
    - C. Employees in years four and beyond shall have their cost-of-living increase take effect at the beginning of each fiscal year.
    - 2. Part-time non-union Clerical and General Personnel
      - A. Starting salary shall be no greater than \$5.00 per hour.
      - B. Annual increases shall be in accordance with Part I, Section B of this salary schedule.
    - 3. E.M.T. Certification

"Employees required to obtain an E.M.T. Certificate shall be compensated by an additional \$1.00 per hour upon successful completion of an E.M.T. program."

- Article 33. Upon motion duly made and seconded and motion to amend by Alan I. Dunham, and after discussion, it was Unanimously Voted to raise and appropriate the amount of Forty-five Thousand Five Hundred (\$45,500) Dollars to upgrade present non-union full-time and part-time Clerical and General Personnel with the following positions:
  - A. Full-time employees at a rate of one (1) additional dollar per hour.
  - B. Part-time employees at a rate of not more than .75¢ per hour.

Article 34. Upon motion duly made and seconded and motion to amend by Alan I. Dunham, Town Treasurer and Tax Collector it was Unanimously Voted to raise and appropriate the amount of Twelve Thousand, One Hundred Eighty-five Dollars and fifty-five cents (\$12,185.55) for the purpose of providing a cost of living increase for non-union employees covered by the Wage and Personnel Plan.

Article 35. Upon motion duly made and seconded, it was Unanimously Voted to raise and appropriate the sum of Eleven Thousand Three Hundred Thirty-Four Dollars and Forty-eight Cents (\$11,334.48) for the purpose of upgrading the wages of the Building Inspector. This sum of \$11,334.48 would be in addition to item of \$9,665.52 equaling a total of Twenty-one Thousand (\$21,000.00) Dollars.

Article 36. Upon motion duly made and seconded and motion to amend by Alan I. Dunham, Town Treasurer and Tax Collector, and Selectman, Daniel B. Daly, Jr. it was Unanimously Voted to fix the salaries of Elected Town Officers in accordance with General Laws, Chapter 41, Section 108, as amended as follows:

Article 37. Upon motion duly made and seconded, and motion to amend by Matthew J. Mendes, Sr., Chairman of the Board of Assessors, it was Unanimously Voted to change the Assessors Temporary Clerk to Assessors Full-time Clerical permanent position and to raise and appropriate the sum of \$8,190.00 for this position.

# Selectmen's Report

The past year has been not only a busy one for the Board of Selectmen, but it has also been a year of changes.

Last April, Mr. Frank Kane was elected to the Board replacing Mr. Mazzilli, whose absence from the Board was only temporary because he returned to the Board seven months later in a special election to take Mr. Dan Daly's position which he resigned to accept the Vice Principal position at the new Carver High School.

Among all these changes, the Board was quite busy in dealing with many issues not the least of which was the water situation on Lakenham Drive. After many meetings with the DEQE and the residents, a temporary system was installed at the end of the year, and through an agreement that the Board was able to work out with a water supply company the filling of the temporary tank on an I.O.U. basis or at least until Town Meeting.

The Board also, with regards to the water problems, hired a consultant to conduct a water study for a future water system which was able to be done through a grant the Selectmen obtained from the State in the amount of \$200,000.00.

In addition to the above, the Board has also been successful in finally establishing a Wage & Personnel Committee chaired by Joan White and successfully obtained Town Meeting approval to hire an outside consultant, which just recently completed a Wage & Classification Plan. This will be taken up at this year's Annual Town Meeting.

Through a grant application the Town was also given an EOCD Grant for an Executive Secretary position, which will also be taken up at the upcoming Town Meeting.

The Board has also been quite busy in handling contract negotiations with the Town's three (3) unions and was heavily involved in working with the Computer Study Committee chaired by Dan Ryan, in finally getting a proposal approved for the Town's first Computer System, which will be done in conjunction with the Carver High School Department.

As is quite evident, the responsibilities of the Board are quite time consuming and the Board would never be able to do all the work without the cooperation of the many other elected or appointed Committee Members and we would like to take this opportunity to say "Thank You" to any of you who have helped in some way to make Town Government work for this past year and encourage all residents to get active in their Town.

We would also like to thank Jeanne Roby, the Selectmen's Administrative Assistant and Pat Clark, Secretary, for their outstanding dedication to the Selectmen's Office for the past years.

The Board reactivated the Cable T.V. Committee which is chaired by Paul Strobis. Campbell Cable Company sold to Adelphia within this past year. At a recent meeting the new owners have promised to complete the entire Town as soon as possible.

# **Board of Assessors**

This year the Assessors, employing the services of Appraisal Consultants of New England a State-approved revaluation company, completed a mandatory Triennial recertification of values on all property in Carver. Current property values reflect fair market values as of January 1, 1987. The recertification process was completed in October 1987 and was followed immediately by a two week field review conducted by the Department of Revenue as part of the State recertification procedure.

During the past year this office was severly impacted by the turnover in office staff. In the latter part of 1986 and early 1987 four assessing clerks were hired and subsequently left due mainly to the low wages paid. On March 18th, 1987 Joan Christiano resigned her position as Assistant Assessor and that position remained vacant until May 11, 1987 when former Board member Judith Yelle was hired to fill that position. Other new additions to the office staff include, Brid Jackimowicz, hired in November 1986 and Becky Johnson, hired in January 1987 both as Assessing clerks.

April Town Meeting saw two new members elected to the Board of Assessors, Charles Hamilton was elected to a two year term of office and Robert F. McGrath was elected to a one year term of office. Matthew Mendes was also re-elected for a three year term of office.

In compliance with statutory regulations for Assessors and assessing personnel all members of the office staff and Board have completed course 101 in Assessment Practices and continue to attend courses and seminars offered by the Massachusetts Association of Assessing Officers throughout the year in order to stay informed of changes in the laws and regulations pertaining to assessment of property in Massachusetts.

Research pertaining to the selection of computer hardware and necessary appraisal software for the Assessors office was conducted by the Board. Several vendors were contacted and interviewed and the field was ultimately narrowed to two companies. Appraisal Consultants of New England and Patriot Properties, Inc. The firm that is selected to provide the computer will also be contracted to provide the Town's appraisal and revaluation services during the next three years. A final choice of companies and implementation of this project is anticipated to begin within the next few months.

The Board of Assessors and the office staff remained actively involved in the Plymouth County Assessors 61A Study Committee. The goal of this committee is to promote fair and equitable valuation of agricultural property assessed under the provisions of Chapter 61A and valued annually by the Farmland Valuation Advisory Committee.

During the past twelve months the office staff recorded 600 changes in ownership of property on five sets of records. Plans were received through the Planning Board for eight new subdivisions and 800 building permits were processed for assessment purposes.

36 map revisions were sent to the cartographer to update the assesors plans through 1987. These changes reflect land splits, easements, subdivisions and boundary surveys.

The office staff researched and processed over 3,000 applications for abatement of excise taxes for both fiscal 1986 and fiscal 1987 Motor vehicle excise on trailers and Automobiles. A total of 8,000 excise tax bills were processed through the office from the Registry of Motor Vehicles.

Applications were handled, liens recorded and released and conveyance taxes assessed and valuations updated to comply with FVAC annual guidelines on 98 accounts in Chapter 61, Chapter 61A, and Chapter 61B.

162 statutory exemptions for veterans, elderly, blind and handicapped persons and

61 abatements for overvaluation were accepted and processed for fiscal year 1987.

The Assessors office received an IBM Copy machine through the generosity of the Carver Insurance Agency this year, and wish to express their appreciation.

# **Ambulance Report**

The Carver Ambulance Service has been in effect since 1977. For most of the eleven years this service was provided by the Police Department. In the past few years, we have established a civilian E.M.T. Service to work with the Police Department. At the present time there are twelve civilians and twelve Police Officers. We have a class of twelve civilians in a course which will graduate in March.

To insure the provision of a good ambulance service to the citizens of Carver, we have the Plymouth and Middleboro Ambulance Companies as a back-up. Under the direction of Co-ordinator Stanley McAulliffe of South Meadow, and Thomas Walsh, as his assistant, we feel we provide an outstanding ambulance service to the citizens of Carver. We are also providing service to the Town of Plympton for Ten Thousand Dollars (\$10,000.00) a year.

All expenses are paid for by money received from insurance companies, which means no cost to the Town. We provide two (2) Class 1 ambulances.

Over two thousand ambulance runs were made to the local hospitals. In order to make this successful, it takes all of the dedicated people we have and anyone interested in becoming an E.M.T.

# Office of Emergency Preparedness

The emergency plans for the Town of Carver for the response to an incident at the Pilgrim Nuclear Power Plant were completely rewritten with the assistance of the Massachusetts Civil Defense Agency (MCDA) and Boston Edison. All town departments participated in this project which has resulted in a new Emergency Response Plan. In addition to protecting the citizens of Carver from any nuclear power plant emergency these plans will also prove invaluable in mitigating any crisis arising from a hurricane or severe winter storm. This plan has now been submitted to the Massachusetts Civil Defense Agency for overall review and to the Commissioner of Public Safety. It will then be submitted to the Federal Emergency Management Agency for final approval.

The Town of Carver received new and updated radiological measuring equipment from the State Civil Defense Agency.

The Town of Carver also received a grant from Boston Edison to pay for an assistant to the Civil Defense office and Boston Edison will also be rebuilding the Civil Defense office and equipping it with the necessary materials to bring it into compliance with Federal Emergency Management Agency requirements for towns within the Emergency Planning Zone (EPZ) of a nuclear power plant.

Members of the Civil Defense staff attended several State and Edison sponsored seminars on public safety. The Town of Carver's Civil Defense staff are now all certified radiological officers.

The Civil Defense office and the Police station are now equipped with a new emergency communications system called BECONS that will allow the Civil Defense staff to communicate with MCDA, Boston Edison, and all other towns within the EPZ.

The Civil Defense staff of Carver will continue to work closely with the Massachusetts Civil Defense Agency to assure the citizens of Carver will continue to have the best emergency response plans, training and assistance that the Commonwealth can provide.

Civil Defense is a function of Federal, State, and local governments and is established to insure the safety of citizens and to mitigate the damage caused to communities by natural and national disasters.

### Director's Report

Many services are provided for the Elderly (59 years of age or older) or handicapped, in the Town of Carver, by the Council on Aging. A list of these services, I.D. cards for discounts names placed on mailing list and a list of surrounding area stores who have Discounts for the Elderly may be obtained at the Atwood House in South Carver, which is open daily from 9:00 A.M. to 4:00 P.M. Monday through Friday, for information and referral.

All mini-bus reservations, mall trips, shopping trips, luncheons at the Atwood House Nutrition Center, Medicals, mini-bus drivers, newsletters, home-delivered meals, business calls, information and referral calls have been co-ordinated by the Service Director for the Council on Aging throughout the past year. The Director also assisted many people, of all ages, in commodity food to those who qualified.

The Drop-in at the Marcus Atwood Multi-purpose Center is opened daily from 12 noon to 4:00 P.M., where many activities are enjoyed and all Seniors and Handicapped are invited to attend.

Newsletters are mailed out every three months, keeping the elderly informed on any new legislation, changes in Medicaid or Medicare, Tax information, and three month calendar activities, services, Nutrition Center menus for the ensuing months. Due to rising costs of postage and permits, the mailing has gone from every two months to every three months.

The Council on Aging has seven (7) employees whose salaries are funded by outside agencies. There are three (3) Senior Aides, with various duties, who are paid by the Department of Labor. The Chef, Assistant Chef, and the Site Manager for the Nutrition Center are paid from a grant obtained from the Old Colony Planning Council (The Area Agency on Aging) and the Dishwasher is paid by the Friends of the Carver Council on Aging, Inc.

Luncheons are served daily at the Nutrition Center. The donation is \$1.00. People 59 years of age or older or handicapped are welcome. There is no set income requirement. Since the Nutrition Center has been in operation the "Meals on Wheels" program has been growing rapidly, as all meals are cooked on the premises.

The Carver Council on aging continues to thank the Honorable Board of Selectmen, The Town Boards and the Townspeople for their continuing support of their programs.

# Old Colony Planning Council Area Agency on Aging

As your representatives to the Old Colony Planning Council, Area Agency on Aging Advisory Committee, we are pleased to present this report of the Area Agency's activities for 1987.

The Old Colony Planning Council, acting as the Area Agency on Aging, is responsible for administering Title III funds under the Older Americans Act in the twenty-three communities in the service area. The Area Agency funds and coordinates a wide range of community, in-home and nutrition services through local Councils on Aging and other elder service agencies.

In 1987, several communities in the region directly benefited from funding under Title III-B of the Older Americans Act. These communities included: Brockton for the Dorn-Davies Senior Center; Bridgewater, Easton, and Lakeville for Outreach Programs; Hanover for Senior Center Renovations; Marshfield for the Chore and Minor Home Repair Program; Plymouth for Senior Center Programs; Plympton for the Rent-A-Kid Program; and Whitman for the development of Senior Center Architectural Plans.

In addition to the funding for individual communities, several regional programs received funding to provide services in all or part of the service area. Included among these regional programs are the Volunteer Transportation Program and the Nursing Home Ombudsman Program both administered by the Area Agency on Aging. Old Colony Elderly Services administered the Emergency Assistance Program for elders throughout the service area and the Minibus Program for elders in the communities of Halifax, Hanover, Hanson, Plympton, Rockland, West Bridgewater and Whitman.

Other regionally administered programs funded this year include the Senior Law Project, two home health aide programs, and a hospice program. New regional programs funded this year were two in-home mental health programs and a program to assist mobility-impaired elders in making their home environment safe.

Nutrition services in the form of congregate and home delivered meals are made available through Title III-C monies in many communities in the service area. Several communities including Carver and Middleboro/Lakeville received funding assistance to prepare and provide meals locally. Additionally, many communities in the region operated nutrition sites and received catered meals under the auspices of Old Colony Elderly Services. The communities which hosted OCES nutrition sites and provided home delivered meals include Avon, Brockton, Easton, Halifax, Hanson, Pembroke, Plymouth, Stoughton and Wareham. Several other communities operated locally supported nutrition programs and received home delivered meals from Old Colony Elderly Services for their frail and homebound elders. These nutrition programs play an integral role in attending to both the social and nutritional needs of elders.

The Council gratefully acknowledges the generous support and cooperation of the Area Agency on Aging member communities, specifically the participation and involvement of the members of the Area Agency on Aging Advisory Committee chaired by Mr. John Mather. The Council also recognizes the work of local boards and commissions and the many government agencies, public and private institutions and individuals who have assisted the Council.

# Carver Public Library

The year 1987 was an active one at the library. It was a time of continuing growth and expansion. Programs and policies initiated during the previous year were continued on a larger scale in 1987.

An average of over 500 patrons used the library weekly during a user survey that was conducted this last year. This figure and the increasing book circulation continues to reflect the growth of the Town in general. To meet the needs of this growth, the Library focused on grant applications for computerization and networking. In order to become part of the network of libraries in the New Bedford regional system, we had to start computerizing our book collection. We applied to the state for a microcomputer grant and received an IBM PC XT. With the aid of the Board of Library Commissioners computer classes, we began the lengthy ongoing process of retrospective conversion. Using volunteer and staff time away from general duties to the maximum, the adult collection is now being sent through computer lines to a computer database for the network. We hope to see Carver patrons accessing the New Bedford network (called SEAL, South East Automated Libraries) by the fall of 1988. We will be increasing the library user collection from our 23,000 to over 900,000 volumes. After an automated system is chosen by SEAL members, the big project of converting our patron files will be started.

The Library wishes to thank all who have donated time and money for the conversion project. We would especially like to thank Mr. David Piper and the C.A.P.S. for their help. The Garden Club has been a great help with the Library grounds and even donated a new fence. With the combined gifts of C.A.P.S. and Mrs. Althea Atwood we now have an indoor book return to protect the books and audiovisual materials from the weather and extreme temperatures. Mrs. Althea Atwood, trustee emeritus, gave generously to help make the public library in Carver what it is today. She was always the first to offer aid and brighten our days with her wonderful personality. We are all saddened by her death. Thank you to all who have donated to create a library trust fund in her name. We also received a special book, the biography of Christa McAullif, from the Plymouth Carver Education Association. This was given in memory of the Challenger tragedy.

Special impetus was given this year to the literacy projects throughout the country. Our approach to this important problem was to encourage each child in the Gov. John Carver Elementary School to have a library card. To achieve this, the Librarian spent many hours in the school IMC getting to know the library classes and handing out card applications. We now have all but about 100 students with public library cards.

We would like to welcome Vicki Zonfrelli as our new Children's Department aide. She has helped with the twice weekly preschool storytime as well as many other children's programming activities. This year the twice weekly preschool storytime was supplemented with films, a juggling troupe, A Halloween game room and party, and the New England Theater Guild program for Thanksgiving. Our winter reading program was fun especially with the help of Giorgio's Pizza for donating the pizzas as prizes.

Attendance was high for the annual microwave adult class. Adult use of the best seller collection and the videotape collection have also increased. The Atwood meeting room was used by many local groups including Scouts, Campfire girls, soccer and other sports groups, the Carver Arts Lottery Council, and the Mass. Council on Arts and Humanities regional sessions.

Last December the library's longtime director, Mrs. Karen Miller, left her position at the library after eight years of service. The staff and patrons both were sorry to see

her leave. Under her guidance the library has grown enormously over the past few years. Her contribution to the Town's library is immeasurable and we feel secure in stating that the citizens of Carver are grateful for her fine and dedicated service. Early in January 1988 the Board of Trustees for the library gave her a farewell party which was open to the public. Numerous patrons and local friends attended to say goodbye and to wish her well in her new position.

As of December 1, 1987 the library has been under the direction of Mr. Roger E. Wood who was hired to replace Mrs. Miller as library director.

The next few years will see numerous changes in the library especially in the area of automation. We are and will strive to meet the ever increasing demands of the growing community.

We would like to thank the many patrons who have donated books to the library and the Friends of the Carver Public Library. The library's staff would also like to extend their thanks to our loyal and dedicated staff of volunteers. During the course of the year the following people volunteered their services: Louise Denehy, Diedre Murray, Teresa Katuska, Anita Palmerino, Catherine Salveson, Phyllis Partridge, Doris McNeil, Eva Burke, Lorraine Howes, Margaret Hoolahan and Ruth Donovan.

# Trustees for **Plymouth County Cooperative Extension**

The County Cooperative Extension Service is located on High Street, Hanson (on the grounds of the County Hospital). Cooperative Extension is a partnership of the United States Department of Agriculture, the land-grant college—the University of Massachusetts, Amherst and county government.

County Agents are specialists in: Agriculture, Community Resource Development, Home Economics, 4-H and Nutrition Education and deliver programs in these areas to local residents.

Staff consists of a director, two regional agricultural specialists, a community resource development and specialist, two home economists, three 4-H agents and a split position, 4-H/home horticulture. In addition, Cooperative Extension administers a federally funded nutrition education program, The Expanded Food and Nutrition Education Program (E.F.N.E.P.), located in Brockton. This is staffed by a nutrition specialist and program assistants (6 full-time equivalents) who deliver the educational program to families with limited resources.

Cooperative Extension serves the public through educational conferences, workshops, phone call assistance, field visits and timely newsletters.

In our 4-H program last year 12,535 youth were enrolled, of that number 588 were enrolled in club programs, and 11,947 were exposed to 4-H through short-term projects. 815 volunteers assisted in conducting the county 4-H program.

Newsletters, free for the asking, are *Garden Clippings*, a monthly horticulture fact-filled publication; *So-Sew*, informational "how-to" letter for the serious home sewing; *Creative Living*, provides current information in the areas of clothing and textiles, human development, housing and home management. Newsletters for commercial agricultural enterprises are available (Small Fruit, Vegetables, Tree Fruits, Small Farms and Livestock).

# Plymouth County Mosquito Control Project

The Commissioners of the Plymouth County Mosquito Control Project are pleased to submit the following report of our activities during 1987.

The Project is a special district created by the State Legislature in 1957, and is now composed of 22 Plymouth County towns, the City of Brockton, and the Town of Cohasset in Norfolk County. The Project is a regional response to a regional problem and provides a way of organizing specialized equipment, specially trained employees, and mosquito control professionals into a single agency with a broad geographical area of responsibility.

This year there has been increased public fear concerning the possibility of mosquito transmitted AIDS. To date, however, there has been absolutely no scientific evidence to suggest that mosquitoes are in any way responsible for the transmission of AIDS Virus.

One of the few viruses that can be transmitted by mosquitoes is the one causing Eastern Equine Encephalitis. The threat of Eastern Equine Encephalitis (EEE) was low in 1987. Populations of mammal-feeding mosquitoes were at very low levels when field samples of bird-feeding mosquitoes turned up evidence of the virus. Had populations of mosquitoes capable of moving the virus to humans been higher, additional spraying would have been initiated. As expected, no horse or human cases occurred. The recurring possibility of EEE in Southeastern Massachusetts continues to insure increasing levels of cooperation between this Project and the Massachusetts Department of Public Health.

Overall, 1987 was another year of improvement and progress. Of primary importance was our water management work. A record number of mosquito producing areas were altered, and will no longer require spraying for larvae. Other improvements included reduction in the overall complaint response time, and the initiation of a systematic, county wide trapping program to monitor changes in mosquito populations. All of these accomplishments helped strengthen our Integrated Pest Management (IPM) program.

The figures specific to the Town of Carver are given below. While mosquitoes do not respect town lines, the information given below does provide a tally of the activities which have had the greatest impact on the health and comfort of Carver residents.

1. *Insect Application.* 5,585 acres were treated using truck mounted sprayers for control of adult mosquitoes. More than one application was made to the same site if mosquitoes reinvaded the area. The first treatments were made in May and the last in September. The average complaint response time was three days.

Effort continues to be targeted at mosquitoes in the larval stage, which can be found in woodland pools, swamps, marshes, and other standing water areas. Inspectors continually gather data on these sites and treat with highly specific larvicides when immature mosquitoes are present. Last year a total of 91 inspections were made to 63 catalogued breeding sites.

- 2. Machine Reclamation. 1,230 linear feet of ditch was reconstructed in Carver. This work is important and impacts mosquito populations over a long period of time. Mosquito production in areas where water management has been completed show dramatic reductions and reduce the need for insecticide use.
- 3. Mosquito Survey. A systematic sampling of the mosquitoes in Carver indicates the Coquillettidia perturbans was the most abundant species. Other important species

collected included Culiseta melanura, Aedes abserratus and Culex restuans.

We encourage citizens or municipal officials to call our office for information about mosquitoes, mosquito-borne diseases, control practices, or any other matters of concern.

# Department of Public Works

The Honorable Board of Selectmen:

During the past year the accomplishments of your Board of Public Works were as follows:

New pavement: Road leveling done with Grader. Beaver Dam Road 2,500 ft.; Holmes Street 1,000 ft.; finish Mayflower Road 1,320 ft.; Crystal Lake 1,500 ft.

Chapter projects completed this year: Cranberry Road & Rochester Road. Some 5,871 tons of bituminous concrete was put down on these roads. Line painting, loam and gravel work was also done on these roads at a cost of \$171,751.90.

Over 1,000 ft. of drainage on Rochester Road. This was also project money. 200 ft. of drainage on Center St. has been completed. Future drainage on High St. & Plymouth St. to be done this year.

Line painting was done on the following streets, Tremont, Wareham, Beaver Dam, Meadow St., Purchase St., Silva St. Total footage was 64,775 ft.

Street sweeping Route 58, S. Meadow Rd. and all housing developments were done this year.

Maintenance of Private ways—Pine City, Walker Rd., Bunny's Rd., Andrews' Point Rd., Bates Pond, Old Federal Rd., Crystal Lake Drive. These roads are patched, graded for crown and drainage safety.

There have been 30 burials so far this year.

Snow removal has been heavy this year. The subcontractors have been there when most needed. Sanding has also been tremendous.

The Youth Program, headed by Rocky Gomes, did another good job this year. Lots of painting and maintenance of recreation areas.

M.C.I. workers have also done a good job taking care of cemeteries, cutting road side brush, cleaning up after heavy wind storms by picking up branches all over town. They also pick up a lot of roadside trash. They are a real asset to the Town.

Sand seal oiling was done on the following roads—16,900 ft. on Mayflower Rd., Brook St., Pleasant St. and High St.

One of our real problems is getting easements from local land owners to drain some of these problem areas.

We have many more projects to get started on. Hopefully, we can all work together and get these done.

We would like to thank all the employees of the DPW and all other Departments for their help in a most successful year. Bill Halunen deserves a super thank you for keeping things going smoothly. Alan Dunham, Pat Clark and Jeanne Roby once again gave it their all.

# **Carver Public Schools**

The Carver Public Schools opened on September 2, 1987, with 1196 students, preschool through grade six. A staff of over 100 professionals and para-professionals continue to provide quality service to Carver children.

School Committee members Karen Bell, Charles Erwin, Johanna Leighton, Ellen Napier and Erwin Washburn met on a continuing basis to conduct school business through the year, after electing Mr. Washburn Chairperson for the 34th time during his 36 years as a committee member. The school budget was approved for \$3,148,320. Grant monies through Chapter 188, Special Education and various other programs amounted to over \$300,000. Most of this funding is applied to direct services in the form of additional teaching positions and supplies. A number of new professional staff joined us this year: J. Eldridge—Music, D. Saperstein—Special Needs, J. Barden—grade 4, K. Bourke—Special Needs, C. Honen—School Social Worker, J. Kennedy—grade 4, E. Lightman—Special Needs, J. Kent—grade 5, A. O'Malley—Speech/Language, D. Naglieri—Special Needs, S. Salute—grade 5, D. Rodarte—Special Needs, R. Tinkham—Health/Phys. Ed., D. Tracia—Phys. Ed., A. Butler—Curriculum Coordinator and J. Snarsky—Enrichment Program.

In September 1987, Carver students in grades 7–12 were transported to Plymouth South High School until work on Carver High School was complete. On January 4, 1988, Carver High School opened its doors and for the first time in many years, all Carver students were being educated within town boundaries.

The Carver Home School Association has been very active this year. It has accomplished many worthwhile endeavors on behalf of the children of the Gov. John Carver School. It has had two successful fundraisers including "Santa's Workshop." Not only was that a successful way to raise funds for programs but also it was an educational experience that the children enjoyed. Funds raised have been used to support the playground committee's efforts to construct a new playground. The Cultural Committee has also used funds to hive enrichment programs such as "Santa's International Sleigh Ride" presented by the Renaissance Theatre Company. The CHSA has also been able to purchase seven computer printers for the school while other equipment is purchased by the proceeds of an ongoing canned food label program. A new program instituted this year is the "Birthday Book Club." This enables a child to purchase a book that is then donated to the school library as a permanent memorial to his/her birthday. The Association will continue in its tradition of giving scholarships and supporting the school system in any capacity needed. We look forward to new projects such as the Spring Fair planned for May. All parents are encouraged to join and participate in making their child's education fuller and enriched. —Mary Jane Sullivan, Secretary.

The Basic Skills Remediation program continued for a second year with a grant of \$64,890. Cultural education blossomed at GJC this year with students involved in and exposed to various programs provided by and in conjunction with the Cultural Education Collaborative. The Carver Arts Lottery PASS program was also active in providing programs for parents and students. Staff education continued in Drug and Alcohol Awareness, in mathematics and in Leadership Training for administrators. A number of building renovations continued as the plan to continually maintain and upgrade our facilities is carried out. The older portion of the Gov. John Carver School (front building) received a face lift with interior/exterior painting, window replacements, new window shades, and carpeting. A new modular classroom was contracted and added on to pod 4 of the rear building.

The 1987-1988 year has been a progressive one for the Carver Public Schools. The

future holds much promise for the community and all our students as we move toward becoming an independent system.

## Municipal Finance Terminology

The following terms are frequently used in the Annual Town Report and at Town Meetings. In order to provide everyone with a better understanding of the meaning, the following definitions are provided.

#### SURPLUS REVENUE: (often referred to as "Excess and Deficiency")

This fund represents the amount by which the Cash, Accounts Receivable and other floating assets exceed the liabilities and reserve. This is a bookkeeping item.

#### AVAILABLE FUND: (often referred to as "Free Cash")

Available Funds is the amount certified annually by the State Bureau of Accounts by deducting from surplus revenue all uncollected taxes for prior years. This fund may be used by a vote of the Town Meeting.

#### OVERLAY:

The Overlay is the amount raised by the Assessors in excess of appropriations and other charges for the purpose of creating a fund to cover abatements granted and avoiding fractions.

#### **OVERLAY RESERVE:**

This is the accumulated amount of the Overlay for various years not used or required to be held in the specific Overlay account for a given year, and may be used by vote of the town for extraordinary or unforeseen purposes or voted into the Reserve Fund.

#### RESERVE FUND:

This fund is established by the voters at an annual town meeting only and may be composed of (a) an appropriation (not exceeding 5% of the tax levy of the preceding year), (b) money transferred from Overlay Reserve, or (c) both.

#### STABILIZATION FUND:

This is a fund created to provide a reserve for capital expenditure. Appropriations from the Stabilization Fund may be made at an Annual Town Meeting by a two-thirds vote for any purpose the town is authorized to borrow money for under Section 7 or 8 of Chapter 44 or for such other purpose as is approved by the Emergency Finance Board.

#### **CHERRY SHEET:**

Named for the cherry colored paper on which the Massachusetts Commission of Corporations and Taxation traditionally has printed it, the cherry sheet carries the figures which must be used by the Assessors in determining the amount to be raised by taxation.

It lists the amounts of county tax and state assessments, as well as the estimated tax distributions from the General Fund, reimbursements, agency funds, and the Sales and Use Taxes.

#### Article 14.

**Article 15.** To see if the Town will vote to amend the Town of Carver Zoning By-Laws by adding the following section:

#### Section 14.0 AQUIFER PROTECTION BY-LAW

#### "A. Purpose

The Water Supply Protection Districts are intended to protect the public health, safety, and welfare by preventing contamination of, and preserving the quantity of ground and surface water which provides existing or potential water supply for the Town's residents, institutions and businesses.

#### B. Definitions

For the purposes of this section, the following terms shall be defined as follows:

Agricultural use—land in agricultural use means land primarily used in the raising of animals, fruits, vegetables, berries, nuts, or other food for human consumption, feed for animals, tobacco, flowers, sod, trees, nursery or greenhouse products, and ornamental plants and shrubs, or in raising forest products under a planned program.

*Hazardous waste*—Materials as defined and regulated by 310 CMR 30.00 et seq. (Massachusetts Hazardous Waste Management Regulations).

*Impervious surface*—Material covering the ground, including but not limited to macadam, concrete, pavement, and buildings that does not allow surface water to penetrate into the soil (cranberry bogs are not considered impervious surfaces).

Maximum groundwater elevation—The seasonal high level of the groundwater table. This level shall be the same as the maximum groundwater elevation defined and determined in 310 CMR 15.00 (Title 5, State Environmental Code).

Mining of land—The removal of geologic materials such as topsoil, sand and gravel, metallic ores or bedrock.

Commercial mining of land—The removal of geologic materials such as topsoil, sand and gravel, metallic ores or bedrock for sale as defined by the Zoning By-Laws of the Town.

Solid waste—Unwanted or discarded solid material with insufficient liquid content to be free flowing, including without limitation rubbish, garbage, junk and refuse. The term does not include vegetative compost, tree stumps and brush.

Special Permit Granting Authority (SPGA)—The members of the Carver Conservation Commission.

Toxic or hazardous materials—Any substance or mixture of such physical, chemical or infectious characteristics as to pose a significant, actual or potential hazard to water supplies and to human health, if such materials were discharged to land or waters of this Town. Toxic or hazardous materials include, without limitation, petroleum products, heavy metals, radioactive materials, virulent infectious wastes, pesticides, herbicides, solvents, thinners and other materials which are listed as U.S. Environmental Protection Agency Priority Pollutants.

#### C. Applicability

- Water Supply Protection Districts shall be considered as overlying other zoning districts.
- 2. The applicability of this section to existing uses or structures and to projects legally begun at the time of adoption, shall be governed by the Town of Carver By-Laws.

- 3. The provisions of Parts D.1 and D.2 shall not apply to the installation, operation, or maintenance of necessary public water, public waste water, public storm water, and public electric facilities and devices.
- 4. The provisions of Part D.2 (except D.2.d) shall not apply to land in agricultural use as defined above.

#### D. Use Regulations

- 1. The following uses are prohibited:
  - a. Solid waste disposal facilities, including without limitation landfills and junk and salvage yards, that require a site assignment from the Board of Health under M.G.L., Ch. 111, s. 150A (the Landfill Site Assignment Law) and regulations adopted by the Department of Environmental Quality Engineering, 310 CMR 19.00;
  - Storage of hazardous wastes in quantities as defined by the Massachusetts
     Hazardous Waste Management Regulations by a "large quantity generator"
     including without limitation chemical wastes, radioactive wastes and waste
     oil;
  - c. Disposal of hazardous wastes.
  - d. Disposal of snow that contains de-icing chemicals and that has been brought in from outside the District;
- 2. If, in the judgement of the Special Permit Granting Authority, the Design and Operation Standards in Part F are adequately satisfied and not otherwise prohibited in Part D.1, the following uses may be allowed upon issuance of a Special Permit and subject to such conditions as the SPGA may impose. Failure to comply with the terms and conditions of a Special Permit shall be grounds for revocation of said permit.
  - a. Commercial mining of land;
  - b. Major construction projects requiring approval of the Carver Planning Board, and which are subject to site plan review;
  - Any uses where more than 10,000 square feet of any lot would be rendered impervious;
  - d. Underground storage of petroleum and other refined petroleum products, including without limitation gasoline, waste oil, and diesel fuel, except within buildings which it will heat or where it currently exists or for in-kind replacement or in quantities for normal household use (less than 500 gallons), provided there is compliance with all local, State and Federal laws;
  - e. Storage of road salt or de-icing chemicals in quanitites greater than for normal household use;
  - f. Manufacture, use, storage, or disposal of toxic or hazardous materials as part of a principal activity, but excluding domestic activities and pesticide applications for normal agricultural use (provided these are in compliance with all local, state and federal laws);
  - g. Motor vehicle service stations, repair garages, car washes, truck or bus terminals, heliports, airports, electronic manufacturing, metal plating, commercial chemical and bacteriological laboratories, and dry cleaning establishments using toxic or hazardous materials on site;

#### E. Site Plan Approval

Any application for a special permit shall be made, reviewed and acted upon in accordance with the following procedures:

- 1. Each application for a special permit shall be filed in writing with the SPGA and shall contain a complete description of the proposed use, together with any supporting information and plans which the SPGA may require. Submissions should include appropriate engineering data to provide a basis for reviewing the impact of the proposed activity on the Groundwater Protection Districts.
- 2. The SPGA shall refer copies of the application to the Board of Health, Planning Board, and the Department of Public Works, which shall review, either jointly or separately, the application and shall submit their recommendations to the SPGA. Failure to make recommendations within 35 days of the referral of the application shall be deemed lack of opposition.
- 3. The SPGA shall hold a public hearing on the application, in conformity with the provisions of M.G.L. Ch. 40A within 65 days after the filing of the application with the SPGA. A written notice of this public hearing will be made by the applicant to all abutters, and proof of notification will be furnished to the SPGA. In addition, this notice will be published in a newspaper of general circulation within the Town not less than 14 days prior to the hearing.
- 4. After notice and public hearing, and after due consideration of the reports and recommendations of the local boards/departments, the SPGA may grant such a special permit provided that it finds the proposed use:
  - a. is in accordance with the provisions of Section F;
  - b. is in harmony with the purpose and intent of this Bylaw and will promote the purposes of the Groundwater Protection Districts;
  - c. is appropriate to the natural topography, soils and other characteristics of the site to be developed;
  - d. will not, during construction or thereafter, have an adverse environmental impact on the aquifer or recharge area; and
  - e. will not adversely affect an existing or potential water supply.

#### F. Design and Operation Standards

- Safeguards—Provision shall be made to adequately protect against toxic or hazardous materials discharge or loss through corrosion, accidental damage, spillage or vandalism through such measures as provision for spill control in the vicinity of chemical or fuel delivery points, secure storage areas for toxic and hazardous materials, and indoor storage provisions for corrodible or dissolvable materials.
- 2. Disposal—No disposal of hazardous wastes within Water Supply Protection Districts shall occur. All provisions of M.G.L., Ch. 111, S. 150A (the Landfill Site Assignment Law) and M.G.L., Ch. 21C (the Massachusetts Hazardous Waste Management Act) shall be adequately satisfied.
- 3. Fill—Fill material used in a Water Supply Protection District shall contain no solid waste, toxic or hazardous materials, or hazardous waste. Adequate documentation shall be provided to ensure proper condition of the fill. The SPGA may require soils testing by a certified laboratory at the applicant's expense.

- 4. Spill containment—For industrial and commercial uses, an emergency response plan to prevent contamination of soil or water in the event of accidental spills or the release of toxic or hazardous materials shall be submitted to the SPGA, if deemed necessary, for approval prior to granting of a Special Permit. Recommendations of the Fire Department on said plan shall be sought.
- 5. Monitoring—Periodic monitoring shall be required when the site location and land use activities indicate a significant risk of contamination to the water supply as determined by the SPGA based upon recommendations of the Department of Public Works, Board of Health, Conservation Commission and/or the SPGA. Such monitoring may include analyses of water or soil for appropriate substances and installation of groundwater monitoring wells constructed and located as specified by the Department of Public Works, Board of Health, the Conservation Commission and the SPGA. All monitoring wells must meet or exceed the proposed or current DEQE design standards for monitoring well installation. All costs will be borne by the owner of the premises.
- 6. On-site recharge—All storm water runoff from impervious surfaces shall be recharged on-site unless in conducting site plan review it is determined that either recharge is infeasible because of site conditions or is undesirable because of uncontrollable risks to water quality from such recharge. Such recharge shall be by surface infiltration through vegetated surfaces unless otherwise approved by the SPGA during site plan review. If dry wells or leaching basins are approved for use, they shall be preceded by oil, grease and sediment traps. Drainage from loading areas for toxic or hazardous materials shall be separately collected for safe disposal.
- 7. Grade reduction—Soil overburden shall not be lowered to finished exterior grades less than five (5) feet above maximum groundwater elevation unless technical evidence can be provided showing to the SPGA's satisfaction that groundwater quantity or quality will not be detrimentally affected. Technical evidence may include, without limitation, a determination of soil and geologic conditions where low permeability will mitigate leachate penetration and evapotranspiration.

#### G. Enforceability

Failure to comply with the provisions of the Carver Aquifer Protection Bylaw may consitute grounds for legal action. Whoever violates any provision of this Bylaw shall be punished by a fine of not more than one thousand dollars (\$1,000.00) or by imprisonment for not more than six (6) months or both. Each day or portion thereof of continuing violation shall constitute a separate offense.

The Water Supply Protection Districts are as follows:

- All areas presently listed as "wetlands" on the Carver Planning Board overlay.
- All areas shown as "floodplains" on the Flood Insurance Rate Maps for the Town of Carver.
- All areas to the south and east of Tremont St. (these areas show "high" availability of groundwater in unconsolidated deposits. Saturated thickness is estimated by the USGS and the Mass. Water Resources Commission to be greater than 50 feet, and therefore provide for significant potential flow).
- All areas to the north and east of Brook St., Snappit Rd. and Plymouth St. (these areas show "high" availability of groundwater in unconsolidated

deposits. Saturated thickness is estimated by the USGS and the Mass. Water Resources Commission to be greater than 50 feet, and therefore provide for significant potential flow)."

Article 18. To see if the Town will vote to appropriate a sum of money for remodeling, reconstructing and making extraordinary repairs to the Carver public school buildings so as to replace their heating systems, including costs incidental and related thereto, and to determine whether such appropriation shall be raised by borrowing or otherwise, or take any other action relative thereto.

Article 19. To see if the Town will vote to transfer the sum of One Thousand Seven Hundred Sixty-five Dollars and forty-seven cents (\$1,765.47) from the Revenue Sharing Trust Fund account, and to transfer the sum of Three Thousand (\$3,000.00) Dollars from Free Cash or available funds in the Treasury and transfer the sum of One Thousand (\$1,000.00) Dollars from the 1986 Pickup Purchase Account for the purpose of making renovations in the Town Hall or take any other action relative thereto.

Article 19.

Article 20. To see if the Town will vote to approve Amendment No. 6 to the Agreement Establishing the Plymouth-Carver Regional School District. The proposed amendment would add a new Subsection I(K) to the Agreement providing in substance that the District staff shall include an assistant superintendent of schools, nominated by the superintendent, whose principal responsibility shall be matters relating to the District school or schools located in Carver and whose salary and related expenses shall be apportioned annually as operating costs to the Town of Carver. The new subsection reads as follows:

#### (K) Assistant Superintendent

The staff employed by Committee shall include an assistant superintendent of schools who shall be nominated by the superintendent of schools as provided by law and whose principal responsibility shall be matters relating to the District school or schools located in the Town of Carver. The salary and other costs related to the office of such assistant superintendent shall be attributed to the regional district school or schools located in the Town of Carver for purposes of apportioning operating costs under subsection IV (E) (1).
