### Carver Community Electricity Aggregation has been Renewed through November 2025

*Carver, MA – (October 18, 2023):* Carver Community Electricity Aggregation is announcing the renewal of the program through the term December 2023 – November 2025. **Most participants do not need to take any action to remain in the program and receive the new pricing for the product in which they are currently enrolled. Read on for more information.**

Most participants in Carver’s program use “Carver Standard”, which offers the same renewable energy content as Eversource Basic Service. “Carver Standard” participants will automatically receive the new program pricing on their December meter read. Due to requirements from the Department of Public Utilities, participants in the 50% and 100% renewable product must affirmatively re-enroll in a product of their choosing to remain in the program. The Program cannot guarantee savings beyond the current term of Eversource Basic Service, as stated in the table above, because future Eversource Basic Service rates are unknown.

The voluntary renewable energy content in the Program's optional product comes from projects that qualify as MA Class I renewables and makes a sizable impact on the Town's carbon footprint. Since Carver Community Electricity Aggregation's launch in 2016, participants have cumulatively purchased 80 MWh of renewable energy. This equates to avoiding over 65,520 pounds of carbon dioxide emissions cumulatively.

Over 4,300 accounts participate in the program, a vast majority of the Town's residential, commercial, and industrial electricity users. Participants have collectively saved more than \$6,500,000 since the program's launch in 2016 (please note, future savings cannot be guaranteed).

This is a Town-operated program open to all Carver residents and businesses.
