## Special Town Meeting Monday, June 16, 2008

The Special Town Meeting of the Inhabitants of the Town of Carver was held on Monday, June 16, 2008 at 7:00 P.M., pursuant to a warrant of the Board of Selectmen, dated May 29, 2008. The meeting was called to order at 7:10 P.M. by the Moderator, John S. Murray, there being a quorum 75 present. The total registered voters at this time were 222. The following Articles were voted on:

**Article 1.** Upon motion duly made and seconded and motion made by Robert Bentley, Community Preservation Commission, it was Unanimously Voted for the Town to appropriate Thirty Nine Thousand Six Hundred Seventy Eight and 33/100 Dollars (\$39,678.33) from the Community Preservation Unrestricted Reserve to pay down FY 2008 BAN interest used to fund the purchase of +/-98 acres of land known as the western portion of the Cole property as referred to as Parcel 1 in Article 1 at the Special Town Meeting held on December 11, 2006, which purchase was authorized thereunder, said sums to be expended under the direction of the Community Preservation Committee in consultation with the Conservation Commission and the Board of Selectmen.

Article 2. Upon motion duly made and seconded and motion made by John Angley, Chairman, Board of Selectmen, it was Unanimously Voted for the Town to transfer from available funds the sum of One Hundred Forty Thousand Seventy Six (\$140,076.00) Dollars recommended by the Board of Selectmen to supplement specific budget line items appropriated at the 2007 Annual Town Meeting as follows:

## **Article 3. WITHDRAWN** (Cole Property Parcel 2 - engineering and permitting of a Zone 2 expansion)

Article 4. Upon motion duly made and seconded and motion made by John Angley, Chairman, Board of Selectmen it So-Passed by Majority Vote for the Town to transfer from available funds the amount of Six Thousand Two Hundred Six Dollars and forty-four cents (\$6,206.44) to update the Town's Wage and Classification survey last performed in 1999.

Article 5. Upon motion duly made and seconded and motion made by Ellen Blanchard, Director of Assessors, it was Unanimously Voted for the Town to increase the gross receipts that seniors may have in the prior calendar year to be eligible to defer property taxes under M.G.L. c. 59 § 5, Clause 41A from \$20,000.00 to \$40,000, with such increase to be effective for deferrals granted for taxes assessed for any fiscal year beginning on or after July 1, 2008.

**Article 6.** Upon motion duly made and seconded and motion made by Ellen Blanchard, Director of Assessors, it was Unanimously Voted for the Town to reduce the rate of interest that accrues on property taxes deferred by eligible seniors under M.G.L. c. 59 § 5, Clause 41A from **8% to 4%**, with such reduced rate to apply to taxes assessed for any fiscal year beginning on or after July 1, 2008.

Selectmen recommended 5-0-0 Finance Committee: No-Action

Upon motion duly made and seconded and motion made by John S. Murray, Moderator, it was Unanimously Voted to adjourn the meeting at 7:35 P.M.
