## SPECIAL TOWN MEETING WARRANT

Plymouth, ss. To either of the Constables of the Town of Carver, County of Plymouth in the Commonwealth of Massachusetts

## **GREETING:**

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the Town of Carver qualified to vote in Town affairs, to meet at the Carver High School, in said Carver, on February 25, 2008 at 7:00 O'CLOCK P.M., then and there to act on the following Articles, namely:

**Article 1.** To see if the Town will vote to transfer from available funds in the treasury the sum of One Hundred Thirty-Two Thousand, Four Hundred Eighty-Eight Dollars and Nine Cents (\$132,488.09) to pay the following unpaid bills under the provisions of Chapter 240, § 7 of the Acts of 1989, or take any other action relative thereto:

- **Article 2.** To see what amount the Town will vote to raise and appropriate or transfer from available funds for the purpose of funding a collective bargaining agreement with the Police Union. (By Board of Selectmen)
- Article 3. To see if the Town will vote to transfer from available funds amounts recommended by the Board of Selectmen to supplement the legal and gasoline budget line items appropriated at the 2007 Annual Town Meeting, or take any other action relative thereto. (By Board of Selectmen)
- **Article 4.** To see if the Town will vote to authorize the Board of Selectmen to acquire, on behalf of the Town, by purchase, gift, eminent domain or otherwise, a twenty (20) foot wide centerline waterline easement from land of the Town located off Pleasant

Street and shown as "20'W WATERLINE EASEMENT" on the Plan entitled "Carver Water Supply Project Proposed Water Line Option 4", a copy of which is on file with the Town Clerk, for water supply purposes including a single lane, twelve (12) foot wide trail within the easement area and a fifteen (15) foot wide temporary construction easement parallel to the Waterline Easement shown as "15'W CONSTRUCTION EASEMENT" on said Plan; and to appropriate a sum of money therefore or take any other action relative thereto. (By Board of Selectmen)

**Article 5.** To see if the Town will vote to transfer from the Treasurer for Tax Title purposes to the Board of Selectmen for general municipal purposes a parcel of Town owned land located at the end of Wade Street Shown as Lot 3B on Platt 112, and to authorize the Board of Selectmen to grant an emergency access easement over the said parcel to be appurtenant to a parcel of land owned by A.D. Makepeace Company located on South Meadow Road shown as Lot 1-4 on Plat 107, or take any other action relative thereto. (By the Planning Board)

And you are directed to serve this warrant by posting attested copies thereof at the several places designated by vote of the Town fourteen days at least before the time of holding said meetings.

Hereof fail not and make due return of this warrant, with your doings thereon, at the time and place of meeting aforesaid.
