

Town of Carver SPECIAL TOWN MEETING WARRANT

Plymouth, ss. To any of the Constables of the Town of Carver. County of Plymouth in the Commonwealth of Massachusetts.

GREETING:

In the name of the Commonwealth of Massachusetts, you are hereby directed to notify and warn the Inhabitants of the Town of Carver qualified to vote in Town affairs, to meet at the Carver High School, all three precincts in said Carver, on the Thirtieth day of November, 2009 at 7:00 O'Clock P.M., then and there to act on the following Articles, namely:

Article 1. To see if the Town will vote to amend the vote taken under Article 3 of the 2009 Annual Town Meeting, and as may be necessary, to raise and appropriate or transfer from available funds sums for such purpose, all for the purpose of balancing the Fiscal Year 2010 municipal budget, or take any other action relative thereto.

(By the Board of Selectmen)

Article 2. To see if the Town will vote to transfer the sum of Three Thousand Dollars (\$3,000.00) from the Council on Aging Salary line item to the Council on Aging Expense line item, or take any other action relative thereto.

(By the Board of Selectmen)

Article 3. To see if the Town will vote to transfer from the Legal Services Account under the Treasurer/Collector (G/L #01-000-151-0075-5305-00) to the Postage Account under the Treasurer/Collector (G/L # 01-000-145-0057-5343-00) a sum of Two Thousand Five Hundred (\$2,500.00) Dollars to pay for postage and mailing costs needed to remind Taxpayers of the due dates for the Fourth (4th) quarter tax bills and other matters pertaining to tax collections, or take any other action relative thereto.

(By Treasurer / Tax Collector)

Article 4. To see if t he Town will vote to transfer the properties of 3 Oak Drive, Map 62, Lot 175; 0 Oak Street, Map 62, Lot 174; O Wade Street, Map 112, Lot 3-b; and 247 Tremont Street, Map 8, Lot 7 from the Tax Collector for purposes of sale at auction to the Board of Selectmen for purposes of sale, and to authorize the Board of Selectmen to convey said property to the Carver Redevelopment Authority, and to take any action necessary to effectuate the purposes of this vote, or take any other action relative thereto.

Article 5.	To see if the Town will vote to grant an exemption from real estate taxes
to any shed/ou	tbuildings 120 square feet n size or less located on a manufactured home
site, or take an	y action relative there to.
